HB 4014 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Authorizes the State Department of Fish and Wildlife and the State Fish and Wildlife Commission to award moneys from the Oregon Conservation and Recreation Fund under a Landowners Living with Beavers Grant Program, on recommendations from the Oregon Conservation and Recreation Advisory Committee.

HB 4016 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Makes certain changes to the Prescribed Fire Liability Pilot Program.

HB 4015  
Permits a developer of a facility or the governing body of a local government after consulting with the developer to elect to defer regulatory authority to the Energy Facility Siting Council for the siting of a battery energy storage system.

HB 4013  
Prohibits the Department of Environmental Quality from enforcing the provisions of the producer responsibility program applicable to wine packaging.

HB 4102  
Specifies the sources of moneys in the Natural and Working Lands Fund.

HB 4112 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the Oregon Department of Administrative Services to adopt rules to govern procurements from clean energy technology companies.
