HB 4138

(1:05 - 1:20 pm) Allows the Oregon Liquor and Cannabis Commission to issue provisional service permits to an applicant for a service permit.

HB 4098

(1:20 - 1:35 pm) Establishes the CHIPS Child Care Fund. Directs the Oregon Business Development Department to develop and administer a child care infrastructure grant program.

HB 4042

(1:35 - 1:50 pm) Authorizes the Oregon Business Development Department to provide financial assistance to projects related to industrial land.

HB 4101

(1:50 - 2:05 pm) Requires the Secretary of State to collect, and share with state agencies, small business development centers and certain organizations, information about the ethnicity, gender and veteran status of an owner or principal of a business that applies for or renews a business registration in this state, if the owner or principal chooses to provide the information.
