(1:05 - 1:35 pm) Appropriates moneys to the Oregon Business Development Department to distribute to Oregon cultural organizations in response to the negative impact of the COVID-19 pandemic on organization finances.

HB 4138
Allows the Oregon Liquor and Cannabis Commission to issue provisional service permits to an applicant for a service permit.

HB 4098 ** **Subsequent Referral(s) to Ways and Means
Establishes the CHIPS Child Care Fund.

HB 4042 ** **Subsequent Referral(s) to Ways and Means
Authorizes the Oregon Business Development Department to provide financial assistance to projects related to industrial land.

HB 4101
Requires the Secretary of State to collect, and share with state agencies, small business development centers and certain organizations, information about the ethnicity, gender and veteran status of an owner or principal of a business that applies for or renews a business registration in this state, if the owner or principal chooses to provide the information.

HB 4040 ** **Subsequent Referral(s) to Ways and Means
Requires the Oregon Business Development Department to study economic development in Oregon.
