Public Hearing

HB 4158

Establishes the Home and Small Center Child Care Fund. Directs the Oregon Business Development Department to administer a grant program to provide financial assistance to child care facilities that serve a maximum of 75 children for the purpose of establishing or expanding child care infrastructure.

HB 4087

Directs the Department of Human Services to establish an Emergency High Acuity Youth Initiative program.

HB 4131

Appropriates moneys from the General Fund to the Housing and Community Services Department for the purpose of making matching deposits into individual development accounts.
