Work Session

- HB 4085 ** **Subsequent Referral(s) to Ways and Means
Directs the Department of Human Services to provide grants to assist individuals who are noncitizens and who do not possess valid immigration documentation to change their immigration status or obtain lawful permanent resident status.
- HB 4086
Modifies when the Department of Human Services is required to investigate child abuse reports.
- HB 4087 ** **Subsequent Referral(s) to Ways and Means
Directs the Department of Human Services to establish an Emergency High Acuity Youth Initiative program.
- HB 4159 ** **Subsequent Referral(s) to Ways and Means
Requires the Office of Immigrant and Refugee Advancement to contract with entities to provide eligible newcomers with case management, short-term and long-term support services.
