#### Public Hearing

HB 4077

Authorizes moneys in the High Cost Disabilities Account to be distributed to school districts that have a community impact that causes disproportionately high costs associated with the provision of special education and related services.

HB 4078

Directs the Department of Education to develop and implement a standardized method to be used by school districts and the department to electronically create, collect, use, maintain, disclose, transfer and access student data.

#### Possible Work Session

HB 4068

Directs the Oregon Department of Administrative Services to prepare a tentative budget for the funding of the State School Fund. Requires the department to form a committee for the purpose of preparing the tentative budget.

HB 4079

Removes the percentage cap on the amount of moneys that are distributed from the State School Fund to school districts for students eligible for special education as children with disabilities.

HB 4082

Requires the Department of Education to establish and administer the Summer Learning Grant program.
