HB 4119

Enhances the protections for post-secondary institutions of education, student athletes and others regarding the provision of compensation for a student's name, image, likeness or athletic reputation.

HB 4125

Directs the Legislative Policy and Research Director to conduct a study on the impact of Senate Bill 242 (2011) on higher education in this state.

HB 4154

Establishes the Semiconductor Talent Sustaining Fund and subaccounts of the fund.
