#### Public Hearing

SB 1558

Makes an exception to abbreviated school day requirements for when a student voluntarily does not schedule a class for one or more class periods or for certain asynchronous instruction.

SB 1583

Prohibits discrimination when selecting textbooks, instructional materials, program materials or library books that are used in the public schools of this state.

#### Possible Work Session

SB 1502 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the governing bodies of school districts, education service districts, community college districts and public universities to live stream governing body meetings if technically practicable, and to post the recordings of the meetings on their official public body websites or social media sites.

SB 1532 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the Department of Education to develop and implement a statewide education plan for students who are asylum seekers, refugees or any other immigrant.

SB 1592 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Appropriates moneys from the General Fund to the Higher Education Coordinating Commission for distribution to certain institutions of higher education to expand the behavioral health workforce in Oregon.

SB 1551 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Waives the requirement that an otherwise eligible Oregon Promise grant recipient must have completed high school within six months of enrolling in certain community college courses for those individuals who completed high school or its equivalent in 2020 or 2021.
