#### Public Hearing and Possible Work Session

- SB 1554 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the Oregon Health Authority to study access to behavioral health treatment in this state.
- SB 1569 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires medical assistance reimbursement of cognitive assessment and care planning for recipients who experience the signs or symptoms of cognitive impairment.
- SB 1594 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires a behavioral health care facility to have in place a safety plan to ensure the safety of the employees of the facility.

#### Work Session

- SB 1506  
Allows a pharmacist to test for and treat a certain virus.
- SB 1565 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Requires the Department of Human Services to pay for attendant care services for children with developmental disabilities who have very high behavioral health needs or very high medical needs.
- SB 1578 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the Oregon Health Authority to establish and maintain an online portal with the functionality to provide online scheduling for health care providers and coordinated care organizations to use to contact health care interpreters directly and to process billing.
