SB 1575

CARRIED OVER FROM THE 2/14/24 MEETING: Provides that a public body may not include certain provisions relating to payment of defense costs in a contract with a person or entity providing architecture, landscape architecture, engineering, photogrammetric mapping, transportation planning, land surveying services or related services.

SB 1574

Provides that abuse of a corpse in the first degree involving sexual activity is a sex crime for purposes of sex offender reporting.

SB 1576

Requires the Judicial Department to study civil law matters.

SB 1587 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Grants certain immunities to children's advocacy centers and to employees and designated agents of children's advocacy centers.
