## **SUMMARY**

Digest: The Act approves certain fees charged by state agencies. (Flesch Readability Score: 75.5).

Approves certain new or increased fees adopted by state agencies.

Declares an emergency, effective on passage.

- 5 291.055 (1)(e), the following new or increased fees, adopted by the De-
- 6 partment of Public Safety Standards and Training and approved by the
- 7 Oregon Department of Administrative Services, are approved:
- 8 (1) Private Security Entity License Fee: \$624
- 9 (2) Late Renewal Fee: \$50
- 10 (3) Duplicate or Replacement License Fee: \$24
- 11 (4) Non-sufficient Funds Penalty Fee: \$25
- 12 SECTION 2. For the purpose of carrying out the provisions of ORS
- 13 291.055 (1)(e), a fingerprinting and background check fee of \$140,
- 14 adopted by the Higher Education Coordinating Commission and ap-
- 15 proved by the Oregon Department of Administrative Services, is ap-
- 16 proved.
- SECTION 3. For the purpose of carrying out the provisions of ORS
- 18 291.055 (1)(e), the following new or increased fees, adopted by the State
- 19 Department of Agriculture and approved by the Oregon Department
- 20 of Administrative Services, are approved:

- 1 (1) Hemp Grower Late Fee: \$250
- 2 (2) Noncommercial Pesticide Applicator License per year, including 3 one category: \$50
- 4 (3) Noncommercial Pesticide Applicator License per year, for each additional category: \$7.50
- (4) Noncommercial Pesticide Applicator License per year, for each
  additional category after license issued: \$12.50
- 8 (5) Noncommercial Pesticide Trainee License: \$50
- 9 <u>SECTION 4.</u> For the purpose of carrying out the provisions of ORS 291.055 (1)(e), the following new or increased fees, adopted by the Department of Environmental Quality and approved by the Oregon Department of Administrative Services, are approved:
- 13 (1) Seismic Risk Assessment Submittal Fee: \$39,000
- 14 (2) Annual Compliance Fee: \$23,000
- 15 (3) Risk Mitigation Implementation Plan Submittal Fee: \$36,000
- 16 (4) Mattress Stewardship Fee: \$205,000
- 17 (5) Carrier Permit Annual Compliance: \$200
- SECTION 5. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), an Alcohol Delivery Training Program Review Fee of \$250, adopted by the Oregon Liquor and Cannabis Commission and approved by the Oregon Department of Administrative Services, is approved.
- SECTION 6. This 2024 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2024 Act takes effect on its passage.
