## SUMMARY

Digest: The Act approves certain fees charged by state agencies. (Flesch Readability Score: 75.5).

Approves certain new or increased fees adopted by state agencies.

Declares an emergency, effective on passage.

## A BILL FOR AN ACT

Relating to state financial administration; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), the following new or increased fees, adopted by the Department of Public Safety Standards and Training and approved by the Oregon Department of Administrative Services, are approved:**

**(1) Private Security Entity License Fee: \$624**

**(2) Late Renewal Fee: \$50**

**(3) Duplicate or Replacement License Fee: \$24**

**(4) Non-sufficient Funds Penalty Fee: \$25**

**SECTION 2. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), a fingerprinting and background check fee of \$140, adopted by the Higher Education Coordinating Commission and approved by the Oregon Department of Administrative Services, is approved.**

**SECTION 3. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), the following new or increased fees, adopted by the State Department of Agriculture and approved by the Oregon Department of Administrative Services, are approved:**

1 (1) Hemp Grower Late Fee: \$250

2 (2) Noncommercial Pesticide Applicator License per year, including  
3 one category: \$50

4 (3) Noncommercial Pesticide Applicator License per year, for each  
5 additional category: \$7.50

6 (4) Noncommercial Pesticide Applicator License per year, for each  
7 additional category after license issued: \$12.50

8 (5) Noncommercial Pesticide Trainee License: \$50

9 **SECTION 4.** For the purpose of carrying out the provisions of ORS  
10 291.055 (1)(e), the following new or increased fees, adopted by the De-  
11 partment of Environmental Quality and approved by the Oregon De-  
12 partment of Administrative Services, are approved:

13 (1) Seismic Risk Assessment Submittal Fee: \$39,000

14 (2) Annual Compliance Fee: \$23,000

15 (3) Risk Mitigation Implementation Plan Submittal Fee: \$36,000

16 (4) Mattress Stewardship Fee: \$205,000

17 (5) Carrier Permit Annual Compliance: \$200

18 **SECTION 5.** For the purpose of carrying out the provisions of ORS  
19 291.055 (1)(e), an Alcohol Delivery Training Program Review Fee of  
20 \$250, adopted by the Oregon Liquor and Cannabis Commission and  
21 approved by the Oregon Department of Administrative Services, is  
22 approved.

23 **SECTION 6.** This 2024 Act being necessary for the immediate pres-  
24 ervation of the public peace, health and safety, an emergency is de-  
25 clared to exist, and this 2024 Act takes effect on its passage.
