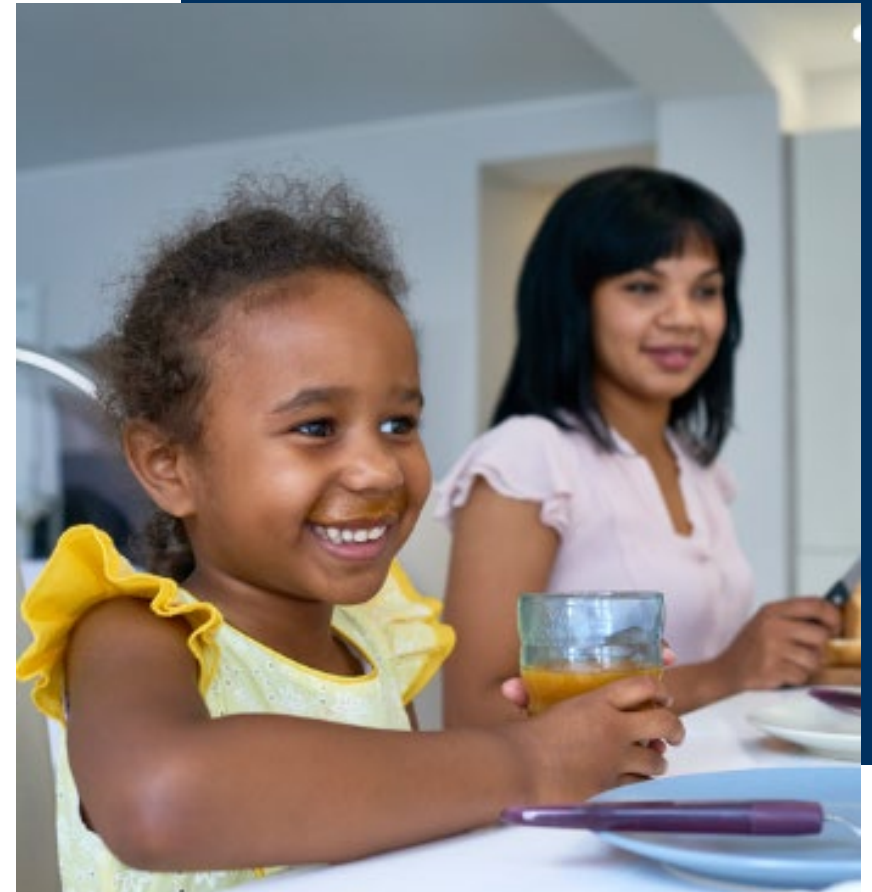

Self-Sufficiency Programs work to build well-being

- Our services **lift people out of poverty** and keep them **from experiencing poverty** in the first place.
- Our policies and practices **reduce the racial wealth gap** and **support each person** served to achieve financial stability.
- Our holistic services are tailored to connect people with future-focused skills, training, and education to **secure stable and well-paying jobs** connected to their long-term goals.
- Our case management, resource navigation support and referrals are accessible and equitable so **people can address the barriers unique to them.**



Food security is an essential part of well-being

People's health and well-being are shaped by many intersecting factors, including consistent access to nutritious foods.

Self-Sufficiency Programs (SSP) supports well-being by addressing conditions people experience across these factors, and we are reshaping our programs in ways that **emphasize prevention and serve people more holistically.**

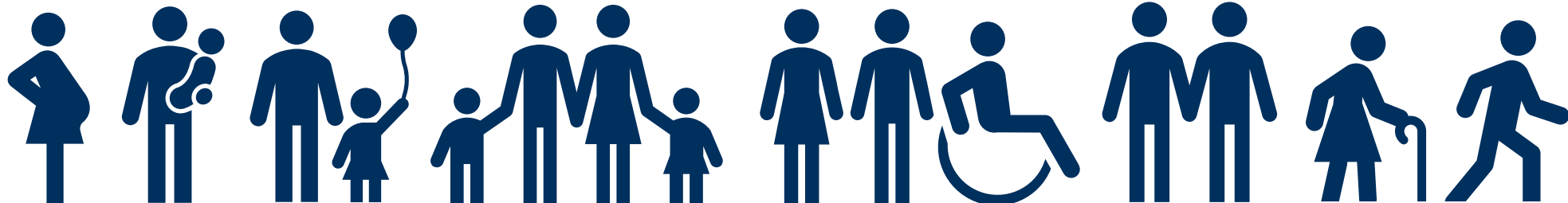

Today's focus

- **Summer EBT** is a new, permanent and nationwide nutrition assistance program created by the Consolidated Appropriations Act of 2023
- Provides **\$40 per child per summer month** for a total benefit of \$120, issued in June
- States can participate beginning in summer 2024.

Summer EBT will help address the summer hunger gap when many children lose access to the free and reduced-price meals they had at school.



Partnering to reduce child hunger

This legislative session, ODHS, Oregon Department of Education and Oregon Health Authority are jointly requesting the resources necessary to launch Summer EBT in 2024.

The program would serve an estimated 294,000 Oregon children with a total annual issuance of \$35.3 million.



Why Summer EBT?



High food costs continue to limit access

Average daily cost of food per person (U.S.)

\$11.04

Average daily SNAP benefit per person

\$5.32

12.4%

Increase in grocery prices from October 2021 to 2022*



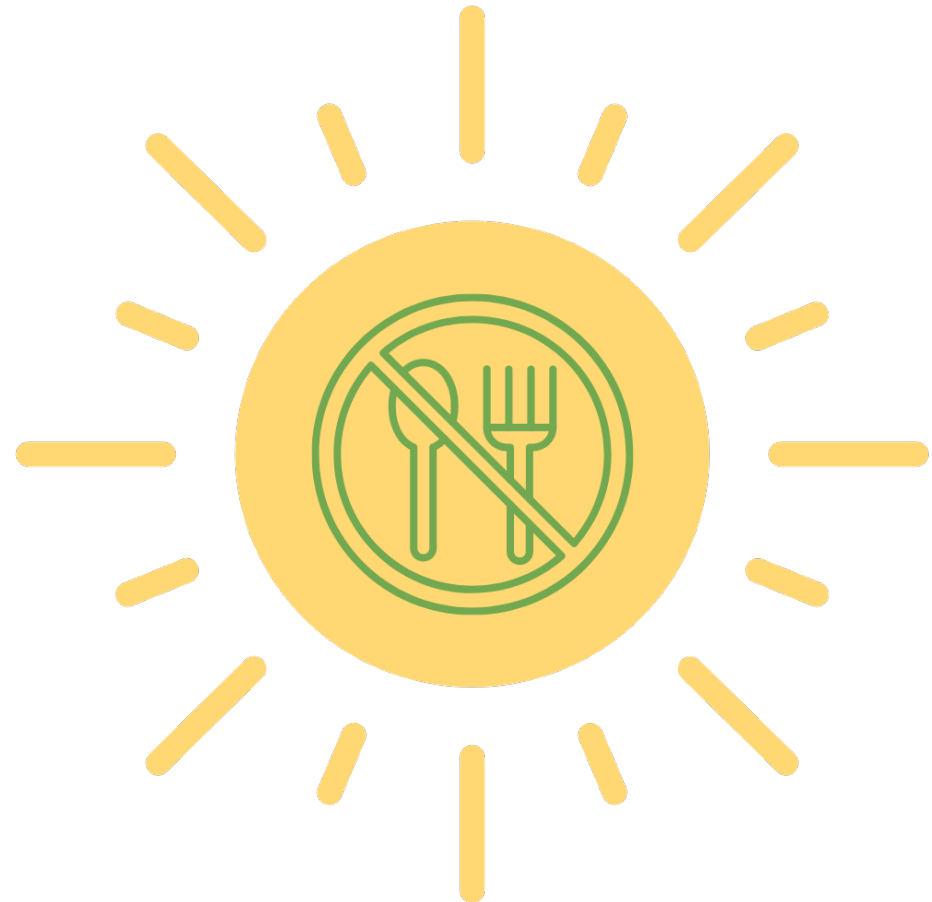

Direct food assistance makes a difference

Summer EBT is built on national research that shows providing food dollars to low-income families with school-age children helps close the hunger gap. **Pandemic EBT** demonstrated the potential for programs like Summer EBT:

Summer EBT brings federal funds into Oregon

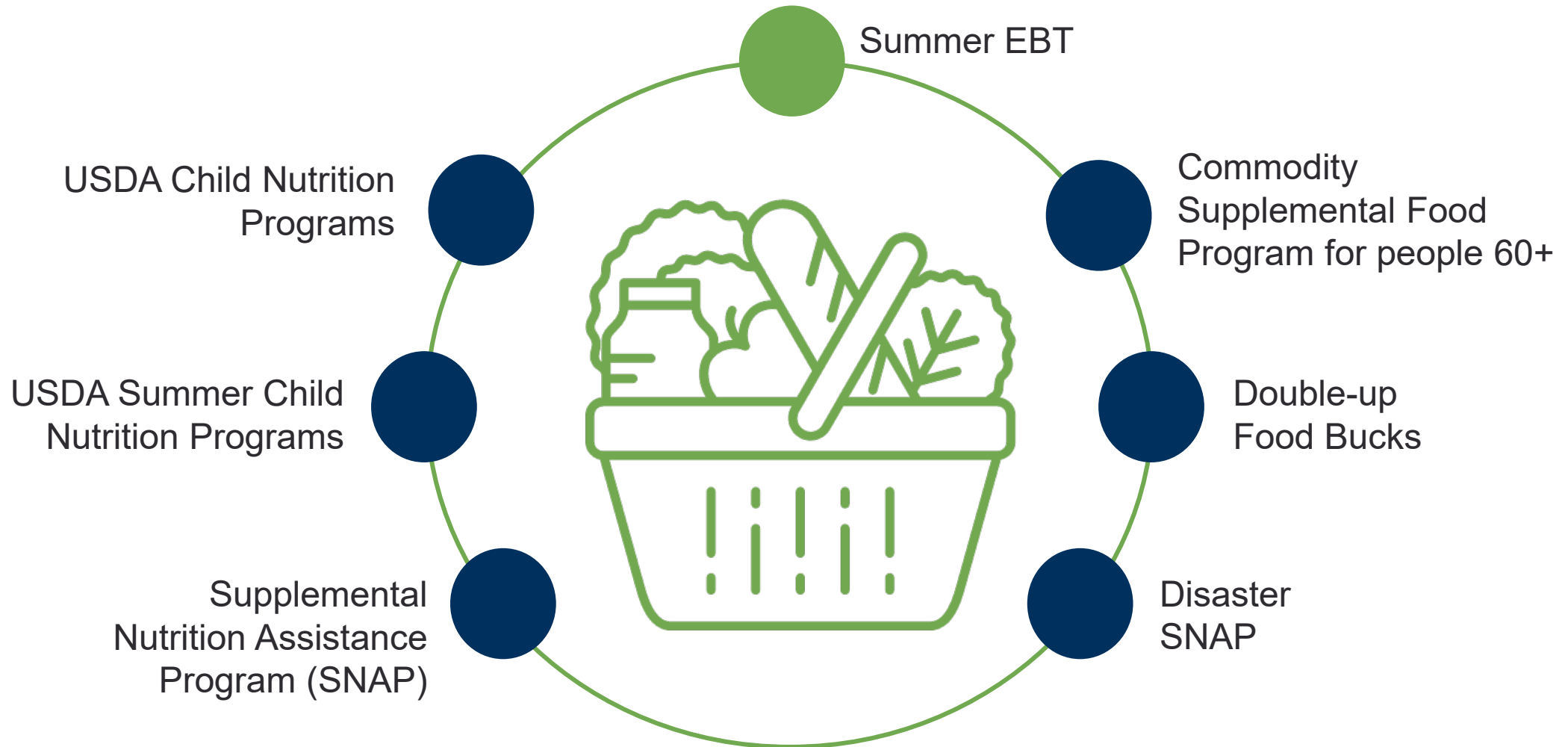
Federal funding this biennium: \$70.5M for Oregon families to buy groceries for children, \$12.5M matching funds for administrative costs

\$1.50

Every \$1 spent in EBT food benefits generates at least \$1.50 and as much as \$1.80 in local economic activity*

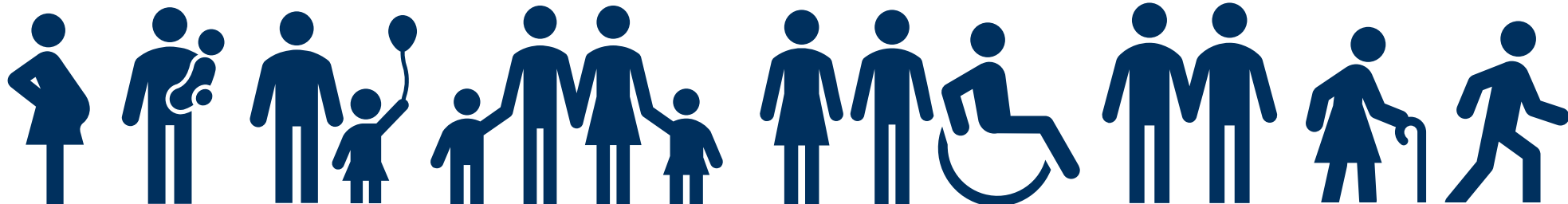

Summer EBT details

- States must apply to the United States Agriculture Department's Food and Nutrition Services (FNS) annually to offer Summer EBT
- FNS expects benefits to be issued every June
- ODHS is lead agency in partnership with the Oregon Department of Education and Oregon Health Authority



Program eligibility

- Children enrolled in a National School Lunch and School Breakfast Program-participating school who qualify for free or reduced-price meals
- Children qualifying for free meals through other federal assistance programs:
 - SNAP
 - Foster care
 - Food Distribution Program on Indian Reservations
 - Programs for unhoused children
 - HeadStart
 - Programs for children who are migrant



How it works

Two ways children can get approved to receive Summer EBT:

- 1. About 70% will have streamlined certification:**
 - Eligible for free and reduced-price school meals or other public assistance programs
 - No action needed by parents or guardians
- 2. About 30% will need to apply:**
 - ODHS will need to create an application and help determine eligibility.

Benefits are put on a pre-loaded card families can use to buy groceries.

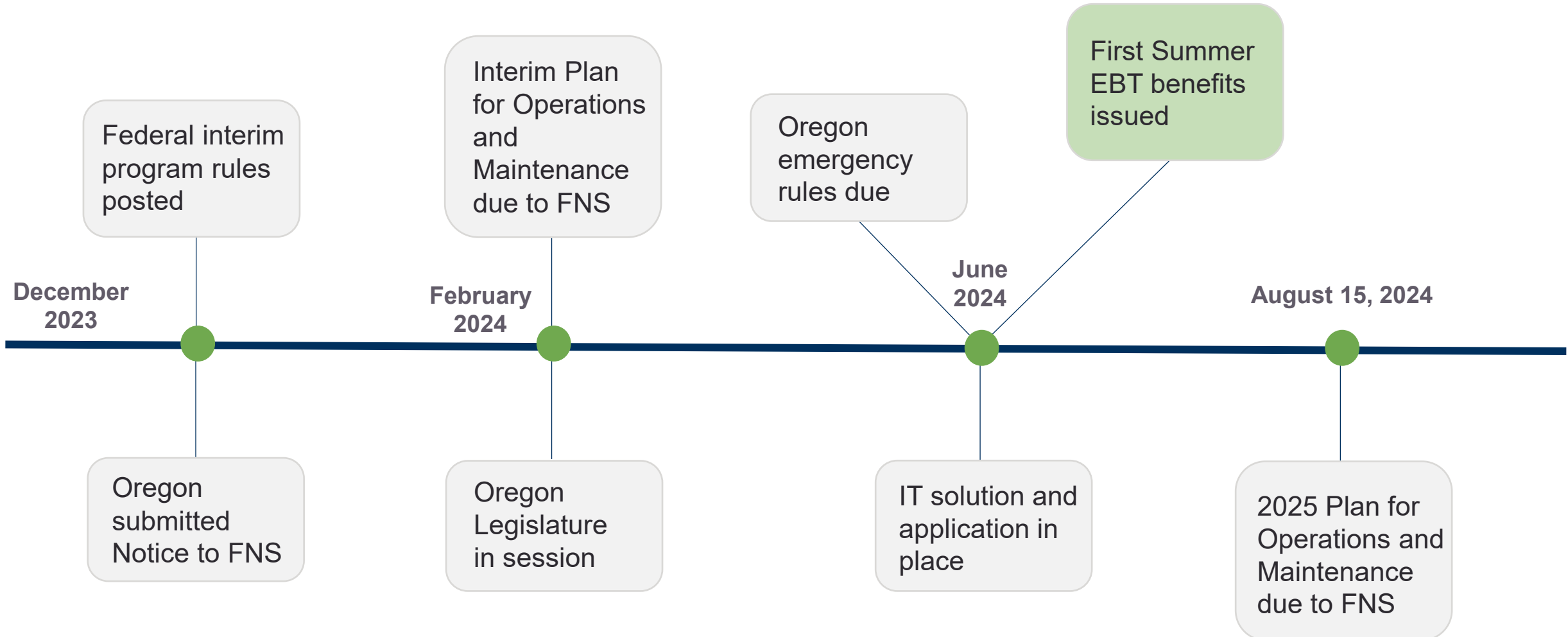

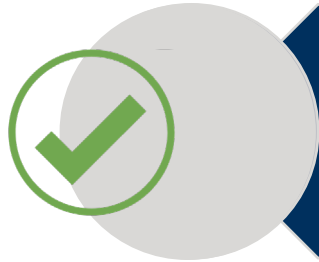

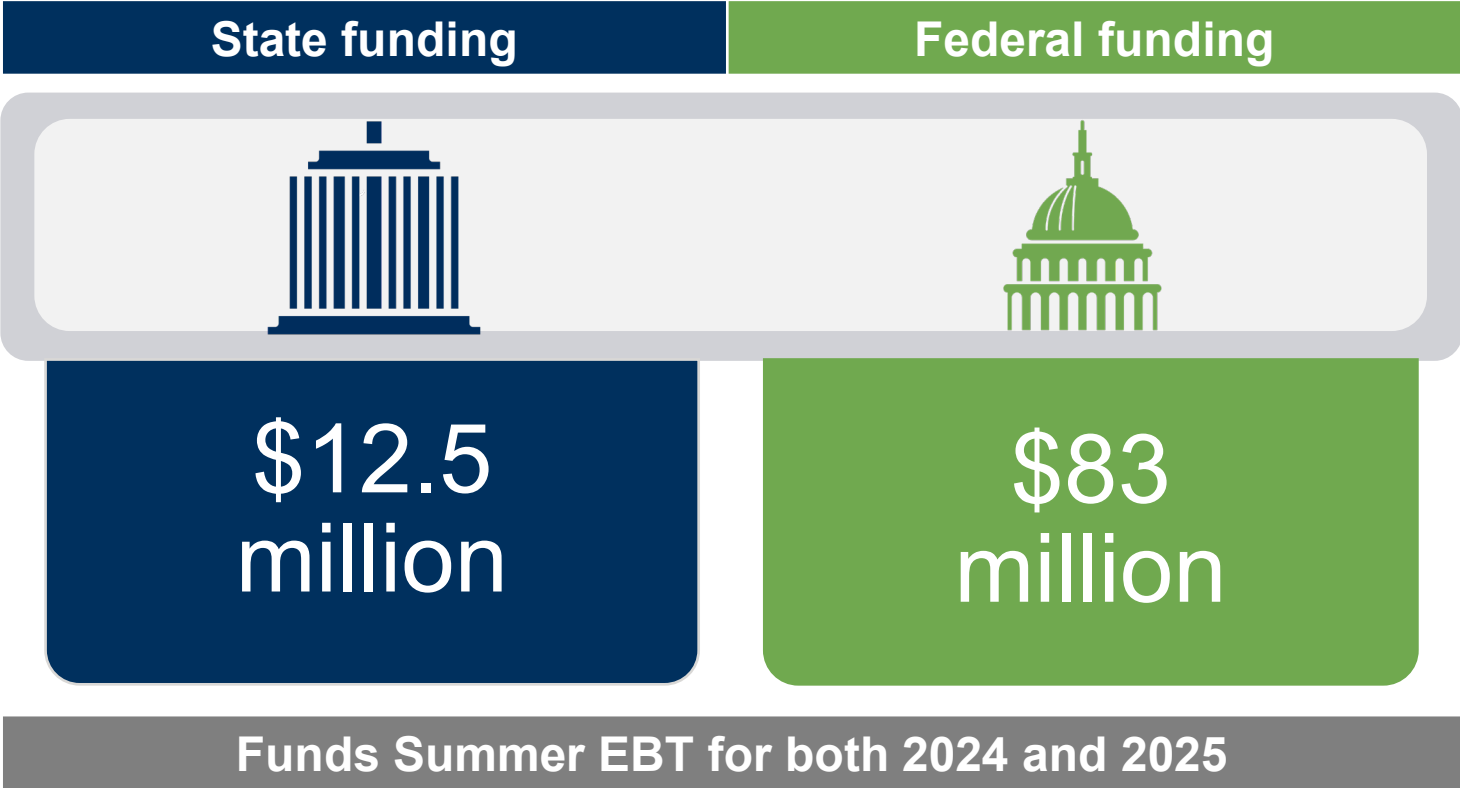
Approval to submit operations and budget plans to FNS in February
