Measure Description

HB 4130-B13 replaces the introduced measure. The measure directs the Legislative Policy and Research Director to conduct a study on business entities engaged in the practice of medicine and to report findings to an interim legislative committee related to health care policy by November 1, 2024. The study must explore the topics prescribed in the measure and provide recommendations, including proposed legislation. The results of the study must be reviewed by a work group prior to issuing the report.

Fiscal Analysis

Legislative Policy and Research Office

The fiscal impact on the Legislative Policy and Research Office (LPRO) is \$262,096 General Fund and one full-time limited duration position (0.19 FTE). To meet the requirements of the measure, LPRO will contract with a vendor to complete the study; contract costs are estimated at \$150,000 General Fund. One full-time, limited duration Senior LPRO Analyst (0.19 FTE) position will provide staffing support for the study and the work group. There may be additional costs to obtain proprietary data, the cost of which is currently indeterminate but may require additional funding.

Other Entities

The measure has no fiscal impact on the Department of Consumer and Business Services, the Department of Justice, the Oregon Health Authority, Secretary of State, or the Oregon Medical Board.

Relevant Dates

The measure declares an emergency and takes effect on passage.
