# **Summary of Revenue Changes**

Senate Bill 1585 appropriates \$481,371 General Fund to the Department of Human Services (DHS) and increases Federal Funds expenditure limitation by \$698,970 to establish a Task Force on Maximizing Supplemental Nutrition Assistance Program (SNAP) Benefits to review options for adding hot foods that are ready to eat for eligible SNAP recipients.

## **Summary of Human Services Subcommittee Action**

Senate Bill 1585 directs DHS to convene a task force to review options to maximize food choices for SNAP recipients, including the use of SNAP benefits to purchase hot, ready to eat food, such as restaurant meals. DHS will staff the task force and develop a plan to implement task force recommendations no later than 12 months after receiving federal approval if needed. Nine states currently offer the Restaurant Meals Program, a state option to allow certain SNAP participants to use their benefits to buy meals at restaurants. The task force is required to submit a report on implementation of the program to the Legislature no later than January 31, 2025.

The measure appropriates \$481,371 General Fund to DHS and increases Federal Funds expenditure limitation by \$698,970 to pay for information technology system changes and staff required to implement the bill. The staff consists of four positions (2.00 FTE), including one permanent Operations and Policy Analyst 3 (OPA 3) position, two limited-duration OPA 3 positions, and one limited duration Program Analyst 2 position to support the work of the task force, conduct retailer specific outreach, help develop the ONE System changes and ensure the program meets ongoing federal requirements.

More than half of the funding (\$629,780 total funds, or 53%) is for one-time expenses related to ONE System changes and Electronic Benefit Transfer vendor costs. In 2025-27, the estimated cost of \$305,895 total funds will cover the ongoing staff cost associated with the one permanent OPA 3 position. SNAP benefits and any related changes allowing the use of benefits for hot meals are covered solely by federal funds from the U.S. Department of Agriculture.
