Summary of Revenue Changes

House Bill 4132 appropriates \$894,324 General Fund to the Oregon Department of Fish and Wildlife (ODFW) for the implementation of recommendations made by the Ocean Policy Advisory Council in 2022 related to marine reserves.

Summary of Natural Resources Subcommittee Action

House Bill 4132 directs ODFW, the Fish and Wildlife Commission, and the State Land Board to implement recommendations from the Ocean Policy Advisory Council to develop an adaptive management plan and a collaborative process through social monitoring data for marine reserves. The bill requires ODFW to develop and implement an adaptive management plan including specific, measurable, achievable, relevant, and time-oriented objectives for ecological and socioeconomic monitoring and research, consistent measurable indicators of social impacts, efficient long-term ecological sampling protocols, assessment for the capacity of the marine reserves, and defined goals for outreach and engagement.

The measure appropriates \$894,324 General Fund and establishes three permanent full-time positions. These positions include one Natural Resource Specialist 3 position (0.63 FTE) to implement and develop long-term ecological sampling protocols, one Economist 2 position (0.63 FTE) for socio-economic research and monitoring, and one Public Affairs Specialist 2 position (0.63 FTE) for ongoing social outreach and engagement. The bill also provides \$100,000 for a Sea-Grant based fellow position to support new research and \$315,000 for contracts to conduct facilitation services, social research, and marine policy research.
