SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Updates the tie date to the federal Internal Revenue Code and other federal tax laws. Becomes law 91 days from sine die. (Flesch Readability Score: 64.9).

Updates the connection date to the federal Internal Revenue Code and other provisions of federal tax law. **Removes impermissible provision for continuing update to federal law property tax definitions.**

Takes effect on the 91st day following adjournment sine die.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 178.300 is amended to read:

9 178.300. As used in ORS 178.300 to 178.360:

10 (1) "Account" means an individual account established in accordance with ORS 178.300 to
11 178.360.

12 (2) "Account owner" means the person who has the right to withdraw funds from the account.
13 The account owner may also be the designated beneficiary of the account.

14 (3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

15 (4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated
16 at the time the account is opened as having the right to receive a qualified withdrawal for the
17 payment of qualified higher education expenses, or if the designated beneficiary is replaced in ac-
18 cordance with ORS 178.350, the replacement.

19 (5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank,
20 a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a
21 mutual fund, an investment firm or other similar entity authorized to do business in this state.

22 (6) "Higher education institution" means an eligible education institution as defined in section
23 529(e)(5) of the Internal Revenue Code.

24 (7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect
25 on December 31, [2022] **2023**.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (8) “Member of the family” shall have the same meaning as contained in section 529(e) of the
2 Internal Revenue Code.

3 (9) “Network” means the Oregon 529 Savings Network established under ORS 178.305.

4 (10) “Nonqualified withdrawal” means a withdrawal from an account that is not a qualified
5 withdrawal.

6 (11) “Qualified higher education expenses” means tuition and other permitted expenses as set
7 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated
8 beneficiary at a higher education institution, expenses associated with registered apprenticeship
9 programs described in section 529(c)(8) of the Internal Revenue Code and amounts paid as principal
10 or interest on a qualified education loan to the extent allowed under section 529(c)(9) of the Internal
11 Revenue Code.

12 (12) “Qualified withdrawal” means a withdrawal made as prescribed under ORS 178.355 and
13 made:

14 (a) From an account to pay the qualified higher education expenses of the designated benefi-
15 ciary;

16 (b) As the result of the death or disability of the designated beneficiary;

17 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)
18 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the
19 extent of the amount of the scholarship, allowance or payment; or

20 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

21 **SECTION 2.** ORS 178.375 is amended to read:

22 178.375. As used in this section and ORS 178.380 and 178.385:

23 (1) “ABLE account” means an account established by an eligible individual, owned by the eli-
24 gible individual and maintained under the qualified ABLE program established by the Oregon 529
25 Savings Board under ORS 178.380.

26 (2) “ABLE Act” means the Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014
27 (Division B of P.L. 113-295).

28 (3) “Designated beneficiary” has the same meaning as contained in section 529A of the Internal
29 Revenue Code.

30 (4) “Eligible individual” has the same meaning as contained in section 529A of the Internal Re-
31 venue Code.

32 (5) “Internal Revenue Code” means the federal Internal Revenue Code as amended and in effect
33 on December 31, [2022] **2023**.

34 (6) “Qualified disability expense” has the same meaning as contained in section 529A of the
35 Internal Revenue Code.

36 **SECTION 3.** ORS 238A.005 is amended to read:

37 238A.005. For the purposes of this chapter:

38 (1) “Active member” means a member of the pension program or the individual account program
39 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

40 (2) “Actuarial equivalent” means a payment or series of payments having the same value as the
41 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
42 sumptions adopted by the board.

43 (3) “Board” means the Public Employees Retirement Board.

44 (4) “Eligible employee” means a person who performs services for a participating public em-
45 ployer, including persons considered employees of a participating public employer under 26 U.S.C.

1 3121(d)(2), as in effect on January 1, [2023] **2024**, and elected officials other than judges. “Eligible
2 employee” does not include:

3 (a) Persons engaged as independent contractors;

4 (b) Aliens working under a training or educational visa;

5 (c) Persons provided sheltered employment or make-work by a public employer;

6 (d) Persons categorized by a participating public employer as student employees;

7 (e) Any person who is in custody in a state institution;

8 (f) Employees of foreign trade offices of the Oregon Business Development Department who live
9 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);

10 (g) An employee actively participating in an alternative retirement program established under
11 ORS 353.250 or an optional retirement plan established under ORS 341.551;

12 (h) Employees of a public university listed in ORS 352.002 who are actively participating in an
13 optional retirement plan offered under ORS 243.815;

14 (i) Persons employed in positions classified as post-doctoral scholar positions by a public uni-
15 versity listed in ORS 352.002, or by the Oregon Health and Science University, under ORS 350.370;

16 (j) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
17 for membership in the system under the provisions of ORS chapter 238 or other law;

18 (k) Any person who belongs to a class of employees who are not eligible to become members
19 of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

20 (L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS chapter 238 and who
21 continues to receive retirement benefits while employed; and

22 (m) Judges.

23 (5) “Firefighter” means:

24 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
25 duties include the fighting of fires;

26 (b) The State Fire Marshal, chief deputy state fire marshals and deputy state fire marshals;

27 (c) An employee of the State Fire Marshal whose primary duties include fire investigation, fire
28 prevention, fire safety, fire control or fire suppression;

29 (d) An employee of the State Forestry Department who is certified by the State Forester as a
30 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
31 fires as described in ORS 477.064; and

32 (e) An employee of the Oregon Military Department whose primary duties include fighting
33 structural, aircraft, wildland or other fires.

34 (6) “Fund” means the Public Employees Retirement Fund.

35 (7)(a) “Hour of service” means:

36 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
37 by a participating public employer for performance of duties in a qualifying position; and

38 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
39 during which an employee does not perform duties but for which the employee is directly or indi-
40 rectly paid or entitled to payment by a participating public employer for services in a qualifying
41 position, as long as the hour is within the number of hours regularly scheduled for the performance
42 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
43 thorized leave.

44 (b) “Hour of service” does not include any hour for which payment is made or due under a plan
45 maintained solely for the purpose of complying with applicable unemployment compensation laws.

1 (8) "Inactive member" means a member of the pension program or the individual account pro-
2 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
3 is not a retired member and who is not employed in a qualifying position.

4 (9) "Individual account program" means the defined contribution individual account program of
5 the Oregon Public Service Retirement Plan established under ORS 238A.025.

6 (10) "Institution of higher education" means a public university listed in ORS 352.002, the
7 Oregon Health and Science University or a community college, as defined in ORS 341.005.

8 (11) "Member" means an eligible employee who has established membership in the pension pro-
9 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
10 membership has not been terminated under ORS 238A.110 or 238A.310.

11 (12) "Participating public employer" means a public employer as defined in ORS 238.005 that
12 provides retirement benefits for employees of the public employer under the system.

13 (13) "Pension program" means the defined benefit pension program of the Oregon Public Service
14 Retirement Plan established under ORS 238A.025.

15 (14) "Police officer" means a police officer as described in ORS 238.005.

16 (15) "Qualifying position" means one or more jobs with one or more participating public em-
17 ployers in which an eligible employee performs 600 or more hours of service in a full calendar year,
18 or would perform 600 or more hours of service if the employee were employed for the full calendar
19 year, excluding any service in a job for which benefits are not provided under the Oregon Public
20 Service Retirement Plan pursuant to ORS 238A.070 (2).

21 (16) "Retired member" means a pension program member who is receiving a pension as provided
22 in ORS 238A.180 to 238A.195.

23 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the
24 participating public employer, including remuneration in the form of living quarters, board or other
25 items of value, to the extent the remuneration is, or would be if the member were an Oregon resi-
26 dent, includable in the employee's taxable income under Oregon law. "Salary" includes the addi-
27 tional amounts specified in paragraph (b) of this subsection, but does not include the amounts
28 specified in paragraph (c) of this subsection, regardless of whether those amounts are includable in
29 taxable income.

30 (b) "Salary" includes the following amounts:

31 (A) Payments of employee and employer money into a deferred compensation plan that are made
32 at the election of the employee.

33 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
34 employee.

35 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
36 plan by the employer at the election of the employee and that is not includable in the taxable in-
37 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2022]
38 **2023**.

39 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
40 election of the employee and that is not included in the taxable income of the employee by reason
41 of 26 U.S.C. 402(e)(3), as in effect on December 31, [2022] **2023**.

42 (E) Retroactive payments described in ORS 238.008.

43 (F) The amount of an employee contribution to the individual account program that is paid by
44 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
45 (1) and (2)(a).

1 (G) The amount of an employee contribution to the individual account program that is not paid
2 by the employer under ORS 238A.335.

3 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
4 652.190.

5 (c) "Salary" does not include the following amounts:

6 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
7 employer.

8 (B) Payments made on account of an employee's death.

9 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
10 leave.

11 (D) Any severance payment, accelerated payment of an employment contract for a future period
12 or advance against future wages.

13 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

14 (F) Payment for a leave of absence after the date the employer and employee have agreed that
15 no future services in a qualifying position will be performed.

16 (G) Payments for instructional services rendered to public universities listed in ORS 352.002 or
17 the Oregon Health and Science University when those services are in excess of full-time employment
18 subject to this chapter. A person employed under a contract for less than 12 months is subject to
19 this subparagraph only for the months covered by the contract.

20 (H) The amount of an employee contribution to the individual account program that is paid by
21 the employer and is not deducted from the compensation of the employee, as provided under ORS
22 238A.335 (1) and (2)(b).

23 (I) Compensation described and authorized under ORS 341.556 that is not paid by the community
24 college employing the faculty member.

25 (J) Compensation described and authorized under ORS 352.232 that is not paid by the public
26 university employing the officer or employee.

27 (K) Compensation described and authorized under ORS 353.270 that is not paid by Oregon
28 Health and Science University.

29 (L) For years before 2020, any amount in excess of \$200,000 for a calendar year. If any period
30 over which salary is determined is less than 12 months, the \$200,000 limitation for that period shall
31 be multiplied by a fraction, the numerator of which is the number of months in the determination
32 period and the denominator of which is 12. The board shall adopt rules adjusting this dollar limit
33 to incorporate cost-of-living adjustments authorized by the Internal Revenue Service.

34 (M) For years beginning on or after January 1, 2020, any amount in excess of \$195,000 for a
35 calendar year. If any period over which salary is determined is less than 12 months, the \$195,000
36 limitation for that period shall be multiplied by a fraction, the numerator of which is the number
37 of months in the determination period and the denominator of which is 12. On January 1 of each
38 year, the board shall adjust the dollar limit provided by this subparagraph to reflect any percentage
39 changes in the Consumer Price Index for All Urban Consumers, West Region (All Items), as pub-
40 lished by the Bureau of Labor Statistics of the United States Department of Labor.

41 (18) "System" means the Public Employees Retirement System.

42 (19) "Workers' compensation benefits" means:

43 (a) Payments made under ORS chapter 656; or

44 (b) Payments provided in lieu of workers' compensation benefits under ORS 656.027 (6).

45 **SECTION 4.** ORS 238A.125 is amended to read:

1 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
2 be paid an annual pension for the life of the member as follows:

3 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
4 by the number of years of retirement credit attributable to service as a police officer or firefighter.

5 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
6 multiplied by the number of years of retirement credit attributable to service as other than a police
7 officer or firefighter.

8 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the annual benefit payable to
9 a member under the pension program and under any other tax-qualified defined benefit plan main-
10 tained by the participating public employer may not exceed the applicable limitations set forth in
11 26 U.S.C. 415(b), as in effect on December 31, [2022] **2023**. The Public Employees Retirement Board
12 shall adopt rules for the administration of this limitation, including adjustments in the annual dollar
13 limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

14 (3) The board shall make no actuarial adjustment in a member's pension calculated under this
15 section by reason of the member's retirement after normal retirement age.

16 **SECTION 5.** ORS 238A.150 is amended to read:

17 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.250, an eligible em-
18 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
19 vices, and who subsequently returns to employment with a participating public employer with
20 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the
21 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS
22 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)
23 of this section.

24 (2) The board shall adopt rules establishing benefits and service credit for any period of service
25 in the uniformed services by an employee described in subsection (1) of this section. For the purpose
26 of adopting rules under this subsection, the board shall consider and take into account all federal
27 law relating to benefits and service credit for any period of service in the uniformed services, in-
28 cluding 26 U.S.C. 414(u), as in effect on December 31, [2022] **2023**. Benefits and service credit under
29 rules adopted by the board pursuant to this subsection may not exceed benefits and service credit
30 required under federal law for periods of service in the uniformed services.

31 **SECTION 6.** ORS 238A.170 is amended to read:

32 238A.170. (1) An active member of the pension program who is 72 years of age or older must
33 retire not later than April 1 of the calendar year following the calendar year in which the member
34 terminates employment with all participating public employers. An inactive member of the pension
35 program must retire not later than April 1 of the calendar year following the calendar year in which
36 the member attains 72 years of age.

37 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.250, the entire interest of a
38 member of the pension program must be distributed over a time period commencing no later than
39 the required beginning date set forth in subsection (1) of this section, and must be distributed in a
40 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-
41 lations implementing that section, as in effect on January 1, [2023] **2024**. The Public Employees Re-
42 tirement Board shall adopt rules implementing those minimum distribution requirements.

43 **SECTION 7.** ORS 238A.230 is amended to read:

44 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-
45 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided

1 for in this section to:

2 (a) The spouse of the member to the extent not provided to a former spouse in accordance with
3 a judgment or order under ORS 238.465;

4 (b) The former spouse of the member as provided in a judgment or order under ORS 238.465; or

5 (c) Any other person who is constitutionally required to be treated in the same manner as a
6 spouse for the purpose of retirement benefits.

7 (2) The death benefit to be paid under this subsection is for the life of the member's spouse,
8 former spouse or other person who is constitutionally required to be treated in the same manner
9 as a spouse, and is:

10 (a) If the member dies before the earliest retirement date for the member under ORS 238A.165,
11 the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the
12 deceased member, which shall be calculated as if the member became an inactive member on the
13 date of death and retired at the earliest retirement date for the member as described in ORS
14 238A.165;

15 (b) If the member dies on or after the earliest retirement date for the member under ORS
16 238A.165 and before normal retirement age under ORS 238A.160, the actuarial equivalent of the
17 pension that would otherwise have been paid to the deceased member, which shall be calculated as
18 if the member retired under ORS 238A.185 and as if the member's retirement date was the first of
19 the month following the date of death of the member; or

20 (c) If the member dies on or after reaching normal retirement age as described in ORS 238A.160,
21 the actuarial equivalent of the pension that would otherwise have been paid to the deceased mem-
22 ber, which shall be calculated under ORS 238A.125 as if the member's retirement date was the first
23 of the month following the date of death of the member.

24 (3) The death benefit provided under this section is first effective on the first day of the month
25 following the date of death of the member.

26 (4) The surviving spouse or other person who is constitutionally required to be treated in the
27 same manner as a spouse for the purpose of retirement benefits may elect to delay payment of the
28 death benefit, which shall be actuarially adjusted for age and interest when payments commence,
29 but payment must commence no later than December 31 of the calendar year in which the member
30 would have reached 72 years of age. If a person who delays payment under this subsection dies be-
31 fore payments commence:

32 (a) The person's beneficiary shall receive, in a lump sum, the sum of the payments the person
33 would have received had the person not elected to delay payment of the death benefit.

34 (b) If the person who delays payment under this subsection has not designated a beneficiary, the
35 person's benefit shall be paid to a personal representative appointed for the person's estate.

36 (5) Notwithstanding any other provision of ORS 238A.100 to 238A.250, distributions of death
37 benefits under the pension program must comply with the minimum distribution requirements of 26
38 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on January 1, [2023]
39 2024. The board shall adopt rules implementing those minimum distribution requirements.

40 **SECTION 8.** ORS 238A.370 is amended to read:

41 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition
42 to the employee and employer accounts of a member of the individual account program for a cal-
43 endar year, together with the annual additions to the accounts of the member under any other de-
44 fined contribution plan maintained by the participating public employer for a calendar year, may
45 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.

1 For purposes of this section, “annual addition” has the meaning given that term in 26 U.S.C.
 2 415(c)(2), as in effect on December 31, [2022] **2023**, and “compensation” has the meaning given the
 3 term “participant’s compensation” in 26 U.S.C. 415(c)(3), as in effect on December 31, [2022] **2023**.
 4 The Public Employees Retirement Board shall adopt rules for the administration of this limitation,
 5 including adjustments in the annual dollar limitation to reflect cost-of-living adjustments authorized
 6 by the Internal Revenue Service.

7 **SECTION 9.** ORS 238A.400 is amended to read:

8 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS
 9 238A.165, a member of the individual account program shall receive in a lump sum the amounts in
 10 the member’s employee account, rollover account and employer account to the extent the member
 11 is vested in those accounts under ORS 238A.320.

12 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-
 13 ual account program may elect to receive the amounts in the member’s employee account and em-
 14 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in
 15 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is
 16 equal to the anticipated life span of the member as actuarially determined by the Public Employees
 17 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event
 18 may the period selected by the member exceed the time allowed by the minimum distribution re-
 19 quirements described in subsection (5) of this section. The board shall by rule establish the manner
 20 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance
 21 during the payout period elected by the member under this subsection. The board by rule may es-
 22 tablish minimum monthly amounts payable under this subsection. The board may require that a
 23 lump sum payment, or an installment schedule different than the schedules provided for in this
 24 subsection, be used to pay the vested amounts in the member’s accounts if those amounts are not
 25 adequate to generate the minimum monthly amounts specified by the rule.

26 (3) A member of the individual account program electing to receive installments under sub-
 27 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies
 28 before all amounts in the employee and vested employer accounts are paid, all remaining installment
 29 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary
 30 may elect to receive a lump sum distribution of the remaining amounts.

31 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive
 32 vested amounts in the member’s employee account, rollover account and employer account in the
 33 manner provided by this section when the member retires for service under the provisions of ORS
 34 chapter 238.

35 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a
 36 member of the individual account program must be distributed over a time period commencing no
 37 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner
 38 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-
 39 plementing that section, as in effect on January 1, [2023] **2024**. The board shall adopt rules imple-
 40 menting those minimum distribution requirements.

41 **SECTION 10.** ORS 238A.410 is amended to read:

42 238A.410. (1)(a) If a member of the individual account program dies before retirement, the
 43 amounts in the member’s employee account, rollover account and employer account, to the extent
 44 the member is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the
 45 beneficiary or beneficiaries designated by the member for the purposes of this section.

1 (b) If a member of the individual account program dies before retirement, the amounts in the
 2 employee pension stability account established for the member under ORS 238A.353 shall be applied
 3 by the Public Employees Retirement Board to pay the costs of any benefit payable under ORS
 4 238.395 or 238A.230 that accrues on or after July 1, 2020. If the amounts in the employee pension
 5 stability account exceed the costs of the benefit payable under ORS 238.395 or 238A.230 that accrues
 6 on or after July 1, 2020, the excess amounts shall be paid in a lump sum to the beneficiary or ben-
 7 efiiciaries designated by the member for the purposes of this section.

34 (B) The purchase by a lending institution of bonds, the proceeds of which are used to finance

26 be received by an employee, a former employee or the employee's legal successor for services ren-
27 dered to or for an employer, including reimbursements received by or for an individual for medical

29 pendent care spending account, legal services plan, any cafeteria plan described in section 125 of

38 meals, or similar payments to a trade, professional or other similar association, and fundraising re-
39 cepts received by any person when any excess receipts are donated or used exclusively for chari-
40 table purposes;

41 (L) Damages received as the result of litigation in excess of amounts that, if received without
42 litigation, would be treated as commercial activity;

43 (M) Property, money and other amounts received or acquired by an agent on behalf of another
44 in excess of the agent's commission, fee or other remuneration;

45 (N) Tax refunds from any tax program, other tax benefit recoveries and reimbursements for the

1 tax imposed under ORS 317A.100 to 317A.158 made by entities that are part of the same unitary
2 group as provided under ORS 317A.106, and reimbursements made by entities that are not members
3 of a unitary group that are required to be made for economic parity among multiple owners of an
4 entity whose tax obligation under ORS 317A.100 to 317A.158 is required to be reported and paid
5 entirely by one owner, as provided in ORS 317A.106;

6 (O) Pension reversions;

7 (P) Contributions to capital;

8 (Q) Receipts from the sale, transfer, exchange or other disposition of motor vehicle fuel or any
9 other product used for the propulsion of motor vehicles;

10 (R) In the case of receipts from the sale of cigarettes or tobacco products by a wholesale dealer,
11 retail dealer, distributor, manufacturer or seller, an amount equal to the federal and state excise
12 taxes paid by any person on or for such cigarettes or tobacco products under subtitle E of the
13 Internal Revenue Code or ORS chapter 323;

14 (S) In the case of receipts from the sale of malt beverages or wine, as defined in ORS 471.001,
15 cider, as defined in ORS 471.023 or distilled liquor, as defined in ORS 471.001, by a person holding
16 a license issued under ORS chapter 471, an amount equal to the federal and state excise taxes paid
17 by any person on or for such malt beverages, wine or distilled liquor under subtitle E of the Internal
18 Revenue Code or ORS chapter 471 or 473, and any amount paid to the Oregon Liquor and Cannabis
19 Commission for sales of distilled spirits by an agent appointed under ORS 471.750;

20 (T) In the case of receipts from the sale of marijuana items, as defined in ORS 475C.009, by a
21 person holding a license issued under ORS 475C.005 to 475C.525, an amount equal to the federal and
22 state excise taxes paid by any person on or for such marijuana items under subtitle E of the Internal
23 Revenue Code or ORS 475C.670 to 475C.734 and any local retail taxes authorized under ORS
24 475C.453;

25 (U) Local taxes collected by a restaurant or other food establishment on sales of meals, prepared
26 food or beverages;

27 (V) Tips or gratuities collected by a restaurant or other food establishment and passed on to
28 employees;

29 (W) Receipts realized by a vehicle dealer certified under ORS 822.020 or a person described in
30 ORS 320.400 (8)(a)(B) from the sale or other transfer of a motor vehicle, as defined in ORS 801.360,
31 to another vehicle dealer for the purpose of resale by the transferee vehicle dealer, but only if the
32 sale or other transfer was based upon the transferee's need to meet a specific customer's preference
33 for a motor vehicle or is an exchange of new vehicles between franchised motor vehicle dealerships;

34 (X) Registration fees or taxes collected by a vehicle dealer certified under ORS 822.020 or a
35 person described in ORS 320.400 (8)(a)(B) at the sale or other transfer of a motor vehicle, as defined
36 in ORS 801.360, that are owed to a third party by the purchaser of the motor vehicle and passed to
37 the third party by the dealer;

38 (Y) Receipts from a financial institution for services provided to the financial institution in
39 connection with the issuance, processing, servicing and management of loans or credit accounts, if
40 the financial institution and the recipient of the receipts have at least 50 percent of their ownership
41 interests owned or controlled, directly or constructively through related interests, by common own-
42 ers;

43 (Z) In the case of amounts retained as commissions by a holder of a license under ORS chapter
44 462, an amount equal to the amounts specified under ORS chapter 462 that must be paid to or col-
45 lected by the Department of Revenue as a tax and the amounts specified under ORS chapter 462 to

- 1 be used as purse money;
- 2 (AA) Receipts of residential care facilities as defined in ORS 443.400 or in-home care agencies
3 as defined in ORS 443.305, to the extent that the receipts are derived from or received as compen-
4 sation for providing services to a medical assistance or Medicare recipient;

- 34 (NN) Moneys collected for public purpose funding as described in ORS 759.430;
- 35 (OO) Moneys collected or recovered and paid into the federal universal service fund as deter-
36 mined by the Federal Communications Commission;
- 37 (PP) In the case of a seller or provider of telecommunications services, the amount of tax im-
38 posed under ORS 403.200 for access to the emergency communications system that is collected from
39 subscribers or consumers;
- 40 (QQ) In the case of a transient lodging tax collector, the amount of tax imposed under ORS
41 320.305 and of any local transient lodging tax imposed upon the occupancy of transit lodging;

9 (WW)(i) Cost paid by a dealer for items of precious metal.

10 (ii) As used in this subparagraph, "item of precious metal" means an item of gold, silver,

35 (i) Governmental entities.

36 (j) Any person with commercial activity that does not exceed \$750,000 for the tax year, other
37 than a person that is part of a unitary group as provided in ORS 317A.106 with commercial activity
38 in excess of \$750,000.

39 (k) Hospitals subject to assessment under ORS 414.855, long term care facilities subject to as-
40 sessment under ORS 409.801 or any entity subject to assessment under ORS 414.880 or section 3 or
41 5, chapter 538, Oregon Laws 2017.

42 (L) Manufactured dwelling park nonprofit cooperatives organized under ORS chapter 62.

43 (5) "Financial institution" has the meaning given that term in ORS 314.610, except that "finan-
44 cial institution" does not include a credit union.

45 (6)(a) "FR Y-9" means the consolidated or parent-only financial statements that a holding com-

1 pany is required to file with the Federal Reserve Board pursuant to 12 U.S.C. 1844.

2 (b) In the case of a holding company required to file both consolidated and parent-only financial
3 statements, “FR Y-9” means the consolidated financial statements that the holding company is re-
4 quired to file.

5 (7) “Governmental entity” means:

6 (a) The United States and any of its unincorporated agencies and instrumentalities.

7 (b) Any incorporated agency or instrumentality of the United States wholly owned by the United
8 States or by a corporation wholly owned by the United States.

9 (c) The State of Oregon and any of its unincorporated agencies and instrumentalities.

10 (d) Any county, city, district or other political subdivision of the state.

11 (e) A special government body as defined in ORS 174.117.

12 (f) A federally recognized Indian tribe.

13 (8) “Groceries” means food as defined in 7 U.S.C. 2012(k), but does not include cannabinoid
14 edibles or marijuana seeds.

15 (9)(a) “Hedging transaction” means a hedging transaction as defined in section 1221 of the
16 Internal Revenue Code or a transaction accorded hedge accounting treatment under Financial Ac-
17 counting Standards Board Statement No. 133.

18 (b) “Hedging transaction” does not include a transaction in which an actual transfer of title of
19 real or tangible property to another entity occurs.

20 (10) “Insurer” has the meaning given that term in ORS 317.010.

21 (11) “Internal Revenue Code,” except where the Legislative Assembly has provided otherwise,
22 refers to the laws of the United States or to the Internal Revenue Code as they are amended and
23 in effect on December 31, [2022] **2023**.

24 (12) “Labor costs” means total compensation of all employees, not to include compensation paid
25 to any single employee in excess of \$500,000.

26 (13)(a) “Motor vehicle fuel or any other product used for the propulsion of motor vehicles”
27 means:

28 (A) Motor vehicle fuel as defined in ORS 319.010; and

29 (B) Fuel the use of which in a motor vehicle is subject to taxation under ORS 319.530.

30 (b) “Motor vehicle fuel or any other product used for the propulsion of motor vehicles” does not

45 (4) "Individual development account" means a contract between an account holder and a

1 fiduciary organization, for the deposit of funds into a financial institution by the account holder and
2 the deposit of matching funds into a designated account by the fiduciary organization, to allow the
3 account holder to accumulate assets for use toward achieving a specific purpose approved by the
4 fiduciary organization.

5 (5) “Lower income household” means a household having an income equal to or less than the

32 who has earned at least \$1,000 in wages during the alternate base year; and

33 (b) An employee to whom paid family and medical leave insurance benefits may be available
34 under ORS 657B.015.

35 (13) "Eligible employee's average weekly wage" means an amount calculated by the Director of
36 the Employment Department by dividing the total wages earned by an eligible employee during the
37 base year by the number of weeks in the base year.

38 (14)(a) "Employee" means:

39 (A) An individual performing services for an employer for remuneration or under any contract
40 of hire, written or oral, express or implied.

41 (B) A home care worker as defined in ORS 410.600.

42 (b) "Employee" does not include:

43 (A) An independent contractor as defined in ORS 670.600.

44 (B) A participant in a work training program administered under a state or federal assistance
45 program.

1 (C) A participant in a work-study program that provides students in secondary or postsecondary
2 educational institutions with employment opportunities for financial assistance or vocational train-
3 ing.

4 (D) A railroad worker exempted under the federal Railroad Unemployment Insurance Act.

5 (E) A volunteer.

6 (F) A judge as defined in ORS 260.005.

7 (G) A member of the Legislative Assembly.

8 (H) A holder of public office as defined in ORS 260.005.

9 (15)(a) "Employer" means any person that employs one or more employees working anywhere in
10 this state or any agent or employee of such person to whom the duties of the person under this
11 chapter have been delegated.

12 (b) "Employer" includes:

13 (A) A political subdivision of this state or any county, city, district, authority or public corpo-
14 ration, or any instrumentality of a county, city, district, authority or public corporation, organized
15 and existing under law or charter;

16 (B) An individual;

17 (C) Any type of organization, corporation, partnership, limited liability company, association,
18 trust, estate, joint stock company or insurance company;

19 (D) Any successor in interest to an entity described in subparagraph (C) of this paragraph;

20 (E) A trustee, trustee in bankruptcy or receiver; or

21 (F) A trustee or legal representative of a deceased person.

22 (c) "Employer" does not include the federal government or a tribal government.

23 (16) "Employment agency" has the meaning given that term in ORS 658.005.

24 (17) "Family and medical leave insurance benefits" means the wage replacement benefits that
25 are available to a covered individual under ORS 657B.050 or under the terms of an employer plan
26 approved under ORS 657B.210, for family leave, medical leave or safe leave.

27 (18)(a) "Family leave" means leave from work taken by a covered individual:

28 (A) To care for and bond with a child during the first year after the child's birth or during the
29 first year after the placement of the child through foster care or adoption; or

30 (B) To care for a family member with a serious health condition.

31 (b) "Family leave" does not mean:

32 (A) Leave described in ORS 659A.159 (1)(d);

33 (B) Leave described in ORS 659A.159 (1)(e); or

34 (C) Leave authorized under ORS 659A.093.

35 (19) "Family member" means:

36 (a) The spouse of a covered individual;

37 (b) A child of a covered individual or the child's spouse or domestic partner;

38 (c) A parent of a covered individual or the parent's spouse or domestic partner;

39 (d) A sibling or stepsibling of a covered individual or the sibling's or stepsibling's spouse or
40 domestic partner;

41 (e) A grandparent of a covered individual or the grandparent's spouse or domestic partner;

42 (f) A grandchild of a covered individual or the grandchild's spouse or domestic partner;

43 (g) The domestic partner of a covered individual; or

44 (h) Any individual related by blood or affinity whose close association with a covered individual
45 is the equivalent of a family relationship.

1 (20) “Medical leave” means leave from work taken by a covered individual that is made neces-
2 sary by the individual’s own serious health condition.

3 (21) “Parent” means:

4 (a) A biological parent, adoptive parent, stepparent or foster parent of a covered individual;

5 (b) A person who was a foster parent of a covered individual when the covered individual was
6 a minor;

7 (c) A person designated as the legal guardian of a covered individual at the time the covered
8 individual was a minor or required a legal guardian;

9 (d) A person with whom a covered individual was or is in a relationship of in loco parentis; or

10 (e) A parent of a covered individual’s spouse or domestic partner who meets a description under
11 paragraphs (a) to (d) of this subsection.

12 (22) “Safe leave” means leave taken for any purpose described in ORS 659A.272.

13 (23) “Self-employed individual” means:

14 (a) An individual who has self-employment income as defined in section 1402(b) of the Internal
15 Revenue Code as amended and in effect on December 31, [2022] **2023**; or

16 (b) An independent contractor as defined in ORS 670.600.

17 (24) “Serious health condition” has the meaning given that term in ORS 659A.150.

18 (25) “Third party administrator” means a third party that enters into an agreement with the
19 Director of the Employment Department to implement and administer the paid family and medical
20 leave program established under this chapter.

21 (26) “Tribal government” has the meaning given that term in ORS 181A.940.

22 (27)(a) “Wages” has the meaning given that term in ORS 657.105.

23 (b) “Wages” does not mean contribution amounts paid to the Paid Family and Medical Leave
24 Insurance Fund by an employer on behalf of an employee under ORS 657B.150 (5).

25 **SECTION 30. (1) Except as provided in subsections (2) and (3) of this section, the**
26 **amendments to statutes by sections 1 to 29 of this 2024 Act apply to transactions or activities**
27 **occurring on or after January 1, 2024, in tax years beginning on or after January 1, 2024.**

28 **(2) The effective and applicable dates, and the exceptions, special rules and coordination**
29 **with the Internal Revenue Code, as amended, relative to those dates, contained in federal law**
30 **amending the Internal Revenue Code and enacted before January 1, 2024, apply for Oregon**
31 **personal income and corporate excise and income tax purposes, to the extent they can be**
32 **made applicable, in the same manner as they are applied under the Internal Revenue Code**
33 **and related federal law.**

34 **(3)(a) If a deficiency is assessed against any taxpayer for a tax year beginning before**
35 **January 1, 2024, and the deficiency or any portion thereof is attributable to any retroactive**
36 **treatment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842,**
37 **314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2**
38 **and 14 to 26 of this 2024 Act, then any interest or penalty assessed under ORS chapter 305,**
39 **314, 315, 316, 317, 317A or 318 with respect to the deficiency or portion thereof shall be can-**
40 **celed.**

41 **(b) If a refund is due any taxpayer for a tax year beginning before January 1, 2024, and**
42 **the refund or any portion thereof is due the taxpayer on account of any retroactive treat-**
43 **ment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842, 314.011,**
44 **314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2 and 14**
45 **to 26 of this 2024 Act for a tax year beginning before January 1, 2024, then notwithstanding**

1 **ORS 305.270 or 314.415 or any other law, the refund or portion thereof shall be paid without**
2 **interest.**

3 **(c) Any changes required because of the amendments to ORS 178.300, 178.375, 305.239,**
4 **305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and**
5 **317A.100 by sections 1, 2 and 14 to 26 of this 2024 Act for a tax year beginning before January**
6 **1, 2024, shall be made by filing an amended return within the time prescribed by law.**

7 **(d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,**
8 **the Department of Revenue shall make any changes under paragraph (c) of this subsection**
9 **on the return to which the changes relate within the period specified for issuing a notice of**
10 **deficiency or claiming a refund as otherwise provided by law with respect to that return, or**
11 **within one year after a return for a tax year beginning on or after January 1, 2024, and be-**
12 **fore January 1, 2025, is filed, whichever period expires later.**

13 **SECTION 31. This 2024 Act takes effect on the 91st day after the date on which the 2024**
14 **regular session of the Eighty-second Legislative Assembly adjourns sine die.**

15
