HOUSE AMENDMENTS TO HOUSE BILL 4049

1 Delete lines 4 through 19 of the printed bill and insert:

2 "<u>SECTION 1.</u> (1) The Oregon State University Extension Service and the College of Ag-73 ricultural Sciences of Oregon State University shall conduct a statewide study to better un-74 derstand the occurrence and distribution of perfluoroalkyl and polyfluoroalkyl substances 75 (PFAS) found in biosolids applied to agricultural fields that do not produce crops intended for 76 human consumption.

"(2) In conducting the study under this section, the extension service and the college
shall collaborate with the Department of Environmental Quality and Oregon wastewater
service providers to:

"(a) Identify and quantify PFAS concentrations in selected biosolids from wastewater
 treatment facilities in this state;

12 "(b) Identify and quantify PFAS concentrations in the soil profiles of selected agricultural 13 fields that do not produce crops intended for human consumption, on which biosolids ana-14 lyzed in paragraph (a) of this subsection have been applied to land as a soil amendment, and 15 in adjacent agricultural fields without a history of biosolid application;

16 "(c) Utilizing the data collected under paragraphs (a) and (b) of this subsection, deter-17 mine the quantities of PFAS retained within and leached from soil profiles; and

"(d) Identify and quantify PFAS concentrations in crops grown in agricultural fields that
 do not produce crops intended for human consumption analyzed under paragraph (b) of this
 subsection.

"(3) Participation in the study by wastewater treatment service providers, farmers, land
 owners or land managers is voluntary.

"(4) To the greatest extent possible, the extension service and college shall use data col-23lection methods that do not disclose the precise location of agricultural fields or wastewater 24treatment facilities or the identity of owners of agricultural fields or wastewater treatment 2526 facilities that are the subjects of the study. In the reports submitted under subsection (5) of this section, the extension service and college shall present summarized information or 2728 aggregated data that does not directly identify the location of agricultural fields or 29 wastewater treatment facilities or the identity of owners of agricultural fields or wastewater treatment facilities. 30

31 "(5) The extension service and college shall submit to the interim committees of the 32 Legislative Assembly related to agriculture, in the manner provided by ORS 192.245:

"(a) A progress report on the study conducted under this section, no later than Decem ber 15, 2025; and

"(b) A final report on the study conducted under this section, no later than September

- 1 1, 2027. The final report shall include, but need not be limited to:
- 2 "(A) PFAS concentrations in biosolids;
- 3 "(B) PFAS concentrations in background and biosolid-amended soil horizons;
- 4 "(C) PFAS concentrations in crops grown on biosolid-amended soils; and
- 5 "(D) Comparisons to published literature for context and interpretation.".

- 7 In line 24, delete "2026" and insert "2028".
