## House Bill 4079

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Education for Representative Courtney Neron)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Takes away the cap on the amount of state moneys that a school district may receive for a student who is a child with a disability. Allows a school district to receive more state moneys for a student who is homeless. Changes law on July 1, 2024. (Flesch Readability Score: 64.9). Removes the percentage cap on the amount of moneys that are distributed from the State School

Fund to school districts for students eligible for special education as children with disabilities.

Provides additional weight for students who are homeless for purposes of calculating distributions of State School Fund moneys to school districts.

Takes effect July 1, 2024.

4 Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 327.013 is amended to read:

- 6 327.013. The State School Fund distributions for school districts include the following grants:
- 7 (1) General Purpose Grant = Funding Percentage  $\times$  Target Grant  $\times$  District extended ADMw.

For the purpose of the calculation made under this subsection: 8

9 (a) The funding percentage shall be calculated by the Superintendent of Public Instruction to 10 distribute as nearly as practicable the total sum of money available for distribution.

(b) Target Grant = Statewide Target per ADMw Grant + Teacher Experience Factor. For the 11 purpose of the calculation made under this paragraph: 12

13 (A) Statewide Target per ADMw Grant = \$4,500.

(B) Teacher Experience Factor =  $$25 \times {\text{District average teacher experience - statewide av-}}$ 14 erage teacher experience}. As used in this subparagraph, "average teacher experience" means the 15 average, in years, of teaching experience of licensed teachers as reported to the Department of Ed-16 17ucation.

(c) District extended ADMw = ADMw or ADMw of the prior year, whichever is greater. The 18 calculation of the district extended ADMw must be made as provided by ORS 338.155 if a public 19 20charter school is located in the school district. For the purpose of this paragraph:

21(A) Weighted average daily membership or ADMw = average daily membership + an additional 22amount computed as follows:

23(i) 1.0 for each student in average daily membership eligible for special education as a child with a disability under ORS 343.035[, which may not exceed 11 percent of the district's ADM without review 24 and approval by the Department of Education]. Children with disabilities eligible for special educa-2526tion in adult local correctional facilities, as defined in ORS 169.005, or adult regional correctional facilities, as defined in ORS 169.620, may not be included in the calculation made under this sub-27

subparagraph. 1

2 (ii) 0.5 for each student in average daily membership eligible for and enrolled in an English language learner program under ORS 336.079. 3

(iii) 0.2 for each student in average daily membership enrolled in a union high school district 4 or in an area of a unified school district where the district is only responsible for educating students 5 in grades 9 through 12 in that area. 6

(iv) -0.1 for each student in average daily membership enrolled in an elementary district oper-7 ating kindergarten through grade six or kindergarten through grade eight or in an area of a unified 8 9 school district where the district is only responsible for educating students in kindergarten through 10 grade eight.

(v) 0.25 times the sum of the following: 11

12(I) The number of students who are in average daily membership and who are also in poverty 13 families, as determined by the Department of Education based on rules adopted by the State Board of Education that incorporate poverty data published by the United States Census Bureau, student 14 15 data provided by school districts and other data identified by the board;

16 (II) The number of children in foster homes in the district as determined by the report of the Department of Human Services to the United States Department of Education, "Annual Statistical 17 18 Report on Children in Foster Homes and Children in Families Receiving AFDC Payments in Excess of the Poverty Income Level," or its successor, for October 31 of the year prior to the year of dis-19 20tribution; and

(III) The number of children in the district in state-recognized facilities for neglected and de-2122linquent children, based on information from the Department of Human Services for October 31 of 23the year prior to the year of distribution.

(vi) 1.0 for each student in average daily membership who is homeless, as determined 24based on rules adopted by the State Board of Education that identify homeless students in 25a manner that is consistent with the definition of "homeless children and youths" under the 2627McKinney-Vento Homeless Assistance Act, 42 U.S.C. 11434a.

[(vi)] (vii) The amount determined under ORS 327.077 for each remote small elementary school 28and for each small high school in the district. 29

30 (B) All numbers of children used for the computation in this paragraph must reflect any district 31 consolidations that have occurred since the numbers were compiled.

32(C) The total additional weight that shall be assigned to any student in average daily membership in a district, exclusive of students described in subparagraph (A)(v) [and (vi)] to (vii) of this 33 34 paragraph, may not exceed 2.0.

35 (2) High cost disabilities grant = the total amount received by a school district under ORS (327.348 for providing special education and related services to resident pupils with disabilities. 36

(3)(a) Transportation grant equals:

38 (A) 70 percent of approved transportation costs for those school districts ranked below the 80th percentile under paragraph (b) of this subsection. 39

40 (B) 80 percent of approved transportation costs for those school districts ranked in or above the 80th percentile but below the 90th percentile under paragraph (b) of this subsection. 41

(C) 90 percent of approved transportation costs for those school districts ranked in or above the 4290th percentile under paragraph (b) of this subsection. 43

(b) Each fiscal year, the Department of Education shall rank school districts based on the ap-44 proved transportation costs per ADM of each school district, ranking the school district with the 45

- 1 highest approved transportation costs per ADM at the top of the order.
- 2 <u>SECTION 2.</u> The amendments to ORS 327.013 by section 1 of this 2024 Act apply to State
- 3 School Fund distributions commencing with the 2024-2025 distributions.
- 4 <u>SECTION 3.</u> This 2024 Act takes effect on July 1, 2024.
