House Bill 4081

Sponsored by Representative GRAYBER, Senator STEINER; Representatives DEXTER, REYNOLDS (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes a program and an advisory board in the Oregon Health Authority to make it easier to get fast health care. (Flesch Readability Score: 61.4). Establishes the Emergency Medical Services Program and Emergency Medical Services Advisory Board within the Oregon Health Authority. Directs the authority to designate emergency medical services program and emergency medical services are provided as a service of the state of the second services and the second services are provided as a service of the second second service of the second service of the second second second service of the second s medical services regions within the state. Directs the authority to designate emergency medical services centers for the provision of specific types of emergency care. Requires the program to establish and maintain an emergency medical services data system.

Becomes operative on January 1, 2025.

Takes effect on the 91st day following adjournment sine die.

2 (B) Three years after the date on which the board and the authority determine the data 3 system or registry must be adopted, if the emergency medical services center is a critical 4 access or rural health care facility or hospital, with an additional six months in which to 5 demonstrate compliant usage of the data system or registry.

6 (c) If no relevant nationally recognized classification standard is available for a specific 7 type of emergency medical services center, the authority shall convene an advisory com-8 mittee of stakeholders, including but not limited to state and community partners, to develop 9 a proposal for the establishment of classification standards for the designation of an emer-10 gency medical services center.

(d) The board and the authority may grant, at the request of an emergency medical
 services center, an extension to the timeline described in paragraph (b) of this subsection.

(2)(a) An emergency medical services center is not required to obtain categorization or
 designation as described in subsection (1) of this section.

(b) An emergency medical services center described in this subsection is not required to
 adopt and use a specific data system or registry.

(c) An emergency medical services center may concurrently adopt and use data systems
or registries in addition to any data systems or registries required for a specific categorization or designation.

(3) An emergency medical services center that uses any data system or registry shall
 grant to the authority permission to extract data subject to relevant confidentiality re quirements.

(4) The authority shall adopt rules to carry out this section, and may adopt as rules of
 the authority any relevant nationally recognized classification standards and proposed classification standards described in subsection (1) of this section.

SECTION 11. (1) The Oregon Health Authority shall, with the advice of the Emergency 2627Medical Services Advisory Board, designate emergency medical services regions that are consistent with local resources, geography, current patient referral patterns and existing 28regionalized health care structures and networks. The authority and the Emergency Medical 2930 Services Advisory Board shall establish a regional emergency medical services advisory board 31 for each designated emergency medical services region. The authority and the Emergency Medical Services Advisory Board may determine the membership of each regional emergency 32medical services advisory board, and shall ensure that the membership reflects the ge-33 34 ographic, cultural, linguistic and economic diversity of the emergency medical services re-35 gion.

(2) Each emergency medical services region must include at least one hospital categor ized according to the emergency medical services region's emergency medical services ca pabilities as determined by standards adopted by the authority by rule.

(3) The authority, with the advice of the Emergency Medical Services Advisory Board,
shall appoint the members of the regional emergency medical services advisory boards.
