SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes new laws about marijuana and hemp and changes some laws about marijuana and hemp. (Flesch Readability Score: 60.1).

Directs the Oregon Liquor and Cannabis Commission, in consultation with the State Department of Agriculture, to create a map of locations of premises licensed to produce marijuana or industrial hemp. Allows law enforcement agencies to accompany the department to industrial hemp operations throughout the state for specified purposes.

Directs the commission to adopt rules to establish standards for certain industrial hemp products.

Directs the commission to establish a registration system for industrial hemp products that contain cannabinoids and are intended for human or animal consumption or use. Establishes a civil penalty not to exceed \$10,000 for each violation. Becomes operative January 1, 2026.

Establishes a per capita requirement for the issuance of marijuana licenses. Becomes operative January 1, 2025.

Directs the commission to establish uniform standards for minor decoy operations to investigate sales of adult use cannabis items to minors. Becomes operative January 1, 2025.

Directs the commission to adopt rules to issue a temporary permit to a qualified individual to perform work for or on behalf of a marijuana licensee or laboratory.

Declares an emergency, effective on passage.

A BILL FOR AN ACT

Relating to cannabis; creating new provisions; amending ORS 475C.049, 475C.117, 475C.197, 475C.209, 475C.265, 475C.269, 475C.273, 475C.297, 475C.742, 475C.746, 571.306 and 571.309 and section 2, chapter 108, Oregon Laws 2022; repealing ORS 571.312; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

ENFORCEMENT

SECTION 1. (1) **As used in this section:**

(a) **“Industrial hemp”** has the meaning given that term in ORS 571.269.

(b) **“Marijuana”** has the meaning given that term in ORS 475C.009.

(2) The Oregon Liquor and Cannabis Commission shall, with the assistance of the State Department of Agriculture, create and continually update a map of the following:

(a) **Premises for which a license has been issued under ORS 475C.065; and**

(b) **The locations of industrial hemp operations licensed under ORS 571.281.**

(3) The commission shall make the map described in subsection (2) of this section available to law enforcement agencies in this state and public employees and officials who are responsible for the enforcement of state and local laws regulating industrial hemp or

1 marijuana.

2 **SECTION 2.** (1) As used in this section:

3 (a) “Industrial hemp” has the meaning given that term in ORS 571.269.

4 (b) “Marijuana” has the meaning given that term in ORS 475C.009.

5 (2) The Oregon Liquor and Cannabis Commission, in consultation with the State Department of Agriculture, shall develop by rule a methodology to distinguish whether a cannabis plant is marijuana or industrial hemp for purposes of sections 1, 4, 5 and 6 of this 2024 Act. The methodology must include testing criteria and cannabinoid concentrations above which immature or mature cannabis plants are presumptively considered to be marijuana.

10 (3) The department may order a person licensed under ORS 571.281 to destroy any cannabis plants located at an industrial hemp operation for which the person is responsible if the cannabis plants are presumptively considered to be marijuana under the methodology developed pursuant to subsection (2) of this section.

14 **SECTION 3.** Sections 4 to 6 of this 2024 Act are added to and made a part of ORS 571.260 to 571.348.

16 **SECTION 4.** (1) The State Department of Agriculture may enter into an interagency agreement with the Oregon Liquor and Cannabis Commission to allow representatives of the commission to carry out inspections of industrial hemp crops under ORS 571.281 (7) throughout this state.

20 (2) The department and the commission may adopt rules to carry out this section.

21 **SECTION 5.** The State Department of Agriculture shall adopt rules to allow:

22 (1) Law enforcement officers to accompany representatives of the department to an industrial hemp operation for the purposes of providing protection to the department’s representatives; and

25 (2) Public employees and officials who are responsible for the enforcement of state and local laws to accompany representatives of the department to an industrial hemp operations in order to carry out inspections that the public employees or officials are authorized to perform.

29 **SECTION 6.** The Governor may order that the Oregon National Guard provide assistance and support to the State Department of Agriculture and law enforcement in carrying out inspections of industrial hemp crops under ORS 571.281 (7) and other duties of the department related to the enforcement of ORS 571.260 to 571.348.

34 **INDUSTRIAL HEMP**

36 **SECTION 7.** ORS 475C.297 is amended to read:

37 475C.297. The Marijuana Control and Regulation Fund is established in the State Treasury, separate and distinct from the General Fund. Interest earned by the Marijuana Control and Regulation Fund shall be credited to the fund. Moneys in the fund are continuously appropriated to the Oregon Liquor and Cannabis Commission to administer and enforce ORS 475C.005 to 475C.525, 475C.540 to 475C.586, 475C.600 to 475C.648, [and] 475C.925 and 571.309 and sections 2 and 4 of this 2024 Act.

43 **SECTION 8.** ORS 571.306 is amended to read:

44 571.306. [(1) A person licensed under ORS 571.281 may, within the boundaries of this state, transport to or receive from:]

1 transferring or delivering the industrial hemp product directly to a consumer in this state
2 or selling, transferring or delivering the industrial hemp product to a retailer in this state
3 for the purpose of sale to a consumer in this state:

4 (A) Annually submit the information described in subsection (3) of this section to the
5 commission in a manner specified by the commission by rule;

6 (B) Include on the industrial hemp product a label that contains the information de-
7 scribed in subsection (4) of this section; and

8 (C) Pay an annual registration fee established by the commission by rule.

9 (3) A person described in subsection (2) of this section shall submit to the commission
10 the following information about an industrial hemp product that contains cannabinoids and
11 is intended for human or animal consumption or use:

12 (a) The name and type of the product;

13 (b) The name and physical address of the manufacturer of the product;

14 (c) The mailing address of the manufacturer of the product;

15 (d) A certificate of analysis for a batch of the product;

16 (e) A copy of the label for the product;

17 (f) A statement about whether the product is an adult use cannabis item; and

18 (g) Any other information required by the commission by rule.

19 (4) A person described in subsection (2) of this section shall label an industrial hemp
20 product that contains cannabinoids and is intended for human or animal consumption or use
21 with a label that contains the following information:

22 (a) The name and type of the product;

23 (b) The name and physical address of the manufacturer of the product;

24 (c) The ingredients of the product;

25 (d) The net weight or volume of the product;

26 (e) The serving size and number of servings contained in a package of the product;

27 (f) The potency of the product and a list of the cannabinoid contents of the product;

28 (g) The address of a publicly accessible website that contains the certificate of analysis
29 for the product;

30 (h) Health and safety warnings required by law or rule;

31 (i) If the product is an adult use cannabis item, the following language:

32 (A) "For use only by adults 21 and older."; and

33 (B) "Keep out of reach of children.";

34 (j) If the product is a food product, any other information required by law or rule for food
35 products; and

36 (k) Any other information required by the commission by rule.

37 (5) In adopting rules under subsection (4) of this section, the commission:

38 (a) May establish different labeling standards for different types of industrial hemp pro-
39 ducts that contain cannabinoids and are intended for human or animal consumption or use,
40 and may consider existing product quality requirements or standards applicable to different
41 types of products; and

42 (b) May not adopt rules that are more restrictive than is reasonably necessary to protect
43 the public health and safety.

44 (6) If an industrial hemp product is intended only for human consumption or use, the
45 person described in subsection (2) of this section shall comply with the requirements of ORS

1 571.337 and 571.339.

2 (7)(a) The fee collected under this section may not exceed the cost of administering ORS
3 571.309 and sections 2, 4 and 11 to 14 of this 2024 Act.

4 (b) Fees collected under this section shall be deposited in the Marijuana Control and
5 Regulation Fund established under ORS 475C.297.

6 (8) A person is not required to submit to the commission the information described in
7 subsection (3) of this section for an industrial hemp product that contains cannabinoids and
8 is intended for human or animal consumption or use if another person has submitted the
9 information for the product and the product continues to be consistent with the previously
10 submitted information.

11 (9) The commission may refuse to register an industrial hemp product that contains
12 cannabinoids and is intended for human or animal consumption or use if, based on the in-
13 formation described in subsection (3) or (4) of this section, the sale of the product to a con-
14 sumer is prohibited by section 12 of this 2024 Act or by the commission by rule.

15 (10) This section does not apply to an industrial hemp product that:

16 (a) Does not contain cannabinoids;

17 (b) Is intended only for topical use;

18 (c) Is an industrial hemp grain or fiber product that does not contain added cannabinoids;

19 (d) Is a commercial feed product for animals registered under ORS 633.006 to 633.089; or

20 (e) Is transported through this state en route to a final destination in another state.

21 **SECTION 12.** A person may not sell, transfer or deliver to a consumer in this state an
22 industrial hemp product that contains cannabinoids and is intended for human or animal
23 consumption or use that:

24 (1) Is not registered under section 11 of this 2024 Act.

25 (2) Does not bear a label that meets the requirements of section 11 of this 2024 Act, or
26 bears a label that does not precisely indicate the contents of the container or that may de-
27 ceive a consumer regarding the nature, composition, quantity, age or quality of the contents.

28 (3) Includes upon the packaging any untruthful or misleading statements, including but
29 not limited to, a health claim that is not supported by a consensus of publicly available sci-
30 entific evidence, including evidence from well-designed studies conducted in a manner that
31 is consistent with generally recognized scientific procedures and principles and for which
32 there is significant scientific agreement among experts qualified by scientific training and
33 experience to evaluate such a claim.

34 (4) Is attractive to minors, including by featuring:

35 (a) A cartoon;

36 (b) A design, brand or name that resembles a product that is not an industrial hemp
37 product that contains cannabinoids and is intended for human or animal consumption or use
38 and is of a type typically marketed to minors;

39 (c) A symbol or celebrity that is commonly used to market products to minors;

40 (d) An image of minors; or

41 (e) Words that refer to products that are commonly associated with minors or marketed
42 to minors.

43 (5) In the commission's discretion:

44 (a) Bears or contains any poisonous or deleterious substance, including but not limited
45 to tobacco or nicotine, in a quantity rendering the product injurious in a manner that may

1 pose a risk to human health, or that exceeds any established safe tolerance;

2 (b) Consists in whole or in part of any filthy, putrid or decomposed substance or is oth-
3 erwise unfit for human or animal consumption or use;

4 (c) Is processed, prepared, packaged or held under improper or insanitary conditions or
5 under conditions that increase the probability of contamination with excessive
6 microorganisms or physical contaminants or of cross-contamination;

7 (d) Is held or packaged in containers composed, in whole or in part, of any poisonous or
8 deleterious substance that renders the contents potentially injurious to health;

9 (e) Includes any substitute substance;

10 (f) Is damaged or inferior; or

11 (g) Includes any substance intended to increase the bulk or weight of the product, reduce
12 the quality or strength of the product or make the product appear better or of greater value.

13 (6) Does not meet relevant minimum standards provided by the laws of this state.

14 **SECTION 13.** Subject to ORS chapter 183, the Oregon Liquor and Cannabis Commission
15 may:

16 (1) If the commission has reasonable cause to believe that any quantity or lot of indus-
17 trial hemp product that contains cannabinoids and is intended for human or animal con-
18 sumption or use is sold, transferred or delivered in violation of section 11 or 12 of this 2024
19 Act or rules adopted pursuant to section 11 or 12 of this 2024 Act, issue and enforce an order
20 to prohibit the disposal, distribution or use in any manner of the quantity or lot. The person
21 to whom the order is issued shall immediately remove from locations readily visible and ac-
22 cessible to the public any product in packaged form that is subject to the order. The com-
23 mission may enforce the order until all actions against the order, including any contested
24 case, are resolved, and shall release from the order the product if the violation is cured.

25 (2) Seize any quantity or lot that the commission determines does not comply with sec-
26 tion 11 or 12 of this 2024 Act or rules adopted under section 11 or 12 of this 2024 Act.

27 **SECTION 14.** In addition to any other liability or penalty provided by law, the Oregon
28 Liquor and Cannabis Commission may impose a civil penalty, in the manner provided in ORS
29 183.745, not to exceed \$10,000 for each violation of a provision of section 11, 12 or 13 of this
30 2024 Act, a rule adopted pursuant to section 11, 12 or 13 of this 2024 Act or an order issued
31 by the commission under section 13 of this 2024 Act. Moneys collected under this section
32 shall be deposited in the General Fund and be available for general governmental purposes.

33 **SECTION 14a.** The Oregon Liquor and Cannabis Commission may adopt rules to carry
34 out sections 11 to 14 of this 2024 Act.

35 **SECTION 15.** ORS 475C.297, as amended by section 7 of this 2024 Act, is amended to read:

36 475C.297. The Marijuana Control and Regulation Fund is established in the State Treasury,
37 separate and distinct from the General Fund. Interest earned by the Marijuana Control and Regu-
38 lation Fund shall be credited to the fund. Moneys in the fund are continuously appropriated to the
39 Oregon Liquor and Cannabis Commission to administer and enforce ORS 475C.005 to 475C.525,
40 475C.540 to 475C.586, 475C.600 to 475C.648, 475C.925 and 571.309 and sections 2, [and] 4 and 11 to
41 14 of this 2024 Act.

42 **SECTION 16.** ORS 571.312 is repealed.

43 **SECTION 17.** (1) Sections 11 to 14a of this 2024 Act, the amendments to ORS 475C.297 by
44 section 15 of this 2024 Act and the repeal of ORS 571.312 by section 16 of this 2024 Act become
45 operative on January 1, 2026.

1 (b) The applicant is applying for a license at a premises where the applicant seeks to assume
2 ownership of an existing business for which a license has been issued under ORS 475C.005 to
3 475C.525 and the commission has issued a notice proposing revocation of the license for the existing
4 business or a notice proposing suspension of the license for the existing business pursuant to ORS
5 305.385; or

6 (c) The commission has received information from law enforcement that the applicant or a per-
7 son named on the application is engaging, or has engaged, in the unregulated commerce of
8 marijuana items or unlawful manufacture or delivery of controlled substances.

9 (3) The licenses described in ORS 475C.005 to 475C.525 must be issued by the commission, sub-
10 ject to the provisions of ORS 475C.005 to 475C.525 and rules adopted under ORS 475C.005 to
11 475C.525.

12 (4) The commission may not license a premises that does not have defined boundaries. A prem-
13 ises does not need to be enclosed by a wall, fence or other structure, but the commission may re-
14 quire a premises to be enclosed as a condition of issuing or renewing a license. The commission may
15 not license a mobile premises.

16 **SECTION 22.** (1) **Section 19 of this 2024 Act and the amendments to ORS 475C.049 by**
17 **section 21 of this 2024 Act become operative on January 1, 2025.**

18 (2) **The Oregon Liquor and Cannabis Commission may take any action before the opera-**
19 **tive date specified in subsection (1) of this section that is necessary to enable the commission**
20 **to exercise, on or after the operative date specified in subsection (1) of this section, all of**
21 **the duties, functions and powers conferred on the commission by section 19 of this 2024 Act**
22 **and the amendments to ORS 475C.049 by section 21 of this 2024 Act.**

23 **SECTION 23.** Section 2, chapter 108, Oregon Laws 2022, is amended to read:

27 **MINOR DECOY OPERATIONS**
28

29 **SECTION 24.** Section 25 of this 2024 Act is added to and made a part of ORS 475C.005 to
30 475C.525.

31 **SECTION 25.** (1)(a) **The Oregon Liquor and Cannabis Commission shall by rule develop**
32 **uniform standards for minor decoy operations used to investigate persons selling, trans-**
33 **ferring or delivering industrial hemp products that contain cannabinoids and are intended for**
34 **human or animal consumption or use in this state for violations of the laws of this state**
35 **prohibiting sales of adult use cannabis items to minors.**

36 (b) **Uniform standards established under this section apply to all investigations conducted**
37 **by the commission that use minor decoys. The commission shall encourage all law enforce-**
38 **ment agencies in this state to use the uniform standards established under this section for**
39 **minor decoy operations conducted by the law enforcement agencies.**

40 (2) **To the greatest extent possible, the uniform standards established by the commission**
41 **under this section must:**

42 (a) **Be the same for minor decoy operations conducted by the commission and for minor**
43 **decoy operations conducted by law enforcement agencies of this state; and**

44 (b) **Provide for coordination between the commission and law enforcement agencies of**
45 **this state in conducting minor decoy operations.**

1 (3) The failure of the commission or a law enforcement agency to follow the uniform
2 standards established under this section is not grounds for challenging a complaint, citation
3 or conviction for violation of the laws prohibiting the sale of adult use cannabis items to
4 minors.

5 (4) Notwithstanding any other provision of ORS 475C.005 to 475C.525 or any provision of
6 571.260 to 571.348, the commission may not consider the sale of an adult use cannabis item
7 to a minor that results from a minor decoy operation that is not conducted in compliance
8 with the uniform standards established under this section for the purpose of imposing a civil
9 penalty.

10 (5) The commission shall give notice of the uniform standards established under this
11 section to all law enforcement agencies of this state that conduct minor decoy operations.

12 **SECTION 26.** (1) Section 25 of this 2024 Act becomes operative on January 1, 2025.

13 (2) The Oregon Liquor and Cannabis Commission may take any action before the opera-
14 tive date specified in subsection (1) of this section that is necessary to enable the commission
15 to exercise, on and after the operative date specified in subsection (1) of this section, all of
16 the duties, functions and powers conferred on the commission by section 25 of this 2024 Act.

18 **TEMPORARY PERMITS**

19
20 **SECTION 27.** ORS 475C.269 is amended to read:

21 475C.269. (1) An individual who performs work for or on behalf of a licensee or a laboratory li-
22 censed under ORS 475C.548 must have a valid permit **or temporary permit** issued by the Oregon
23 Liquor and Cannabis Commission under ORS 475C.273 if the individual participates in:

24 (a) The delivery, possession, production, propagation, processing, sampling, securing, selling or
25 testing of marijuana items at the premises or laboratory for which the license has been issued;

26 (b) The recording of the delivery, possession, production, propagation, processing, sampling, se-
27 curing, selling or testing of marijuana items at the premises or laboratory for which the license has
28 been issued; or

29 (c) The verification of any document described in ORS 475C.217.

30 (2) A licensee or a laboratory licensed under ORS 475C.548 must verify that an individual has
31 a valid permit **or temporary permit** issued under ORS 475C.273 before allowing the individual to
32 perform, or continue to perform, any work described in subsection (1) of this section at the premises
33 or laboratory for which the license has been issued.

34 **SECTION 28.** ORS 475C.273 is amended to read:

35 475C.273. (1) The Oregon Liquor and Cannabis Commission shall issue permits to qualified ap-
36 plicants to perform work described in ORS 475C.269. The commission shall adopt rules establishing:

37 (a) The qualifications for performing work described in ORS 475C.269;

38 (b) The term of a permit issued under this section;

39 (c) Procedures for applying for and renewing a permit issued under this section; and

40 (d) Reasonable application, issuance and renewal fees for a permit issued under this section.

41 (2)(a) The commission may require an individual applying for a permit under this section to
42 successfully complete a course, made available by or through the commission, through which the
43 individual receives training on:

44 (A) Checking identification;

45 (B) Detecting intoxication;

1 (C) Handling marijuana items;

2 (D) If applicable, producing and propagating marijuana;

3 (E) If applicable, processing marijuana;

4 (F) The content of ORS 475C.005 to 475C.525 and rules adopted under ORS 475C.005 to 475C.525;

5 (G) If applicable, the content of ORS 475C.540 to 475C.586 and rules adopted under ORS
6 475C.540 to 475C.586; or

7 (H) Any matter deemed necessary by the commission to protect the public health and safety.

8 (b) The commission or other provider of a course may charge a reasonable fee for the course.

9 (c) The commission may not require an individual to successfully complete a course more than
10 once, except that:

11 (A) As part of a final order suspending a permit issued under this section, the commission may
12 require a permit holder to successfully complete the course as a condition of lifting the suspension;
13 and

14 (B) As part of a final order revoking a permit issued under this section, the commission shall
15 require an individual to successfully complete the course prior to applying for a new permit.

16 (3) The commission shall conduct a criminal records check under ORS 181A.195 on an individual
17 applying for a permit under this section.

18 (4) Subject to the applicable provisions of ORS chapter 183, the commission may suspend, revoke
19 or refuse to issue or renew a permit **or temporary permit** if the individual who is applying for or
20 who holds the permit **or temporary permit**:

21 (a) Is convicted of a felony or is convicted of an offense under ORS 475C.005 to 475C.525, except
22 that the commission may not consider a conviction for an offense under ORS 475C.005 to 475C.525
23 if the date of the conviction is two or more years before the date of the application or renewal;

24 (b) Violates any provision of ORS 475C.005 to 475C.525 or 475C.540 to 475C.586 or any rule
25 adopted under ORS 475C.005 to 475C.525 or 475C.540 to 475C.586; or

26 (c) Makes a false statement to the commission.

27 (5) A permit issued under this section is a personal privilege and permits work described under
28 ORS 475C.269 only for the individual who holds the permit.

29 **(6)(a) The commission shall establish by rule a process to issue to an individual, upon
30 receipt of the individual's application for a permit described in subsection (1) of this section,
31 a temporary permit to perform work described in ORS 475C.269 until the issuance or denial
32 of a permit described in subsection (1) of this section.**

33 **(b) A temporary permit expires on the date on which the individual is issued or denied
34 a permit described in subsection (1) of this section.**

35 **(c) The commission may adopt rules to establish conditions for the issuance of a tempo-
36 rary permit under this subsection.**

37 **SECTION 29.** ORS 475C.117 is amended to read:

38 475C.117. (1) A marijuana retailer that holds a license issued under ORS 475C.097 may make
39 deliveries to a consumer pursuant to the consumer's bona fide order received by the marijuana
40 retailer. The delivery of marijuana items under this section may be made to a consumer:

41 (a) Within the same city or unincorporated area of the county in which the marijuana retailer
42 is located; or

43 (b) In a city or the unincorporated area of a county that is adjacent to the city or
44 unincorporated area of the county in which the marijuana retailer is located, provided the adjacent
45 city or county has adopted an ordinance allowing for the delivery of marijuana items by a marijuana

1 retailer located in an adjacent city or unincorporated area of a county.

2 (2) A marijuana retailer that makes deliveries under this section shall:

3 (a) Ensure that deliveries are made in an efficient and timely manner.

4 (b) Upon request, provide to the Oregon Liquor and Cannabis Commission information on each
5 vehicle used to make deliveries of marijuana items under this section, including the make, model,
6 year, color, vehicle identification number and registration plate number.

7 (c) Maintain an electronic or physical record of each bona fide order for the delivery of
8 marijuana items that the marijuana retailer fulfills.

9 (d) Report to the commission, and as necessary to the appropriate law enforcement agency, any
10 accidents or losses involving a delivery vehicle.

11 (3) An individual who makes deliveries on behalf of a marijuana retailer under this section:

12 (a) Shall:

13 (A) Hold a permit **or temporary permit** issued under ORS 475C.273 and carry the permit **or**
14 **temporary permit** while making deliveries under this section.

15 (B) Have a method of secure electronic communication in order to communicate with the
16 marijuana retailer for which the individual is making deliveries.

17 (C) Maintain an electronic or physical record of a bona fide order for a delivery of a marijuana
18 item.

19 (D) Present to the consumer a printed or electronic delivery manifest and obtain on the manifest
20 the consumer's written or electronic signature verifying completion of the delivery of marijuana
21 items.

22 (E) Except in the case of an emergency or unsafe road conditions or as necessary for fuel, rest
23 or vehicle repair, travel only between the premises of the marijuana retailer and the locations at
24 which the deliveries of marijuana items are made.

25 (b) May not:

26 (A) Leave a delivery vehicle that contains marijuana items unattended unless the delivery ve-
27 hicle is locked and equipped with an active vehicle alarm system.

28 (B) Carry more than \$10,000 worth of marijuana items in a delivery vehicle at any one time.

29 (C) Consume, or be under the influence of, marijuana while making deliveries under this section.

30 (4) A delivery vehicle must:

31 (a) While being used for making deliveries, be equipped with an active global positioning system
32 device that tracks the location of the delivery vehicle and enables the marijuana retailer for which
33 the deliveries are being made to identify the location of the delivery vehicle.

34 (b) Be equipped with a lockable container in a secured cargo area of the delivery vehicle that
35 is of a size appropriate to contain the marijuana items being delivered.

36 (c) Be free of any markings that may indicate that the delivery vehicle is used for the purpose
37 of delivering marijuana items.

38 (5) A delivery of marijuana items may not be made to a consumer who is located on land owned
39 or leased by the federal government.

40 (6) The commission may adopt rules to carry out the purposes of this section.

41 **SECTION 30.** ORS 475C.197 is amended to read:

42 475C.197. (1) Notwithstanding the lapse, suspension or revocation of a permit **or temporary**
43 **permit** issued under ORS 475C.273, the Oregon Liquor and Cannabis Commission may:

44 (a) Proceed with any investigation of, or any action or disciplinary proceeding against, the per-
45 son who held the permit **or temporary permit**; [or]

1 (b) Revise or render void an order suspending or revoking the permit **or temporary permit**[.];

15 (d) The name of the licensee from which the marijuana or marijuana items are being trans-

18 (f) The location of any overnight stop during transportation, and the estimated time of the
19 overnight stop; and

20 (g) The destination of the marijuana and marijuana items being transported.

44 (g) Since the issuance of the license, has been convicted of a felony, of violating any of the
45 marijuana laws of this state, general or local, or of any misdemeanor or violation of any municipal

1 ordinance committed on the premises for which the license has been issued.

2 (h) Has sold a marijuana item to a person under 21 years of age.

3 (2) In addition to the grounds listed in subsection (1) of this section, the commission may take
4 an action described in subsection (1) of this section if there is a history of a lack of institutional
5 control involving the premises for which a license has been issued under ORS 475C.005 to 475C.525
6 or 475C.548.

7 (3)(a) The commission may revoke a license under subsection (1)(a) of this section only when the
8 conduct poses a significant risk to public health or safety.

9 (b) The commission shall consider as mitigating factors to the conduct described in subsection
10 (1) of this section the following:

11 (A) Self-reporting by a licensee or applicant;

12 (B) A demonstration that, to the satisfaction of the commission, the conduct of the licensee or
13 applicant is not persistent or serious; and

14 (C) A demonstration that, to the satisfaction of the commission, the licensee's willingness and
