SENATE AMENDMENTS TO SENATE BILL 1516

On page 1 of the printed bill, delete lines 4 through 28 and delete page 2 and insert:

2	"SECTION 1. (1) The Ireland Trade Commission is established.
3	"(2) The commission consists of at least seven but no more than nine members appointed
4	as follows:
5	"(a) The President of the Senate shall appoint one member from among members of the
6	Senate.
7	"(b) The Speaker of the House of Representatives shall appoint one member from among
8	members of the House.
9	"(c) The Governor shall appoint at least five but no more than seven members, including:
10	"(A) At least one member representing an institution of higher education; and
11	"(B) At least one member representing a statewide trade organization.
12	"(3) The commission shall:
13	"(a) Advance bilateral trade and investment between Oregon and Ireland;
14	"(b) Initiate joint action on policy issues of mutual interest to Oregon and Ireland;
15	"(c) Promote business and academic exchanges between Oregon and Ireland;
16	"(d) Encourage mutual economic support between Oregon and Ireland;
17	"(e) Encourage mutual investment in the infrastructure of Oregon and Ireland; and
18	"(f) Address other issues as determined by the commission.
19	"(4) A majority of the members of the commission constitutes a quorum for the trans-

- "(6) The commission shall elect one of its members to serve as chairperson.
- "(7) The term of a member appointed by the Governor is four years. The term of a member appointed by the President of the Senate or the Speaker of the House of Representative is two years. If there is a vacancy for any cause, the appointing authority shall make an appointment to become immediately effective.

"(5) Official action by the commission requires the approval of a majority of the members

- "(8) The commission shall meet at least twice per year at times and places specified by the call of the chairperson or of a majority of the members of the commission.
 - "(9) The commission may adopt rules necessary for the operation of the commission.
- "(10) The commission may submit reports in the manner provided by ORS 192.245, and may include recommendations for legislation, to an interim committee of the Legislative Assembly related to trade, and to the Governor.
- "(11)(a) Members of the commission who are not legislators shall be paid compensation and expenses as provided in ORS 292.495.

- "(b) Members of the commission who are legislators shall be paid compensation and expense reimbursement as provided in ORS 171.072.
- "(12) The Legislative Policy and Research Director shall provide administrative staff support for meetings of the commission.
- "(13) All agencies of state government, as defined in ORS 174.111, are directed to assist the commission in the performance of the duties of the commission and, to the extent permitted by laws relating to confidentiality, to furnish information and advice the members of the commission consider necessary to perform their duties.

"SECTION 2. This 2024 Act takes effect on the 91st day after the date on which the 2024 regular session of the Eighty-second Legislative Assembly adjourns sine die.".
