

# B-Engrossed Senate Bill 1552

Ordered by the Senate March 7  
Including Senate Amendments dated February 16 and March 7

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

- Digest: Makes many changes to the education laws of this state. (Flesch Readability Score: 69.7).
- Establishes a youth advisory group. Prescribes the membership and duties of the group. Directs the Department of Education to establish a work group to develop standards for the group.
- Directs the department to develop a plan for the collection of course-level completion and grade data for all public school students in grades 6 through 12.
- Directs the Higher Education Coordinating Commission to establish a direct admissions program for community colleges and public universities.
- Directs the Legislative and Policy Research Director to conduct a study on the Quality Education Model and the state's system of financing public education for kindergarten through grade 12.
- Changes the entity that makes determinations related to the Oregon Opportunity Grant program to the commission. Requires that the manner by which the commission determines the state share under the program be done by rule.
- Modifies calculations of funding for the Youth Corrections Education Program and the Juvenile Detention Education Program. Directs the department to establish a target funding level for programs. Authorizes the department to transfer moneys from the Statewide Education Initiatives Account for the purpose of meeting the target funding level.
- Expands the authority of the commission to enter into contracts or agreements for Oregon's Open Educational Resources (OER) Program.
- Clarifies the requirements for school district policies related to short-acting opioid antagonists.
- Modifies the membership requirements of the Educator Advancement Council, the scope of duties of the council and the requirements of certain grants awarded by the council.
- Directs the commission to convene a work group to conduct a study related to evidence-based corequisite student support models.
- Allows an applied baccalaureate degree program or Bachelor of Science: Nursing degree program to be eligible for funding from the Community College Support Fund.
- Clarifies the eligibility of part-time faculty members at a public institution of higher education to receive employee-only health care benefits.
- Directs the commission to conduct a study related to the forestry workforce.
- Exempts from public meetings laws meetings of certain subcommittees of the Transfer Council.
- Allows a person, prior to beginning an education, a training or an apprenticeship program for an occupational or a professional license, to petition a licensing board, a commission or an agency for a determination as to whether a criminal conviction will prevent the person from receiving the license.
- Specifies laws that are applicable to approved recovery schools.
- Clarifies the applicability of just cause provisions to classified school employees.
- Modifies payment requirements for substitute teachers.
- Repeals sections related to the repealed Early Success Reading Initiative.
- Declares an emergency, effective on passage.

3 **YOUTH ADVISORY GROUP**  
4

5 **SECTION 1.** (1) The Department of Education shall establish a work group to develop  
6 standards that are used to select the members of the youth advisory group established by  
7 section 4 of this 2024 Act.

8 (2) The work group shall consist of members selected by the Deputy Superintendent of  
9 Public Instruction in consultation with the Youth Development Division, the Oregon Health  
10 Authority and the Racial Justice Council.

11 (3) To the greatest extent practicable, the work group shall consist of:

12 (a) Youth representing tribal youth councils;

13 (b) Youth representing youth and student leadership organizations;

14 (c) Youth participating in alternative education pathways;

15 (d) Youth from immigrant and refugee communities;

16 (e) Individuals representing culturally and ethnically specific community-based organiza-  
17 tions, including organizations that assist immigrant and refugee communities;

18 (f) Individuals who are administrators, teachers and other school staff who support youth  
19 and student leadership in public schools, including education service districts, school dis-  
20 tricts, schools and youth reengagement programs;

21 (g) Youth who serve as advisors to the State Board of Education or serve on Department  
22 of Education work groups related to student success initiatives;

23 (h) Youth who serve on the Youth Development Council or who participate in Youth  
24 Development Division programs;

25 (i) Youth who serve on Oregon Health Authority work groups;

27 (k) Additional members identified and recommended by the work group.

2 (5)(a) The youth advisory group shall meet at least six times each year on the dates determined  
3 by a majority of the members of the youth advisory group. The youth advisory group shall also meet  
4 at other times specified or requested by a majority of the members of the youth advisory group.

5 (b) The youth advisory group shall meet in the place and manner determined by a majority of  
6 the members of the youth advisory group. All or part of the members of the youth advisory group  
7 may attend the meetings electronically, unless otherwise provided by a majority of the members of  
8 the youth advisory group.

9 (6) The Department of Education shall:

10 (a) Provide staff support to the youth advisory group; and

18 **SECTION 9.** (1) **The Department of Education shall develop a plan for the collection of**  
19 **course-level completion and grade data for all public school students in grades 6 through 12.**

20 (2) **No later than September 15, 2024, the Department of Education shall submit a report**  
21 **in the manner provided by ORS 192.245, and may include recommendations for legislation,**  
22 **to the interim committees of the Legislative Assembly related to education regarding:**

23 (a) **The plan developed under subsection (1) of this section; and**

24 (b) **The funding the department will require during the 2025-2027 biennium for the pur-**  
25 **poses of the plan.**

26 **SECTION 10.** **Section 9 of this 2024 Act is repealed on January 2, 2025.**

33 (2) The Higher Education Coordinating Commission shall be guided by the legislative findings  
34 in ORS 341.009, 350.001 and 350.005 and the goals and mission of post-secondary education set forth  
35 in ORS 350.009 and 350.014.

36 (3) The Higher Education Coordinating Commission shall:

37 (a) Develop state goals for the state post-secondary education system, including community col-  
38 leges and public universities listed in ORS 352.002, and for student access programs.

39 (b) Determine strategic investments in the state’s community colleges, public universities and  
40 student access programs necessary to achieve state post-secondary education goals.

41 (c) Coordinate the post-secondary elements of data collection and structure, with the advice and  
42 recommendation of the state’s independent institutions, community colleges and public universities,  
43 as appropriate, in order to construct a state longitudinal data system.

44 (d) Adopt a strategic plan for achieving state post-secondary education goals, taking into con-  
45 sideration the contributions of this state’s independent institutions, philanthropic organizations and

1 other organizations dedicated to helping Oregonians reach state goals. State post-secondary educa-  
2 tion goals as described in this section should include, but need not be limited to:

3 (A) Increasing the educational attainment of the population;

4 (B) Increasing this state's global economic competitiveness and the quality of life of its resi-  
5 dents;

6 (C) Ensuring affordable access for qualified Oregon students at each college or public university;

7 (D) Removing barriers to on-time completion; and

8 (E) Tracking progress toward meeting the state's post-secondary education goals established in  
9 the strategic plan described in this paragraph.

10 (e)(A) Each biennium, after receiving funding requests from the state's community colleges and  
11 public universities as authorized by law, recommend to the Governor a consolidated higher educa-  
12 tion agency request budget aligned with the strategic plan described in paragraph (d) of this sub-  
13 section, including appropriations for:

14 (i) Student access programs;

15 (ii) Public universities listed in ORS 352.002, including but not limited to education and general  
16 operations, statewide public services and state-funded debt service;

17 (iii) Community colleges, including but not limited to education and general operations and  
18 state-funded debt service;

19 (iv) New facilities or programs;

20 (v) Capital improvements and deferred maintenance;

21 (vi) Special initiatives and investments; and

22 (vii) Any other program, duty or function a public university listed in ORS 352.002 is authorized  
23 to undertake.

24 (B) In the development of the consolidated higher education agency request budget:

25 (i) Determine the costs necessary to provide quality post-secondary education;

26 (ii) Solicit input from educators, education policy experts, appropriate legislative committees,  
27 students and other persons interested in the development of the funding model; and

28 (iii) Solicit public input regarding educational priorities.

29 (f) Adopt rules governing the distribution of appropriations from the Legislative Assembly to  
30 community colleges, public universities listed in ORS 352.002 and student access programs. These  
31 rules must be based on allocation formulas developed in consultation with the state's community  
32 colleges and public universities, as appropriate.

33 (g) Approve or disapprove any significant change to the academic program of a community col-  
34 lege or a public university listed in ORS 352.002. In reaching a decision under this paragraph, the  
35 commission shall consider the recommendation from the community college or public university  
36 seeking to make the change to an academic program that is issued pursuant to the obligation of the  
37 governing board of a community college or public university to review and approve academic pro-  
38 grams. The commission shall ensure that approved programs:

39 (A) Are consistent with the mission statement of the community college or public university;

40 (B) Do not unnecessarily duplicate academic programs offered by Oregon's other community  
41 colleges or public universities;

42 (C) Are not located in a geographic area that will cause undue hardship to Oregon's other  
43 community colleges or public universities; and

44 (D) Are allocated among Oregon's community colleges and public universities to maximize the  
45 achievement of statewide needs and requirements.

- 1 (h) For public universities listed in ORS 352.002:
- 2 (A) Approve the mission statement adopted by a governing board of a public university.
- 3 (B) Review and determine whether a proposed annual increase of resident undergraduate en-
- 4 rollment fees of greater than five percent is appropriate.
- 5 (C) Advise the Governor and the Legislative Assembly on issues of university governance.
- 6 (D) Approve and authorize degrees.
- 7 (E) Perform the evaluation and certification required by ORS 350.095.
- 8 (i) Authorize degrees to be offered by independent post-secondary institutions in this state under
- 9 ORS 348.594 to 348.615.
- 10 (j) Oversee the licensing of career schools under ORS 345.010 to 345.340.
- 11 (k) Have the authority to enter into and administer interstate agreements regarding the pro-
- 12 vision of post-secondary distance education. The participation by an educational institution that is
- 13 not based in this state in distance learning courses or programs that are part of an interstate
- 14 agreement entered into and administered under this paragraph does not constitute operating in this
- 15 state for purposes of ORS 348.594 to 348.615. The commission, by rule, may impose a fee on any
- 16 educational institution that seeks to operate under or participate in such interstate agreements. The
- 17 fee amount shall be established to recover designated expenses incurred by the commission in par-
- 18 ticipating in such agreements.
- 19 (L) Administer a statewide longitudinal data system.
- 20 (m) In coordination with the Department of Education, the Employment Department and other
- 21 state agencies, conduct statewide longitudinal studies and reporting of early learning, kindergarten
- 22 through grade 12 education, higher education and workforce programs. For the purposes of this
- 23 paragraph:
- 24 (A) The commission shall enter into written interagency agreements with the Department of
- 25 Education, the Employment Department and any other state agencies necessary for conducting
- 26 statewide longitudinal studies and reporting.
- 27 (B) The commission may share data from the statewide longitudinal data system with persons
- 28 or public bodies. For purposes of this subparagraph, the commission shall adopt rules to establish
- 29 procedures for requesting or sharing data and may enter into written agreements for sharing data.
- 30 (C) The commission is considered an authorized representative of state educational agencies
- 31 under applicable state and federal law for purposes of accessing, compiling and storing student data
- 32 for research, audit and evaluation purposes.
- 33 **(n) Establish a direct admissions program for community colleges in this state and public**
- 34 **universities listed in ORS 352.002. The commission shall adopt rules to:**
- 35 **(A) Establish a method for the collection of student data necessary to implement the**
- 36 **program, which may include collaborating with the Department of Education to the extent**
- 37 **necessary to collect the student data; and**
- 38 **(B) Maximize opportunities for underserved students and first generation college stu-**
- 39 **dents to participate in the program.**
- 40 (4)(a) The Higher Education Coordinating Commission shall implement a process to review and
- 41 appropriately act on student complaints regarding any school operating in this state. As part of the
- 42 process implemented under this subsection, the commission may:
- 43 (A) Receive student complaints from students regarding a school;
- 44 (B) Specify the type of information that must be included in a student complaint;
- 45 (C) Investigate and resolve student complaints that relate to state financial aid;

1 (D) Refer a student complaint to another entity for investigation and resolution as provided in  
2 paragraph (b) of this subsection;

3 (E) Adopt rules to implement the provisions of this subsection; and

4 (F) Enter into agreements to implement the provisions of this subsection.

5 (b) The commission may refer the investigation and resolution of a student complaint to:

6 (A) An appropriate state agency if the complaint alleges that a school has violated a state law  
7 concerning consumer protection, civil rights, employment rights or environmental quality;

8 (B) A school's accrediting association if the complaint relates to the school's authorization to  
9 offer academic degree programs or to the quality of the school's academic degree programs; or

10 (C) The school at which the student is enrolled if the commission determines that the complaint  
11 should be resolved through the school's internal review process.

12 (c) As used in this subsection:

13 (A)(i) "School" means an independent institution of higher education that meets the require-  
14 ments of ORS 348.597 (2)(a).

15 (ii) "School" does not mean a school that is exempt from ORS 348.594 to 348.615 under ORS  
16 348.597 (2)(b) or (c).

17 (B) "Student" means a person who is enrolled at a school for the purpose of obtaining a degree,  
18 certificate or other recognized educational credential offered by that school.

19 (5) A student complaint that is received by the Higher Education Coordinating Commission, in-  
20 cluding but not limited to a student complaint filed under subsection (4) of this section, is not sub-  
21 ject to disclosure under ORS 192.311 to 192.478.

22 (6) In addition to the duties described in subsections (2) to (4) of this section, the Higher Edu-  
23 cation Coordinating Commission shall advise the Legislative Assembly, the Governor, community  
24 colleges, public universities and other state boards and commissions on policies in order to:

25 (a) Ensure or improve access to higher education by diverse and underserved populations.

26 (b) Encourage student success and completion initiatives.

27 (c) Improve the coordination of the provision of educational services, including:

28 (A) Transfers and coenrollment throughout the higher education system;

29 (B) Accelerated college credit programs for high school students;

30 (C) Applied baccalaureate and other transfer degrees;

31 (D) Programs and grants that span multiple institutions; and

32 (E) Reciprocity agreements with other states.

33 (d) In coordination with the State Board of Education, enhance the use and quality of dual  
34 credit, career and technical pathways and efforts to create a culture of college attendance in this  
35 state.

36 (e) In coordination with the State Workforce and Talent Development Board, local workforce  
37 development boards, the Oregon Health and Science University and independent institutions, ensure  
38 that the state's colleges and universities offer programs in high-demand occupations that meet  
39 Oregon's workforce needs.

40 (f) Improve economies of scale by encouraging and facilitating the use of the shared services  
41 among post-secondary institutions in this state.

42 (7) The Higher Education Coordinating Commission, in a manner consistent with ORS chapter  
43 183, may adopt administrative rules.

44 (8) With the exception of the rulemaking authority granted in subsection (7) of this section, the  
45 Higher Education Coordinating Commission may delegate any of its powers, duties or functions to

1 a committee of the commission or to the executive director of the commission.

2 (9) The Higher Education Coordinating Commission may, subject to the Public Contracting Code,  
3 enter into contracts and agreements, including grant agreements, with public and private entities  
4 for those higher education and workforce development activities that are consistent with ORS  
5 350.001 and 350.005, with the policies set forth in ORS chapters 341 and 348 and with statutory  
6 policies related to career schools and public universities.

7 (10)(a) The Higher Education Coordinating Commission may exercise only powers, duties and  
8 functions expressly granted by the Legislative Assembly. Except as otherwise expressly provided by  
9 law, all other authorities reside at the institutional level with the respective boards of the post-  
10 secondary institutions.

11 (b) The commission has implied and direct authority to implement the powers, duties and func-  
12 tions expressly granted to the commission by the Legislative Assembly.

13 (c) Notwithstanding paragraph (b) of this subsection, the commission may not exercise any au-  
14 thority, express or implied, statutorily provided to a governing board of a public university listed in  
15 ORS 352.002 or a community college operated under ORS chapter 341.

16  
17 **STATE FUNDING OF EDUCATION**

18  
19 **SECTION 12.** (1) **The Legislative Policy and Research Director shall conduct a study of:**

20 **(a) The Quality Education Model; and**

21 **(b) The state's system of financing public education from kindergarten through grade 12.**

22 **(2) The study conducted under this section must include at least:**

23 **(a) A review of the education funding formula for public education for kindergarten**  
24 **through grade 12 in this state and an exploration of options that would provide a uniform**  
25 **and equitable design for financing the cost of an adequate education for all public school**  
26 **students in kindergarten through grade 12 in this state.**

27 **(b) A review and evaluation of the Quality Education Model, including the processes used**  
28 **to:**

29 **(A) Determine the best practices included in the model;**

30 **(B) Estimate school district operating expenses for purposes of the model;**

31 **(C) Select quality indicators for the model; and**

32 **(D) Accurately calculate the cost of a quality education for all students of this state.**

33 **(c) The identification of trends and disparities since the 2019-2020 school year in student**  
34 **performance across the state in kindergarten through grade 12 based on current school**  
35 **funding.**

36 **(d) The establishment of the baseline for the costs, programs, staffing and facilities**  
37 **needed to provide the opportunity for an adequate education.**

38 **(e) A review of the costs and existing funding for special education and related services**  
39 **and an exploration of possible alternative funding formulas.**

40 **(3) For the purpose of conducting the study described in this section, the director may**  
41 **enter into a contract with a public, private or nonprofit research entity. When entering into**  
42 **a contract, the director shall give preference, to the greatest extent practicable, to a re-**  
43 **search entity that has conducted similar studies in other states.**

44 **(4) All agencies of state government, as defined in ORS 174.111, are directed to assist the**  
45 **director, and any entity working under contract with the director, in conducting the study**

1 **and, to the extent permitted by laws related to confidentiality, to furnish information and**  
2 **advice necessary for the director or contractor to complete the study.**

3 **(5) The director shall submit a report in the manner provided by ORS 192.245 to the in-**  
4 **terim committees of the Legislative Assembly related to education no later than January 31,**  
5 **2025.**

6 **SECTION 13. Section 12 of this 2024 Act is repealed on June 30, 2025.**

7 **SECTION 14.** ORS 171.857 is amended to read:

8 171.857. (1) For each odd-numbered year regular session of the Legislative Assembly, the Presi-  
9 dent of the Senate and the Speaker of the House of Representatives shall jointly appoint a special  
10 legislative committee to issue a report pursuant to section 8, Article VIII of the Oregon Constitu-  
11 tion.

12 (2) The committee may not transact business unless a quorum is present. A quorum consists of  
13 a majority of committee members from the House of Representatives and a majority of committee  
14 members from the Senate.

15 (3) Action by the committee requires the affirmative vote of a majority of committee members  
16 from the House of Representatives and a majority of committee members from the Senate.

17 *[(4) Members of the committee are entitled to compensation and expense reimbursement as provided*  
18 *in ORS 171.072.]*

19 *[(5) The Legislative Assembly in the report shall:]*

20 **(4) In the report, the Legislative Assembly shall accomplish one of the following:**

21 (a) Demonstrate that the amount within the budget appropriated for the state's system of  
22 kindergarten through grade 12 public education is the amount of moneys, as determined by the  
23 Quality Education Commission established by ORS 327.500, that is sufficient to meet the quality  
24 goals[; or].

25 (b) Identify the reasons that the amount appropriated for the state's system of kindergarten  
26 through grade 12 public education is not sufficient, the extent of the insufficiency and the impact  
27 of the insufficiency on the ability of the state's system of kindergarten through grade 12 public ed-  
28 ucation to meet the quality goals. In identifying the impact of the insufficiency, the Legislative As-  
29 sembly shall include in the report how the amount appropriated in the budget may affect both the  
30 current practices and student performance identified by the commission under ORS 327.506 (4)(a) and  
31 the best practices and student performance identified by the commission under ORS 327.506 (4)(b).

32 *[(6)(a)]* **(5)(a)** Notwithstanding subsection *[(5)]* (4) of this section, the *[Legislative Assembly]*  
33 **committee** may make a determination that the report of the Quality Education Commission should  
34 not be used as the basis for carrying out the reporting requirements of section 8, Article VIII of the  
35 Oregon Constitution, and subsection *[(5)]* (4) of this section. If the report is not used, the *[Legislative*  
36 *Assembly]* **committee** shall identify the reasons for not using the report to meet the reporting re-  
37 quirements and shall outline an alternative methodology for making the findings required by section  
38 8, Article VIII of the Oregon Constitution.

39 (b) The alternative methodology shall be based on:

40 (A) Research, data and public values; and

41 (B) The performance of successful schools, professional judgment or a combination of the per-  
42 formance of successful schools and professional judgment.

43 (c) The Legislative Assembly shall include in the report that uses the alternative methodology  
44 a determination of how the amount appropriated may affect the ability of the state's system of  
45 kindergarten through grade 12 public education to meet quality goals established by law, including

1 expected student performance against those goals.

2 [(7)] (6) The Legislative Assembly shall identify in the report whether the state's system of  
3 post-secondary public education has quality goals established by law. If there are quality goals, the  
4 Legislative Assembly shall include in the report a determination that the amount appropriated in  
5 the budget is sufficient to meet those goals or an identification of the reasons the amount appro-  
6 priated is not sufficient, the extent of the insufficiency and the impact of the insufficiency on the  
7 ability of the state's system of post-secondary public education to meet those quality goals.

8 [(8)] (7) The report shall be issued within 180 days after the Legislative Assembly adjourns sine  
9 die.

10 [(9)] (8) The Legislative Assembly shall provide public notice of the report's issuance, including  
11 posting the report on the Internet and providing a print version of the report upon request.

13 **FINANCIAL AID DISTRIBUTIONS**

14  
15 **SECTION 15.** ORS 348.205 is amended to read:

16 348.205. (1) The Oregon Opportunity Grant program is established within the Higher Education  
17 Coordinating Commission.

18 (2) Under the program, the cost of education of a qualified student shall be shared by the stu-  
19 dent, the family of the student, the federal government and the state.

20 (3) The [*Director of the Office of Student Access and Completion*] **commission** shall determine the  
21 cost of education of a qualified student based on the type of eligible post-secondary institution the  
22 student is attending. The cost of education equals:

23 (a) For a student attending a community college, the average cost of education of attending a  
24 community college in this state;

25 (b) For a student attending a public university listed in ORS 352.002, the average cost of edu-  
26 cation of attending a public university;

27 (c) For a student attending a two-year Oregon-based, generally accredited, not-for-profit institu-  
28 tion of higher education, the average cost of education of attending a community college in this  
29 state; and

30 (d) For a student attending the Oregon Health and Science University or a four-year Oregon-  
31 based, generally accredited, not-for-profit institution of higher education, the average cost of edu-  
32 cation of attending a public university listed in ORS 352.002.

33 (4)(a) The [*director*] **commission** shall determine the amount of the student share. The student  
34 share shall be based on:

35 (A) The type of eligible post-secondary institution the student is attending;

36 (B) The number of hours of work that the [*director*] **commission** determines may be reasonably  
37 expected from the student; and

38 (C) The amount of loans that the [*director*] **commission** determines would constitute a manage-  
39 able debt burden for the student.

40 (b) The student shall determine how to cover the student share through income from work,  
41 loans, savings and scholarships.

42 (c) The student share for a student who attends a community college may not exceed the amount  
43 that the [*director*] **commission** determines a student may earn based on the number of hours of work  
44 reasonably expected from the student under paragraph (a) of this subsection.

45 (d) The student share for a student who attends an eligible post-secondary institution that is not

1 a community college may not exceed the sum of the amount that the [*director*] **commission** deter-  
2 mines a student may receive as loans plus the amount a student may earn based on the number of  
3 hours of work reasonably expected from the student under paragraph (a) of this subsection.

4 (5) The [*director*] **commission** shall determine the amount of the family share. The family share  
5 shall be based on the resources of the family.

6 (6) The [*director*] **commission** shall determine the amount of the federal share based on how  
7 much the student or the student's family is expected to receive from the federal government.

8 (7)(a) The [*director*] **commission** shall determine the amount of the state share **by rule**. The  
9 state share shall be equal to the cost of education reduced by the student share, family share and  
10 amount received by the student from the federal government.

11 (b) The [*director*] **commission** shall establish a minimum amount that a student may receive as  
12 a state share. If the [*director*] **commission** determines that the amount of the state share of a stu-  
13 dent is below the minimum amount, the student may not receive the state share.

14 (c) The [*director*] **commission** may not reduce the amount of the state share of a student based  
15 on amounts available to the student by virtue of being the designated beneficiary of a college  
16 savings network account established under ORS 178.300 to 178.360.

17 (8) Subject to subsection (9) of this section, if the [*director*] **commission** determines that there  
18 are insufficient moneys to award the state share to all qualified students, the [*director*]  
19 **commission**:

20 (a) May establish the maximum amount that a student may receive as a state share. This amount  
21 may vary based on whether the student is attending an eligible post-secondary institution on a  
22 half-time or full-time basis.

23 (b) May establish procedures that prioritize awarding Oregon Opportunity Grants to qualified  
24 students with the greatest financial need or whose circumstances would enhance the promotion of  
25 equity guidelines published by the [*Higher Education Coordinating*] commission.

26 (c) May not reduce the amount of the state share awarded to students in the low income range  
27 in a greater proportion than the amount that the state share for students in other income ranges  
28 is reduced.

29 [*(9)(a) The Higher Education Coordinating commission shall adopt rules that prioritize current*  
30 *foster children and former foster children for receiving Oregon Opportunity Grants when the Oregon*  
31 *Opportunity Grant program does not have sufficient funding to serve all eligible Oregon students.]*

32 [*(b) For the purposes of this subsection, "former foster child" has the meaning given that term in*  
33 *ORS 350.300.]*

34 (9) **The commission shall adopt rules that implement the Oregon Opportunity Grant**  
35 **program. The rules adopted by the commission shall:**

36 (a) **Specify the manner by which the commission determines the state share.**

37 (b) **Prioritize current foster children and former foster children for receiving Oregon**  
38 **Opportunity Grants when the Oregon Opportunity Grant program does not have sufficient**  
39 **funding to serve all eligible Oregon students. As used in this paragraph, "former foster**  
40 **child" has the meaning given that term in ORS 350.300.**

41 **SECTION 15a.** The amendments to ORS 348.205 by section 15 of this 2024 Act first apply  
42 to state shares determined for the 2025-2026 academic year.

43 **SECTION 16.** ORS 348.250 is amended to read:

44 348.250. (1) Grants established under ORS 348.260 shall be awarded by the Higher Education  
45 Coordinating Commission in the manner provided in this section.



1 (2) Persons interested in obtaining a grant established under ORS 348.260 may apply to the  
2 *[Director of the Office of Student Access and Completion]* **commission** for a grant.

3 (3) The *[director]* **commission** shall screen or cause to be screened the applications and shall  
4 determine for each available grant the person best qualified to receive that grant. A qualified ap-  
5 plicant is eligible to receive a grant established under ORS 348.260 if:

6 (a) The applicant's financial need is such that in the opinion of the *[director]* **commission** fi-  
7 nancial aid is warranted; and

8 (b) The applicant plans to be a student at the eligible post-secondary institution where the grant  
9 is to be used.

10 (4) The *[director]* **commission** shall not discriminate for or against any applicant for a grant.

11 (5) Nothing in this section or ORS 348.260, 348.505 to 348.615, 348.696 or 348.992 shall be con-  
12 strued to require any institution to admit a grant recipient or to attempt to control or influence the  
13 policies of the institution.

14 (6) Whenever funds are not available to award grants to all qualified students, the *[director]*  
15 **commission** may give priority to applicants who are or plan to be full-time students at the eligible  
16 post-secondary institution where the grant is to be used. A student shall be considered to be a  
17 full-time student if the combination of credit hours at more than one eligible post-secondary insti-  
18 tution equals full-time attendance, according to the institution disbursing the grant funds.

19 (7) As used in this section, "discriminate" has the meaning given "discrimination" in ORS  
20 659.850.

21 **SECTION 17.** ORS 348.260 is amended to read:

22 348.260. (1) In addition to any other form of student financial aid authorized by law, the Higher  
23 Education Coordinating Commission may award Oregon Opportunity Grants to qualified students.

24 (2) The amount of a grant shall equal the state share of a qualified student's cost of education  
25 as determined by the *[Director of the Office of Student Access and Completion]* **commission** and  
26 comply with applicable rules and procedures described in ORS 348.205.

27 (3) Grant funds necessary to meet matching requirements for federal funds may also be used to  
28 award grants to qualified students in any eligible post-secondary institution approved by the com-  
29 mission.

30 (4) Grants may be awarded under this section to qualified students enrolled for any term, in-  
31 cluding summer term. The commission may prescribe the method and date or dates by which a stu-  
32 dent must apply to the commission to qualify for a grant.

33 (5)(a) A qualified student who receives a grant under this section may apply for renewal of the  
34 grant on an annual basis. The commission may not renew the grant if the qualified student has not  
35 made a timely application for renewal of the grant.

36 (b) The commission shall by rule establish academic standards and benchmarks that a qualified  
37 student must meet to have the student's grant renewed.

38 (c) If a qualified student who receives a grant under this section makes a timely application for  
39 renewal of the grant, meets the academic standards and benchmarks established by the commission  
40 under this subsection and continues to meet all other grant eligibility criteria, the grant shall be  
41 renewed for a second year of attendance at an eligible post-secondary institution.

42 (d) Upon timely application by a qualified student who meets the academic standards and  
43 benchmarks established by the commission under this subsection and who continues to meet all  
44 other grant eligibility criteria, the commission may continue to renew the grant until the qualified  
45 student has received the equivalent of four full-time undergraduate years of grant funding for an

1 eligible program as defined by the commission.

2 (6)(a) The [*Director of the Office of Student Access and Completion*] **commission** shall inform el-  
3 igible post-secondary institutions of the identity of qualified students who attend the institution and  
4 who receive a grant under this section for more than one academic year.

5 (b) To the extent possible, eligible post-secondary institutions shall ensure that qualified stu-  
6 dents identified under this subsection are made aware of the academic guidance and counseling  
7 services available at the institution.

8 (7) A qualified student who receives a grant under this section must attend the eligible post-  
9 secondary institution upon which the grant application is based unless the [*Director of the Office of*

28 [(a)] **(A)** Youths placed in a youth care center, as defined in ORS 420.855, that is within a de-  
29 tention facility, as defined in ORS 419A.004; and

30 [(b)] **(B)** Youths lodged overnight who receive educational services on consecutive days within  
31 a detention facility, as defined in ORS 419A.004.

32 [(2)] **(b)** “Youth Corrections Education Program” means the provision of educational services to  
33 youths in youth correction facilities, as defined in ORS 420.005.

34 **(2) The Department of Education shall administer the Youth Corrections Education  
35 Program and the Juvenile Detention Education Program in a manner that provides youths  
36 in those programs with a quality education.**

37 **(3)(a) The Superintendent of Public Instruction may contract with an education service  
38 district or a school district to provide teachers, counselors or other personnel for the Youth  
39 Corrections Education Program and the Juvenile Detention Education Program.**

40 **(b) When a contract is entered into with an education service district, the Youth Cor-  
41 rections Education Program and the Juvenile Detention Education Program are not consid-  
42 ered a component district of the education service district and the youths enrolled in the  
43 programs may not be counted when determining the number of pupils in average daily  
44 membership for purposes of ORS 334.175 (5).**

45 **(4) When determining the amount to be paid under a contract entered into as provided**

34 opment of the repository; and

43 **SECTION 29.** ORS 339.869 is amended to read:

44 339.869. (1) The State Board of Education, in consultation with the Oregon Health Authority, the  
45 Oregon State Board of Nursing and the State Board of Pharmacy, shall adopt:



1 (a) Rules for the administration of prescription and nonprescription medication to students by  
2 trained school personnel and for student self-medication. The rules shall include age appropriate  
3 guidelines and training requirements for school personnel.

4 (b) Rules for the administration of premeasured doses of epinephrine by school personnel trained  
5 as provided by ORS 433.815 to any student or other individual on school premises who the personnel  
6 believe in good faith is experiencing a severe allergic reaction, regardless of whether the student  
7 or individual has a prescription for epinephrine.

8 (c)(A) Rules for the administration of medication that treats adrenal insufficiency by school  
9 personnel trained as provided by ORS 433.815 to any student on school premises whose parent or  
10 guardian has provided for the personnel the medication as described in ORS 433.825 (3) and who the  
11 personnel believe in good faith is experiencing an adrenal crisis, as defined in ORS 433.800.

12 (B) Rules adopted under this paragraph must:

13 (i) Include guidelines on the designation and training of school personnel who will be responsible  
14 for administering medication; and

15 (ii) Specify that a school district is only required to train school personnel when the school  
16 district has been notified by a parent or guardian that a student enrolled in a school of the school  
17 district has been diagnosed with adrenal insufficiency.

18 (d) Guidelines for the management of students with life-threatening food allergies and adrenal  
19 insufficiency, which must include:

20 (A) Standards for the education and training of school personnel to manage students with life-  
21 threatening allergies or adrenal insufficiency.

22 (B) Procedures for responding to life-threatening allergic reactions or an adrenal crisis, as de-  
23 fined in ORS 433.800.

24 (C) A process for the development of individualized health care and allergy or adrenal insuffi-  
25 ciency plans for every student with a known life-threatening allergy or adrenal insufficiency.

26 (D) Protocols for preventing exposures to allergens.

27 (e) Rules for the administration of a short-acting opioid antagonist to any student or other in-  
28 dividual on school premises who the individual administering the short-acting opioid antagonist be-  
29 lieves in good faith is experiencing an opioid overdose.

30 (2)(a) School district boards shall adopt policies and procedures that provide for:

31 (A) The administration of prescription and nonprescription medication to students by trained  
32 school personnel, including the administration of medications that treat adrenal insufficiency;

33 (B) Student self-medication; and

34 (C) The administration of premeasured doses of epinephrine to students and other individuals.

35 (b) Policies and procedures adopted under paragraph (a) of this subsection shall be consistent  
36 with the rules adopted by the State Board of Education under subsection (1) of this section. A school  
37 district board shall not require school personnel who have not received appropriate training to ad-  
38 minister medication.

39 (3)(a) School district boards may adopt policies and procedures that provide for the adminis-  
40 tration of a short-acting opioid antagonist.

41 (b) Policies and procedures adopted under paragraph (a) of this subsection shall be consistent  
42 with the rules adopted by the State Board of Education under subsection (1) of this section.

43 (4)(a) A school district [*board*] shall provide to the parent or legal guardian of each minor stu-  
44 dent enrolled in a school in the school district information regarding short-acting opioid antagonists.  
45 The information described in this subsection must include at least:

1 (A) A description of short-acting opioid antagonists and their purpose;

2 (B) A statement regarding, in an emergency situation, the risks of administering to an individual  
3 a short-acting opioid antagonist and the risks of not administering to an individual a short-acting  
4 opioid antagonist;

5 [(C) A statement that all schools within the school district have access to short-acting opioid an-  
6 tagonists and the necessary medical supplies to administer the short-acting opioid antagonist on site;  
7 and]

8 (C) **A statement identifying which schools, if any, in the school district will have short-  
9 acting opioid antagonists, and the necessary medical supplies to administer short-acting  
10 opioid antagonists, on site and available for emergency situations; and**

11 (D) A statement that a representative of a school may administer to a student a short-acting  
12 opioid antagonist in an emergency if the student appears to be unconscious and experiencing an  
13 opioid overdose.

14 (b) A school district board shall ensure that the parent or legal guardian of a minor student  
15 enrolled in a school within the school district is immediately notified when a short-acting opioid  
16 antagonist is administered to the student if the short-acting opioid antagonist is administered while  
17 the student is at school, on school property under the jurisdiction of the school district or at any  
18 activity under the jurisdiction of the school district.

19 (c) **The State Board of Education shall adopt rules that prescribe minimum requirements  
20 for the information provided under paragraph (a) of this subsection.**

37 (1) **As used in this section and ORS 342.943, “educator” means a person who is:**

38 (a) **A teacher, an administrator or another school employee who is employed to provide  
39 instruction or support to students in early childhood education or in kindergarten through  
40 grade 12; or**

41 (b) **Entering into or enrolled in an educator preparation program.**

42 (2)(a) The Educator Advancement Council shall be established and function under an intergov-  
43 ernmental agreement, pursuant to ORS 190.003 to 190.130, between state agencies and one or more  
44 school districts and education service districts. **The state agencies that must be parties to the  
45 intergovernmental agreement are the Department of Education, the Department of Early**

1 **Learning and Care, the Teacher Standards and Practices Commission and the Higher Edu-**  
2 **cation Coordinating Commission.**

3 (b) The purposes of the council are to provide resources related to educator professional  
4 learning and to provide other educator supports.

5 (3) The intergovernmental agreement establishing the council shall outline the governance  
6 framework and the administrative details necessary for the efficient and effective implementation  
7 of the duties of the council.

8 (4)(a) The council shall consist of:

9 (A) Members who are representatives of the parties to the intergovernmental agreement estab-  
10 lishing the council.

11 (B) No more than 10 members who are practicing educators, classified staff in a public school  
12 or for an education service district, early learning providers and professionals and school district  
13 board members.

14 (C) No more than 10 members who are representatives of educator preparation providers,  
15 education-focused nonprofit organizations, education-focused philanthropic organizations, profes-  
16 sional education associations, community-based education organizations that represent families and  
17 students, post-secondary institutions of education and federally recognized Indian tribes of this state.

18 (b) Subject to any limits designated as provided by the intergovernmental agreement establishing  
19 the council, the majority of the members of the council identified under paragraph (a) of this sub-  
20 section may propose additional members of the council. The inclusion of additional members on the  
21 council shall be subject to the procedures established by the council under the intergovernmental  
22 agreement.

23 (5) The council shall:

24 (a) Establish a system of educator networks, as described in ORS 342.943, by which every edu-  
25 cator in this state has access to professional learning opportunities;

26 (b) Administer the beginning teacher and administrator mentorship program under ORS 329.788  
27 to 329.820;

28 (c) Coordinate the distribution of moneys to educator networks from the Educator Advancement  
29 Fund based on the needs of the educators identified by the networks;

30 (d) Connect educator networks and facilitate communications within and among the networks  
31 to improve teaching and learning; and

32 (e) Continuously assess the needs of educators in this state and coordinate priorities based on  
33 the moneys available for distribution from the Educator Advancement Fund.

34 (6) The Department of Education shall provide support to the strategic direction of the council  
35 by:

36 (a) Conducting and coordinating research to monitor:

37 (A) Teaching and learning conditions;

38 (B) Educator workforce supply and demand; and

39 (C) Common outcomes and measures anticipated to promote improvement in teaching and  
40 learning.

41 (b) Assisting the council in coordinating and connecting educator networks, supporting profes-  
42 sional learning priorities, enabling access to professional learning and supports, leveraging funding  
43 sources and managing innovation funds.

44 (c) Recommending statutory and agency rule changes needed to support the purposes of the  
45 council.

- 1 (d) Supporting programs that help to achieve the purposes of the Educators Equity Act.
- 2 (e) Supporting a statewide plan for increasing:
  - 3 (A) The supply of culturally diverse teacher candidates; and
  - 4 (B) The successful recruitment of effective educators to work in high-need schools and in prac-  
5 tice areas with a shortage of educators.
- 6 (f) Identifying high-leverage educator practices to be developed by educators throughout their  
7 careers.
- 8 (g) Providing accountability of the council by ensuring that the council:
  - 9 (A) Gives preference, when making recommendations about funding distributions, to entities that  
10 have demonstrated success in improving student indicators.
  - 11 (B) Considers the delivery of services for the benefit of all regions of this state when establish-  
12 ing the system of educator networks.
  - 13 (C) Works toward improving student progress indicators identified by the Department of Edu-  
14 cation or set forth in ORS 350.014.
  - 15 (D) Includes and connects education providers and leaders from prekindergarten through post-  
16 secondary education.
- 17 (h) Providing staff support for the administrative functions of the council.
- 18 (i) Developing a system that allows for the statewide dissemination of emerging practices and  
19 evidence-based models.
- 20 (j) Providing technical assistance to the council, including online systems for sharing profes-  
21 sional learning resources and supporting educator networks.
- 22 (k) Administering the distribution of grant and contract funds for programs described in this  
23 section.
- 24 (L) Providing administrative support to the educator networks, including:
  - 25 (A) Making recommendations to the council about the selection of the sponsors of educator  
26 networks;
  - 27 (B) Providing technical assistance to educator networks; and
  - 28 (C) Entering into grant agreements or contracts for the distribution of funds to educator net-  
29 works.
- 30 (7)(a) The State Board of Education and the Teacher Standards and Practices Commission may  
31 adopt any rules necessary at the request of the council to support the council or to perform any  
32 duties assigned to the board or commission under this section.
- 33 (b) The council may adopt rules pursuant to ORS chapter 183 for the purposes of ORS 329.788  
34 to 329.820 and 342.943.
- 35 (8) The council shall be considered a board for purposes of ORS chapter 180.

36 **SECTION 32. Notwithstanding ORS 329.805 (2), grants awarded under ORS 329.805 during**  
37 **the 2023-2025 biennium are not required to be awarded on a competitive basis.**

**COREQUISITE STUDENT SUPPORT**

41 **SECTION 33. (1) As used in this section, “corequisite” means a course or requirement**  
42 **related to mathematics or writing that a student must take or satisfy at the same time that**  
43 **the student is taking or satisfying another course or requirement in mathematics or writing**  
44 **that is required for a program of study or a degree.**

45 **(2) The Higher Education Coordinating Commission shall convene a work group to study**

1 evidence-based corequisite student support models, including models that use in-class tutor-  
2 ing, online learning labs, paired courses and other aligned academic supports. The work  
3 group shall provide information to the commission to assist the commission in:

4 (a) Determining whether to require the community colleges in this state to implement  
5 evidence-based corequisite student support models and identifying the most effective models  
6 to implement;

7 (b) Identifying the steps and resources required for community colleges in this state to  
8 transition from traditional prerequisite development education to evidence-based corequisite  
9 student support models;

10 (c) Identifying the steps and resources required for community colleges in this state to  
11 implement corequisite student support models in conjunction with courses of study in  
12 mathematics;

13 (d) Determining whether evidence-based corequisite student support models should be  
14 funded by Community College Support Fund grants;

15 (e) Identifying any statutory changes or administrative rule changes necessary to provide  
16 and fund evidence-based corequisite student support models; and

17 (f) Identifying how to determine if a person should participate in a corequisite, and  
18 whether participation should be voluntary or mandatory.

19 (3)(a) The work group convened under this section shall be appointed by the executive  
20 director of the Higher Education Coordinating Commission and shall include:

21 (A) The Director of the Office of Community Colleges and Workforce Development, or  
22 the director's designee;

23 (B) One representative of a research center focused on the policies and practices of  
24 community colleges in this state;

25 (C) Three community college faculty members who have experience in teaching  
26 corequisite or developmental education;

27 (D) Three community college faculty members who have experience in teaching the first  
28 credit-bearing college-level course in mathematics or writing;

29 (E) One representative of a statewide organization representing community college fac-  
30 ulty members;

31 (F) One community college president;

32 (G) One chief academic officer or chief instructional administrator for a community col-  
33 lege;

34 (H) One developmental education or adult basic education administrator for a community  
35 college;

36 (I) One student services administrator or professional for a community college; and

37 (J) One community college student.

38 (b) The commission shall solicit nominations from organizations representing faculty,  
39 students and community colleges to determine the membership of the work group.

40 (4) No later than December 15, 2024, the work group shall submit to the Higher Education  
41 Coordinating Commission a report on the study conducted as provided by this section.

42 SECTION 34. Section 33 of this 2024 Act is repealed on January 2, 2025.

44 **APPLIED BACCALAUREATE PROGRAMS**

1       **SECTION 35.** ORS 341.013 is amended to read:

11       the Higher Education Coordinating Commission:

13       (b) The method by which the program will be created, including any necessary accreditation by  
14       the relevant accrediting agency;

15       (c) Documentation of local unmet workforce needs that would be addressed by offering the pro-  
16       gram; and

17       (d) Documentation that the community college has the expertise, resources and student interest  
18       necessary to make the program successful.

19       (4) A proposed applied baccalaureate degree program or Bachelor of Science: Nursing degree  
20       program must be approved by the commission. The commission shall approve a proposed applied  
21       baccalaureate degree program or Bachelor of Science: Nursing degree program if:

22       (a) The community college submits all of the information and documentation required under  
23       subsection (3) of this section; and

24       (b) The commission determines that the criteria set forth in ORS 350.075 (3)(g) are satisfied.

25       **(5) An applied baccalaureate degree program or Bachelor of Science: Nursing degree**  
26       **program that is approved by the commission is eligible for funding from the Community**  
27       **College Support Fund established in ORS 341.620.**

28       [(5)] (6) The commission may adopt rules to implement this section.

29       **SECTION 36. (1) The amendments to ORS 341.013 by section 35 of this 2024 Act become**  
30       **operative January 1, 2025.**

31       **(2) The amendments to ORS 341.013 by section 35 of this 2024 Act first apply to expenses**  
32       **incurred for the 2025-2026 academic year.**

33       **SECTION 37. As part of the Higher Education Coordinating Commission’s budget pres-**  
34       **entation during the 2025 regular session of the Legislative Assembly, the commission shall**  
35       **include in a report prepared in the manner required under ORS 192.245 the following infor-**  
36       **mation:**

37       **(1) The estimated impact of funding the applied baccalaureate degree program and the**  
38       **Bachelor of Science: Nursing degree program from the Community College Support Fund**

40       **(2) The extent the commission can determine the approximate cost of funding the applied**  
41       **baccalaureate degree program and the Bachelor of Science: Nursing degree program from**  
42       **the Community College Support Fund for the 2025-2026 academic year.**

43       **(3) Any recommendations for funding the applied baccalaureate degree program or the**  
44       **Bachelor of Science: Nursing degree program in a manner other than from the Community**  
45       **College Support Fund.**

**SECTION 38.** Section 37 of this 2024 Act is repealed on June 30, 2025.

**FACULTY HEALTH CARE BENEFITS**

**SECTION 39.** ORS 350.355 is amended to read:

350.355. (1)(a) Except as provided in paragraph (b) of this subsection, a part-time faculty member at a public institution of higher education is eligible for the same employee-only health care benefits, including dental benefits and vision benefits, as full-time faculty members if the part-time faculty member is eligible for membership in the Public Employees Retirement System or another plan authorized under ORS chapter 238 or 238A by *[teaching]* **working** either at a single public institution of higher education or in aggregate at multiple public institutions of higher education during the previous academic year.

(b) The total cost of providing any health benefit plan offered by a public institution of higher education to a part-time faculty member under this section may not increase annually by more than the annual increase in premium amounts paid for contracted health benefit plans that is permitted under ORS 243.135 (8)(b) or 243.866 (9)(b).

(2)(a) In order to receive employee-only health care benefits under this section, a part-time faculty member must select a home public institution of higher education for the duration of the benefit year under a process established by each institution. A home public institution of higher education selected under this subsection:

*[(A) Must be one at which the part-time faculty member is working during the academic term at the time of the application; and]*

**(A) Must be one from which the part-time faculty member received a salary, a grant or other payment for work performed by the part-time faculty member that is substantially similar to work performed by a full-time faculty member, including teaching, research or student mentorship and advising;**

**(B) Must be one from which the part-time faculty member received payment, as described in subparagraph (A) of this paragraph, at:**

**(i) The time of the application; or**

**(ii) Any time during the previous benefit year, if the part-time faculty member is not currently receiving payment from any public institution of higher education but otherwise is eligible for employee-only health care benefits; and**

*[(B)] (C) Is responsible for:*

(i) Determining whether the part-time faculty member is eligible to receive health care benefits under this section;

(ii) Determining, on an annual basis, whether a part-time faculty member who was found to be eligible to receive health care benefits under sub-subparagraph (i) of this subparagraph continues to be eligible to receive health care benefits under this section;

(iii) Collecting the premiums for health benefit plans that must be paid by the part-time faculty member under subsection (3) of this section;

(iv) Paying the full cost of the insurance premiums for providing health benefit plans to the part-time faculty member, subject to reimbursement as described in subsection (4) of this section; and

(v) Administering and providing health benefit plans to the part-time faculty member in the manner described in this section.

1 (b) In order to receive health care benefits under this section, a part-time faculty member must  
2 provide the home public institution of higher education with all information necessary for the in-  
3 stitution to determine the eligibility of the part-time faculty member to receive health care benefits  
4 under this section.

5 (c) No later than 30 days before the deadline to submit an application to receive health care  
6 benefits under this section, each public institution of higher education must notify all part-time  
7 faculty members who have been employed by the institution during the current academic year and  
8 the previous academic year of:

9 (A) The eligibility requirements to receive health benefits under this section;

10 (B) The health care benefits and associated costs available to qualifying part-time faculty mem-  
11 bers; and

12 (C) Instructions on how part-time faculty members may apply to receive health care benefits  
13 under this section.

14 (3)(a) Except as provided in paragraph (b) of this subsection, a part-time faculty member at a  
15 public institution of higher education shall pay 10 percent of all insurance premiums for health  
16 benefit plans.

17 (b) A public institution of higher education may provide by collective bargaining at the institu-  
18 tion to pay for some or all of the insurance premiums that must otherwise be paid by a part-time  
19 faculty member under paragraph (a) of this subsection. The public institution of higher education  
20 may not be reimbursed under subsection (4) of this section for the costs the institution incurs to  
21 provide health benefit plans under this paragraph.

22 (4)(a) Every three months a public institution of higher education may request reimbursement  
23 from the Higher Education Coordinating Commission for the cost of paying insurance premiums for  
24 providing health benefit plans to each part-time faculty member who has selected the institution as  
25 the faculty member’s home public institution of higher education under subsection (2) of this section.

26 (b) The commission shall use moneys from the Part-Time Faculty Insurance Fund established  
27 under ORS 350.357 to fully reimburse each public institution of higher education for all documented  
28 costs requested by the institution under this subsection, except for any costs described in subsection  
29 (3) of this section.

30 (5) Unless otherwise provided for by collective bargaining, a part-time faculty member at a  
31 public institution of higher education who is eligible for health care benefits under subsection (1)  
32 of this section may receive health care benefits only in the manner provided by this section.

33 (6) Each agency request budget filed by the Higher Education Coordinating Commission under  
34 ORS 291.208 must include, as part of the budget, moneys sufficient to provide health care benefits  
35 to part-time faculty members in the manner required by this section.

36 (7) The Higher Education Coordinating Commission may adopt rules necessary to implement  
37 subsection (4) of this section.

38  
39 **FORESTRY WORKFORCE STUDY**

40  
41 **SECTION 40. (1) As used in this section:**

42 (a) **“Forestry sector” means private businesses, nonprofit organizations, educational and**  
43 **workforce providers and public entities that are engaged in logging, forestation, wildland fire**  
44 **prevention and suppression, construction and maintenance of roads required for forestry,**  
45 **aggregate production of forestry products, trucking related to forestry, tree services, tech-**



1 nical and professional services required for forestry, forest surveying, fuel mitigation efforts  
2 related to forestry, forestry habitat restoration, watershed improvement, crop tree release  
3 and stand improvement, forest tract management, tree nurseries, mechanical services for  
4 forestry, provision of forestry products, training resources for the forestry workforce, edu-  
5 cational resources for the forestry workforce, human resources for the forestry workforce  
6 and other in-forest or forest-affiliated services.

7 (b) "Forestry workforce" means the owners, proprietors, partners and employees of  
8 companies and organizations composing the forestry sector.

9 (2) The Higher Education Coordinating Commission shall conduct a forestry workforce  
10 study to assist the commission in understanding and addressing challenges in Oregon's  
11 forestry workforce.

12 (3) The study conducted under this section shall:

13 (a) Identify existing secondary and post-secondary education, training, apprenticeship and  
14 workforce development programs that prepare Oregonians for careers in the forestry  
15 workforce;

16 (b) Collect data on participation in, completion of and employment outcomes for pro-  
17 grams identified in paragraph (a) of this subsection;

18 (c) Identify the number, type and location of businesses, nonprofit organizations, educa-  
19 tion and workforce providers and public entities composing the forestry sector in this state;

20 (d) Collect data on the number, occupations, industries, wages and demographics of the  
21 forestry workforce in this state;

22 (e) Assess current and projected forestry workforce needs;

23 (f) Identify challenges faced by the forestry sector in retaining and recruiting the  
24 forestry workforce; and

25 (g) Develop recommendations to enhance the recruitment and retention of the forestry  
26 workforce.

27 (4) When conducting the study under this section, the commission shall:

28 (a) Assess the current forestry workforce, the workforce's demographics and needs and  
29 the community benefits of forestry. The assessment required under this paragraph shall take  
30 into consideration state plans and initiatives related to forest health, climate and economic  
31 development that may influence the demands on the forestry workforce.

32 (b) Collaborate with Oregon business associations that represent private forest employers  
33 and forest management enterprises to assess the future forestry workforce capacity re-  
34 quirements, as well as the potential impacts, benefits and opportunities for the forestry  
35 workforce.

36 (c) Consult with state and federal economic development, labor, employment and licens-  
37 ing agencies to account for current tracking and monitoring techniques for the forestry  
38 workforce and to ensure that the study is not duplicative of other studies.

39 (d) Consult with state and federal natural resource agencies to align priorities and un-  
40 derstand future forestry workforce needs.

41 (e) Consult with state training and education agencies to fully understand career path-  
42 ways and training opportunities for the forestry workforce.

43 (5) The commission may enter into a contract with a public or private entity for the  
44 purpose of conducting the study described in this section.

45 (6) The commission shall submit a report in the manner provided by ORS 192.245 to the

1 interim committees of the Legislative Assembly related to natural resources, education and  
2 higher education no later than June 30, 2025.

3 **SECTION 41.** Section 40 of this 2024 Act is repealed on January 2, 2026.

4 **SECTION 42.** In addition to and not in lieu of any other appropriation, there is appro-  
5 priated to the Higher Education Coordinating Commission, for the biennium ending June 30,  
6 2025, out of the General Fund, the amount of \$300,000, for the purpose of the study described

30 (k) Meetings of the Oregon Health and Science University Board of Directors or its designated  
31 committee regarding candidates for the position of president of the university or regarding sensitive  
32 business, financial or commercial matters of the university not customarily provided to competitors  
33 related to financings, mergers, acquisitions or joint ventures or related to the sale or other dispo-  
34 sition of, or substantial change in use of, significant real or personal property, or related to health  
35 system strategies.

36 (L) Oregon Health and Science University faculty or staff committee meetings.

37 **(m) Meetings of Transfer Council subcommittees that are established under ORS 350.426**  
38 **and that relate to the common course numbering system and the coordination, establish-**  
39 **ment, alignment, effectiveness and maintenance of foundational curricula.**

40 [(m)] (n) Communications between or among members of a governing body that are:

41 (A) Purely factual or educational in nature and that convey no deliberation or decision on any  
42 matter that might reasonably come before the governing body;

43 (B) Not related to any matter that, at any time, could reasonably be foreseen to come before the  
44 governing body for deliberation and decision; or

45 (C) Nonsubstantive in nature, such as communication relating to scheduling, leaves of absence

1 and other similar matters.

2 (2) Because of the grave risk to public health and safety that would be posed by misappropriation or misapplication of information considered during such review and approval, ORS 192.610 to  
3 192.705 shall not apply to review and approval of security programs by the Energy Facility Siting  
4 Council pursuant to ORS 469.530.

7 **EDUCATION FOR OCCUPATIONAL OR PROFESSIONAL LICENSE**  
8

9 **SECTION 44.** ORS 670.280 is amended to read:

10 670.280. (1) As used in this section:

11 (a) "License" includes a registration, certification or permit.

12 (b) "Licensee" includes a registrant or a holder of a certification or permit.

13 (2) Except as provided in ORS 342.143 (3) or 342.175 (3), a licensing board, commission or agency  
14 may not deny, suspend or revoke an occupational or professional license solely for the reason that  
15 the applicant or licensee has been convicted of a crime, but it may consider the relationship of the  
16 facts which support the conviction and all intervening circumstances to the specific occupational  
17 or professional standards in determining the fitness of the person to receive or hold the license.  
18 There is a rebuttable presumption as to each individual applicant or licensee that an existing or  
19 prior conviction for conduct that has been classified or reclassified as a Class E violation does not  
20 make an applicant for an occupational or professional license or a licensee with an occupational or  
21 professional license unfit to receive or hold the license.

22 (3) Except as provided in ORS 342.143 (3) and 342.175 (3), a licensing board, commission or  
23 agency may deny an occupational or professional license or impose discipline on a licensee based  
24 on conduct that is not undertaken directly in the course of the licensed activity, but that is sub-  
25 stantially related to the fitness and ability of the applicant or licensee to engage in the activity for  
26 which the license is required. In determining whether the conduct is substantially related to the  
27 fitness and ability of the applicant or licensee to engage in the activity for which the license is re-  
28 quired, the licensing board, commission or agency shall consider the relationship of the facts with  
29 respect to the conduct and all intervening circumstances to the specific occupational or professional  
30 standards. There is a rebuttable presumption as to each individual applicant or licensee that an  
31 existing or prior conviction for conduct that has been classified or reclassified as a Class E violation  
32 is not related to the fitness and ability of the applicant or licensee to engage in the activity for  
33 which the license is required.

34 **(4)(a) Prior to beginning an education, a training or an apprenticeship program for an**  
35 **occupational or professional license, a person who was convicted of a crime may petition a**  
36 **licensing board, commission or agency for a determination as to whether a criminal con-**  
37 **viction will prevent the person from receiving an occupational or professional license. The**  
38 **licensing board, commission or agency may charge a reasonable fee to pay the costs of**  
39 **making the determination.**

40 **(b) A determination from a licensing board, commission or agency that a criminal con-**  
41 **viction will not prevent the person from obtaining an occupational or professional license**  
42 **may be rescinded if, at the time the person submits a complete application, the person:**

43 **(A) Has allegations or charges pending in criminal court;**

44 **(B) Has failed to disclose a previous criminal conviction;**

45 **(C) Has been convicted of another crime during the period between the determination and**

1 the person's submission of a completed application for an occupational or professional li-  
2 cense; or

3 (D) Has been convicted of a crime that, during the period between the determination and  
4 the person's submission of a completed application for an occupational or professional li-  
5 cense, became subject to a change in state or federal law that prohibits licensure for an oc-  
6 cupational or professional license because of a conviction of that crime.

7 (c) A licensing board, commission or agency shall reconsider a determination that a  
8 criminal conviction will prevent the person from obtaining an occupational or professional  
9 license if the person submits a completed application for an occupational or professional li-  
10 cense.

11 (d) A determination made under this subsection:

12 (A) Shall be made by the same entity that reviews completed applications for an occu-  
13 pational or professional license for the licensing board, commission or agency;

14 (B) Shall be subject to the same confidentiality requirements that are applicable to  
15 completed applications for an occupational or professional license for the licensing board,  
16 commission or agency; and

17 (C) Is not considered a final determination of the licensing board, commission or agency.

18 (e) Nothing in this subsection prohibits a licensing board, commission or agency from  
19 denying licensure for a reason other than conviction of a crime.

20 (f) A licensing board, commission or agency may adopt rules necessary to implement the  
21 provisions of this subsection.

22 (g) This subsection does not apply to the Department of Public Safety Standards and  
23 Training or to any regulation of psilocybin services.

24 **SECTION 44a.** (1) The amendments to ORS 670.280 by section 44 of this 2024 Act become  
25 operative on July 1, 2025.

26 (2) Notwithstanding the operative date set forth in subsection (1) of this section, a li-  
27 censing board, commission or agency may choose to make determinations as described in  
28 ORS 670.280 (4) before the operative date set forth in subsection (1) of this section.

## 30 RECOVERY SCHOOLS

31  
32 **SECTION 45.** ORS 336.680 is amended to read:

33 336.680. (1) As used in this section, "approved recovery school" means a school that is under  
34 an agreement with the Department of Education to provide students enrolled in the school with a  
35 holistic approach to:

36 (a) Educational services for grades 9 through 12; and

37 (b) Health care services related to recovery from substance use disorders.

38 (2) The department shall provide or cause to be provided appropriate education for students  
39 enrolled in an approved recovery school. For the purpose of paying the costs of providing education  
40 to students enrolled in an approved recovery school, the Superintendent of Public Instruction shall  
41 make the following:

42 (a) Payments from amounts available from the State School Fund under ORS 327.029.

43 (b) Payments from the Statewide Education Initiatives Account, as provided by rule adopted by  
44 the State Board of Education in collaboration with the advisory committee convened under ORS  
45 336.685. The rules adopted as provided by this paragraph may include a minimum amount, a maxi-

1 mum amount or both for approved recovery schools.

2 (3) The Superintendent of Public Instruction may contract with a school district, an education  
3 service district or a public charter school to provide or cause to be provided appropriate education  
4 to students enrolled in an approved recovery school. Unless otherwise specified, any educational  
5 services provided under a contract entered into under this subsection shall be paid as described in  
6 this section and not by any other state moneys distributed based on average daily membership that  
7 are available to the school district, education service district or public charter school for the pur-  
8 pose of providing educational services.

9 (4) The State Board of Education shall adopt by rule the standards for a recovery school to  
10 become and operate as an approved recovery school. The standards must provide that:

11 (a) The recovery school must align, to the extent identified by the board, with standards for  
12 accreditation established by a nonprofit accrediting organization composed of representatives of re-  
13 recovery schools and individuals who support the growth of recovery schools. The standards must in-  
14 clude requirements that:

15 (A) The recovery school, in compliance with timelines established by the department, be ac-  
16 credited by a nonprofit accrediting organization that establishes standards for recovery schools.  
17 Nothing in this subparagraph requires the recovery school to be accredited at the time the super-  
18 intendent first enters into a contract with the recovery school.

19 (B) Student enrollment in the recovery school is voluntary. No school district or state or local  
20 agency may compel or otherwise require a student to enroll in a recovery school. Students enrolled  
21 in an approved recovery school may not be counted in determining the number of pupils in average  
22 daily membership for purposes of ORS 334.175 (5).

23 (C) All students who reside in this state and who meet the eligibility criteria established under  
24 subsection (8) of this section may enroll in an approved recovery school if space is available. If  
25 space is not available, the approved recovery school may prioritize for enrollment student groups  
26 identified in ORS 327.180 (2)(b).

27 (D) The school district, education service district or public charter school with which the de-  
28 partment has entered into a contract for a recovery school must agree to award high school diplo-  
29 mas, modified diplomas, extended diplomas and alternative certificates as provided by ORS 329.451  
30 and 339.877. An entity that awards high school diplomas as provided by this subparagraph:

31 (i) May not impose requirements for a high school diploma that are in addition to the require-  
32 ments prescribed by ORS 329.451 (2)(a) or by rule of the State Board of Education; and

33 (ii) Must accept any credits previously earned by students in another school or educational  
34 program in this state and apply those credits toward the requirements prescribed by ORS 329.451  
35 (2)(a) or by rule of the State Board of Education.

36 (E) Except as provided by [*subparagraph (F)*] **subparagraphs (F) and (G)** of this paragraph, the  
37 recovery school must satisfy the same laws that apply to public charter schools under ORS 338.115.

38 (F) All administrators and teachers at the recovery school must be licensed by the Teacher  
39 Standards and Practices Commission.

40 **(G) An approved recovery school is not required to comply with the enrollment require-**  
41 **ments prescribed by ORS 338.115 (1)(bb) or (5).**

42 **(H) An approved recovery school must comply with the requirements of the uniform**  
43 **budget and accounting system adopted by rule of the State Board of Education under ORS**  
44 **327.511.**

45 (b) Recovery schools will be approved, to the greatest extent practicable, in a manner that:

1 (A) Represents a geographic distribution across this state; and

2 (B) Takes into consideration the needs for services by the community in which the recovery  
3 school would be located.

4 (5) Any school that provides the services of a recovery school may enter into a contract with  
5 the superintendent to become an approved recovery school, including schools already providing the  
6 services of a recovery school and schools that are proposing to provide the services of a recovery  
7 school.

8 (6) An approved recovery school may enter into agreements with other entities, including  
9 community-based organizations and federally recognized tribes of this state, for the purposes of  
10 providing educational and health care services to students enrolled in the approved recovery school.

11 (7)(a) The department shall be responsible for:

12 (A) Identifying, locating and evaluating students enrolled in an approved recovery school who  
13 may be in need of special education and related services; and

14 (B) Ensuring that eligible students receive special education and related services.

15 (b) For the purpose of this subsection, the department may enter into a contract with a school  
16 district or an education service district.

17 (8) The department shall establish eligibility criteria for students to enroll in an approved re-  
18covery school, based on input from the advisory committee convened under ORS 336.685 and based  
19on research from a nonprofit organization composed of representatives of recovery schools and in-  
20dividuals who support the growth of recovery schools and other relevant organizations.

21 (9) For the purposes of administering this section:

22 (a) The State Board of Education shall adopt any necessary rules.

23 (b) The department shall collaborate with the Oregon Health Authority, the Youth Development  
24 Division, the Alcohol and Drug Policy Commission, the Oregon Youth Authority, the Department  
25 of Human Services and local public health and mental health authorities or providers and shall co-  
26ordinate, to the greatest extent practicable, funding of services provided in relation to approved  
27 recovery schools.

28 (10) Each biennium, the Department of Education shall prepare a report on the progress, suc-  
29cesses and challenges of approved recovery schools and submit that report to:

30 (a) The interim committees of the Legislative Assembly related to education; and

31 (b) The advisory committee convened under ORS 336.685.

33 **EMPLOYMENT OF CLASSIFIED SCHOOL EMPLOYEES**

34  
35 **SECTION 46.** ORS 332.544 is amended to read:

36 332.544. (1) As used in this section, "classified school employee" includes all employees of a  
37 school district **in a position represented by a collective bargaining unit**, except those for whom  
38 a teaching or administrative license is required as a basis for employment in a school district.

39 (2) A classified school employee shall have the right to be dismissed, demoted or disciplined only  
40 for just cause.

41 (3) School district employees subject to the civil service provisions of ORS 242.310 to 242.640  
42 are exempt from the provisions of this section.

43 **SECTION 47.** ORS 334.231 is amended to read:

44 334.231. (1) As used in this section, "classified school employee" includes all employees of an  
45 education service district **in a position represented by a collective bargaining unit**, except those

1 for whom a teaching or administrative license is required as a basis for employment in an education  
2 service district.

3 (2) A classified school employee shall have the right to be dismissed, demoted or disciplined only  
4 for just cause.

6 **SUBSTITUTE TEACHER PAY**  
7

8 **SECTION 48.** ORS 342.610 is amended to read:

9 342.610. (1)(a) A teacher employed as a substitute teacher may not be paid less per day than 85  
10 percent of 1/190th of the statewide average salary of a beginning teacher who holds a bachelor's  
11 degree.

12 (b) The Department of Education shall compute the statewide average salary of a beginning  
13 teacher who holds a bachelor's degree to be used for purposes of this subsection by:

14 (A) Using the latest data available to the department; and

15 (B) Not using data from earlier than the preceding school year.

16 (2) A school district shall set the working hours for a substitute teacher and, when a teacher  
17 is employed as a substitute teacher for the school district, the school district shall pay the substitute  
18 teacher a salary that is:

19 (a) No less than one-half of the daily minimum salary computed under subsection (1) of this  
20 section if the teacher is employed as a substitute teacher for **one-half day or** less than one-half day;  
21 or

22 (b) No less than the daily minimum salary computed under subsection (1) of this section if the  
23 teacher is employed as a substitute teacher for **more than** one-half day [*or more*].

24 (3)(a) Notwithstanding subsection (1) of this section, a teacher employed as a substitute teacher  
25 for more than 10 consecutive days in any one assignment for the same teacher shall not be paid  
26 after the 10th day of the assignment less per day than:

27 (A) For school districts with no salary scale, 100 percent of 1/190th of the statewide average  
28 salary computed in subsection (1) of this section; or

29 (B) For school districts with a salary scale, the higher of:

30 (i) 1/190th of the employing school district's salary for a beginning teacher who holds a  
31 bachelor's degree; or

32 (ii) The daily minimum salary computed under subsection (1) of this section.

33 (b) Used sick leave, whether paid or unpaid, and weekends, school holidays and days when  
34 schools are closed by weather or other conditions and when substitute teachers are not required to  
35 appear in person at the school may not be considered in determining consecutive days for purposes  
36 of this subsection.

37 (c) When substituting for a part-time teacher, the part of the day worked by the substitute  
38 teacher shall count as a full day in determining consecutive days for purposes of this subsection.

39 (4) Notwithstanding subsections (1) and (3) of this section, if a school district has a class  
40 schedule based on a four-day week:

41 (a) The daily minimum salary computed under subsection (1) or (3) of this section must be  
42 multiplied by 1.125; and

43 (b) Calculations described in subsection (3) of this section must be made after a teacher has been  
44 employed as a substitute teacher for more than eight consecutive days in any one assignment for  
45 the same teacher.

1 (5)(a) A school district shall classify a substitute teaching assignment as a temporary position  
2 when the school district determines that a teacher will be employed as a substitute teacher for 60  
3 or more consecutive days in any one assignment for the same teacher.

4 (b) The designation under paragraph (a) of this subsection must occur either:

5 (A) At the beginning of the substitute teaching assignment; or

6 (B) As soon as practicable, but no later than 10 consecutive days, after the school district de-  
7 termines that a substitute teaching assignment will be extended to 60 or more consecutive days.

8 (c) If a school district has a class schedule based on a four-day week, the school district shall:

9 (A) Classify a substitute teaching assignment as a temporary position when the school district  
10 determines that a teacher will be employed as a substitute teacher for 48 or more consecutive days  
11 in any one assignment for the same teacher; and

12 (B) Make the designation described in paragraph (b)(B) of this subsection when the school dis-  
13 trict determines that a teacher will be employed as a substitute teacher for 48 or more consecutive  
14 days in any one assignment for the same teacher.

15 (d) Nothing in this subsection prohibits a school district from making the classification required  
16 under paragraph (a) or (c) of this subsection after fewer consecutive days.

17 (6) A teacher employed by a school district as a substitute teacher shall be paid for any training  
18 that is required for that teacher to apply for or be assigned to a substitute teaching assignment.

19 (7) This section does not apply to substitute teachers represented in a bargaining unit in the  
20 school district by which they are employed.

21 **SECTION 49. The amendments to ORS 342.610 by section 48 of this 2024 Act apply to**  
22 **hours worked on or after the effective date of this 2024 Act.**

39 **SECTION 53. Notwithstanding any other provision of law, the General Fund appropriation**  
40 **made to the Legislative Policy and Research Committee by section 15, chapter 383, Oregon**  
41 **Laws 2023, for the biennium ending June 30, 2025, is increased by \$363,817, for the costs as-**  
42 **sociated with the implementation of section 12 of this 2024 Act.**

43 **SECTION 54. Notwithstanding any other provision of law, the General Fund appropriation**  
44 **made to the Oregon Health Authority by section 1 (4), chapter 591, Oregon Laws 2023, for the**  
45 **biennium ending June 30, 2025, for public health, is increased by \$135,937, for the costs as-**



1 sociated with the implementation of section 44 of this 2024 Act.

2 **SECTION 55.** Notwithstanding any other provision of law, the General Fund appropriation  
3 made to the Oregon Health Authority by section 1 (7), chapter 591, Oregon Laws 2023, for the  
4 biennium ending June 30, 2025, for state assessments and enterprise-wide costs, is increased  
5 by \$7,200, for the costs associated with the implementation of section 44 of this 2024 Act.
