

# Senate Bill 1555

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act creates new drug crimes and increases penalties for some drug offenses. The Act makes other changes to Ballot Measure 110, including changes to treatment funding. The Act also creates a new diversion program and a process for setting aside certain drug convictions. The Act goes into effect when the Governor signs it. (Flesch Readability Score: 60.5).

Creates the crime of using a controlled substance in public. Punishes by up to 364 days' jail, \$6,250 fine, or both. Creates the crime of possessing, purchasing, making, delivering or selling a pill press. Punishes by up to five years' imprisonment, \$125,000 fine, or both. Increases the penalties for possession of a controlled substance. Punishes by up to 364 days' jail, \$6,250 fine, or both. Directs counties to supervise persons convicted of certain property misdemeanors. Requires that for certain drug and property crimes, the court must require an evaluation and treatment as part of probation. Creates a diversion program for certain drug crimes. Directs the court to enter an order setting aside a conviction for certain drug crimes when specified conditions are met.

Directs the Alcohol and Drug Policy Commission to provide grants and funding for drug treatment and other related services. Transfers the duties of the Oversight and Accountability Council to the commission.

Requires a prison sentence for the unlawful delivery or manufacture of a controlled substance when the person has a prior conviction. Increases the penalties for the unlawful delivery of a controlled substance that results in the death of a person. Punishes by up to 20 years' imprisonment, \$375,000 fine, or both.

Provides that possession of a controlled substance with the intent to deliver constitutes delivery. Authorizes local governments to enact laws prohibiting the use of controlled substances. Declares an emergency, effective on passage.

## CREATION OF NEW DRUG OFFENSES

### (Use of Controlled Substances in Public Places)

**SECTION 1. Section 2 of this 2024 Act is added to and made a part of ORS 475.752 to 475.980.**

**SECTION 2. (1) It is unlawful for a person to knowingly or intentionally use a controlled substance in a public place unless the substance was obtained directly from, or pursuant to a valid prescription or order of, a practitioner while acting in the course of professional**

1 practice, or except as otherwise authorized by ORS 475.005 to 475.285 and 475.752 to 475.980.

2 (2) Violation of this section is a Class A misdemeanor.

3 (3) As used in this section, “public place” means a place to which the general public has  
4 access and includes, but is not limited to, hallways, lobbies and other parts of apartment  
5 houses and hotels not constituting rooms or apartments designed for actual residence, and  
6 highways, streets, schools, places of amusement, parks, playgrounds, premises and vehicles  
7 used in connection with public passenger transportation.

9 (Drug Encapsulating, Tableting or Counterfeiting Equipment)

11 **SECTION 3.** Section 4 of this 2024 Act is added to and made a part of ORS 475.752 to  
12 475.980.

13 **SECTION 4.** (1) Except as authorized by a registration under ORS 475.125, it is unlawful  
14 for any person to possess, purchase, make, deliver, sell or possess with intent to sell or de-  
15 liver a tableting machine, an encapsulating machine or controlled substance counterfeiting  
16 materials, knowing, intending or having reasonable cause to believe that the machine or  
17 materials will be used to manufacture a controlled substance or a counterfeit substance.

18 (2) A violation of subsection (1) of this section is a Class C felony.

19 (3) When the court sentences a person under this section, the court shall use crime  
20 category 6 of the sentencing guidelines grid of the Oregon Criminal Justice Commission, and  
21 shall determine the sentence by using the criminal history scale of the sentencing guidelines  
22 grid.

23 (4) As used in this section:

24 (a) “Controlled substance counterfeiting material” means a punch, die, plate, stone or  
25 other item designed to print, imprint or reproduce the trademark, trade name or other  
26 identifying mark, imprint or device of another or any likeness of any of the foregoing upon  
27 a drug or container or labeling thereof so as to render such drug a counterfeit controlled  
28 substance.

29 (b) “Encapsulating machine” means equipment that can be used to fill shells or capsules  
30 with powdered or granular solids or semisolid material to produce coherent solid contents.

31 (c) “Tableting machine” means equipment that can be used to compact, compress or  
32 mold powdered or granular solids or semisolid material to produce coherent solid tablets.

 10 for any person to manufacture or deliver a controlled substance. Any person who violates this sub-  
 11 section with respect to:

12 (a) A controlled substance in Schedule I, is guilty of a Class A felony, except as otherwise pro-  
 13 vided in ORS 475.886 and 475.890.

14 (b) A controlled substance in Schedule II, is guilty of a Class B felony, except as otherwise

 30 475.752 [(7)(b)] (7), 475.854 [(2)(c)] (2)(b) or 475.874 [(2)(c)] (2)(b) as a Class A misdemeanor. The  
 31 election must be made by the district attorney orally or in writing at the time of the first appear-

10 **SECTION 14.** ORS 51.050 is amended to read:

11 51.050. (1) Except as otherwise provided in this section, in addition to the criminal jurisdiction  
12 of justice courts already conferred upon and exercised by them, justice courts have jurisdiction of  
13 all offenses committed or triable in their respective counties. The jurisdiction conveyed by this  
14 section is concurrent with any jurisdiction that may be exercised by a circuit court or municipal  
15 court.

16 (2) In any justice court that has not become a court of record under ORS 51.025, a defendant  
17 charged with a misdemeanor shall be notified immediately after entering a plea of not guilty of the  
18 right of the defendant to have the matter transferred to the circuit court for the county where the  
19 justice court is located. The election shall be made within 10 days after the plea of not guilty is  
20 entered, and the justice shall immediately transfer the case to the appropriate court.

21 (3) A justice court does not have jurisdiction over the trial of any felony or a designated drug-

28 shall be deposited by the courts in the account. All moneys in the account are continuously appro-  
29 priated to the Department of Revenue to be distributed by the Department of Revenue as provided  
30 in this section. The Department of Revenue shall keep a record of moneys transferred into and out  
31 of the account.

4 the establishment, operation and maintenance of alcohol and drug abuse prevention, early inter-  
5 vention and treatment services provided through a county.

6 (e) Allocations to the Oregon State Police for the purpose of the enforcement of the laws relat-  
7 ing to driving under the influence of intoxicants.

8 (f) Allocations to the Arrest and Return Account established under ORS 133.865.

9 (g) Allocations to the Intoxicated Driver Program Fund established under ORS 813.270.

10 (h) Allocations to the State Court Technology Fund established under ORS 1.012.

11 *[(4) Notwithstanding subsections (2) and (3) of this section, the Legislative Assembly shall allocate*  
12 *all moneys deposited into the Criminal Fine Account as payment of fines on Class E violations to the*  
13 *Drug Treatment and Recovery Services Fund established under ORS 430.384.]*

**(Supervision Duty)**

(a) Operate prisons for offenders sentenced to terms of incarceration for more than 12 months;

(b) Provide central information and data services sufficient to:

(A) Allow tracking of offenders; and

(B) Permit analysis of correlations between sanctions, supervision, services and programs, and future criminal conduct; and

(c) Provide interstate compact administration and jail inspections.

(2) Subject to ORS 423.483, each county, in partnership with the department, shall assume responsibility for community-based supervision, sanctions and services for offenders convicted of felonies, designated drug-related misdemeanors, [or] designated person misdemeanors **or designated property misdemeanors** who are:

(a) On parole;

(b) On probation;

(c) On post-prison supervision;

(d) Sentenced, on or after January 1, 1997, to 12 months or less incarceration;

(e) Sanctioned, on or after January 1, 1997, by a court or the State Board of Parole and Post-Prison Supervision to 12 months or less incarceration for violation of a condition of parole, probation or post-prison supervision; or

(f) On conditional release under ORS 420A.206.

(3) Notwithstanding the fact that the court has sentenced a person to a term of incarceration, when an offender is committed to the custody of the supervisory authority of a county under ORS 137.124 (2) or (4), the supervisory authority may execute the sentence by imposing sanctions other than incarceration if deemed appropriate by the supervisory authority. If the supervisory authority releases a person from custody under this subsection and the person is required to report as a sex offender under ORS 163A.010, the supervisory authority, as a condition of release, shall order the person to report to the Department of State Police, a city police department or a county sheriff's office or to the supervising agency, if any:

(a) When the person is released;

(b) Within 10 days of a change of residence;

(c) Once each year within 10 days of the person's birth date;

(d) Within 10 days of the first day the person works at, carries on a vocation at or attends an institution of higher education; and

(e) Within 10 days of a change in work, vocation or attendance status at an institution of higher education.

(4) As used in this section:

(a) "Attends," "institution of higher education," "works" and "carries on a vocation" have the meanings given those terms in ORS 163A.005.

2 (D) Unlawful possession of heroin under ORS 475.854 [(2)(b)] **(2)(a)**;

3 (E) Unlawful possession of 3,4-methylenedioxymethamphetamine under ORS 475.874 [(2)(b)]  
4 **(2)(a)**;

5 (F) Unlawful possession of cocaine under ORS 475.884 [(2)(b)] **(2)(a)**; [or]

6 (G) Unlawful possession of methamphetamine under ORS 475.894 [(2)(b).] **(2)(a)**; or

7 **(H) Unlawful use of a controlled substance in a public place under section 2 of this 2024**

9 (c) “Designated person misdemeanor” means:

10 (A) Assault in the fourth degree constituting domestic violence if the judgment document is as

14 (C) Sexual abuse in the third degree under ORS 163.415.

15 **(d) “Designated property misdemeanor” means:**

16 **(A) Theft in the third degree under ORS 164.043;**

17 **(B) Theft in the second degree under ORS 164.045;**

18 **(C) Criminal trespass in the second degree under ORS 164.245;**

19 **(D) Criminal trespass in the first degree under ORS 164.255;**

20 **(E) Unlawful entry into a motor vehicle under ORS 164.272;**

21 **(F) Criminal mischief in the second degree under ORS 164.354;**

22 **(G) An attempt to commit any of the following offenses:**

23 **(i) Theft in the first degree under ORS 164.055;**

24 **(ii) Unauthorized use of a vehicle under ORS 164.135;**

26 **(iv) Identity theft under ORS 165.800; or**

32 **SECTION 28. (1) Notwithstanding ORS 137.540, for a person charged with or convicted**  
33 **of a designated drug-related misdemeanor or designated property misdemeanor, the following**  
34 **must be ordered as condition of probation or included as part of any conditional discharge**  
35 **diversion agreement under section 29 of this 2024 Act:**

36 **(a) A requirement that the person be evaluated to determine whether the person is a**  
37 **drug-dependent person, and that the person provide written consent for such evaluation; and**

38 **(b) A requirement that, if the evaluation described in paragraph (a) of this subsection**  
39 **indicates that the person is a drug-dependent person and that the person may benefit from**  
40 **treatment for drug dependence, the person complete the course of treatment as directed by**  
41 **the evaluator.**

42 **(2) When an evaluation and treatment is required under subsection (1) of this section:**

43 **(a) The state shall fund the costs of the evaluation and treatment, including supervision**  
44 **related to the person’s compliance with evaluation and treatment requirements.**

6  
7 **SECTION 29.** (1)(a) The district attorney shall offer any person charged with a designated  
8 drug-related misdemeanor who meets the eligibility requirements described in subsection (5)  
9 of this section the opportunity to enter into a conditional discharge diversion agreement. If  
10 the defendant enters into the agreement within 30 days after arraignment, or at a later date  
11 with the consent of the district attorney, the court shall defer further proceedings and place  
12 the person on probation. The terms of the probation shall be defined by the agreement.

13 (b) A conditional discharge diversion agreement described in this section carries the  
14 understanding that if the defendant fulfills the terms of the agreement, the criminal charges  
15 filed against the defendant will be dismissed with prejudice.

16 (c) The agreement must contain a waiver of the following rights of the defendant with  
17 respect to each criminal charge:

18 (A) The right to a speedy trial and trial by jury;

19 (B) The right to present evidence on the defendant's behalf;

20 (C) The right to confront and cross-examine witnesses against the defendant;

21 (D) The right to contest evidence presented against the defendant, including the right to  
22 object to hearsay evidence; and

23 (E) The right to appeal from a judgment of conviction resulting from an adjudication of  
24 guilt entered under subsection (2) of this section, unless the appeal is based on an allegation  
25 that the sentence exceeds the maximum allowed by law or constitutes cruel and unusual  
26 punishment.

27 (d) The agreement must include a requirement that the defendant pay any restitution  
28 owed to the victim as determined by the court, and any fees for court-appointed counsel or-  
29 dered by the court under ORS 135.050.

30 (e) The agreement may not contain a requirement that the defendant enter a plea of  
31 guilty or no contest on any charge in the accusatory instrument.

32 (f) Entering into the agreement does not constitute an admission of guilt and is not  
33 sufficient to warrant a finding or adjudication of guilt by a court.

34 (g) Police reports or other documents associated with the criminal charges in a court file  
35 other than the probation agreement may not be admitted into evidence, and do not establish  
36 a factual basis for finding the defendant guilty, unless the court resumes criminal pro-  
37 ceedings and enters an adjudication of guilt under subsection (2) of this section.

38 (2) Upon violation of a term or condition of the conditional discharge diversion agree-  
39 ment, the court may resume the criminal proceedings and may find the defendant guilty of  
40 the offenses in the accusatory instrument in accordance with the waiver of rights in the  
41 agreement. The defendant may not contest the sufficiency of the evidence establishing the  
42 defendant's guilt of the offenses in the accusatory instrument.

43 (3) Upon a determination by the court that the terms and conditions of the conditional  
44 discharge diversion agreement have been met, the court shall discharge the person and dis-  
45 miss the proceedings against the person. Discharge and dismissal under this section shall

1 be without adjudication of guilt and is not a conviction for purposes of this section or for  
2 purposes of disqualifications or disabilities imposed by law upon conviction of a crime.

3 (4) In the event that the period of probation under this section expires, but the terms  
4 and conditions of the conditional discharge diversion agreement have not been fulfilled and  
5 no probation violation proceeding was initiated prior to the expiration of the period of pro-  
6 bation, the court may not discharge the person and dismiss the proceedings against the  
7 person. The court shall instead issue an order requiring the person to appear and to show  
8 cause why the court should not enter an adjudication of guilt as described in subsection (2)  
9 of this section due to the failure of the person to fulfill the terms and conditions of the  
10 agreement prior to expiration of the period of probation. At the hearing on the order to show  
11 cause, after considering any evidence or argument from the district attorney and the person,

27 (B) Participated in a previous conditional discharge diversion program, a conditional

29 (C) Been sentenced to probation for a designated drug misdemeanor.

30 (d) The defendant does not have a criminal history score of A or B on the sentencing  
31 guidelines grid of the Oregon Criminal Justice Commission.

32 (6) As used in this section, "designated drug-related misdemeanor" has the meaning  
33 given that term in ORS 423.478.

35 (Expungement of Convictions)

36  
37 **SECTION 30.** (1)(a) A court that sentences a person to probation for a designated drug-  
38 related misdemeanor, and that imposes as a condition of probation either completion of a  
39 substance abuse treatment program or completion of an substance abuse evaluation and any  
40 treatment program recommended as a result of the evaluation, shall periodically review the  
41 probation of the person.

42 (b) If the court overseeing the person's probation is different from the court that im-

 9 **(Funding for Evidence-Informed Services)**

 11 **SECTION 31. (1) As used in this section:**

12 (a) “Commission” means the Alcohol and Drug Policy Commission established under ORS  
 13 430.221.

14 (b) “Community court program” means an evidence-informed program that utilizes con-  
 15 tingency management to address addiction with incentives and swift, certain and fair sanc-  
 16 tions for noncompliance.

17 (c) “Community harm reduction” means evidence-informed policies and practices that  
 18 reduce harm to the community caused by drug-dependent persons and persons unlawfully  
 19 distributing controlled substances.

20 (d) “Detoxification facility” means a facility approved by the Oregon Health Authority  
 21 that provides emergency care or treatment for drug-dependent persons.

22 (e) “Drug-dependency related offense” means an offense that is motivated by a depend-  
 23 ence on a controlled substance.

24 (f) “Drug-dependent person” means an individual who has lost the ability to control the  
 25 personal use of controlled substances with abuse potential, or who uses controlled sub-  
 26 stances to the extent that the health of the individual, or the health of other individuals, is  
 27 substantially impaired or endangered, or the social or economic function of the individual is  
 28 substantially disrupted. A drug-dependent person may or may not be physically dependent,  
 29 a condition in which the body requires a continuing supply of a controlled substance to avoid  
 30 characteristic withdrawal symptoms, or psychologically dependent, a condition characterized  
 31 by an overwhelming mental desire for continued use of a controlled substance.

32 (g) “Individual harm reduction” means evidence-informed policies and practices that re-  
 33 duce harm to drug-dependent persons, with or without the use of law enforcement.

34 (h) “Local planning committee” means a local planning committee for alcohol and drug  
 35 prevention and treatment services appointed by or designated by the county governing body  
 36 under ORS 430.342.

37 (i) “Police officer” means a member of a law enforcement unit who is employed on a  
 38 part-time or full-time basis as a peace officer, commissioned by a city, a county or the De-  
 39 partment of State Police and responsible for enforcing the criminal laws of this state, and  
 40 any person formally deputized by a law enforcement unit to take custody of a person who is  
 41 intoxicated or under the influence of one or more controlled substances.

42 (j) “Prevention” means evidence-informed policies, procedures and practices that reduce  
 43 the rate of persons that become drug-dependent persons among the population that is the  
 44 target for the policies, procedures and practices.

45 (k) “Recovery” means the state of a person who was a drug-dependent person but who

1 is no longer drug-dependent.

2 (L) "Sobering center" means a facility that meets all of the following criteria:

3 (A) The facility operates for the purpose of providing to individuals who are acutely  
4 intoxicated a safe, clean and supervised environment until the individuals are no longer  
5 acutely intoxicated.

6 (B) The facility contracts with or is affiliated with a treatment program or a provider  
7 approved by the Oregon Health Authority to provide addiction treatment and the contract  
8 or affiliation agreement includes, but is not limited to, case consultation, training and advice  
9 and a plan for making referrals to addiction treatment.

10 (C) The facility, in consultation with the addiction treatment program or provider, has  
11 adopted comprehensive written policies and procedures incorporating best practices for the  
12 safety of intoxicated individuals, employees of the facility and volunteers at the facility.

13 (D) The facility is registered with the Oregon Health Authority under ORS 430.262.

14 (m) "Treatment" means a program that utilizes evidence-based methods to assist a  
15 drug-dependent person to become a person in recovery, and that:

16 (A) Is based on published research in at least two peer-reviewed journals that cite the  
17 methods used in the program as effective in treating drug-dependent persons by assisting the  
18 persons to become persons in recovery;

19 (B) Is standardized so that the program can be replicated with the same or similar effi-  
20 cacy;

21 (C) Has been studied in more than one environment and has provided consistent and ef-  
22 fective results; and

23 (D) Is subject to ongoing evaluation to determine if implementation is adhering to the  
24 protocol for the method and delivering the desired results of assisting drug-dependent per-  
25 sons to become persons in recovery.

26 (n) "Treatment facility" includes outpatient facilities, inpatient facilities and other facil-  
27 ities that provide treatment services that also meet the minimum standards established un-  
28 der ORS 430.357, any of which may also provide diagnosis and evaluation, medical care,  
29 detoxification, social services or rehabilitation for drug-dependent persons and which operate  
30 in the form of a general hospital, state hospital, foster home, hostel, clinic or other suitable  
31 form approved by the Oregon Health Authority.

32 (2) Using funds from the Drug Treatment and Recovery Services Fund established under  
33 ORS 430.384 or from any other available source, the Alcohol and Drug Policy Commission  
34 shall provide grants and funding to counties, school districts, federally recognized Indian  
35 tribes in this state and Behavioral Health Resource Networks to support the provision of the  
36 following evidence-informed and evidence-based services:

37 (a) Prevention;

38 (b) Treatment;

39 (c) Recovery support; and

40 (d) Individual harm reduction.

41 (3) Using funds from the Drug Treatment and Recovery Services Fund established under  
42 ORS 430.384 or from any other available source, the commission shall provide grants and  
43 funding to cities and counties to support enforcement related to community harm reduction  
44 services as described in subsection (6) of this section.

45 (4) Grants and funding provided by the commission under this section shall ensure that

31 (D) A city government.

32 (E) A county government.

33 (F) A special district.

34 (G) Any private nonprofit organization that receives the majority of its funding from the state  
 35 and requests to participate on the committee.

36 (b) The Public Health Benefit Purchasers Committee shall:

37 (A) Identify and make specific recommendations to achieve uniformity across all public health  
 38 benefit plan designs based on the best available clinical evidence, recognized best practices for  
 39 health promotion and disease management, demonstrated cost-effectiveness and shared demographics  
 40 among the enrollees within the pools covered by the benefit plans.

41 (B) Develop an action plan for ongoing collaboration to implement the benefit design alignment  
 42 described in subparagraph (A) of this paragraph and shall leverage purchasing to achieve benefit  
 43 uniformity if practicable.

44 (C) Continuously review and report to the Oregon Health Policy Board on the committee's  
 45 progress in aligning benefits while minimizing the cost shift to individual purchasers of insurance

1 without shifting costs to the private sector or the health insurance exchange.

2 (c) The Oregon Health Policy Board shall work with the Public Health Benefit Purchasers  
3 Committee to identify uniform provisions for state and local public contracts for health benefit plans  
4 that achieve maximum quality and cost outcomes. The board shall collaborate with the committee  
5 to develop steps to implement joint contract provisions. The committee shall identify a schedule for  
6 the implementation of contract changes. The process for implementation of joint contract provisions  
7 must include a review process to protect against unintended cost shifts to enrollees or agencies.

8 (3)(a) The Health Care Workforce Committee shall include individuals who have the collective  
9 expertise, knowledge and experience in a broad range of health professions, health care education  
10 and health care workforce development initiatives.

11 (b) The Health Care Workforce Committee shall coordinate efforts to recruit and educate health  
12 care professionals and retain a quality workforce to meet the demand that will be created by the  
13 expansion in health care coverage, system transformations and an increasingly diverse population.

14 (c) The Health Care Workforce Committee shall conduct an inventory of all grants and other  
15 state resources available for addressing the need to expand the health care workforce to meet the  
16 needs of Oregonians for health care.

17 (4)(a) The Health Plan Quality Metrics Committee shall include the following members appointed  
18 by the Oregon Health Policy Board:

19 (A) An individual representing the Oregon Health Authority;

20 (B) An individual representing the Oregon Educators Benefit Board;

21 (C) An individual representing the Public Employees' Benefit Board;

22 (D) An individual representing the Department of Consumer and Business Services;

23 (E) Two health care providers;

24 (F) One individual representing hospitals;

25 (G) One individual representing insurers, large employers or multiple employer welfare ar-  
26 rangements;

27 (H) Two individuals representing health care consumers;

28 (I) Two individuals representing coordinated care organizations;

29 (J) One individual with expertise in health care research;

30 (K) One individual with expertise in health care quality measures; and

31 (L) One individual with expertise in mental health and addiction services.

32 (b) The committee shall work collaboratively with the Oregon Educators Benefit Board, the  
33 Public Employees' Benefit Board, the authority and the department to adopt health outcome and  
34 quality measures that are focused on specific goals and provide value to the state, employers,  
35 insurers, health care providers and consumers. The committee shall be the single body to align  
36 health outcome and quality measures used in this state with the requirements of health care data  
37 reporting to ensure that the measures and requirements are coordinated, evidence-based and focused  
38 on a long term statewide vision.

39 (c) The committee shall use a public process that includes an opportunity for public comment  
40 to identify health outcome and quality measures. The health outcome and quality measures identified  
41 by the committee, as updated by the authority under paragraph (g) of this subsection, may be applied  
42 to services provided by coordinated care organizations or paid for by health benefit plans sold  
43 through the health insurance exchange or offered by the Oregon Educators Benefit Board or the  
44 Public Employees' Benefit Board. The authority, the department, the Oregon Educators Benefit  
45 Board and the Public Employees' Benefit Board are not required to adopt all of the health outcome

1 and quality measures identified by the committee but may not adopt any health outcome and quality  
2 measures that are different from the measures identified by the committee. The measures must take  
3 into account the health outcome and quality measures selected by the metrics and scoring subcom-  
4 mittee created in ORS 413.022 and the differences in the populations served by coordinated care  
5 organizations and by commercial insurers.

6 (d) In identifying health outcome and quality measures, the committee shall prioritize measures  
7 that:

8 (A) Utilize existing state and national health outcome and quality measures, including measures  
9 adopted by the Centers for Medicare and Medicaid Services, that have been adopted or endorsed  
10 by other state or national organizations and have a relevant state or national benchmark;

11 (B) Given the context in which each measure is applied, are not prone to random variations  
12 based on the size of the denominator;

13 (C) Utilize existing data systems, to the extent practicable, for reporting the measures to mini-  
14 mize redundant reporting and undue burden on the state, health benefit plans and health care pro-  
15 viders;

16 (D) Can be meaningfully adopted for a minimum of three years;

17 (E) Use a common format in the collection of the data and facilitate the public reporting of the  
18 data; and

19 (F) Can be reported in a timely manner and without significant delay so that the most current  
20 and actionable data is available.

21 (e) The committee shall evaluate on a regular and ongoing basis the health outcome and quality  
22 measures identified under this section.

23 (f) The committee may convene subcommittees to focus on gaining expertise in particular areas  
24 such as data collection, health care research and mental health and substance use disorders in order  
25 to aid the committee in the development of health outcome and quality measures. A subcommittee  
26 may include stakeholders and staff from the authority, the Department of Human Services, the De-  
27 partment of Consumer and Business Services, the Early Learning Council or any other agency staff  
28 with the appropriate expertise in the issues addressed by the subcommittee.

29 (g) The authority shall update annually, if necessary, the health outcome and quality measures  
30 identified by the committee to utilize the latest sets of core quality measures published by the  
31 Centers for Medicare and Medicaid Services in accordance with 42 U.S.C. 1320b-9a and 1320b-9b.

32 (h) This subsection does not prevent the authority, the Department of Consumer and Business  
33 Services, commercial insurers, the Public Employees' Benefit Board or the Oregon Educators Benefit  
34 Board from establishing programs that provide financial incentives to providers for meeting specific  
35 health outcome and quality measures adopted by the committee.

36 (5)(a) The Behavioral Health Committee shall include the following members appointed by the  
37 Director of the Oregon Health Authority:

38 (A) The chairperson of the Health Plan Quality Metrics Committee;

39 (B) The chairperson of the committee appointed by the board to address health equity, if any;

40 (C) A behavioral health director for a coordinated care organization;

41 (D) A representative of a community mental health program;

42 (E) An individual with expertise in data analysis;

43 (F) A member of the Consumer Advisory Council, established under ORS 430.073, that represents  
44 adults with mental illness;

45 (G) A representative of the System of Care Advisory Council established in ORS 418.978;

1 (H) A member [*of the Oversight and Accountability Council, described in ORS 430.389,*] who re-  
 2 presents adults with addictions or co-occurring conditions;

3 (I) One member representing a system of care, as defined in ORS 418.976;

4 (J) One consumer representative;

5 (K) One representative of a tribal government;

6 (L) One representative of an organization that advocates on behalf of individuals with intellec-  
 7 tual or developmental disabilities;

8 (M) One representative of providers of behavioral health services;

9 (N) The director of the division of the authority responsible for behavioral health services, as  
 10 a nonvoting member;

11 (O) The Director of the Alcohol and Drug Policy Commission appointed under ORS 430.220, as  
 12 a nonvoting member;

13 (P) The authority's Medicaid director, as a nonvoting member;

14 (Q) A representative of the Department of Human Services, as a nonvoting member; and

15 (R) Any other member that the director deems appropriate.

16 (b) The board may modify the membership of the committee as needed.

17 (c) The division of the authority responsible for behavioral health services and the director of  
 18 the division shall staff the committee.

19 (d) The committee, in collaboration with the Health Plan Quality Metrics Committee, as needed,  
 20 shall:

21 (A) Establish quality metrics for behavioral health services provided by coordinated care or-  
 22 ganizations, health care providers, counties and other government entities; and

 7 (A) An individual representing Clackamas, Washington or Multnomah County;  
 8 (B) An individual representing Clatsop, Columbia, Coos, Curry, Jackson, Josephine, Lane or

 11 (D) An individual representing a city with a population above 10,000 residents as of July 21,  
 12 2021;

 15 (F) A representative of the Oregon Coalition of Local Health Officials or its successor organ-

35 **SECTION 48.** ORS 475.925 is amended to read:

36 475.925. When a person is convicted of the unlawful delivery or manufacture of a controlled  
37 substance, the court shall sentence the person to a term of incarceration [*ranging from*] **as**  
38 **follows:**

39 (1) 58 months to 130 months, depending on the person’s criminal history, if the delivery or  
40 manufacture involves:

41 (a) 500 grams or more of a mixture or substance containing a detectable amount of cocaine;

42 (b) 500 grams or more of a mixture or substance containing a detectable amount of metham-  
43 phetamine, its salts, isomers or salts of its isomers;

44 (c) 100 grams or more of a mixture or substance containing a detectable amount of heroin;

45 (d) 100 grams or more of a mixture or substance containing a detectable amount of fentanyl, or

1 any substituted derivative of fentanyl as defined by the rules of the State Board of Pharmacy; or  
 2 (e) 100 grams or more or 500 or more pills, tablets or capsules of a mixture or substance con-  
 3 taining a detectable amount of ecstasy.

4 (2) 34 months to 72 months, depending on the person’s criminal history, if the delivery or man-  
 5 ufacture involves:

6 (a) 100 grams or more of a mixture or substance containing a detectable amount of cocaine;

7 (b) 100 grams or more of a mixture or substance containing a detectable amount of metham-  
 8 phetamine, its salts, isomers or salts of its isomers;

9 (c) 50 grams or more of a mixture or substance containing a detectable amount of heroin;

10 (d) 50 grams or more of a mixture or substance containing a detectable amount of fentanyl, or  
 11 any substituted derivative of fentanyl as defined by the rules of the State Board of Pharmacy; or

12 (e) 50 grams or more or 250 or more pills, tablets or capsules of a mixture or substance con-  
 13 taining a detectable amount of ecstasy.

14 (3) **36 months, or any longer term of incarceration required by law or prescribed by the**  
 15 **sentencing guidelines of the Oregon Criminal Justice Commission, if the person has a con-**

39 (b) **When the court sentences a person under this section, the court shall use crime**  
 40 **category 10 of the sentencing guidelines grid of the Oregon Criminal Justice Commission, and**  
 41 **shall determine the sentence by using the criminal history scale of the sentencing guidelines**  
 42 **grid.**

43 (c) **In determining the criminal history for a person to be sentenced under this section,**  
 44 **a prior conviction for unlawful delivery of a controlled substance is a person felony, as that**  
 45 **term is defined in the rules of the commission.**



1 (d) Notwithstanding ORS 161.605, the court shall impose the sentence described in this  
2 subsection, and may not grant a downward dispositional departure or a downward durational  
3 departure under the rules of the commission, except as provided in subsection (3) of this  
4 section.

5 (e) Notwithstanding paragraph (d) of this subsection, the court may impose a sentence  
6 other than the sentence described in this subsection if the court imposes a longer term of  
7 incarceration that is otherwise required or authorized by law.

16 a family or household member or friend of, or cohabitating in a nonintimate relationship  
17 with, the person;

18 (B) There was no consideration; and

19 (C) The person made good faith efforts to assist the state in identifying individuals from  
20 whom the person obtained the controlled substance and cooperate with the prosecution of  
21 those individuals.

22 (b) The court may grant a downward dispositional departure under the rules of the  
23 commission, and impose as a sentence a term of supervised probation, if the court finds by  
24 clear and convincing evidence that:

25 (A) The primary motivation of the delivery of the controlled substance was to support  
26 the person's use of the controlled substance;

27 (B) The person made good faith efforts to assist the state in identifying individuals from  
28 whom the person obtained the controlled substance and cooperate with the prosecution of  
29 those individuals;

30 (C) The person has been diagnosed with a substance use disorder by a court-approved  
31 assessor; and

32 (D) At the time of sentencing, the person has no prior convictions for delivery of a con-  
33 trolled substance or for a person felony, as that term is defined in the rules of the commis-  
34 sion.

35 (c) A person sentenced to probation under this subsection shall, in order to successfully  
36 complete the probationary sentence, complete a treatment program at the assessed level of  
37 care recommended by a treatment provider approved by the court.

38 (d) If the court revokes the probation of a person sentenced under this subsection, the  
39 court shall impose the term of incarceration indicated by the person's criminal history as  
40 described in subsection (2) of this section. The person may not receive a reduction in the  
41 term of incarceration for appropriate institutional behavior that exceeds 20 percent of the  
42 sentence imposed. The person is not eligible for transitional leave under ORS 421.168 or any  
43 other reduction in the term of imprisonment.

45 (a) "Controlled substance" has the meaning given that term in ORS 475.924.

(1) Except as provided in ORS 475.900, 475.907 or 475.925 **or section 51 of this 2024 Act**, when the court sentences a person convicted of delivery of methamphetamine under ORS 475.890 or 475.892, the presumptive sentence is 19 months of incarceration, unless the rules of the Oregon Criminal Justice Commission prescribe a longer presumptive sentence, if the person has two or more previous convictions for any combination of the following crimes:

(a) Delivery or manufacture of methamphetamine under ORS 475.752, 475.886 or 475.890;

(b) Delivery or manufacture of methamphetamine within 1,000 feet of a school under ORS 475.888, 475.892 or 475.904; or

(c) Possession of a precursor substance with intent to manufacture a controlled substance under ORS 475.967.

(2) The court may impose a sentence other than the sentence provided by subsection (1) of this section if the court imposes:

(a) A longer term of incarceration that is otherwise required or authorized by law; or

(b) An upward durational departure sentence that is authorized by law or the rules of the Oregon Criminal Justice Commission based upon findings of substantial and compelling reasons. Unless otherwise authorized by law or rule of the Oregon Criminal Justice Commission, the maximum departure allowed for a person sentenced under this subsection is double the presumptive sentence provided in subsection (1) of this section.

(3) As used in this section, “previous conviction” means:

(a) Convictions occurring before, on or after August 16, 2005; and

(b) Convictions entered in any other state or federal court for comparable offenses.

(4)(a) For a crime committed on or after November 1, 1989, a conviction is considered to have occurred upon the pronouncement of sentence in open court. However, when sentences are imposed for two or more convictions arising out of the same conduct or criminal episode, none of the convictions is considered to have occurred prior to any of the other convictions arising out of the same conduct or criminal episode.

(b) For a crime committed prior to November 1, 1989, a conviction is considered to have occurred upon the pronouncement in open court of a sentence or upon the pronouncement in open court of the suspended imposition of a sentence.

(5) For purposes of this section, previous convictions must be proven pursuant to ORS 137.079.

**RESTORATION OF STATE V. BOYD DELIVERY DEFINITION**

**SECTION 53.** ORS 475.005 is amended to read:

475.005. As used in ORS 475.005 to 475.285 and 475.752 to 475.980, unless the context requires otherwise:

(1) “Abuse” means the repetitive excessive use of a drug short of dependence, without legal or medical supervision, which may have a detrimental effect on the individual or society.

(2) “Administer” means the direct application of a controlled substance, whether by injection, inhalation, ingestion or any other means, to the body of a patient or research subject by:

(a) A practitioner or an authorized agent thereof; or

(b) The patient or research subject at the direction of the practitioner.

(3) “Administration” means the Drug Enforcement Administration of the United States Depart-

1 ment of Justice, or its successor agency.

2 (4) "Agent" means an authorized person who acts on behalf of or at the direction of a man-  
3 ufacturer, distributor or dispenser. It does not include a common or contract carrier, public  
4 warehouseman or employee of the carrier or warehouseman.

5 (5) "Board" means the State Board of Pharmacy.

6 (6) "Controlled substance":

7 (a) Means a drug or its immediate precursor classified in Schedules I through V under the fed-  
8 eral Controlled Substances Act, 21 U.S.C. 811 to 812, as modified under ORS 475.035. The use of the  
9 term "precursor" in this paragraph does not control and is not controlled by the use of the term  
10 "precursor" in ORS 475.752 to 475.980.

11 (b) Does not include:

12 (A) The plant Cannabis family Cannabaceae;

13 (B) Any part of the plant Cannabis family Cannabaceae, whether growing or not;

14 (C) Resin extracted from any part of the plant Cannabis family Cannabaceae;

15 (D) The seeds of the plant Cannabis family Cannabaceae;

16 (E) Any compound, manufacture, salt, derivative, mixture or preparation of a plant, part of a  
17 plant, resin or seed described in this paragraph; or

18 (F) Psilocybin or psilocin, but only if and to the extent that a person manufactures, delivers, or  
19 possesses psilocybin, psilocin, or psilocybin products in accordance with the provisions of ORS  
20 475A.210 to 475A.722 and rules adopted under ORS 475A.210 to 475A.722.

21 (7) "Counterfeit substance" means a controlled substance or its container or labeling, which,  
22 without authorization, bears the trademark, trade name, or other identifying mark, imprint, number  
23 or device, or any likeness thereof, of a manufacturer, distributor or dispenser other than the person  
24 who in fact manufactured, delivered or dispensed the substance.

25 (8) "Deliver" or "delivery" means the actual **transfer**, constructive **transfer** or attempted  
26 transfer, **or possession with intent to transfer**, other than by administering or dispensing, from  
27 one person to another of a controlled substance, whether or not there is an agency relationship.

28 (9) "Device" means instruments, apparatus or contrivances, including their components, parts  
29 or accessories, intended:

30 (a) For use in the diagnosis, cure, mitigation, treatment or prevention of disease in humans or  
31 animals; or

32 (b) To affect the structure of any function of the body of humans or animals.

33 (10) "Dispense" means to deliver a controlled substance to an ultimate user or research subject  
34 by or pursuant to the lawful order of a practitioner, and includes the prescribing, administering,  
35 packaging, labeling or compounding necessary to prepare the substance for that delivery.

36 (11) "Dispenser" means a practitioner who dispenses.

37 (12) "Distributor" means a person who delivers.

38 (13) "Drug" means:

39 (a) Substances recognized as drugs in the official United States Pharmacopoeia, official  
40 Homeopathic Pharmacopoeia of the United States or official National Formulary, or any supplement  
41 to any of them;

42 (b) Substances intended for use in the diagnosis, cure, mitigation, treatment or prevention of  
43 disease in humans or animals;

44 (c) Substances (other than food) intended to affect the structure or any function of the body of  
45 humans or animals; and

1 (d) Substances intended for use as a component of any article specified in paragraph (a), (b) or  
2 (c) of this subsection; however, the term does not include devices or their components, parts or ac-  
3 cessories.

4 (14) "Electronically transmitted" or "electronic transmission" means a communication sent or  
5 received through technological apparatuses, including computer terminals or other equipment or  
6 mechanisms linked by telephone or microwave relays, or any similar apparatus having electrical,  
7 digital, magnetic, wireless, optical, electromagnetic or similar capabilities.

8 (15) "Manufacture" means the production, preparation, propagation, compounding, conversion  
9 or processing of a controlled substance, either directly or indirectly by extraction from substances  
10 of natural origin, or independently by means of chemical synthesis, or by a combination of extraction  
11 and chemical synthesis, and includes any packaging or repackaging of the substance or labeling or  
12 relabeling of its container, except that this term does not include the preparation or compounding  
13 of a controlled substance:

14 (a) By a practitioner as an incident to administering or dispensing of a controlled substance in  
15 the course of professional practice; or

16 (b) By a practitioner, or by an authorized agent under the practitioner's supervision, for the  
17 purpose of, or as an incident to, research, teaching or chemical analysis and not for sale.

18 (16) "Person" includes a government subdivision or agency, business trust, estate, trust or any  
19 other legal entity.

20 (17) "Practitioner" means physician, dentist, veterinarian, scientific investigator, licensed nurse  
21 practitioner, physician assistant or other person licensed, registered or otherwise permitted by law  
22 to dispense, conduct research with respect to or to administer a controlled substance in the course  
23 of professional practice or research in this state but does not include a pharmacist or a pharmacy.

24 (18) "Prescription" means a written, oral or electronically transmitted direction, given by a  
25 practitioner for the preparation and use of a drug. When the context requires, "prescription" also  
26 means the drug prepared under such written, oral or electronically transmitted direction. Any label  
27 affixed to a drug prepared under written, oral or electronically transmitted direction shall promi-  
28 nently display a warning that the removal thereof is prohibited by law.

29 (19) "Production" includes the manufacture, planting, cultivation, growing or harvesting of a  
30 controlled substance.

31 (20) "Research" means an activity conducted by the person registered with the federal Drug  
32 Enforcement Administration pursuant to a protocol approved by the United States Food and Drug  
33 Administration.

34 (21) "Ultimate user" means a person who lawfully possesses a controlled substance for the use  
35 of the person or for the use of a member of the household of the person or for administering to an  
36 animal owned by the person or by a member of the household of the person.

37 (22) "Usable quantity" means:

38 (a) An amount of a controlled substance that is sufficient to physically weigh independent of its  
39 packaging and that does not fall below the uncertainty of the measuring scale; or

40 (b) An amount of a controlled substance that has not been deemed unweighable, as determined  
41 by a Department of State Police forensic laboratory, due to the circumstances of the controlled  
42 substance.

43 (23) "Within 1,000 feet" means a straight line measurement in a radius extending for 1,000 feet  
44 or less in every direction from a specified location or from any point on the boundary line of a  
45 specified unit of property.

**LOCAL AUTHORITY**

**SECTION 54.** ORS 430.402 is amended to read:

430.402. (1) A political subdivision in this state shall not adopt or enforce any local law or regulation that makes any of the following an offense, a violation or the subject of criminal or civil penalties or sanctions of any kind:

(a) Public intoxication.

(b) Public drinking, except as to places where any consumption of alcoholic beverages is generally prohibited.

(c) Drunk and disorderly conduct.

(d) Vagrancy or other behavior that includes as one of its elements either drinking alcoholic beverages or using cannabis or controlled substances in public, being an alcoholic or a drug-dependent person, or being found in specified places under the influence of alcohol, cannabis or controlled substances.

(e) Using or being under the influence of cannabis [*or controlled substances*].

(2) Nothing in subsection (1) of this section shall affect any local law or regulation of any political subdivision in this state against:

(a) Driving while under the influence of intoxicants, as defined in ORS 813.010, or other similar offenses that involve the operation of motor vehicles; or

**(b) Using or being under the influence of a controlled substance as defined in ORS 475.005.**

(b) The Oregon Health Authority, the Alcohol and Drug Policy Commission and the Oversight and Accountability Council may take any action before the operative date specified in paragraph (a) of this subsection that is necessary to enable those entities to exercise, on and after the operative date specified in paragraph (a) of this subsection, all of the duties, functions and powers conferred on those entities by this 2024 Act.
