SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: This Act does not allow a board or a person to choose or not choose materials that are used in a school when the choice is discrimination. (Flesch Readability Score: 66.5).

Prohibits discrimination when selecting textbooks, instructional materials, program materials or library books that are used in the public schools of this state.

Declares an emergency, effective on passage.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> ORS 337.260, as amended by section 3, chapter 202, Oregon Laws 2019, and section 6 2, chapter 328, Oregon Laws 2023, is amended to read:

337.260. (1) Every district school board, the State Board of Education and every committee or 7 [officer] administrator responsible for the adoption of textbooks and other instructional materials 8 for use in the public schools shall adopt textbooks and other instructional materials on American 9 10 history and government that adequately stress the services rendered by those who achieved our national independence, who established our form of constitutional government and who preserved 11 12our federal union. Textbooks and other instructional materials shall adequately address the roles in and contributions to the economic, political and social development of Oregon and the United 13 States by men and women who: 14

15 [(1)] (a) Are Native American;

[(2)] (b) Are of European, African, Asian, Pacific Island, Chicano, Latino, Middle Eastern or
 Jewish descent;

18 [(3)] (c) Have disabilities;

- 19 [(4)] (d) Are immigrants or refugees; or
- 20 [(5)] (e) Are lesbian, gay, bisexual or transgender.

(2) To comply with the prohibition on discrimination required by ORS 659.850, a district school board or a committee or administrator responsible for the adoption of textbooks or other instructional materials under this section may not prohibit the use of, or refuse to approve the use of, textbooks or instructional materials on the basis that the textbooks or instructional materials include a perspective, study or story of, or are created by, any indi1 vidual or group identified in subsection (1) of this section.

2 **SECTION 2.** ORS 337.120 is amended to read:

3 337.120. (1)(a) A district school board, with the assistance of teachers and administrators of the
district, shall adopt a list of textbooks and other instructional materials for each grade and subject
for which instruction is provided by the school district.

6 (b) When adopting a list of textbooks and other instructional materials, the district school 7 board:

8 (A) Shall consider whether the textbooks and other instructional materials are available 9 through online resources that enable students with print disabilities to receive the textbooks and 10 instructional materials free of charge[.]; and

(B) To comply with the prohibition on discrimination required by ORS 659.850, may not prohibit the use of, or refuse to approve the use of, textbooks and instructional materials on the basis that the textbooks or instructional materials include a perspective, study or story of, or are created by, any individual or group against whom discrimination is prohibited under ORS 659.850.

(c) The district school board shall adopt the list in compliance with ORS 337.141 and shall in volve parents and citizens in the process.

18 (2) The district school board shall cause the textbooks or other instructional materials, according to titles, that are included on the list adopted under subsection (1) of this section to be used in 19 its schools at the beginning of the next school year following the state adoption under ORS 337.141, 20except when, pursuant to rules of the State Board of Education, the district school board is au-2122thorized by the Superintendent of Public Instruction to postpone use for a reasonable period of time. 23(3) District school boards shall establish a process and timeline for regularly determining whether textbooks and instructional materials on the list adopted under subsection (1) of this section 24are available through online resources that enable students with print disabilities to receive text-25books and instructional materials free of charge. 26

SECTION 3. ORS 336.082 is amended to read:

336.082. (1) The State Board of Education shall encourage the development and implementation
 of curriculum for public elementary and secondary schools in Oregon that will improve instructional
 effectiveness or efficiency and that does not [discriminate] include discrimination.

(2) The State Board of Education shall stimulate the development of nondiscriminatory courses of study or parts of courses to improve instructional effectiveness or efficiency in public elementary and secondary schools in Oregon. The board may direct the Department of Education or contract with appropriate public educational agencies to develop program materials and to establish a mechanism for the purpose of introducing the materials and implementing the techniques.

36 [(3) As used in subsection (1) of this section, "discriminate" has the meaning given 37 "discrimination" in ORS 659.850.]

(3) To comply with the prohibition on discrimination required by ORS 659.850, a district school board, an administrator or any person responsible for the development or implementation of curriculum in a public elementary or secondary school in Oregon may not prohibit the use of, or refuse to approve the use of, program materials on the basis that the program materials include a perspective, study or story of, or are created by, any individual or group against whom discrimination is prohibited.
