(1) The Task Force on Maximizing Supplemental Nutrition Assistance Pro-4 $\mathbf{5}$ gram Benefits is established. 6 "(2) The task force consists of members appointed by the Director of Human Services 7 who represent the geographic and racial or ethnic diversity of this state and who have: "(a) Expertise in food insecurity. 8 9 (b) Personal experience receiving Supplemental Nutrition Assistance Program benefits. 10 "(c) Experience in the restaurant industry. 11 "(d) Experience in the retail grocery industry. 12"(e) Personal or professional experience in working with Oregonians who experience 13 barriers to accessing hot food, such as seniors, individuals with disabilities or homeless in-14 dividuals. 15"(3) The task force shall analyze options available under any applicable federal waivers 16 or federal programs under 7 U.S.C. 2026, or other options available with federal approval, 17 to maximize the food choices for recipients of Supplemental Nutrition Assistance Program 18 benefits, including by allowing benefits to be used to purchase hot foods and hot foods that 19 are ready for immediate consumption. 20 "(4) The Department of Human Services shall provide staff support to the task force. 21"(5) Based on the analysis of the task force, the Department of Human Services shall 22develop a plan to implement a program to allow recipients to use Supplemental Nutrition 23Assistance Program benefits to purchase hot foods and hot foods that are ready for imme-24diate consumption, including restaurant meals, and shall pursue federal approval from the 25United States Department of Agriculture, if approval is needed, or pursue options currently 26 available under federal law to implement the program. 27"(6) The plan for the program as described in subsection (5) of this section must include, 28but is not limited to, recommendations for an evaluation of the program to examine: 29"(a) Access to the program; "(b) The efficacy of the program in allowing participants to obtain restaurant meals; and 30 31 "(c) The cost of the program. 32 "(7) A majority of the members of the task force constitutes a quorum for the trans-33 action of business. "(8) Official action by the task force requires the approval of a majority of the members 34 35 of the task force.

1 "(9) The task force shall elect one of its members to serve as chairperson.

2 "(10) If there is a vacancy for any cause, the director shall make an appointment to be-3 come immediately effective.

4 "(11) The task force shall meet at times and places specified by the call of the chair-5 person or of a majority of the members of the task force.

"(12) The task force may adopt rules necessary for the operation of the task force.

"(13) No later than January 31, 2025, the task force shall submit a report on the implementation of the program, in the manner provided in ORS 192.245, to the interim committees
of the Legislative Assembly related to human services.

10 "(14) Members of the task force are entitled to compensation and to reimbursement for 11 actual and necessary travel and other expenses the members incur in the performance of 12 their duties on the task force in the manner and amounts provided for in ORS 292.495.

13 "(15) All agencies of state government, as defined in ORS 174.111, are directed to assist 14 the task force in the performance of the duties of the task force and, to the extent permitted 15 by laws relating to confidentiality, to furnish information and advice the members of the task 16 force consider necessary to perform their duties.

"(16) The department shall solicit public feedback on the plan developed under subsection
(5) of this section to ensure that the department receives feedback from an equity perspective before implementing the program.

"(17) The department may implement the program on a statewide basis or initially as a
 pilot program.

22 "SECTION 2. Section 1 of this 2024 Act is amended to read:

 is established.]

25 "[(2) The task force consists of members appointed by the Director of Human Services who repre-26 sent the geographic and racial or ethnic diversity of this state and who have:]

27 "[(a) Expertise in food insecurity.]

28 "[(b) Personal experience receiving Supplemental Nutrition Assistance Program benefits.]

29 "[(c) Experience in the restaurant industry.]

30 "[(d) Experience in the retail grocery industry.]

31 "[(e) Personal or professional experience in working with Oregonians who experience barriers to 32 accessing hot food, such as seniors, individuals with disabilities or homeless individuals.]

33 "[(3) The task force shall analyze options available under any applicable federal waivers or federal 34 programs under 7 U.S.C. 2026, or other options available with federal approval, to maximize the food 35 choices for recipients of Supplemental Nutrition Assistance Program benefits, including by allowing 36 benefits to be used to purchase hot foods and hot foods that are ready for immediate consumption.]

²⁹ "To the extent permitted by federal law, the Department of Human Services shall allow ³⁰ recipients of Supplemental Nutrition Assistance Program benefits who lack access to kitchen ³¹ facilities or a means of preparing meals to use the benefits to purchase hot foods and hot ³² foods that are ready for immediate consumption, including restaurant meals.

33 "<u>SECTION 3.</u> The amendments to section 1 of this 2024 Act by section 2 of this 2024 Act 34 become operative one year after receipt of any approval that is necessary to carry out the 35 plan for implementing the program described in section 1 of this 2024 Act or one year after 36 the notification from the United States Secretary of Agriculture that no federal approval is 37 necessary.

38 "<u>SECTION 4.</u> The Department of Human Services shall notify the Legislative Counsel
 39 immediately upon receipt of:

40 "(1) Any federal approval described in section 3 of this 2024 Act or the denial of approval;
41 or

42 "(2) Notification from the United States Secretary of Agriculture that no approval is
 43 necessary.

44 "<u>SECTION 5.</u> This 2024 Act takes effect on the 91st day after the date on which the 2024
 45 regular session of the Eighty-second Legislative Assembly adjourns sine die.".
