**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act increases some amounts that are protected from debt collectors. The Act changes some laws about bad debt collection methods. (Flesch Readability Score: 63.2).  
Increases certain exemptions from garnishment and execution.  
Modifies provisions relating to unfair debt collection practices.  
Declares an emergency, effective on passage.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 18.345 is amended to read:

8 18.345. (1) All property **of a judgment debtor**, including franchises, or rights or interest  
9 [*therein, of the judgment debtor, shall be*] **in the judgment debtor's property, is** liable to an exe-  
10 cution, except as provided in this section and in other statutes granting exemptions from execution.  
11 The following property **of the judgment debtor**, or rights or interest [*therein of the judgment*  
12 *debtor*] **in the property**, except as provided in ORS 18.305, [*shall be*] **is** exempt from execution:

13 (a) Books, pictures and musical instruments to the value of \$600.

14 (b) Wearing apparel, jewelry and other personal items to the value of \$1,800.

15 (c) The tools, implements, apparatus, team, harness or library, necessary to enable the judgment  
16 debtor to carry on the trade, occupation or profession by which the judgment debtor habitually  
17 earns a living, to the value of \$5,000.

18 [*(d) A vehicle to the value of \$3,000. As used in this paragraph "vehicle" includes an automobile,*  
19 *truck, trailer, truck and trailer or other motor vehicle.*]

20 **(d)(A) A vehicle, including an automobile, truck, trailer, truck and trailer or other motor**  
21 **vehicle, to the value of \$10,000; or**

22 **(B) If the judgment debtor owes a debt that arises out of a child support or spousal**  
23 **support obligation or a money award judgment that includes restitution, a vehicle, including**

1 **an automobile, truck, trailer, truck and trailer or other motor vehicle, to the value of \$3,000.**

2 (e) Domestic animals and poultry kept for family use, to the total value of \$1,000 and food suf-  
3 ficient to support such animals and poultry for 60 days.

4 (f) Household goods, furniture, radios, a television set and utensils all to the total value of  
5 \$3,000, if the judgment debtor holds the property primarily for the personal, family or household use  
6 of the judgment debtor; provisions actually provided for family use and necessary for the support  
7 of a householder and family for 60 days and also 60 days' supply of fuel.

8 (g) All property of the state or any county or incorporated city therein, or of any other public  
9 or municipal corporation of like character.

10 (h) All professionally prescribed health aids for the **judgment** debtor or a dependent of the  
11 **judgment** debtor.

12 (i) Spousal support, child support, or separate maintenance to the extent reasonably necessary  
13 for the support of the **judgment** debtor and any dependent of the **judgment** debtor.

14 (j) The **judgment** debtor's right to receive, or property that is traceable to, an award under any  
15 crime victim reparation law.

16 (k) The **judgment** debtor's right to receive, or property that is traceable to, a payment or pay-  
17 ments, not to exceed a total of \$10,000, on account of personal bodily injury of the **judgment** debtor  
18 or an individual of whom the **judgment** debtor is a dependent.

19 (L) The **judgment** debtor's right to receive, or property that is traceable to, a payment in  
20 compensation of loss of future earnings of the **judgment** debtor or an individual of whom the  
21 **judgment** debtor is or was a dependent, to the extent reasonably necessary for the support of the  
22 **judgment** debtor and any dependent of the **judgment** debtor.

23 (m) Veterans' benefits and loans.

24 (n) The **judgment** debtor's right to receive an earned income tax credit under the federal tax  
25 laws and any moneys that are traceable to a payment of an earned income tax credit under the  
26 federal tax laws.

27 (o) The **judgment** debtor's right to the assets held in, or right to receive payments under, a  
28 medical savings account or health savings account authorized under section 220 or 223 of the  
29 Internal Revenue Code.

30 (p) The **judgment** debtor's interest, not to exceed \$400 in value, in any personal property.  
31 However, this exemption may not be used to increase the amount of any other exemption.

32 (q) The **judgment** debtor's right to receive a tax credit under ORS 315.273, and any moneys that  
33 are traceable to a payment of a tax credit under ORS 315.273.

34 (2) If the property claimed by the judgment debtor as exempt is adjudicated by the court out of  
35 which the execution issued to be of a value in excess of that allowed by the appropriate paragraph  
36 of subsection (1) of this section, the officer seizing the property shall proceed to sell such property.  
37 Out of the proceeds of such sale, the officer shall deduct costs of sale and shall pay to the judgment  
38 debtor an amount equivalent to the value declared to be exempt by any of the paragraphs of sub-  
39 section (1) of this section and shall apply the balance of the proceeds of sale on the execution. A  
40 sale may not be made under such execution unless the highest bid made exceeds the appropriate  
41 exemption claimed and allowed plus costs of sale. If no bid is received in excess of the value allowed  
42 by the appropriate paragraph of subsection (1) of this section, the costs of sale shall be borne by the  
43 judgment creditor.

44 (3) If two or more members of a household are joint judgment debtors, each judgment debtor  
45 shall be entitled to claim the exemptions in subsection (1)(a), (b), (c), (d) and (p) of this section in

1 the same or different properties. The exemptions provided by subsection (1)(a), (b), (c), (d), (j), (k) and  
 2 (p) of this section, when claimed for jointly owned property, may be combined at the option of the  
 3 **judgment** debtors.

4 (4) Notwithstanding any other provision of law except ORS 657.855, if a writ of garnishment or  
 5 other execution is issued to collect past due support as defined in ORS 18.600, 50 percent of unem-  
 6 ployment compensation benefits, workers' compensation benefits and other benefits paid to the  
 7 **judgment** debtor by the United States, by the state or by a political subdivision of the state are  
 8 exempt. The exemption related to unemployment compensation benefits provided by this subsection  
 9 is subject to ORS 657.855. The exemption provided by this subsection applies without regard to  
 10 whether the payment is made on a periodic basis or in a lump sum, including any lump sum payable  
 11 pursuant to a settlement or judgment. Notwithstanding subsection (1)(k) of this section, if a payment  
 12 is made under a settlement or judgment on account of personal bodily injury and the garnishment  
 13 or other execution is issued to collect past due support as defined in ORS 18.600, the lesser of 50  
 14 percent of the payment or \$7,500 is exempt.

15 **SECTION 2.** ORS 18.348 is amended to read:

16 18.348. (1) Funds that are exempt from execution under ORS 18.358, 18.385, 178.345, 238.445,  
 17 344.580, 407.595, 411.760, 414.095, 655.530, 656.234, 657.855 and 748.207 remain exempt when deposited  
 18 in an account in a financial institution as long as the exempt funds are reasonably identifiable.

19 (2) Subsection (1) of this section does not apply to any accumulation of funds greater than  
 20 \$7,500.

21 (3) All funds that are exempt under federal law remain exempt when deposited in an account in  
 22 a financial institution as long as the exempt funds are reasonably identifiable.

23 (4) The application of subsections (1) and (3) of this section is not affected by the commingling  
 24 of exempt and nonexempt funds in an account. For the purpose of identifying exempt funds in an  
 25 account, first in, first out accounting principles shall be used.

26 (5) The provisions of this section do not affect the duties of a garnishee with respect to amounts  
 27 in accounts that are not subject to garnishment under ORS [18.784] **18.785**.

28 **SECTION 3.** ORS 18.385 is amended to read:

29 18.385. (1) Except as provided in this section, 75 percent of the disposable earnings of an indi-  
 30 vidual are exempt from execution.

31 (2) **Except as provided in subsection (6) of this section**, the disposable earnings of an indi-  
 32 vidual are exempt from execution to the extent that payment under a garnishment would result in  
 33 net disposable earnings for an individual of less than the following amounts:

34 [(a) \$254 for any period of one week or less;]

35 [(b) \$509 for any two-week period;]

36 [(c) \$545 for any half-month period;]

37 [(d) \$1,090 for any one-month period; and]

38 [(e) For any other period longer than one week, \$254 multiplied by that fraction produced by di-  
 39 viding the number of days for which the earnings are paid by seven. The amount calculated under this  
 40 paragraph must be rounded to the nearest dollar.]

41 **(a) For any period of one week or less:**

42 **(A) For wages payable before January 1, 2025, \$254.**

43 **(B) For wages payable on or after January 1, 2025, and before July 1, 2025, \$305.**

44 **(C) For wages payable on or after July 1, 2025, and before July 1, 2026, \$338.**

45 **(D) For wages payable on or after July 1, 2026, and before July 1, 2027, \$400.**

1 (E) For wages payable on or after July 1, 2027, the minimum wage specified in ORS  
2 653.025 (1), multiplied by 30.

3 (b) For any two-week period:

4 (A) For wages payable before January 1, 2025, \$509.

5 (B) For wages payable on or after January 1, 2025, and before July 1, 2025, \$611.

6 (C) For wages payable on or after July 1, 2025, and before July 1, 2026, \$675.

7 (D) For wages payable on or after July 1, 2026, and before July 1, 2027, \$832.

8 (E) For wages payable on or after July 1, 2027, the minimum wage specified in ORS  
9 653.025 (1), multiplied by 60.

10 (c) For any half-month period:

11 (A) For wages payable before January 1, 2025, \$545.

12 (B) For wages payable on or after January 1, 2025, and before July 1, 2025, \$655.

13 (C) For wages payable on or after July 1, 2025, and before July 1, 2026, \$737.

14 (D) For wages payable on or after July 1, 2026, and before July 1, 2027, \$912.

15 (E) For wages payable on or after July 1, 2027, the minimum wage specified in ORS  
16 653.025 (1), multiplied by 65.

17 (d) For any one-month period:

18 (A) For wages payable before January 1, 2025, \$1,090.

19 (B) For wages payable on or after January 1, 2025, and before July 1, 2025, \$1,309.

20 (C) For wages payable on or after July 1, 2025, and before July 1, 2026, \$1,458.

21 (D) For wages payable on or after July 1, 2026, and before July 1, 2027, \$1,792.

22 (E) For wages payable on or after July 1, 2027, the minimum wage specified in ORS  
23 653.025 (1), multiplied by 130.

24 (e) For any other period longer than one week:

25 (A) The following amount multiplied by that fraction produced by dividing the number  
26 of days for which the earnings are paid by seven, rounded to the nearest dollar:

27 (i) For wages payable before January 1, 2025, \$254.

28 (ii) For wages payable on or after January 1, 2025, and before July 1, 2025, \$305.

29 (iii) For wages payable on or after July 1, 2025, and before July 1, 2026, \$338.

30 (iv) For wages payable on or after July 1, 2026, and before July 1, 2027, \$400.

31 (B) For wages payable on or after July 1, 2027, the minimum wage specified in ORS  
32 653.025 (1), multiplied by 30 and multiplied again by that fraction produced by dividing the  
33 number of days for which the earnings are paid by seven. The amount calculated under this  
34 sub-paragraph must be rounded to the nearest dollar.

35 (3) Beginning in 2027, the State Court Administrator shall calculate the exemption  
36 amounts specified in subsection (2) of this section each year on or before July 1 and shall  
37 publish the results of the calculations on the Judicial Department website. In making the  
38 calculations, the State Court Administrator shall round to the nearest dollar. The adjusted  
39 exemption amounts become effective on July 1 of the year in which the State Court Admin-  
40 istrator makes the calculation.

41 [(3)] (4) If an individual is paid for a period shorter than one week[.]:

42 (a) The exemption calculated under subsection (2) of this section may not exceed [\$254] the  
43 following amount for any one-week period[.]:

44 (A) For wages payable before January 1, 2025, \$254.

45 (B) For wages payable on or after January 1, 2025, and before July 1, 2025, \$305.

1 (C) For wages payable on or after July 1, 2025, and before July 1, 2026, \$338.

2 (D) For wages payable on or after July 1, 2026, and before July 1, 2027, \$400.

3 (E) For wages payable on or after July 1, 2027, the minimum wage specified in ORS  
4 653.025 (1), multiplied by 30.

5 (b) The exemption calculated under subsection (6) of this section may not exceed \$254.

6 [(4)] (5) An employer shall deduct from the amount of disposable earnings determined to be  
7 nonexempt under subsections (1) [to (3)], (2) and (4) of this section any amounts withheld from the  
8 individual's earnings for the same period of time under an order issued pursuant to ORS 25.378 or  
9 419B.408 or ORS chapter 110. The employer shall make payment under a garnishment only of those  
10 amounts remaining after the deduction is made.

11 (6) If a writ of garnishment includes or is attached to a notice from a state or federal  
12 child support agency, or includes or is attached to an attestation that a debt arises out of a  
13 child support or spousal support obligation or a money award judgment that includes  
14 restitution, the individual's disposable earnings are exempt only to the extent that payment  
15 under a garnishment would result in net disposable earnings for an individual of less than  
16 the following amounts:

17 (a) \$254 for any period of one week or less;

18 (b) \$509 for any two-week period;

19 (c) \$545 for any half-month period;

20 (d) \$1,090 for any one-month period; and

21 (e) For any other period longer than one week, \$254 multiplied by that fraction produced  
22 by dividing the number of days for which the earnings are paid by seven. The amount cal-  
23 culated under this paragraph must be rounded to the nearest dollar.

24 [(5)] (7) Subsections (1) to [(4)] (6) of this section do not apply to:

25 (a) Any order of a court of bankruptcy.

26 (b) Any debt due for federal tax.

27 [(6)] (8) Subsections (2) to [(4)] (6) of this section do not apply to any debt due for state tax.  
28 Subsection (1) of this section does not apply to a debt due for state tax if a state agency issues a  
29 special notice of garnishment under ORS 18.855 (6).

30 [(7)] (9) A court may not make, execute or enforce any order or process in violation of this  
31 section.

32 [(8)] (10) Any waiver by an individual of the provisions of this section is void.

33 [(9)] (11) An employer may not discharge any individual because the individual has had earnings  
34 garnished.

35 **SECTION 4.** ORS 18.395 is amended to read:

36 18.395. (1)(a) **Except as provided in paragraph (b) of this subsection,** a homestead [shall be]  
37 is exempt from sale on execution, from the lien of every judgment and from liability in any form for  
38 the debts of the owner to the amount in value of [\$40,000] **\$150,000**, except as otherwise provided  
39 by law. The exemption [shall be] is effective without the necessity of a claim thereof by the judgment  
40 debtor. When two or more members of a household are **judgment** debtors whose interests in the  
41 homestead are subject to sale on execution, the lien of a judgment or liability in any form, their  
42 combined exemptions under this section shall not exceed [\$50,000] **\$300,000**.

43 (b) **A homestead is exempt from sale on execution, from the lien of every judgment and**  
44 **from liability in any form for the debts of the owner arising out of a child support or spousal**  
45 **support obligation or a money award judgment that includes restitution to the amount in**

1 value of \$40,000, except as otherwise provided by law. The exemption is effective without the  
 2 necessity of a claim thereof by the judgment debtor. When two or more members of a  
 3 household are judgment debtors whose interests in the homestead are subject to sale on ex-  
 4 ecution, the lien of a judgment or liability in any form, their combined exemptions under this  
 5 section shall not exceed \$50,000.

6 (c) To qualify for the exemption under paragraph (a) or (b) of this subsection, the home-  
 7 stead must be the actual abode of and occupied by the owner, or the owner's spouse, parent or child,  
 8 but the exemption shall not be impaired by:

9 [(a)] (A) Temporary removal or temporary absence with the intention to reoccupy the same as  
 10 a homestead;

11 [(b)] (B) Removal or absence from the property; or

12 [(c)] (C) The sale of the property.

13 (d)(A) The State Court Administrator shall index the amounts identified as exempt from  
 14 execution under paragraph (a) of this subsection each year on or before July 1 to reflect in-  
 15 creases or decreases in the cost of living for the previous calendar year, based on changes  
 16 in the Consumer Price Index for All Urban Consumers, West Region (All Items), as published  
 17 by the Bureau of Labor Statistics of the United States Department of Labor or a successor  
 18 agency. The State Court Administrator shall publish the adjusted exemption limitations on  
 19 the Judicial Department website. In adjusting the amounts, the State Court Administrator  
 20 shall round to the nearest \$100, but shall use unrounded adjusted amounts to calculate the  
 21 amounts of the exemptions during the succeeding year. The new amounts become effective  
 22 on July 1 of the year in which the State Court Administrator makes the adjustment.

23 (B) The indexing described in subparagraph (A) of this paragraph does not apply to the  
 24 amount of any exemption specified for a debt that arises out of a child support or spousal  
 25 support obligation or a money award judgment that includes restitution.

26 (2) The exemption [*shall extend*] extends to the proceeds derived from [*such sale to an amount*  
 27 *not exceeding \$40,000 or \$50,000, whichever amount*] selling the homestead in the amount that is  
 28 applicable under subsection (1)(a) or (b) of this section, if the proceeds are held for a period not  
 29 exceeding one year and held with the intention to procure another homestead therewith.

30 (3) The exemption period under subsection [(1)(b) and (c)] (1)(c)(B) and (C) of this section [*shall*  
 31 *be*] is one year from the removal, absence or sale, whichever occurs first.

32 (4) When the owner of a homestead has been granted a discharge in bankruptcy or has conveyed  
 33 the homestead property, the value thereof, for the purpose of determining a leviable interest in ex-  
 34 cess of the homestead exemption, [*shall be*] is the value on the date of the petition in bankruptcy,  
 35 whether the value is determined in the bankruptcy proceedings or not, or on the date the  
 36 conveyance becomes effective, whichever [*shall first occur*] occurs first. However, with respect to  
 37 judgments not discharged in the bankruptcy, or entered against the owner after discharge, the value  
 38 on the effective date of conveyance [*shall be*] is controlling.

39 (5) Except as provided in subsection (7) of this section, [*no*] a homestead that is the actual abode  
 40 of and occupied by the judgment debtor, or that is the actual abode of and occupied by a spouse,  
 41 dependent parent or dependent child of the judgment debtor, [*shall*] may not be sold on execution  
 42 to satisfy a judgment that at the time of entry does not exceed \$3,000. However, such judgment  
 43 [*shall remain*] remains a lien upon the real property, and the property may be sold on execution:

44 (a) At any time after the sale of the property by the judgment debtor; and

45 (b) At any time after the property is no longer the actual abode of and occupied by the judgment

1 debtor or the spouse, dependent parent or dependent child of the judgment debtor.

2 (6) The limitation on execution sales imposed by subsection (5) of this section is not impaired  
3 by temporary removal or temporary absence with the intention to reoccupy the property as a  
4 homestead.

5 (7) The limitation on execution sales imposed by subsection (5) of this section does not apply if  
6 two or more judgments are owing to a single judgment creditor and the total amount owing to the  
7 judgment creditor, determined by adding the amount of each individual judgment as of the date the  
8 judgment was entered, is greater than \$3,000.

9 (8) Upon the issuance of an order authorizing sale as required by ORS 18.904, and in conform-  
10 ance with subsection (5) of this section, the sheriff may proceed to sell the property. If the home-  
11 stead exemption applies, the sheriff shall pay the homestead owner out of the proceeds the [*sum of*  
12 *\$40,000 or \$50,000, whichever is applicable,*] **applicable amount under subsection (1)(a) or (b) of**  
13 **this section** and apply the balance of the proceeds on the execution. However, [*no sale shall be*  
14 *made where the homestead* ] **the sheriff may not sell the homestead if an** exemption applies unless  
15 the sum bid for the homestead [*is in excess of the sum of the costs of sale and \$40,000 or \$50,000,*  
16 *whichever is applicable*] **exceeds the sum of the costs of the sale and the amount of the appli-**  
17 **cable exemption.** If no such bid is received, the **petitioner shall bear the** expense of the sale [*shall*  
18 *be borne by the petitioner*].

19 (9) The homestead exemption provided by this section applies to a purchaser's interest under a  
20 land sale contract, as defined by ORS 18.960.

21 (10) The homestead exemption provided by this section applies to:

22 (a) A floating home, as defined by ORS 830.700; and

23 (b) A manufactured dwelling, as defined by ORS 446.003.

24 **SECTION 5.** ORS 18.402 is amended to read:

25 18.402. [*The homestead mentioned in ORS 18.395 shall consist*] **A homestead described in ORS**  
26 **18.395 consists**, when not located in any town or city laid off into blocks and lots, of any quantity  
27 of land not exceeding 160 acres, and when located in any such town or city, of any quantity of land  
28 not exceeding one block. However, a homestead under this section [*shall not exceed in value the sum*  
29 *of \$40,000 or \$50,000, whichever amount is applicable under*] **may not exceed in value the applica-**  
30 **ble amount specified in ORS 18.395 (1)(a) or (b).**

31 **SECTION 6.** ORS 18.412 is amended to read:

32 18.412. (1) At any time after the date of execution of an agreement to transfer the ownership  
33 of property in which a homestead exemption exists pursuant to ORS 18.395, the homestead owner  
34 or the owner's transferee may give notice of intent to discharge the property from the judgment lien  
35 to a judgment creditor. Each notice [*shall*] **must** bear the caption of the action in which the judg-  
36 ment was recovered and [*shall*] **must**:

37 (a) Identify the property and the judgment and state that the judgment debtor is about to  
38 transfer, or has transferred, the property and that the transfer is intended to discharge the property  
39 from any lien effect of the judgment;

40 (b) State the fair market value of the property on the date of the notice or of any applicable  
41 petition in bankruptcy, whichever is applicable, and list the encumbrances against the property, in-  
42 cluding the nature and date of each encumbrance, the name of the encumbrancer and the amount  
43 presently secured by each encumbrance;

44 (c) State that the property is claimed by the person giving the notice to be wholly exempt from  
45 the lien of the judgment or, if the value of the property exceeds the sum of the encumbrances

1 specified as required under paragraph (b) of this subsection that are senior to the judgment lien and  
2 [\$40,000 or \$50,000, whichever amount of the homestead exemption is applicable under] **the applicable**  
3 **amount of the homestead exemption specified in ORS 18.395 (1)(a) or (b)**, that the amount of the  
4 excess or the amount due on the judgment, whichever is less, will be deposited with the court ad-  
5 ministrator for the court in which the judgment was entered for the use of the judgment holder; and

6 (d) Advise the holder of the judgment that the property may be discharged from any lien arising  
7 from the judgment, without further notice to the judgment creditor, unless prior to a specified date,  
8 which in no case may be earlier than 14 days after the date of mailing of the notice, the judgment  
9 creditor files objections and a request for a hearing on the matter as provided in ORS 18.415.

10 (2) Each notice described by subsection (1) of this section [shall] **must** be sent by certified mail  
11 to the judgment creditor, as shown by the court records, at the judgment creditor's present or last-  
12 known address according to the best knowledge of the person sending the notice. A copy of each  
13 notice, together with proof of mailing, may be filed with the court administrator for the court in  
14 which the judgment was entered and [shall] **must** be filed by the court administrator with the re-  
15 cords and files of the action in which the judgment was recovered.

16 **SECTION 7.** ORS 18.600 is amended to read:

17 18.600. As used in ORS 18.600 to 18.850:

18 (1) "Account" means an account at a financial institution, including a master account or sub-  
19 account, to which an electronic payment may be directly routed.

20 (2) "Check" has the meaning given that term in ORS 73.0104.

21 (3) "Creditor" means a person to whom a debt is owed by a debtor.

22 (4) "Debt" means any monetary obligation for which a garnishment may be issued under ORS  
23 18.605.

24 (5) "Debtor" means a person whose property is being garnished for the purpose of paying a debt  
25 owed to a creditor.

26 (6) "Federal benefit payment" means:

27 (a) A benefit payment from the United States Social Security Administration that is protected  
28 under 42 U.S.C. 407 and 1383(d)(1);

29 (b) A benefit payment from the United States Department of Veterans Affairs that is protected  
30 under 38 U.S.C. 5301(a);

31 (c) A benefit payment from the Railroad Retirement Board that is protected under 45 U.S.C.

45 (a) The creditor, if the writ is issued by the court administrator on behalf of the creditor under

2 (b) The issuer, if the writ is issued under ORS 18.635 by any person other than the court ad-

4 (12) "Past due support" means the amount of child or spousal support, or both, determined under  
5 a court or administrative order in a proceeding under ORS 25.501 to 25.556 or ORS chapter 107, 108,  
6 109, 110, 419B or 419C that has not been paid or is certified to be owed by another state under ORS  
7 25.083.

8 (13) "Wages" includes all amounts paid for the services of an employee by an employer, includ-  
9 ing amounts paid as a commission or bonus.

10 (14) "Writ" means a writ of garnishment.

12 18.618. (1)(a) Notwithstanding ORS 18.615, the following are not garnishable property:

16 (D) Property in the possession of a personal representative that constitutes the subject matter

INSTRUCTIONS TO GARNISHEE

38

39 Except as specifically provided in these instructions, you must complete and deliver the  
40 Garnishee Response within seven calendar days after you receive the writ of garnishment. If the  
41 writ does not comply with Oregon law, the writ is not effective to garnish any property of the  
42 Debtor, but you still must complete and deliver the Garnishee Response. You must complete and  
43 deliver the response even though you cannot determine from the writ whether you hold any property  
44 or owe any debt to the Debtor. If the seventh calendar day is a Saturday, Sunday or legal holiday,  
45 you must deliver your response on or before the next following day that is not a Saturday, Sunday

1 or legal holiday.

2  
3 The writ is not effective, and you need not make a Garnishee Response, if:

- 4
- 5 • You do not receive the writ within 60 days after the date of issuance shown on the face of
  - 6 the writ.
  - 7
  - 8 • You do not receive an original writ of garnishment or a copy of the writ.
  - 9

10 Statutes that may affect your rights and duties under the writ can be found in ORS 18.600 to

11 18.850.

12

13 NOTE: The Garnishor may be the Creditor, the attorney for the Creditor or some other person

14 who is authorized by law to issue the writ of garnishment. See the writ to determine who the

15 Garnishor is.

16

17 STEP 1. FILL OUT THE GARNISHEE RESPONSE.

18

19 All garnishees who are required to deliver a garnishee response must fill in Part I of the

20 Garnishee Response. Garnishees who employ the Debtor must also fill in Part II of the response.

21 You should keep a copy of the response for your records.

22

23 Completing Part I of the Garnishee Response. If you discover before you deliver your response

24 that a bankruptcy petition has been filed by or on behalf of the Debtor, and the bankruptcy petition

25 was filed after a judgment was entered against the Debtor or after the debt otherwise became sub-

26 ject to garnishment (see the date specified in the writ), you must put a check by the appropriate

27 statement in Part I. If a bankruptcy petition has been filed, you should not make any payments to

28 the Garnishor unless the court orders otherwise. You need not complete any other part of the re-

29 sponse, but you still must sign the response and deliver it in the manner described in Step 2 of these

30 instructions.

31 In all other cases you must list in Part I all money and personal property of the Debtor that is

32 in your possession, control or custody at the time of delivery of the writ. You must also list all debts

33 that you owe to the Debtor, whether or not those debts are currently due (e.g., money loaned to you

34 by the Debtor that is to be repaid at a later time).

35 If you are the employer of the Debtor at the time the writ is delivered to you, you must put a

36 check by the appropriate statement in Part I. In addition, you must complete Part II of the response.

37 If you believe that you may hold property of the Debtor or that you owe a debt to the Debtor,

38 but you are not sure, you must put a check by the appropriate statement and provide an explana-

39 tion. When you find out what property you hold that belongs to the Debtor, or you find out whether

40 you owe money to the Debtor and how much, you must prepare and deliver an amended response.

41 You must do this even if you find out that you have no property of the Debtor or that you do not

42 owe anything to the Debtor.

43 If you determine that the writ, on its face, does not comply with Oregon laws governing writs

44 of garnishment, or if you are unable to determine the identity of the Debtor from the information

45 in the writ, then the writ is not effective to garnish any property of the Debtor. You must put a

1 check by the appropriate statement in Part I and provide an explanation. You still must complete  
2 the response and deliver the response in the manner described in Step 2 of these instructions.

3 If you have received an order to withhold income that applies to the income of the Debtor and  
4 that order has priority over the garnishment, and if compliance with the order will reduce or elim-  
5 inate the money or property that you would otherwise deliver under the garnishment, you must put  
6 a check by the appropriate statement in Part I. You still must fill out the remainder of the response  
7 and deliver the response in the manner described in Step 2 of these instructions. If you employ the  
8 Debtor, you still must complete Part II of the response.

9 If you receive notice of a challenge to the garnishment before you send your response, you must  
10 complete and deliver your response as otherwise required by these instructions. However, see Step  
11 3 of these instructions regarding payment of money or delivery of property after receipt of notice  
12 of a challenge to the garnishment.

13 If you owe a debt to the Debtor and the Debtor owes a debt to the holder of an underlying lien  
14 on your property, you may be able to offset the amount payable to the underlying lienholder. See  
15 ORS 18.620. You must note that you have made the offset in Part I of the response (under  
16 "Other") and specify the amount that was offset.

17  
18 Completing Part II of the Garnishee Response (employers only). You must fill in Part II of the  
19 response if you employ the Debtor on the date the writ of garnishment is delivered to you, or if you  
20 previously employed the Debtor and still owe wages to the Debtor on the date the writ is delivered  
21 to you.

22  
23 Wages affected. Except as provided below, the writ garnishes all wages that you owe to the  
24 Debtor for work performed before the date you received the writ, even though the wages will not  
25 be paid until a later date. The writ also garnishes all wages that are attributable to services per-  
26 formed during the 90-day period following the date you received the writ, even though you would  
27 not pay the Debtor for all or part of those services until after the end of the 90-day period. Wages  
28 subject to garnishment under the writ include all amounts paid by you as an employer, whether on  
29 an hourly, weekly or monthly basis, and include commission payments and bonuses.

30  
31 Example 1: Debtor A is employed by you and is paid a monthly salary on the first day of  
32 each month. You receive a writ of garnishment on July 17. The writ garnishes all wages  
33 that you owe to Debtor A for work performed on or before July 17. If Debtor A was paid  
34 on July 1 for services performed in the month of June, the writ garnishes Debtor A's salary  
35 for the period beginning July 1 and ending October 15 (90 days after receipt of the writ).

36  
37 The writ does not garnish any wages you owe to a Debtor for a specific pay period if:

38 (a) The writ is delivered to you within two business days before the Debtor's normal payday for  
39 the pay period;

40 (b) When the writ is delivered to you, the Debtor's wages are paid by direct deposit to a finan-  
41 cial institution, or you use an independent contractor as payroll administrator for your payroll; and

42 (c) Before the writ was delivered to you, you issued instructions to the financial institution or  
43 the payroll administrator to pay the Debtor for the pay period.

44 If any wages are not garnishable by reason of the issuance of instructions to a financial insti-  
45 tution or a payroll administrator as described above, you must so note in the Garnishee Response.

1 Thereafter, you must pay to the Garnishor all wages that are subject to garnishment that are at-  
2 tributable to services performed by the Debtor during the 90-day period following the date you re-  
3 ceived the writ.

4  
5 Calculation of wages subject to garnishment. A Wage Exemption Calculation form is attached  
6 to the writ of garnishment. You must use this form to calculate the amount of the Debtor's wages  
7 that is subject to garnishment. You should read the instructions printed on the Wage Exemption  
8 Calculation form to determine the normal wage exemption and the minimum wage exemption for  
9 each payment you make under the writ.

10 A Wage Exemption Calculation form must be sent with the first payment you make under the  
11 writ. For the 90-day period during which the writ is effective, you must also fill out and return a  
12 Wage Exemption Calculation form with a subsequent payment any time the initial calculation  
13 changes. Finally, you must fill out and return a Wage Exemption Calculation form with the final  
14 payment that you make under the writ.

15  
16 Payment of amount subject to garnishment. Payments under the writ must be made at the fol-  
17 lowing times, unless the amount owing on the judgment or other debt is fully paid before the final  
18 payment is made or the writ is released:

19 (a) You must make a payment to the Garnishor of all wages subject to garnishment at the time  
20 you next pay wages to the Debtor. Complete the wage exemption computation, using the Wage Ex-  
21 emption Calculation form, to determine the portion of the Debtor's wages that is subject to  
22 garnishment. Be sure to adjust the minimum exemption amount for any payment that covers less  
23 than a full pay period. You must include a copy of the Wage Exemption Calculation form with this  
24 first payment.

25  
26 Example 2: Using the facts given in Example 1, when you next make any payment of wages  
27 to Debtor A after you receive the writ on July 17, you must complete the Wage Exemption  
28 Calculation form and send the form to the Garnishor along with all amounts determined to  
29 be subject to garnishment that are attributable to the period covered by the payment. If you  
30 pay Debtor A on August 1, the payment will be for all wages attributable to the period be-  
31 ginning July 1 and ending July 31.

32  
33 (b) Unless the writ of garnishment is satisfied or released, during the 90-day period following the  
34 date you received the writ, you must pay to the Garnishor all wages that are determined to be  
35 subject to garnishment whenever you issue a paycheck to the Debtor. If the Debtor is paid on a  
36 weekly basis, you must make payment under the writ on a weekly basis. If the Debtor is paid on a  
37 monthly basis, you must make payment under the writ on a monthly basis. If the amount paid to the  
38 Debtor varies from paycheck to paycheck, or changes at any time from the amount being paid at the  
39 time the writ was delivered to you, you must perform a new wage exemption computation to deter-  
40 mine the amount of wages subject to garnishment under the writ. You must send a copy of the new  
41 Wage Exemption Calculation form with your payment to the Garnishor.

42  
43 Example 3: Using the facts given above, as you make each subsequent payment of wages to  
44 Debtor A you must make a payment of that portion of the Debtor's wages that are subject  
45 to garnishment. If you continue to pay Debtor A on the first of each month, payments must

1 be made on September 1 and October 1.

2

3 (c) Upon the expiration of the 90-day period, you must make a final payment to the Garnishor  
4 for all wages that were owing to the Debtor for the work performed by the Debtor through the 90th  
5 day following your receipt of the writ. This payment may be made at the time of the Debtor's next  
6 paycheck. You will need to complete another Wage Exemption Calculation form to determine the  
7 amount of the wages subject to garnishment.

8

9 Example 4: Using the facts given above, you must make a final payment for the wages owing  
10 to Debtor A for the period beginning October 1 and ending October 15. You may make this  
11 payment at the time you issue Debtor A's paycheck on November 1, but you must make the  
12 payment at any time you issue a paycheck to Debtor A after October 15. Be sure that in  
13 completing the wage exemption computation for the final payment you adjust the minimum  
14 exemption amount to take into account the fact that the period covered is only 15 days of  
15 the full month (see instructions on Wage Exemption Calculation form).

16

17 Processing fee. You may collect a \$2 processing fee for each week of wages, or fraction of a  
18 week of wages, for which a payment is made under the writ. The fee must be collected after you  
19 make the last payment under the writ. The fee must be withheld from the wages of the debtor, and  
20 is in addition to the amounts withheld for payment to the Garnishor under the writ or under any  
21 other writ you have received.

22

23 If you receive more than one writ of garnishment. If you receive a second writ of garnishment  
24 for the same Debtor from another Garnishor, the first writ will have priority for wages. The priority  
25 of the first writ lasts for the 90-day period following delivery of that writ to you, or until the first  
26 writ is paid in full, whichever comes first. In your response to the second writ, you must put a check  
27 by the appropriate statement in Part II and indicate the date on which the first writ will expire (90  
28 days after the date you received the writ). You should make no payments under the second writ  
29 until expiration of the first writ. The expiration date of the second writ is 90 days after the date  
30 you received the second writ; the expiration date is not affected by any delay in payment attribut-  
31 able to the priority of the first writ.

32

33 STEP 2. DELIVER THE GARNISHEE RESPONSE.

34

35 You must deliver your Garnishee Response and copies of the response in the manner provided  
36 in this step. The response and copies may be mailed or delivered personally.

37

38 You must complete and deliver the Garnishee Response within seven calendar days after you  
39 receive the writ of garnishment. If the seventh calendar day is a Saturday, Sunday or legal holiday,  
40 you must deliver your response on or before the next following day that is not a Saturday, Sunday  
41 or legal holiday.

42

43 If you are required to hold any property under the writ or make any payment under the writ,  
44 either at the time of making your response or later, you must:

45 (a) Send the original of your Garnishee Response to the Garnishor at the address indicated on

1 the writ under Important Addresses.

2 (b) Send a copy of your Garnishee Response to the court administrator at the address indicated  
3 on the writ under Important Addresses.

4 (c) Send a copy of your Garnishee Response to the Debtor if an address is indicated on the writ  
5 under Important Addresses.

6  
7 If you are not required to hold any property under the writ or make any payment under the  
8 writ, either at the time of making your response or later, you must:

9 (a) Send the original of your Garnishee Response to the Garnishor at the address indicated on  
10 the writ under Important Addresses.

11 (b) Send a copy of your Garnishee Response to the Debtor if an address is indicated on the writ  
12 under Important Addresses.

13  
14 STEP 3. DELIVER THE FUNDS OR OTHER PROPERTY.

15  
16 As long as the writ is in effect, you may be liable to the Creditor if you pay any debt or turn  
17 over any property to the Debtor except as specifically allowed by law. If you have any money or  
18 property of the Debtor in your possession, control or custody at the time of delivery of the writ, or  
19 owe any debt to the Debtor, you must pay the money or hold the property as required by this step.  
20 Exceptions to this requirement are listed below.

21  
22 IF YOU ARE HOLDING MONEY FOR THE DEBTOR OR OWE A DEBT THAT IS CUR-  
23 RENTLY DUE, you must pay the money to the Garnishor with your response. You must send your  
24 payment to the Garnishor at the address indicated on the writ under Important Addresses. Make  
25 your check payable to the Garnishor.

26  
27 IF YOU OWE A DEBT TO THE DEBTOR THAT WILL BECOME DUE WITHIN 45 DAYS  
28 AFTER THE DATE YOU RECEIVED THE WRIT, you must send your payment directly to the  
29 Garnishor at the address provided in the writ when the debt becomes due. Make your check payable  
30 to the Garnishor.

31  
32 IF YOU ARE HOLDING PROPERTY THAT BELONGS TO THE DEBTOR, OR OWE A DEBT  
33 TO THE DEBTOR THAT WILL NOT BECOME DUE WITHIN 45 DAYS AFTER THE DATE YOU  
34 RECEIVED THE WRIT, you must keep the property or debt in your possession, control or custody  
35 until you receive written notice from the Sheriff. The Sheriff's notice will tell you what to do with  
36 the property or debt. If you have followed all of the instructions in the writ and you receive no  
37 notice from the Sheriff within 30 days after the date on which you delivered your Garnishee Re-  
38 sponse, you may treat the writ as being of no further force or effect.

39  
40 EXCEPTIONS:

41  
42 1. Challenge to garnishment or specific directions from court. If you are making any payments  
43 under the garnishment and before making a payment you receive notice of a challenge to the  
44 garnishment from the court, or receive a specific direction from the court to make payments to the  
45 court, you must send or deliver the payment directly to the court administrator. If the money is

1 currently due when you receive the notice, send the payment promptly to the court. If the payment  
2 is for a debt that is payable within 45 days after you receive the writ, make the payment to the  
3 court promptly when it becomes due. If you make payment by check, make the check payable to the  
4 State of Oregon. Because you may be liable for any payment that does not reach the court, it is  
5 better not to send cash by mail.

6 A challenge to the garnishment does not affect your duty to follow the instructions you receive  
7 from the Sheriff for property that belongs to the Debtor and debts that you owe to the Debtor that  
8 do not become due within 45 days.

9  
10 2. Previous writ of garnishment. If you receive a second writ of garnishment for the same Debtor  
11 from another Garnishor, the first writ will have priority and you need not make payments or deliver  
12 property under the second writ to the extent that compliance with the first writ will reduce or  
13 eliminate the payment of money or delivery of property that you would otherwise make under the  
14 garnishment. You must still deliver a Garnishee Response to the second writ, and must commence  
15 payment under the second writ as soon as the first writ is satisfied or expires.

16  
17 3. Offset for payment of underlying lien. If you owe a debt to the Debtor and the Debtor owes  
18 a debt to the holder of an underlying lien on your property, you may be able to offset the amount  
19 payable to the underlying lienholder. See ORS 18.620.

20  
21 4. Subsequent events:

22  
23 (a) Bankruptcy. If you make your response and then discover that a voluntary or involuntary  
24 bankruptcy petition has been filed by or on behalf of the Debtor after the judgment was entered  
25 against the Debtor or after the debt otherwise became subject to garnishment (see date in writ), you  
26 may not make any further payments or delivery of property under the writ unless the court orders  
27 otherwise. If you have not delivered all property that is subject to garnishment under this writ when  
28 you discover that a bankruptcy petition has been filed, you must mail the following notice to the  
29 Garnishor and to the Debtor.

30  
31 (b) Order to withhold income. If you make your response and then receive an order to withhold  
32 income that has priority over the writ, you may make payments or deliver property under the writ  
33 only after payment of the amounts required under the order to withhold income. If you have not  
34 delivered all property that is subject to garnishment under this writ when you receive an order to  
35 withhold income that has priority, you must mail the following notice to the Garnishor and to the  
36 Debtor.

23 **child support or spousal support obligation or a judgment that contains a money award of**  
24 **restitution, you must provide the Debtor with full customary access to all payments listed**  
25 **in (4) above that were made by direct deposit or electronic transfer to an account within the**  
26 **lookback period the Debtor has with your institution.**

27  
28 If the Garnishor fails to pay the search fee required by ORS 18.790 and you do not employ the  
29 Debtor, you are not required to deliver a Garnishee Response and you may deal with any property  
30 of the Debtor as though the garnishment had not been issued.

31  
32 If the Debtor owes a debt to you that was due at the time you received the writ of garnishment,  
33 you may be able to offset the amount of that debt. See ORS 18.795. You must note that you have  
34 made the offset in Part I of the Garnishee Response (under "Other") and specify the amount that  
35 was offset.

36  
37 Before making a payment under the writ, you may first deduct any processing fee that you are  
38 allowed under ORS 18.790. If you are required to conduct a garnishment account review, you may  
39 not charge or collect a processing fee against any amount that is not subject to garnishment, and  
40 may not charge or collect a garnishment processing fee against any amounts in the account after  
41 the date that you conduct the review.

42  
43 You need not deliver any property contained in a safe deposit box unless the Garnishor pays  
44 you in advance for the costs that will be incurred in gaining entry to the box. See ORS 18.792.

1 If you are required to conduct a garnishment account review and you determine from the review  
2 that one or more of the payments listed in ORS [18.784 (3)] **18.785 (2)(c)(B)** have been deposited into  
3 the Debtor’s account by direct deposit or electronic payment during the lookback period described  
4 in ORS [18.784 (2)] **18.785 (2)(d)**, and that there is a positive balance in the account, you must issue  
5 a notice to the account holder in substantially the form set forth in ORS 18.847. The notice must  
6 be issued directly to the account holder or to a fiduciary who administers the account and receives  
7 communications on behalf of the account holder. The notice must be sent separately to the account  
8 holder and may not be included with other materials being provided to the account holder that do  
9 not relate to the garnishment. You must send the notice to the account holder within three business  
10 days after you complete the garnishment account review. You may issue one notice with information  
11 related to multiple accounts of a single account holder.

45 initial calculation changes. Finally, you must fill out and return a Wage Exemption Calculation form

3 Normal wage exemption. The wage exemption calculation is based on the amount of the payment  
4 you make under the writ of garnishment. The normal wage exemption in Line 4 is 75 percent of the  
5 employee's disposable wages in Line 3.

7 Minimum wage exemption. The minimum exemption in Line 5 is also based on the amount of the  
8 payment you are making. The minimum exemption is designed to ensure that an employee receives  
9 at least a certain minimum amount in any one-week period. *[If the payment is for a one-week period*  
10 *(without regard to whether the period is a calendar week or any other seven-day period), the minimum*  
11 *exemption is \$254. The minimum exemption is \$509 if the payment is for a two-week period. If the*

11 will be for all wages for the month of October, but the amounts withheld under the first  
12 writ must be subtracted on Line 8 to determine the October wages subject to garnishment

3       nearest dollar).

5       You **must** use this same calculation for computing the minimum exemption when making  
6       a payment for less than a full pay period (e.g., for the final payment at the end of the 90-day  
7       period covered by the writ).

9       **Example 2:** You pay Debtor A on a monthly basis. You are required to make a final  
10      payment under a writ of garnishment for the wages owing to Debtor A for the period  
11      beginning October 1 and ending October 15. This period is equal to 2.143 weeks (15  
12      divided by 7). The minimum exemption is \$544 ( $\$254 \times 2.143$  rounded to the nearest  
13      dollar).

14  
15      The amount of time actually worked by the Debtor during the period covered by the  
16      paycheck does **not** affect the calculation of the minimum exemption.

18      **Example 3:** You pay Debtor A on a weekly basis. Debtor A works two days per week.  
19      The minimum exemption is \$254 for each weekly payment you make for Debtor A.

20  
21      If the payment you are making is based on a period of time less than one week, the  
22      minimum wage exemption may not exceed \$254 for any one-week period.

24      If you receive more than one writ of garnishment. If you receive more than one writ of  
25      garnishment for the same debtor, the writs have priority based on the date on which you  
26      receive them. If the full amount of wages subject to garnishment for a given pay period is  
27      paid on the first writ, you should not make any payment on subsequently received writs until  
28      the first writ expires. In some cases, it may be necessary to make payments on two or more

31      **Example 4:** You have received two writs of garnishment for Debtor A. You pay Debtor  
32      A on a monthly basis. The first writ expires on October 16. The second writ will not  
33      expire until November 15. You will need to prepare two wage exemption calculation  
34      forms for Debtor A's October wages and make payments under both writs. The wage  
35      exemption calculation form for the first writ will be for the wages attributable to  
36      October 1 to October 15 as described in Example 2. The wage exemption calculation  
37      form for the second writ will be for all wages for the month of October, but the  
38      amounts withheld under the first writ must be subtracted on Line 8 to determine the  
39      October wages subject to garnishment under the second writ.

42      **SECTION 17.** ORS 18.845 is amended to read:

43      18.845. **Except as provided in section 19 of this 2024 Act,** a notice of exemptions form must  
44      be in substantially the form set forth in this section. Nothing in the notice form described in this  
45      section is intended to expand or restrict the law relating to exempt property. A determination as

1 to whether property is exempt from execution, attachment and garnishment must be made by refer-  
2 ence to other law. The form provided in this section may be modified to provide more information  
3 or to update the notice based on subsequent changes in exemption laws.

1 vided for in ORS 18.790, all reasonable costs incurred by the garnishee in gaining entry to the safe  
2 deposit box. The costs shall be paid to the garnishee by the state agency or the county tax collector  
3 at least five days before the date the state agency or the county tax collector takes possession of  
4 the property in the safe deposit box. If the state agency or the county tax collector fails to pay such  
5 costs to the garnishee within 20 days after the delivery of the garnishee response, the garnishment  
6 shall not be effective to garnish any property of the debtor that may be contained in the safe deposit

18 **(19) One rifle or shotgun and one pistol. The combined value of all firearms claimed as**  
19 **exempt may not exceed \$1,000.**

20 **(20) Public or private pensions.**

21 **(21) Veterans' benefits and loans.**

22 **(22) Medical assistance benefits.**

23 **(23) Health insurance proceeds and disability proceeds of life insurance policies.**

24 **(24) Cash surrender value of life insurance policies not payable to your estate.**

25 **(25) Federal annuities.**

26 **(26) Other annuities to \$250 per month (excess over \$250 per month is subject to the same**  
27 **exemption as wages).**

28 **(27) Professionally prescribed health aids for you or any of your dependents.**

29 **\*(28) Rental assistance to an elderly person allowed pursuant to ORS 458.375.**

30 **\*(29) Your right to receive, or property traceable to:**

31 **\*(a) An award under any crime victim reparation law.**

32 **\*(b) A payment or payments, not exceeding a total of \$10,000, on account of personal**  
33 **bodily injury suffered by you or an individual of whom you are a dependent.**

34 **\*(c) A payment in compensation of loss of future earnings of you or an individual of**  
35 **whom you are or were a dependent, to the extent reasonably necessary for your support and**  
36 **the support of any of your dependents.**

37 **(30) Amounts paid to you as an earned income tax credit under federal tax law.**

38 **(31) Your right to the assets held in, or right to receive payments under, a medical**  
39 **savings account or health savings account authorized under section 220 or 223 of the Internal**  
40 **Revenue Code.**

41 **(32) Interest in personal property to the value of \$400, but this cannot be used to increase**  
42 **the amount of any other exemption.**

43 **(33) Equitable interests in property.**

44 **Note: If two or more people in your household owe the claim or judgment, each of them**  
45 **may claim the exemptions marked by an asterisk (\*).**

3       **SPECIAL RULES APPLY FOR DEBTS THAT ARE OWED FOR CHILD SUPPORT AND**  
4 **SPOUSAL SUPPORT. Some property that may not otherwise be taken for payment against**  
5 **the debt may be taken to pay for overdue support. For instance, Social Security benefits,**  
6 **workers' compensation benefits, unemployment benefits, veterans' benefits and pensions are**  
7 **normally exempt, but only 50 percent of a lump sum payment of these benefits is exempt if**  
8 **the debt is owed for a support obligation.**

11       **SECTION 28.** ORCP 84 D is amended to read:

12       D Writ of attachment.

13       D(1) Issuance; contents; to whom directed; issuance of several writs. If directed by an order  
14 authorizing provisional process under Rule 83, the clerk shall issue a writ of attachment. The writ  
15 shall be directed to the sheriff of any county in which property of the defendant may be, and shall  
16 require the sheriff to attach and safely keep all the property of the defendant within the county not  
17 exempt from execution, or so much thereof as may be sufficient to satisfy the plaintiff's demand, the  
18 amount of which shall be stated in conformity with the complaint, together with costs and expenses.  
19 Several writs may be issued at the same time to the sheriffs of different counties.

20       D(2) Manner of executing writ. The sheriff to whom the writ is directed and delivered shall note  
21 upon the writ the date of such delivery, and shall execute the writ without delay, as follows:

22       D(2)(a) Personal property not in possession of third party. Tangible personal property not in the  
23 possession of a third person shall be attached by taking it into the sheriff's custody. If any property  
24 attached is perishable, or livestock, where the cost of keeping is great, the sheriff shall sell the same  
25 in the manner in which property is sold on execution. The proceeds thereof and other property at-  
26 tached shall be retained by the sheriff to answer any judgment that may be recovered in the action,  
27 unless sooner subjected to execution upon another judgment. Plaintiff's lien shall attach when the  
28 property is taken into the sheriff's custody.

29       D(2)(b) Other personal property. Tangible and intangible personal property in the possession,  
30 control or custody of or debts or other monetary obligations owing by a third person shall be at-  
31 tached by writs of garnishment issued by the clerk of a court or by an attorney as provided in ORS  
32 18.600 to 18.850.

33       D(3) Notice to defendant. After taking property into custody under subsection (2)(a) of this sec-  
34 tion, the sheriff shall promptly mail or deliver to the defendant, at the last-known address of the  
35 defendant, a copy of the writ of attachment, a copy of the claim of lien filed pursuant to section C  
36 of this rule, if any, a notice of exemptions form provided by ORS 18.845 **or section 19 of this 2024**  
37 **Act, as appropriate**, and a challenge to garnishment form provided by ORS 18.850. The sheriff may  
38 meet the requirements of this subsection by mailing the documents to the last-known address of the  
39 defendant as provided by the plaintiff. The sheriff may withhold execution of the writ until the  
40 plaintiff provides such address or a statement that the plaintiff has no knowledge of the defendant's  
41 address. The sheriff shall have no duty under this subsection if the plaintiff provides a statement  
42 that the plaintiff has no knowledge of the defendant's address.

43       D(4) Return of writ; inventory. When the writ of attachment has been fully executed or dis-  
44 charged, the sheriff shall return the same, with the sheriff's proceedings indorsed thereon, to the  
45 clerk of the court where the action was commenced, and the sheriff shall make a full inventory of



1 the property attached and return the same with the writ.

2 D(5) Indemnity to sheriff. Whenever a writ of attachment is delivered to the sheriff, if the sheriff  
3 has actual notice of any third party claim to the personal property to be levied on or is in doubt  
4 as to ownership of the property, or of encumbrances thereon, or damage to the property held that  
5 may result by reason of its perishable character, such sheriff may require the plaintiff to file with  
6 the sheriff a surety bond, indemnifying the sheriff and the sheriff's bondsmen against any loss or  
7 damage by reason of the illegality of any holding or sale on execution, or by reason of damage to  
8 any personal property held under attachment. Unless a lesser amount is acceptable to the sheriff,  
9 the bond shall be in double the amount of the estimated value of the property to be seized.

10 **SECTION 29.** ORS 646.639 is amended to read:

11 646.639. (1) As used in this section and ORS 646A.670:

12 (a) "Charged-off debt" means a debt that a creditor treats as a loss or expense and not as an  
13 asset.

14 (b) "Consumer" means a natural person who purchases or acquires property, services or credit  
15 for personal, family or household purposes.

16 (c) "Consumer transaction" means a transaction between a consumer and a person that sells,  
17 leases or provides property, services or credit to consumers.

18 (d) "Credit" means a right that a creditor grants to a consumer to defer payment of a debt, to  
19 incur a debt and defer payment of the debt, or to purchase or acquire property or services and defer  
20 payment for the property or services.

21 (e) "Creditor" means a person that, in the ordinary course of the person's business, engages in  
22 consumer transactions that result in a consumer owing a debt to the person.

23 (f) "Debt" means an obligation or alleged obligation that arises out of a consumer transaction.

24 (g)(A) "Debt buyer" means a person that regularly engages in the business of purchasing  
25 charged-off debt for the purpose of collecting the charged-off debt or hiring another person to collect  
26 or bring legal action to collect the charged-off debt.

27 (B) "Debt buyer" does not include a person that acquires charged-off debt as an incidental part  
28 of acquiring a portfolio of debt that is predominantly not charged-off debt.

29 (h) "Debt collector" means a person that by direct or indirect action, conduct or practice col-  
30 lects or attempts to collect a debt owed, or alleged to be owed, to a creditor or debt buyer.

31 (i) "Debtor" means a consumer who owes or allegedly owes a debt, including a consumer who  
32 owes an amount that differs from the amount that a debt collector attempts to collect or that a debt  
33 buyer purchased or attempts to collect.

34 (j) "Legal action" means a lawsuit, mediation, arbitration or any other proceeding in any court,  
35 including a small claims court.

36 (k) "Original creditor" means the last entity that extended credit to a consumer to purchase  
37 goods or services, to lease goods or as a loan of moneys.

38 (L) "Person" means an individual, corporation, trust, partnership, incorporated or  
39 unincorporated association or any other legal entity.

40 (2) A debt collector engages in an unlawful collection practice if the debt collector, while col-  
41 lecting or attempting to collect a debt, does any of the following:

42 (a) Uses or threatens to use force or violence to cause physical harm to a debtor or to the  
43 debtor's family or property.

44 (b) Threatens arrest or criminal prosecution.

45 (c) Threatens to seize, attach or sell a debtor's property if doing so requires a court order and

1 the debt collector does not disclose that seizing, attaching or selling the debtor's property requires  
2 prior court proceedings.

3 (d) Uses profane, obscene or abusive language in communicating with a debtor or the debtor's  
4 family.

5 (e) Communicates with a debtor or any member of the debtor's family repeatedly or continuously  
6 or at times known to be inconvenient to the debtor or any member of the debtor's family and with  
7 intent to harass or annoy the debtor or any member of the debtor's family.

8 (f) Communicates or threatens to communicate with a debtor's employer concerning the nature  
9 or existence of the debt.

10 (g) Communicates without a debtor's permission or threatens to communicate with the debtor  
11 at the debtor's place of employment if the place of employment is other than the debtor's residence,  
12 except that the debt collector may:

13 (A) Write to the debtor at the debtor's place of employment if a home address is not reasonably  
14 available and if the envelope does not reveal that the communication is from a debt collector other  
15 than the person that provided the goods, services or credit from which the debt arose.

16 (B) Telephone a debtor's place of employment without informing any other person of the nature  
17 of the call or identifying the caller as a debt collector but only if the debt collector in good faith  
18 has made an unsuccessful attempt to telephone the debtor at the debtor's residence during the day  
19 or during the evening between the hours of 6 p.m. and 9 p.m. The debt collector may not contact  
20 the debtor at the debtor's place of employment more frequently than once each business week and  
21 may not telephone the debtor at the debtor's place of employment if the debtor notifies the debt  
22 collector not to telephone at the debtor's place of employment or if the debt collector knows or has  
23 reason to know that the debtor's employer prohibits the debtor from receiving such communication.  
24 For the purposes of this subparagraph, any language in any agreement, contract or instrument that  
25 creates or is evidence of the debt and that purports to authorize telephone calls at the debtor's place  
26 of employment does not give permission to the debt collector to call the debtor at the debtor's place  
27 of employment.

28 (h) Communicates with a debtor in writing without clearly identifying the name of the debt  
29 collector, the name of the person, if any, for whom the debt collector is attempting to collect the  
30 debt and the debt collector's business address, on all initial communications. In subsequent commu-  
31 nications involving multiple accounts, the debt collector may eliminate the name of the person, if  
32 any, for whom the debt collector is attempting to collect the debt and substitute the term  
33 "various" in place of the person's name.

34 (i) Communicates with a debtor orally without disclosing to the debtor, within 30 seconds after  
35 beginning the communication, the name of the individual who is initiating the communication and  
36 the true purpose of the communication.

37 (j) Conceals the true purpose of the communication so as to cause any expense to a debtor in  
38 the form of long distance telephone calls, telegram fees, additional charges for wireless communi-  
39 cation or other charges the debtor might incur by using a medium of communication.

40 (k) Attempts or threatens to enforce a right or remedy while knowing or having reason to know  
41 that the right or remedy does not exist, or threatens to take any action that the debt collector in  
42 the regular course of business does not take.

43 (L) Uses any form of communication that simulates legal or judicial process or that appears to  
44 be authorized, issued or approved by a governmental agency, governmental official or an attorney  
45 at law if the corresponding governmental agency, governmental official or attorney at law has not

1 in fact authorized or approved the communication.

2 (m) Represents that an existing debt may be increased by the addition of attorney fees, investi-  
3 gation fees or any other fees or charges if the fees or charges may not legally be added to the ex-  
4 isting debt.

5 (n) Collects or attempts to collect, **by any means, including through legal action**, interest or  
6 other charges or fees that exceed the actual debt unless the agreement, contract or instrument that  
7 creates the debt expressly authorizes, or a law expressly allows, the interest or other charges or  
8 fees. **A debt collector may not be held liable in any action brought under this paragraph if**  
9 **the debt collector shows by a preponderance of evidence that the violation was not inten-**  
10 **tional and resulted from a bona fide error notwithstanding the maintenance of procedures**  
11 **reasonably adapted to avoid any such error. The fact that the debt collector obtains a judg-**  
12 **ment for less than the amount sought in the complaint, or fails to obtain a judgment at all,**  
13 **does not by itself constitute evidence of a violation of this paragraph.**

14 (o) Threatens to assign or sell a debtor's account and misrepresents or implies that the debtor  
15 would lose any defense to the debt or would be subjected to harsh, vindictive or abusive collection  
16 tactics.

17 (p) Uses the seal or letterhead of a public official or a public agency, as those terms are defined  
18 in ORS 171.725.

19 (q) Collects or attempts to collect any debt that the debt collector knows, or after exercising  
20 reasonable diligence would know, arises from medical expenses that qualify for reimbursement under  
21 the Oregon Health Plan or under Medicaid, except that:

22 (A) The debt collector does not engage in an unlawful collection practice if the debt collector  
23 can produce an affidavit or certificate from the original creditor that shows that the original cred-  
24 itor complied with Oregon Health Authority rules barring payments for services that Medicaid fee-  
25 for-service plans or contracted health care plans cover; and

26 (B) For purposes of this paragraph, a prepaid managed care health services organization, a co-  
27 ordinated care organization or a public body, as defined in ORS 174.109, or an agent or assignee of  
28 the organization or public body, is not a debt collector if the organization or public body seeks to  
29 collect a debt that arises under ORS 416.540.

30 (r) Files a legal action to collect or files a legal action to attempt to collect a debt if the debt  
31 collector knows, or after exercising reasonable diligence would know, that an applicable statute of  
32 limitations bars the collection or the collection attempt.

33 *[(s) Knowingly collects any amount, including any interest fee, charge or expense incidental to the*  
34 *principal obligation, unless the amount is expressly authorized by the agreement creating the debt or*  
35 *permitted by law.]*

36 (s) **Collects or attempts to collect or threatens to collect a debt by any means, including**  
37 **through legal action, if the debt collector knows, or through the exercise of reasonable care**  
38 **should know, that the debt does not exist or is not owed by the debtor. A debt collector may**  
39 **not be held liable in any action brought under this paragraph if the debt collector shows by**  
40 **a preponderance of evidence that the violation was not intentional and resulted from a bona**  
41 **fide error notwithstanding the maintenance of procedures reasonably adapted to avoid any**  
42 **such error. The fact that the debt collector obtains a judgment for less than the amount**  
43 **sought in the complaint or fails to obtain a judgment at all does not by itself establish a vi-**  
44 **olation of this paragraph.**

45 (t) Collects or attempts to collect a debt if the debt collector is a debt buyer, or is acting on a

1 debt buyer's behalf, and collects or attempts to collect purchased debt before providing to a debtor,  
2 within 30 days after the date of the debtor's request, all of the documents listed in subsection (4)(b)  
3 of this section.

4 (u) Collects or attempts to collect a debt without complying with the requirements of ORS  
5 646A.677.

6 (3) A debt collector engages in an unlawful collection practice if the debt collector, by use of  
7 any direct or indirect action, conduct or practice, enforces or attempts to enforce an obligation  
8 made void and unenforceable by the provisions of ORS 759.720 (3) to (5).

9 (4) A debt buyer or debt collector acting on behalf of a debt buyer engages in an unlawful col-  
10 lection practice if the debt buyer or debt collector:

11 (a) Files legal action against a debtor or files legal action to attempt to collect a debt if the debt  
12 buyer or debt collector knows or after exercising reasonable diligence would know that an applica-  
13 ble statute of limitations bars the legal action to collect or the legal action to attempt to collect the  
14 debt;

15 (b) Brings a legal action against a debtor or otherwise brings a legal action to attempt to collect  
16 a debt without possessing business records that satisfy the requirements of ORS 40.460 (6), or of ORS  
17 24.115, if the record is a foreign judgment, that establish the nature and the amount of the debt and  
18 that include:

19 (A) The original creditor's name, written as the original creditor used the name in dealings with  
20 the debtor;

21 (B) The name and address of the debtor;

22 (C) The name, address and telephone number of the person that owns the debt and a statement  
23 as to whether the person is a debt buyer;

24 (D) The last four digits of the original creditor's account number for the debt, if the original  
25 creditor's account number for the debt had four or more digits;

26 (E) A detailed and itemized statement of:

27 (i) The amount the debtor last paid on the debt, if the debtor made a payment, and the date of  
28 the payment;

29 (ii) The amount and date of the debtor's last payment on the debt before the debtor defaulted  
30 or before the debt became charged-off debt;

31 (iii) The balance due on the debt on the date on which the debt became charged-off debt;

32 (iv) The amount and rate of interest, any fees and any charges that the original creditor im-  
33 posed, if the debt buyer or debt collector knows the amount, rate, fee or charge;

34 (v) The amount and rate of interest, any fees and any charges that the debt buyer or any pre-  
35 vious owner of the debt imposed, if the debt buyer or debt collector knows the amount, rate, fee or  
36 charge;

37 (vi) The attorney fees the debt buyer or debt collector seeks, if the debt buyer or debt collector  
38 expects to recover attorney fees; and

39 (vii) Any other fee, cost or charge the debt buyer seeks to recover;

40 (F) Evidence that the debt buyer and only the debt buyer owns the debt;

41 (G) The date on which the debt buyer purchased the debt; and

42 (H) A copy of the agreement between the original creditor and the debtor that is either:

43 (i) The contract or other writing the debtor signed that created and is evidence of the original  
44 debt; or

45 (ii) A copy of the most recent monthly statement that shows a purchase transaction or balance

1 transfer or the debtor's last payment, if the debtor made a payment, if the debt is a credit card debt  
2 or other debt for which a contract or other writing that is evidence of the debt does not exist;

3 (c) Fails to provide to a debtor, after the debt buyer or debt collector receives payment in cash  
4 or the debtor requests the receipt, a receipt that:

5 (A) Shows the name of the creditor or creditors for whom the debt buyer or debt collector re-  
6 ceived the payment and, if the creditor is not the original creditor, the account number that the  
7 original creditor assigned; and

8 (B) States clearly whether the debt buyer or debt collector accepts the payment as payment in  
9 full or as a full and final compromise of the debt and, if not, the balance remaining on the debt after  
10 the payment;

11 (d) Collects or attempts to collect a debt before providing, in response to a debtor's request, the  
12 documents required under paragraph (b) of this subsection. A debt buyer or a debt collector that  
13 acts on the debt buyer's behalf does not engage in an unlawful collection practice under this para-  
14 graph if the debt buyer or debt collector collects or attempts to collect a debt after providing the  
15 required documents to the debtor; or

16 (e) Uses any direct or indirect action, conduct or practice to violate a provision of this section  
17 or ORS 646A.670.

18 (5) A debt collector is not acting on a debt buyer's behalf, and is not subject to the duties to  
19 which a debt buyer is subject under this section and ORS 646A.670, if the debt collector collects or  
20 attempts to collect a debt on behalf of an owner that retains a direct interest in the debt or if the  
21 debt is not a debt that a debt buyer purchased.

22 **SECTION 30.** ORS 646.641 is amended to read:

23 646.641. (1) Any person injured as a result of willful use or employment by another person of  
24 an unlawful collection practice may bring an action in an appropriate court to enjoin the practice  
25 or to recover actual damages or [\$200] **\$1,000**, whichever is greater. The court or the jury may  
26 award punitive damages, and the court may provide such equitable relief as it deems necessary or  
27 proper.

28 (2) In any action brought by a person under this section, the court may award reasonable at-  
29 torney fees [*to the prevailing party*] **and costs at trial and on appeal to a prevailing plaintiff. The**  
30 **court may award reasonable attorney fees and costs at trial and on appeal to a prevailing**  
31 **defendant only if the court finds that the plaintiff had no objectively reasonable basis for**  
32 **bringing the action or asserting the ground for appeal.**

33 (3) Actions brought under this section shall be commenced within [*one year*] **three years** from  
34 the date of the injury.

38 18.838, 18.840, 18.845, 18.847, 18.854, 18.855, 18.888, 18.892 and 18.896 and ORCP 84 D by sections  
39 1 to 17, 20 to 25 and 28 of this 2024 Act and the repeal of ORS 18.784 by section 31 of this 2024  
40 Act:

41 (a) **Become operative on January 1, 2025; and**

42 (b) **Apply to writs of garnishment and writs of execution issued on or after January 1,**  
43 **2025, and to notices of wage garnishment that are in effect on or after January 1, 2025.**

44 (2) **An agency of state government, as defined in ORS 174.111, may take any action before**  
45 **the operative date specified in subsection (1) of this section to enable the agency to exercise,**

1 on and after the operative date specified in subsection (1) of this section, all of the duties,  
2 functions and powers conferred on the agency by sections 19 and 27 of this 2024 Act and the

7 **SECTION 33.** The amendments to ORS 646.639 and 646.641 by sections 29 and 30 of this  
8 2024 Act apply to attempts to collect a debt that occur on or after the effective date of this  
9 2024 Act.

10 **SECTION 34.** In addition to and not in lieu of any other appropriation, there is appro-  
11 priated to the Department of Revenue, for the biennium ending June 30, 2025, out of the  
12 General Fund, the amount of \$631,834, which may be expended to implement the changes to  
13 debt collection in this 2024 Act.

14 **SECTION 35.** Notwithstanding any other law limiting expenditures, the amount of  
15 \$229,729 is established for the biennium ending June 30, 2025, as the maximum limit for pay-  
16 ment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but  
17 excluding lottery funds and federal funds, collected or received by the Department of Re-  
18 venue, to implement the changes to debt collection in this 2024 Act.

19 **SECTION 36.** This 2024 Act being necessary for the immediate preservation of the public  
20 peace, health and safety, an emergency is declared to exist, and this 2024 Act takes effect  
21 on its passage.
