

## SENATE AMENDMENTS TO SENATE BILL 1595

1 On page 1 of the printed bill, line 5, delete “prescribing an effective date” and insert “declaring  
2 an emergency”.

3 Delete lines 7 through 26 and delete pages 2 through 59 and insert:

4 “**SECTION 1.** ORS 18.345 is amended to read:

5 “18.345. (1) All property **of a judgment debtor**, including franchises, or rights or interest  
6 [*therein, of the judgment debtor, shall be*] **in the judgment debtor’s property, is** liable to an exe-  
7 cution, except as provided in this section and in other statutes granting exemptions from execution.  
8 The following property **of the judgment debtor**, or rights or interest [*therein of the judgment*  
9 *debtor*] **in the property**, except as provided in ORS 18.305, [*shall be*] **is** exempt from execution:

10 “(a) Books, pictures and musical instruments to the value of \$600.

11 “(b) Wearing apparel, jewelry and other personal items to the value of \$1,800.

12 “(c) The tools, implements, apparatus, team, harness or library, necessary to enable the judg-  
13 ment debtor to carry on the trade, occupation or profession by which the judgment debtor habitually  
14 earns a living, to the value of \$5,000.

15 “[*(d) A vehicle to the value of \$3,000. As used in this paragraph ‘vehicle’ includes an automobile,*  
16 *truck, trailer, truck and trailer or other motor vehicle.*]

17 “**(d)(A) A vehicle, including an automobile, truck, trailer, truck and trailer or other mo-**  
18 **tor vehicle, to the value of \$10,000; or**

19 “**(B) If the judgment debtor owes a debt that arises out of a child support or spousal**  
20 **support obligation or a money award judgment that includes restitution, a vehicle, including**  
21 **an automobile, truck, trailer, truck and trailer or other motor vehicle, to the value of \$3,000.**

22 “(e) Domestic animals and poultry kept for family use, to the total value of \$1,000 and food  
23 sufficient to support such animals and poultry for 60 days.

24 “(f) Household goods, furniture, radios, a television set and utensils all to the total value of  
25 \$3,000, if the judgment debtor holds the property primarily for the personal, family or household use  
26 of the judgment debtor; provisions actually provided for family use and necessary for the support  
27 of a householder and family for 60 days and also 60 days’ supply of fuel.

28 “(g) All property of the state or any county or incorporated city therein, or of any other public  
29 or municipal corporation of like character.

30 “(h) All professionally prescribed health aids for the **judgment** debtor or a dependent of the  
31 **judgment** debtor.

32 “(i) Spousal support, child support, or separate maintenance to the extent reasonably necessary  
33 for the support of the **judgment** debtor and any dependent of the **judgment** debtor.

34 “(j) The **judgment** debtor’s right to receive, or property that is traceable to, an award under  
35 any crime victim reparation law.

1 “(k) The **judgment** debtor’s right to receive, or property that is traceable to, a payment or  
2 payments, not to exceed a total of \$10,000, on account of personal bodily injury of the **judgment**  
3 debtor or an individual of whom the **judgment** debtor is a dependent.

4 “(L) The **judgment** debtor’s right to receive, or property that is traceable to, a payment in  
5 compensation of loss of future earnings of the **judgment** debtor or an individual of whom the  
6 **judgment** debtor is or was a dependent, to the extent reasonably necessary for the support of the  
7 **judgment** debtor and any dependent of the **judgment** debtor.

8 “(m) Veterans’ benefits and loans.

9 “(n) The **judgment** debtor’s right to receive an earned income tax credit under the federal tax  
10 laws and any moneys that are traceable to a payment of an earned income tax credit under the  
11 federal tax laws.

12 “(o) The **judgment** debtor’s right to the assets held in, or right to receive payments under, a  
13 medical savings account or health savings account authorized under section 220 or 223 of the  
14 Internal Revenue Code.

15 “(p) The **judgment** debtor’s interest, not to exceed \$400 in value, in any personal property.  
16 However, this exemption may not be used to increase the amount of any other exemption.

17 “(q) The **judgment** debtor’s right to receive a tax credit under ORS 315.273, and any moneys  
18 that are traceable to a payment of a tax credit under ORS 315.273.

19 “(2) If the property claimed by the judgment debtor as exempt is adjudicated by the court out  
20 of which the execution issued to be of a value in excess of that allowed by the appropriate para-  
21 graph of subsection (1) of this section, the officer seizing the property shall proceed to sell such  
22 property. Out of the proceeds of such sale, the officer shall deduct costs of sale and shall pay to  
23 the judgment debtor an amount equivalent to the value declared to be exempt by any of the para-  
24 graphs of subsection (1) of this section and shall apply the balance of the proceeds of sale on the  
25 execution. A sale may not be made under such execution unless the highest bid made exceeds the  
26 appropriate exemption claimed and allowed plus costs of sale. If no bid is received in excess of the  
27 value allowed by the appropriate paragraph of subsection (1) of this section, the costs of sale shall  
28 be borne by the judgment creditor.

29 “(3) If two or more members of a household are joint judgment debtors, each judgment debtor  
30 shall be entitled to claim the exemptions in subsection (1)(a), (b), (c), (d) and (p) of this section in  
31 the same or different properties. The exemptions provided by subsection (1)(a), (b), (c), (d), (j), (k) and  
32 (p) of this section, when claimed for jointly owned property, may be combined at the option of the  
33 **judgment** debtors.

34 “(4) Notwithstanding any other provision of law except ORS 657.855, if a writ of garnishment  
35 or other execution is issued to collect past due support as defined in ORS 18.600, 50 percent of un-  
36 employment compensation benefits, workers’ compensation benefits and other benefits paid to the  
37 **judgment** debtor by the United States, by the state or by a political subdivision of the state are  
38 exempt. The exemption related to unemployment compensation benefits provided by this subsection  
39 is subject to ORS 657.855. The exemption provided by this subsection applies without regard to  
40 whether the payment is made on a periodic basis or in a lump sum, including any lump sum payable  
41 pursuant to a settlement or judgment. Notwithstanding subsection (1)(k) of this section, if a payment  
42 is made under a settlement or judgment on account of personal bodily injury and the garnishment  
43 or other execution is issued to collect past due support as defined in ORS 18.600, the lesser of 50  
44 percent of the payment or \$7,500 is exempt.

45 “**SECTION 2.** ORS 18.348 is amended to read:

1 “18.348. (1) Funds that are exempt from execution under ORS 18.358, 18.385, 178.345, 238.445,  
2 344.580, 407.595, 411.760, 414.095, 655.530, 656.234, 657.855 and 748.207 remain exempt when deposited  
3 in an account in a financial institution as long as the exempt funds are reasonably identifiable.

4 “(2) Subsection (1) of this section does not apply to any accumulation of funds greater than  
5 \$7,500.

6 “(3) All funds that are exempt under federal law remain exempt when deposited in an account  
7 in a financial institution as long as the exempt funds are reasonably identifiable.

8 “(4) The application of subsections (1) and (3) of this section is not affected by the commingling  
9 of exempt and nonexempt funds in an account. For the purpose of identifying exempt funds in an  
10 account, first in, first out accounting principles shall be used.

11 “(5) The provisions of this section do not affect the duties of a garnishee with respect to  
12 amounts in accounts that are not subject to garnishment under ORS [18.784] **18.785**.

13 “**SECTION 3.** ORS 18.385 is amended to read:

14 “18.385. (1) Except as provided in this section, 75 percent of the disposable earnings of an indi-  
15 vidual are exempt from execution.

16 “(2) **Except as provided in subsection (6) of this section**, the disposable earnings of an indi-  
17 vidual are exempt from execution to the extent that payment under a garnishment would result in  
18 net disposable earnings for an individual of less than the following amounts:

19 “[*(a) \$254 for any period of one week or less;*]

20 “[*(b) \$509 for any two-week period;*]

21 “[*(c) \$545 for any half-month period;*]

22 “[*(d) \$1,090 for any one-month period; and*]

23 “[*(e) For any other period longer than one week, \$254 multiplied by that fraction produced by di-*  
24 *viding the number of days for which the earnings are paid by seven. The amount calculated under this*  
25 *paragraph must be rounded to the nearest dollar.*]

26 “(a) **For any period of one week or less:**

27 “(A) **For wages payable before January 1, 2025, \$254.**

28 “(B) **For wages payable on or after January 1, 2025, and before July 1, 2025, \$305.**

29 “(C) **For wages payable on or after July 1, 2025, and before July 1, 2026, \$338.**

30 “(D) **For wages payable on or after July 1, 2026, and before July 1, 2027, \$400.**

31 “(E) **For wages payable on or after July 1, 2027, the minimum wage specified in ORS**  
32 **653.025 (1), multiplied by 30.**

33 “(b) **For any two-week period:**

34 “(A) **For wages payable before January 1, 2025, \$509.**

35 “(B) **For wages payable on or after January 1, 2025, and before July 1, 2025, \$611.**

36 “(C) **For wages payable on or after July 1, 2025, and before July 1, 2026, \$675.**

37 “(D) **For wages payable on or after July 1, 2026, and before July 1, 2027, \$832.**

38 “(E) **For wages payable on or after July 1, 2027, the minimum wage specified in ORS**  
39 **653.025 (1), multiplied by 60.**

40 “(c) **For any half-month period:**

41 “(A) **For wages payable before January 1, 2025, \$545.**

42 “(B) **For wages payable on or after January 1, 2025, and before July 1, 2025, \$655.**

43 “(C) **For wages payable on or after July 1, 2025, and before July 1, 2026, \$737.**

44 “(D) **For wages payable on or after July 1, 2026, and before July 1, 2027, \$912.**

45 “(E) **For wages payable on or after July 1, 2027, the minimum wage specified in ORS**

1 **653.025 (1), multiplied by 65.**

2 **“(d) For any one-month period:**

3 **“(A) For wages payable before January 1, 2025, \$1,090.**

4 **“(B) For wages payable on or after January 1, 2025, and before July 1, 2025, \$1,309.**

5 **“(C) For wages payable on or after July 1, 2025, and before July 1, 2026, \$1,458.**

6 **“(D) For wages payable on or after July 1, 2026, and before July 1, 2027, \$1,792.**

7 **“(E) For wages payable on or after July 1, 2027, the minimum wage specified in ORS**  
8 **653.025 (1), multiplied by 130.**

9 **“(e) For any other period longer than one week:**

10 **“(A) The following amount multiplied by that fraction produced by dividing the number**  
11 **of days for which the earnings are paid by seven, rounded to the nearest dollar:**

12 **“(i) For wages payable before January 1, 2025, \$254.**

13 **“(ii) For wages payable on or after January 1, 2025, and before July 1, 2025, \$305.**

14 **“(iii) For wages payable on or after July 1, 2025, and before July 1, 2026, \$338.**

15 **“(iv) For wages payable on or after July 1, 2026, and before July 1, 2027, \$400.**

16 **“(B) For wages payable on or after July 1, 2027, the minimum wage specified in ORS**  
17 **653.025 (1), multiplied by 30 and multiplied again by that fraction produced by dividing the**  
18 **number of days for which the earnings are paid by seven. The amount calculated under this**  
19 **sub-paragraph must be rounded to the nearest dollar.**

20 **“(3) Beginning in 2027, the State Court Administrator shall calculate the exemption**  
21 **amounts specified in subsection (2) of this section each year on or before July 1 and shall**  
22 **publish the results of the calculations on the Judicial Department website. In making the**  
23 **calculations, the State Court Administrator shall round to the nearest dollar. The adjusted**  
24 **exemption amounts become effective on July 1 of the year in which the State Court Admin-**  
25 **istrator makes the calculation.**

26 **“[(3)] (4) If an individual is paid for a period shorter than one week[.]:**

27 **“(a) The exemption calculated under subsection (2) of this section may not exceed [254] the**  
28 **following amount for any one-week period[.]:**

29 **“(A) For wages payable before January 1, 2025, \$254.**

30 **“(B) For wages payable on or after January 1, 2025, and before July 1, 2025, \$305.**

31 **“(C) For wages payable on or after July 1, 2025, and before July 1, 2026, \$338.**

32 **“(D) For wages payable on or after July 1, 2026, and before July 1, 2027, \$400.**

33 **“(E) For wages payable on or after July 1, 2027, the minimum wage specified in ORS**  
34 **653.025 (1), multiplied by 30.**

35 **“(b) The exemption calculated under subsection (6) of this section may not exceed \$254.**

36 **“[(4)] (5) An employer shall deduct from the amount of disposable earnings determined to be**  
37 **nonexempt under subsections (1) [to (3)], (2) and (4) of this section any amounts withheld from the**  
38 **individual’s earnings for the same period of time under an order issued pursuant to ORS 25.378 or**  
39 **419B.408 or ORS chapter 110. The employer shall make payment under a garnishment only of those**  
40 **amounts remaining after the deduction is made.**

41 **“(6) If a writ of garnishment includes or is attached to a notice from a state or federal**  
42 **child support agency, or includes or is attached to an attestation that a debt arises out of a**  
43 **child support or spousal support obligation or a money award judgment that includes**  
44 **restitution, the individual’s disposable earnings are exempt only to the extent that payment**  
45 **under a garnishment would result in net disposable earnings for an individual of less than**

1 **the following amounts:**

2 **“(a) \$254 for any period of one week or less;**

3 **“(b) \$509 for any two-week period;**

4 **“(c) \$545 for any half-month period;**

5 **“(d) \$1,090 for any one-month period; and**

6 **“(e) For any other period longer than one week, \$254 multiplied by that fraction produced**  
7 **by dividing the number of days for which the earnings are paid by seven. The amount cal-**  
8 **culated under this paragraph must be rounded to the nearest dollar.**

9 “[5] (7) Subsections (1) to [(4)] (6) of this section do not apply to:

10 “(a) Any order of a court of bankruptcy.

11 “(b) Any debt due for federal tax.

12 “[6] (8) Subsections (2) to [(4)] (6) of this section do not apply to any debt due for state tax.  
13 Subsection (1) of this section does not apply to a debt due for state tax if a state agency issues a  
14 special notice of garnishment under ORS 18.855 (6).

15 “[7] (9) A court may not make, execute or enforce any order or process in violation of this  
16 section.

17 “[8] (10) Any waiver by an individual of the provisions of this section is void.

18 “[9] (11) An employer may not discharge any individual because the individual has had  
19 earnings garnished.

20 **“SECTION 4.** ORS 18.395 is amended to read:

21 **“18.395. (1)(a) Except as provided in paragraph (b) of this subsection, a homestead [shall**  
22 **be] is exempt from sale on execution, from the lien of every judgment and from liability in any form**  
23 **for the debts of the owner to the amount in value of [\$40,000] \$150,000, except as otherwise provided**  
24 **by law. The exemption [shall be] is effective without the necessity of a claim thereof by the judgment**  
25 **debtor. When two or more members of a household are judgment debtors whose interests in the**  
26 **homestead are subject to sale on execution, the lien of a judgment or liability in any form, their**  
27 **combined exemptions under this section shall not exceed [\$50,000] \$300,000.**

28 **“(b) A homestead is exempt from sale on execution, from the lien of every judgment and**  
29 **from liability in any form for the debts of the owner arising out of a child support or spousal**  
30 **support obligation or a money award judgment that includes restitution to the amount in**  
31 **value of \$40,000, except as otherwise provided by law. The exemption is effective without the**  
32 **necessity of a claim thereof by the judgment debtor. When two or more members of a**  
33 **household are judgment debtors whose interests in the homestead are subject to sale on ex-**  
34 **ecution, the lien of a judgment or liability in any form, their combined exemptions under this**  
35 **section shall not exceed \$50,000.**

36 **“(c) To qualify for the exemption under paragraph (a) or (b) of this subsection, the**  
37 **homestead must be the actual abode of and occupied by the owner, or the owner’s spouse, parent**  
38 **or child, but the exemption shall not be impaired by:**

39 “[a] (A) Temporary removal or temporary absence with the intention to reoccupy the same as  
40 a homestead;

41 “[b] (B) Removal or absence from the property; or

42 “[c] (C) The sale of the property.

43 **“(d)(A) The State Court Administrator shall index the amounts identified as exempt from**  
44 **execution under paragraph (a) of this subsection each year on or before July 1 to reflect in-**  
45 **creases or decreases in the cost of living for the previous calendar year, based on changes**

1 in the Consumer Price Index for All Urban Consumers, West Region (All Items), as published  
2 by the Bureau of Labor Statistics of the United States Department of Labor or a successor  
3 agency. The State Court Administrator shall publish the adjusted exemption limitations on  
4 the Judicial Department website. In adjusting the amounts, the State Court Administrator  
5 shall round to the nearest \$100, but shall use unrounded adjusted amounts to calculate the  
6 amounts of the exemptions during the succeeding year. The new amounts become effective  
7 on July 1 of the year in which the State Court Administrator makes the adjustment.

8 “(B) The indexing described in subparagraph (A) of this paragraph does not apply to the  
9 amount of any exemption specified for a debt that arises out of a child support or spousal  
10 support obligation or a money award judgment that includes restitution.

11 “(2) The exemption [shall extend] extends to the proceeds derived from [such sale to an amount  
12 not exceeding \$40,000 or \$50,000, whichever amount] selling the homestead in the amount that is  
13 applicable under subsection (1)(a) or (b) of this section, if the proceeds are held for a period not  
14 exceeding one year and held with the intention to procure another homestead therewith.

15 “(3) The exemption period under subsection [(1)(b) and (c)] (1)(c)(B) and (C) of this section [shall  
16 be] is one year from the removal, absence or sale, whichever occurs first.

17 “(4) When the owner of a homestead has been granted a discharge in bankruptcy or has con-  
18 veyed the homestead property, the value thereof, for the purpose of determining a leviable interest  
19 in excess of the homestead exemption, [shall be] is the value on the date of the petition in bank-  
20 ruptcy, whether the value is determined in the bankruptcy proceedings or not, or on the date the  
21 conveyance becomes effective, whichever [shall first occur] occurs first. However, with respect to  
22 judgments not discharged in the bankruptcy, or entered against the owner after discharge, the value  
23 on the effective date of conveyance [shall be] is controlling.

24 “(5) Except as provided in subsection (7) of this section, [no] a homestead that is the actual  
25 abode of and occupied by the judgment debtor, or that is the actual abode of and occupied by a  
26 spouse, dependent parent or dependent child of the judgment debtor, [shall] may not be sold on  
27 execution to satisfy a judgment that at the time of entry does not exceed \$3,000. However, such  
28 judgment [shall remain] remains a lien upon the real property, and the property may be sold on  
29 execution:

30 “(a) At any time after the sale of the property by the judgment debtor; and

31 “(b) At any time after the property is no longer the actual abode of and occupied by the judg-  
32 ment debtor or the spouse, dependent parent or dependent child of the judgment debtor.

33 “(6) The limitation on execution sales imposed by subsection (5) of this section is not impaired  
34 by temporary removal or temporary absence with the intention to reoccupy the property as a  
35 homestead.

36 “(7) The limitation on execution sales imposed by subsection (5) of this section does not apply  
37 if two or more judgments are owing to a single judgment creditor and the total amount owing to the  
38 judgment creditor, determined by adding the amount of each individual judgment as of the date the  
39 judgment was entered, is greater than \$3,000.

40 “(8) Upon the issuance of an order authorizing sale as required by ORS 18.904, and in conform-  
41 ance with subsection (5) of this section, the sheriff may proceed to sell the property. If the home-  
42 stead exemption applies, the sheriff shall pay the homestead owner out of the proceeds the [sum of  
43 \$40,000 or \$50,000, whichever is applicable,] applicable amount under subsection (1)(a) or (b) of  
44 this section and apply the balance of the proceeds on the execution. However, [no sale shall be  
45 made where the homestead ] the sheriff may not sell the homestead if an exemption applies unless

1 the sum bid for the homestead [*is in excess of the sum of the costs of sale and \$40,000 or \$50,000,*  
2 *whichever is applicable*] **exceeds the sum of the costs of the sale and the amount of the appli-**  
3 **cable exemption.** If no such bid is received, the **petitioner shall bear the** expense of the sale [*shall*  
4 *be borne by the petitioner*].

5 “(9) The homestead exemption provided by this section applies to a purchaser’s interest under  
6 a land sale contract, as defined by ORS 18.960.

7 “(10) The homestead exemption provided by this section applies to:

8 “(a) A floating home, as defined by ORS 830.700; and

9 “(b) A manufactured dwelling, as defined by ORS 446.003.

10 “**SECTION 5.** ORS 18.402 is amended to read:

11 “18.402. [*The homestead mentioned in ORS 18.395 shall consist*] **A homestead described in ORS**  
12 **18.395 consists,** when not located in any town or city laid off into blocks and lots, of any quantity  
13 of land not exceeding 160 acres, and when located in any such town or city, of any quantity of land  
14 not exceeding one block. However, a homestead under this section [*shall not exceed in value the sum*  
15 *of \$40,000 or \$50,000, whichever amount is applicable under*] **may not exceed in value the applica-**  
16 **ble amount specified in ORS 18.395 (1)(a) or (b).**

17 “**SECTION 6.** ORS 18.412 is amended to read:

18 “18.412. (1) At any time after the date of execution of an agreement to transfer the ownership  
19 of property in which a homestead exemption exists pursuant to ORS 18.395, the homestead owner  
20 or the owner’s transferee may give notice of intent to discharge the property from the judgment lien  
21 to a judgment creditor. Each notice [*shall*] **must** bear the caption of the action in which the judg-  
22 ment was recovered and [*shall*] **must**:

23 “(a) Identify the property and the judgment and state that the judgment debtor is about to  
24 transfer, or has transferred, the property and that the transfer is intended to discharge the property  
25 from any lien effect of the judgment;

26 “(b) State the fair market value of the property on the date of the notice or of any applicable  
27 petition in bankruptcy, whichever is applicable, and list the encumbrances against the property, in-  
28 cluding the nature and date of each encumbrance, the name of the encumbrancer and the amount  
29 presently secured by each encumbrance;

30 “(c) State that the property is claimed by the person giving the notice to be wholly exempt from  
31 the lien of the judgment or, if the value of the property exceeds the sum of the encumbrances  
32 specified as required under paragraph (b) of this subsection that are senior to the judgment lien and  
33 [*\$40,000 or \$50,000, whichever amount of the homestead exemption is applicable under*] **the applicable**  
34 **amount of the homestead exemption specified in ORS 18.395 (1)(a) or (b),** that the amount of the  
35 excess or the amount due on the judgment, whichever is less, will be deposited with the court ad-  
36 ministrator for the court in which the judgment was entered for the use of the judgment holder; and

37 “(d) Advise the holder of the judgment that the property may be discharged from any lien arising  
38 from the judgment, without further notice to the judgment creditor, unless prior to a specified date,  
39 which in no case may be earlier than 14 days after the date of mailing of the notice, the judgment  
40 creditor files objections and a request for a hearing on the matter as provided in ORS 18.415.

41 “(2) Each notice described by subsection (1) of this section [*shall*] **must** be sent by certified mail  
42 to the judgment creditor, as shown by the court records, at the judgment creditor’s present or last-  
43 known address according to the best knowledge of the person sending the notice. A copy of each  
44 notice, together with proof of mailing, may be filed with the court administrator for the court in  
45 which the judgment was entered and [*shall*] **must** be filed by the court administrator with the re-

1 cords and files of the action in which the judgment was recovered.

2 “**SECTION 7.** ORS 18.600 is amended to read:

3 “18.600. As used in ORS 18.600 to 18.850:

4 “(1) ‘Account’ means an account at a financial institution, including a master account or sub-  
5 account, to which an electronic payment may be directly routed.

6 “(2) ‘Check’ has the meaning given that term in ORS 73.0104.

7 “(3) ‘Creditor’ means a person to whom a debt is owed by a debtor.

8 “(4) ‘Debt’ means any monetary obligation for which a garnishment may be issued under ORS  
9 18.605.

10 “(5) ‘Debtor’ means a person whose property is being garnished for the purpose of paying a debt  
11 owed to a creditor.

12 “(6) ‘Federal benefit payment’ means:

13 “(a) A benefit payment from the United States Social Security Administration that is protected  
14 under 42 U.S.C. 407 and 1383(d)(1);

15 “(b) A benefit payment from the United States Department of Veterans Affairs that is protected  
16 under 38 U.S.C. 5301(a);

17 “(c) A benefit payment from the Railroad Retirement Board that is protected under 45 U.S.C.  
18 231m(a) and 352(e); or

19 “(d) A benefit payment from the United States Office of Personnel Management that is protected  
20 under 5 U.S.C. 8346 and 8470.

21 “(7) ‘Financial institution’ means a financial institution or trust company as those terms are  
22 defined in ORS 706.008.

23 “(8) ‘Garnishable property’ means all property described in ORS 18.615, but does not include:

24 “(a) Any property that is not subject to garnishment under ORS 18.618; and

23 INSTRUCTIONS TO GARNISHEE

24

25 Except as specifically provided in these instructions, you must complete and deliver the  
26 Garnishee Response within seven calendar days after you receive the writ of garnishment. If the  
27 writ does not comply with Oregon law, the writ is not effective to garnish any property of the  
28 Debtor, but you still must complete and deliver the Garnishee Response. You must complete and  
29 deliver the response even though you cannot determine from the writ whether you hold any property  
30 or owe any debt to the Debtor. If the seventh calendar day is a Saturday, Sunday or legal holiday,  
31 you must deliver your response on or before the next following day that is not a Saturday, Sunday  
32 or legal holiday.

33

34 The writ is not effective, and you need not make a Garnishee Response, if:

35

36 • You do not receive the writ within 60 days after the date of issuance shown on the face of  
37 the writ.

38

39 • You do not receive an original writ of garnishment or a copy of the writ.

40

41 Statutes that may affect your rights and duties under the writ can be found in ORS 18.600 to  
42 18.850.

43

44 NOTE: The Garnishor may be the Creditor, the attorney for the Creditor or some other person  
45 who is authorized by law to issue the writ of garnishment. See the writ to determine who the

1 Garnishor is.

2  
3 STEP 1. FILL OUT THE GARNISHEE RESPONSE.

4  
5 All garnishees who are required to deliver a garnishee response must fill in Part I of the  
6 Garnishee Response. Garnishees who employ the Debtor must also fill in Part II of the response.  
7 You should keep a copy of the response for your records.

8  
9 Completing Part I of the Garnishee Response. If you discover before you deliver your response  
10 that a bankruptcy petition has been filed by or on behalf of the Debtor, and the bankruptcy petition  
11 was filed after a judgment was entered against the Debtor or after the debt otherwise became sub-  
12 ject to garnishment (see the date specified in the writ), you must put a check by the appropriate  
13 statement in Part I. If a bankruptcy petition has been filed, you should not make any payments to  
14 the Garnishor unless the court orders otherwise. You need not complete any other part of the re-  
15 sponse, but you still must sign the response and deliver it in the manner described in Step 2 of these  
16 instructions.

17 In all other cases you must list in Part I all money and personal property of the Debtor that is  
18 in your possession, control or custody at the time of delivery of the writ. You must also list all debts  
19 that you owe to the Debtor, whether or not those debts are currently due (e.g., money loaned to you  
20 by the Debtor that is to be repaid at a later time).

21 If you are the employer of the Debtor at the time the writ is delivered to you, you must put a  
22 check by the appropriate statement in Part I. In addition, you must complete Part II of the response.

23 If you believe that you may hold property of the Debtor or that you owe a debt to the Debtor,  
24 but you are not sure, you must put a check by the appropriate statement and provide an explana-  
25 tion. When you find out what property you hold that belongs to the Debtor, or you find out whether  
26 you owe money to the Debtor and how much, you must prepare and deliver an amended response.  
27 You must do this even if you find out that you have no property of the Debtor or that you do not  
28 owe anything to the Debtor.

29 If you determine that the writ, on its face, does not comply with Oregon laws governing writs  
30 of garnishment, or if you are unable to determine the identity of the Debtor from the information  
31 in the writ, then the writ is not effective to garnish any property of the Debtor. You must put a  
32 check by the appropriate statement in Part I and provide an explanation. You still must complete  
33 the response and deliver the response in the manner described in Step 2 of these instructions.

34 If you have received an order to withhold income that applies to the income of the Debtor and  
35 that order has priority over the garnishment, and if compliance with the order will reduce or elim-  
36 inate the money or property that you would otherwise deliver under the garnishment, you must put  
37 a check by the appropriate statement in Part I. You still must fill out the remainder of the response  
38 and deliver the response in the manner described in Step 2 of these instructions. If you employ the  
39 Debtor, you still must complete Part II of the response.

40 If you receive notice of a challenge to the garnishment before you send your response, you must  
41 complete and deliver your response as otherwise required by these instructions. However, see Step  
42 3 of these instructions regarding payment of money or delivery of property after receipt of notice  
43 of a challenge to the garnishment.

44 If you owe a debt to the Debtor and the Debtor owes a debt to the holder of an underlying lien  
45 on your property, you may be able to offset the amount payable to the underlying lienholder. See

1 ORS 18.620. You must note that you have made the offset in Part I of the response (under  
2 “Other”) and specify the amount that was offset.

3  
4 Completing Part II of the Garnishee Response (employers only). You must fill in Part II of the  
5 response if you employ the Debtor on the date the writ of garnishment is delivered to you, or if you  
6 previously employed the Debtor and still owe wages to the Debtor on the date the writ is delivered  
7 to you.

8  
9 Wages affected. Except as provided below, the writ garnishes all wages that you owe to the  
10 Debtor for work performed before the date you received the writ, even though the wages will not  
11 be paid until a later date. The writ also garnishes all wages that are attributable to services per-  
12 formed during the 90-day period following the date you received the writ, even though you would  
13 not pay the Debtor for all or part of those services until after the end of the 90-day period. Wages  
14 subject to garnishment under the writ include all amounts paid by you as an employer, whether on  
15 an hourly, weekly or monthly basis, and include commission payments and bonuses.

16  
17 Example 1: Debtor A is employed by you and is paid a monthly salary on the first day of  
18 each month. You receive a writ of garnishment on July 17. The writ garnishes all wages  
19 that you owe to Debtor A for work performed on or before July 17. If Debtor A was paid  
20 on July 1 for services performed in the month of June, the writ garnishes Debtor A’s salary  
21 for the period beginning July 1 and ending October 15 (90 days after receipt of the writ).

22  
23 The writ does not garnish any wages you owe to a Debtor for a specific pay period if:

24 (a) The writ is delivered to you within two business days before the Debtor’s normal payday for  
25 the pay period;

26 (b) When the writ is delivered to you, the Debtor’s wages are paid by direct deposit to a finan-  
27 cial institution, or you use an independent contractor as payroll administrator for your payroll; and

28 (c) Before the writ was delivered to you, you issued instructions to the financial institution or  
29 the payroll administrator to pay the Debtor for the pay period.

30 If any wages are not garnishable by reason of the issuance of instructions to a financial insti-  
31 tution or a payroll administrator as described above, you must so note in the Garnishee Response.  
32 Thereafter, you must pay to the Garnishor all wages that are subject to garnishment that are at-  
33 tributable to services performed by the Debtor during the 90-day period following the date you re-  
34 ceived the writ.

35  
36 Calculation of wages subject to garnishment. A Wage Exemption Calculation form is attached  
37 to the writ of garnishment. You must use this form to calculate the amount of the Debtor’s wages  
38 that is subject to garnishment. You should read the instructions printed on the Wage Exemption  
39 Calculation form to determine the normal wage exemption and the minimum wage exemption for  
40 each payment you make under the writ.

41 A Wage Exemption Calculation form must be sent with the first payment you make under the  
42 writ. For the 90-day period during which the writ is effective, you must also fill out and return a  
43 Wage Exemption Calculation form with a subsequent payment any time the initial calculation  
44 changes. Finally, you must fill out and return a Wage Exemption Calculation form with the final  
45 payment that you make under the writ.

1        Payment of amount subject to garnishment. Payments under the writ must be made at the fol-  
2        lowing times, unless the amount owing on the judgment or other debt is fully paid before the final  
3        payment is made or the writ is released:

4        (a) You must make a payment to the Garnishor of all wages subject to garnishment at the time  
5        you next pay wages to the Debtor. Complete the wage exemption computation, using the Wage Ex-  
6        emption Calculation form, to determine the portion of the Debtor's wages that is subject to  
7        garnishment. Be sure to adjust the minimum exemption amount for any payment that covers less  
8        than a full pay period. You must include a copy of the Wage Exemption Calculation form with this  
9        first payment.

10

11        Example 2: Using the facts given in Example 1, when you next make any payment of wages  
12        to Debtor A after you receive the writ on July 17, you must complete the Wage Exemption  
13        Calculation form and send the form to the Garnishor along with all amounts determined to  
14        be subject to garnishment that are attributable to the period covered by the payment. If you  
15        pay Debtor A on August 1, the payment will be for all wages attributable to the period be-  
16        ginning July 1 and ending July 31.

17

18        (b) Unless the writ of garnishment is satisfied or released, during the 90-day period following the  
19        date you received the writ, you must pay to the Garnishor all wages that are determined to be  
20        subject to garnishment whenever you issue a paycheck to the Debtor. If the Debtor is paid on a  
21        weekly basis, you must make payment under the writ on a weekly basis. If the Debtor is paid on a  
22        monthly basis, you must make payment under the writ on a monthly basis. If the amount paid to the  
23        Debtor varies from paycheck to paycheck, or changes at any time from the amount being paid at the  
24        time the writ was delivered to you, you must perform a new wage exemption computation to deter-  
25        mine the amount of wages subject to garnishment under the writ. You must send a copy of the new  
26        Wage Exemption Calculation form with your payment to the Garnishor.

27

28        Example 3: Using the facts given above, as you make each subsequent payment of wages to  
29        Debtor A you must make a payment of that portion of the Debtor's wages that are subject  
30        to garnishment. If you continue to pay Debtor A on the first of each month, payments must  
31        be made on September 1 and October 1.

32

33        (c) Upon the expiration of the 90-day period, you must make a final payment to the Garnishor  
34        for all wages that were owing to the Debtor for the work performed by the Debtor through the 90th  
35        day following your receipt of the writ. This payment may be made at the time of the Debtor's next  
36        paycheck. You will need to complete another Wage Exemption Calculation form to determine the  
37        amount of the wages subject to garnishment.

38

39        Example 4: Using the facts given above, you must make a final payment for the wages owing  
40        to Debtor A for the period beginning October 1 and ending October 15. You may make this  
41        payment at the time you issue Debtor A's paycheck on November 1, but you must make the  
42        payment at any time you issue a paycheck to Debtor A after October 15. Be sure that in  
43        completing the wage exemption computation for the final payment you adjust the minimum  
44        exemption amount to take into account the fact that the period covered is only 15 days of  
45        the full month (see instructions on Wage Exemption Calculation form).

1        Processing fee. You may collect a \$2 processing fee for each week of wages, or fraction of a  
2 week of wages, for which a payment is made under the writ. The fee must be collected after you  
3 make the last payment under the writ. The fee must be withheld from the wages of the debtor, and  
4 is in addition to the amounts withheld for payment to the Garnishor under the writ or under any  
5 other writ you have received.

6  
7        If you receive more than one writ of garnishment. If you receive a second writ of garnishment  
8 for the same Debtor from another Garnishor, the first writ will have priority for wages. The priority  
9 of the first writ lasts for the 90-day period following delivery of that writ to you, or until the first  
10 writ is paid in full, whichever comes first. In your response to the second writ, you must put a check  
11 by the appropriate statement in Part II and indicate the date on which the first writ will expire (90  
12 days after the date you received the writ). You should make no payments under the second writ  
13 until expiration of the first writ. The expiration date of the second writ is 90 days after the date  
14 you received the second writ; the expiration date is not affected by any delay in payment attribut-  
15 able to the priority of the first writ.

16  
17        STEP 2. DELIVER THE GARNISHEE RESPONSE.

18  
19        You must deliver your Garnishee Response and copies of the response in the manner provided  
20 in this step. The response and copies may be mailed or delivered personally.

21  
22        You must complete and deliver the Garnishee Response within seven calendar days after you  
23 receive the writ of garnishment. If the seventh calendar day is a Saturday, Sunday or legal holiday,  
24 you must deliver your response on or before the next following day that is not a Saturday, Sunday  
25 or legal holiday.

26  
27        If you are required to hold any property under the writ or make any payment under the writ,  
28 either at the time of making your response or later, you must:

29        (a) Send the original of your Garnishee Response to the Garnishor at the address indicated on  
30 the writ under Important Addresses.

31        (b) Send a copy of your Garnishee Response to the court administrator at the address indicated  
32 on the writ under Important Addresses.

33        (c) Send a copy of your Garnishee Response to the Debtor if an address is indicated on the writ  
34 under Important Addresses.

35  
36        If you are not required to hold any property under the writ or make any payment under the  
37 writ, either at the time of making your response or later, you must:

38        (a) Send the original of your Garnishee Response to the Garnishor at the address indicated on  
39 the writ under Important Addresses.

40        (b) Send a copy of your Garnishee Response to the Debtor if an address is indicated on the writ  
41 under Important Addresses.

42  
43        STEP 3. DELIVER THE FUNDS OR OTHER PROPERTY.

44  
45        As long as the writ is in effect, you may be liable to the Creditor if you pay any debt or turn

1 over any property to the Debtor except as specifically allowed by law. If you have any money or  
2 property of the Debtor in your possession, control or custody at the time of delivery of the writ, or  
3 owe any debt to the Debtor, you must pay the money or hold the property as required by this step.  
4 Exceptions to this requirement are listed below.

5  
6 IF YOU ARE HOLDING MONEY FOR THE DEBTOR OR OWE A DEBT THAT IS CUR-  
7 RENTLY DUE, you must pay the money to the Garnishor with your response. You must send your  
8 payment to the Garnishor at the address indicated on the writ under Important Addresses. Make  
9 your check payable to the Garnishor.

10  
11 IF YOU OWE A DEBT TO THE DEBTOR THAT WILL BECOME DUE WITHIN 45 DAYS  
12 AFTER THE DATE YOU RECEIVED THE WRIT, you must send your payment directly to the  
13 Garnishor at the address provided in the writ when the debt becomes due. Make your check payable  
14 to the Garnishor.

15  
16 IF YOU ARE HOLDING PROPERTY THAT BELONGS TO THE DEBTOR, OR OWE A DEBT  
17 TO THE DEBTOR THAT WILL NOT BECOME DUE WITHIN 45 DAYS AFTER THE DATE YOU  
18 RECEIVED THE WRIT, you must keep the property or debt in your possession, control or custody  
19 until you receive written notice from the Sheriff. The Sheriff's notice will tell you what to do with  
20 the property or debt. If you have followed all of the instructions in the writ and you receive no  
21 notice from the Sheriff within 30 days after the date on which you delivered your Garnishee Re-  
22 sponse, you may treat the writ as being of no further force or effect.

23  
24 EXCEPTIONS:

25  
26 1. Challenge to garnishment or specific directions from court. If you are making any payments  
27 under the garnishment and before making a payment you receive notice of a challenge to the  
28 garnishment from the court, or receive a specific direction from the court to make payments to the  
29 court, you must send or deliver the payment directly to the court administrator. If the money is  
30 currently due when you receive the notice, send the payment promptly to the court. If the payment  
31 is for a debt that is payable within 45 days after you receive the writ, make the payment to the  
32 court promptly when it becomes due. If you make payment by check, make the check payable to the  
33 State of Oregon. Because you may be liable for any payment that does not reach the court, it is  
34 better not to send cash by mail.

35 A challenge to the garnishment does not affect your duty to follow the instructions you receive  
36 from the Sheriff for property that belongs to the Debtor and debts that you owe to the Debtor that  
37 do not become due within 45 days.

38  
39 2. Previous writ of garnishment. If you receive a second writ of garnishment for the same Debtor  
40 from another Garnishor, the first writ will have priority and you need not make payments or deliver  
41 property under the second writ to the extent that compliance with the first writ will reduce or  
42 eliminate the payment of money or delivery of property that you would otherwise make under the  
43 garnishment. You must still deliver a Garnishee Response to the second writ, and must commence  
44 payment under the second writ as soon as the first writ is satisfied or expires.

1        3. Offset for payment of underlying lien. If you owe a debt to the Debtor and the Debtor owes  
2 a debt to the holder of an underlying lien on your property, you may be able to offset the amount  
3 payable to the underlying lienholder. See ORS 18.620.

4  
5        4. Subsequent events:  
6

7        (a) Bankruptcy. If you make your response and then discover that a voluntary or involuntary  
8 bankruptcy petition has been filed by or on behalf of the Debtor after the judgment was entered  
9 against the Debtor or after the debt otherwise became subject to garnishment (see date in writ), you  
10 may not make any further payments or delivery of property under the writ unless the court orders  
11 otherwise. If you have not delivered all property that is subject to garnishment under this writ when  
12 you discover that a bankruptcy petition has been filed, you must mail the following notice to the  
13 Garnishor and to the Debtor.  
14

15        (b) Order to withhold income. If you make your response and then receive an order to withhold  
16 income that has priority over the writ, you may make payments or deliver property under the writ  
17 only after payment of the amounts required under the order to withhold income. If you have not  
18 delivered all property that is subject to garnishment under this writ when you receive an order to  
19 withhold income that has priority, you must mail the following notice to the Garnishor and to the  
20 Debtor.

*[Unless a Notice of Right to Garnish Federal Benefits from the United States Government or from a state child support enforcement agency is attached to or included in the garnishment, you must conduct a garnishment account review for each account that you hold for the debtor. If a Notice of Right to Garnish Federal Benefits from the United States Government or from a state child support enforcement agency is attached to or included in the garnishment, you should not conduct a garnishment account review, and should proceed upon the garnishment in the normal manner.]*

*[If you hold an account for the debtor, and any of the payments listed below has been deposited in the account by direct deposit or electronic payment during the lookback period described in ORS 18.784 (2) (the period that begins on the date preceding the date of your garnishment account review and that ends on the corresponding date of the month two months earlier, or on the last day of the month two months earlier if the corresponding date does not exist), an amount equal to the lesser of the sum of those payments or the total balance in the debtor’s account is not subject to garnishment, and you may not deliver that amount to the garnishor:]*

*[(a) Federal benefit payments as defined in ORS 18.600 (payments from the United States Social Security Administration, the United States Department of Veterans Affairs, the United States Office of Personnel Management or the Railroad Retirement Board);]*

*[(b) Payments from a public or private retirement plan as defined in ORS 18.358;]*

*[(c) Public assistance or medical assistance, as defined in ORS 414.025, payments from the State of Oregon or an agency of the State of Oregon;]*

*[(d) Unemployment compensation payments from the State of Oregon or an agency of the State of Oregon;]*

*[(e) Black lung benefits payments from the United States Department of Labor; and]*

*[(f) Workers’ compensation payments from a workers’ compensation carrier.]*

**(1)(a) If you receive a writ of garnishment for a Debtor who has an account with your institution, you must first determine whether a Notice of Right to Garnish Federal Benefits from the United States Government or from a state child support enforcement agency, as provided in 31 C.F.R. part 212, accompanies the writ of garnishment.**

**(b) If a Notice of Right to Garnish Federal Benefits accompanies the writ of garnishment, you must proceed with the garnishment in the normal manner.**

**(c) If the writ of garnishment is attached to an attestation that a debt arises out of a child support or spousal support obligation or a judgment that contains a money award of restitution, the base protected account balance does not apply and you should not perform**

1 the calculation provided by (1)(d), (2), (3), (5) and (6) below, but you must perform a  
2 garnishment account review as provided in (4) and (7) below.

3 (d) If a Notice of Right to Garnish Federal Benefits does not accompany the writ of  
4 garnishment or the writ of garnishment is not attached to an attestation that a debt arises  
5 out of a child support or spousal support obligation or a judgment that contains a money  
6 award that includes restitution, you must immediately determine the total amount in all of  
7 the accounts the Debtor has with your institution.

8 (2)(a) If, after making the determination in (1)(d) above, you find that the total amount  
9 in all of the Debtor's accounts with your institution is less than or equal to the base pro-  
10 tected account balance, as defined in ORS 18.785 (1)(a), shown on the Oregon Judicial De-  
11 partment website as exempt from garnishment:

12 (A) The Debtor's accounts are not subject to garnishment.

13 (B) You must provide full customary access to the Debtor's accounts.

14 (b) As of the effective date of this 2024 Act, the amount that is not subject to  
15 garnishment is \$2,500, but this amount is indexed to the Consumer Price Index for All Urban  
16 Consumers, West Region (All Items), as published by the Bureau of Labor Statistics of the  
17 United States Department of Labor or a successor agency, and may vary from year to year.

18 (3) If, after making the determination in (1)(d) above, you find that the total amount in  
19 all of the Debtor's accounts with your institution exceeds the base protected account balance  
20 shown on the Oregon Judicial Department website as exempt from garnishment:

21 (a) The base protected account balance is not subject to garnishment.

22 (b) You must provide full customary access to the base protected account balance shown  
23 on the Oregon Judicial Department website as exempt from garnishment.

24 (c) You must conduct a garnishment account review.

25 (4) In a garnishment account review, you must determine whether any of the following  
26 payments were made by direct deposit or electronic transfer to any of the Debtor's accounts  
27 with your institution within the lookback period described in ORS 18.785 (2)(d) (the period  
28 that begins on the date preceding the date of your garnishment account review and that ends  
29 on the corresponding date of the month two months earlier, or on the last day of the month  
30 two months earlier if the corresponding date does not exist):

31 (a) Federal benefit payments as defined in ORS 18.600 (benefit payments from the United  
32 States Social Security Administration, the United States Department of Veterans Affairs, the  
33 United States Office of Personnel Management or the Railroad Retirement Board);

34 (b) Payments from a public or private retirement plan as defined in ORS 18.358;

35 (c) Public assistance payments or medical assistance, as defined in ORS 414.025, from the  
36 State of Oregon or an agency of the State of Oregon;

37 (d) Unemployment compensation payments from the State of Oregon or an agency of the  
38 State of Oregon;

39 (e) Black lung benefits payments from the United States Department of Labor; or

40 (f) Workers' compensation payments from a workers' compensation carrier.

41 (5) If in the garnishment account review you determine that any of the payments listed  
42 in (4) above were made by direct deposit or electronic transfer to any of the Debtor's ac-  
43 counts with your institution within the lookback period, you may not garnish, and must  
44 provide full customary access to, the sum of:

45 (a) The base protected account balance shown on the Oregon Judicial Department

1 website as exempt from garnishment; and

2 (b) The amount by which the sum of all payments described in (4) above exceeds the base  
3 protected account balance.

4 (6) Any amount in the Debtor's accounts that exceeds the amounts described in (5) above  
5 is subject to garnishment and you must proceed with garnishment in the ordinary manner.

6 (7) If the writ of garnishment is attached to an attestation that a debt arises out of a  
7 child support or spousal support obligation or a judgment that contains a money award of  
8 restitution, you must provide the Debtor with full customary access to all payments listed  
9 in (4) above that were made by direct deposit or electronic transfer to an account within the  
10 lookback period the Debtor has with your institution.

11  
12 If the Garnishor fails to pay the search fee required by ORS 18.790 and you do not employ the  
13 Debtor, you are not required to deliver a Garnishee Response and you may deal with any property  
14 of the Debtor as though the garnishment had not been issued.

15  
16 If the Debtor owes a debt to you that was due at the time you received the writ of garnishment,  
17 you may be able to offset the amount of that debt. See ORS 18.795. You must note that you have  
18 made the offset in Part I of the Garnishee Response (under "Other") and specify the amount that

The minimum exemption is \$509 if the payment is for a two-week period. If the payment is for one-half of one month (i.e., the Debtor is paid twice each month), the minimum exemption is \$545. The minimum exemption for a monthly payment is \$1,090.

If the payment you are making is based on some period of time other than one week, two weeks, half month or month, and the payment is for more than one week, you must calculate the minimum exemption by multiplying \$254 by the number of weeks covered by the paycheck, including any fraction of a week. You should round the amount calculated to the nearest dollar.

**Example 1:** You pay Debtor A every 10 days. Each 10-day period is equal to 1.429 weeks (10 divided by 7). The minimum exemption is \$363 ( $\$254 \times 1.429$  rounded to the nearest dollar).

You **must** use this same calculation for computing the minimum exemption when making a payment for less than a full pay period (e.g., for the final payment at the end of the 90-day period covered by the writ).

**Example 2:** You pay Debtor A on a monthly basis. You are required to make a final payment under a writ of garnishment for the wages owing to Debtor A for the period beginning October 1 and ending October 15. 32 **SPECIAL RULES APPLY FOR DEBTS THAT ARE OWED FOR CHILD SUPPORT AND**

35 **workers' compensation benefits, unemployment benefits, veterans' benefits and pensions are**

40 **“SECTION 28.** ORCP 84 D is amended to read:  
41 **“D Writ of attachment.**  
42 **“D(1) Issuance; contents; to whom directed; issuance of several writs.** If directed by an order  
43 authorizing provisional process under Rule 83, the clerk shall issue a writ of attachment. The writ  
44 shall be directed to the sheriff of any county in which property of the defendant may be, and shall  
45 require the sheriff to attach and safely keep all the property of the defendant within the county not

2 amount of which shall be stated in conformity with the complaint, together with costs and expenses.

9 charged-off debt for the purpose of collecting the charged-off debt or hiring another person to collect  
10 or bring legal action to collect the charged-off debt.

11 “(B) ‘Debt buyer’ does not include a person that acquires charged-off debt as an incidental part  
12 of acquiring a portfolio of debt that is predominantly not charged-off debt.

13 “(h) ‘Debt collector’ means a person that by direct or indirect action, conduct or practice col-  
14 lects or attempts to collect a debt owed, or alleged to be owed, to a creditor or debt buyer.

15 “(i) ‘Debtor’ means a consumer who owes or allegedly owes a debt, including a consumer who  
16 owes an amount that differs from the amount that a debt collector attempts to collect or that a debt  
17 buyer purchased or attempts to collect.

18 “(j) ‘Legal action’ means a lawsuit, mediation, arbitration or any other proceeding in any court,  
19 including a small claims court.

20 “(k) ‘Original creditor’ means the last entity that extended credit to a consumer to purchase  
21 goods or services, to lease goods or as a loan of moneys.

22 “(L) ‘Person’ means an individual, corporation, trust, partnership, incorporated or  
23 unincorporated association or any other legal entity.

24 “(2) A debt collector engages in an unlawful collection practice if the debt collector, while col-  
25 lecting or attempting to collect a debt, does any of the following:

26 “(a) Uses or threatens to use force or violence to cause physical harm to a debtor or to the  
27 debtor’s family or property.

28 “(b) Threatens arrest or criminal prosecution.

29 “(c) Threatens to seize, attach or sell a debtor’s property if doing so requires a court order and  
30 the debt collector does not disclose that seizing, attaching or selling the debtor’s property requires  
31 prior court proceedings.

32 “(d) Uses profane, obscene or abusive language in communicating with a debtor or the debtor’s  
33 family.

34 “(e) Communicates with a debtor or any member of the debtor’s family repeatedly or contin-  
35 uously or at times known to be inconvenient to the debtor or any member of the debtor’s family and  
36 with intent to harass or annoy the debtor or any member of the debtor’s family.

37 “(f) Communicates or threatens to communicate with a debtor’s employer concerning the nature  
38 or existence of the debt.

39 “(g) Communicates without a debtor’s permission or threatens to communicate with the debtor  
40 at the debtor’s place of employment if the place of employment is other than the debtor’s residence,  
41 except that the debt collector may:

42 “(A) Write to the debtor at the debtor’s place of employment if a home address is not reasonably  
43 available and if the envelope does not reveal that the communication is from a debt collector other  
44 than the person that provided the goods, services or credit from which the debt arose.

45 “(B) Telephone a debtor’s place of employment without informing any other person of the nature

1 of the call or identifying the caller as a debt collector but only if the debt collector in good faith  
2 has made an unsuccessful attempt to telephone the debtor at the debtor's residence during the day  
3 or during the evening between the hours of 6 p.m. and 9 p.m. The debt collector may not contact  
4 the debtor at the debtor's place of employment more frequently than once each business week and  
5 may not telephone the debtor at the debtor's place of employment if the debtor notifies the debt  
6 collector not to telephone at the debtor's place of employment or if the debt collector knows or has  
7 reason to know that the debtor's employer prohibits the debtor from receiving such communication.  
8 For the purposes of this subparagraph, any language in any agreement, contract or instrument that  
9 creates or is evidence of the debt and that purports to authorize telephone calls at the debtor's place  
10 of employment does not give permission to the debt collector to call the debtor at the debtor's place  
11 of employment.

12 "(h) Communicates with a debtor in writing without clearly identifying the name of the debt  
13 collector, the name of the person, if any, for whom the debt collector is attempting to collect the  
14 debt and the debt collector's business address, on all initial communications. In subsequent commu-  
15 nications involving multiple accounts, the debt collector may eliminate the name of the person, if  
16 any, for whom the debt collector is attempting to collect the debt and substitute the term 'various'  
17 in place of the person's name.

18 "(i) Communicates with a debtor orally without disclosing to the debtor, within 30 seconds after  
19 beginning the communication, the name of the individual who is initiating the communication and  
20 the true purpose of the communication.

21 "(j) Conceals the true purpose of the communication so as to cause any expense to a debtor in  
22 the form of long distance telephone calls, telegram fees, additional charges for wireless communi-  
23 cation or other charges the debtor might incur by using a medium of communication.

24 "(k) Attempts or threatens to enforce a right or remedy while knowing or having reason to know  
25 that the right or remedy does not exist, or threatens to take any action that the debt collector in  
26 the regular course of business does not take.

27 "(L) Uses any form of communication that simulates legal or judicial process or that appears to  
28 be authorized, issued or approved by a governmental agency, governmental official or an attorney  
29 at law if the corresponding governmental agency, governmental official or attorney at law has not  
30 in fact authorized or approved the communication.

31 "(m) Represents that an existing debt may be increased by the addition of attorney fees, inves-  
32 tigation fees or any other fees or charges if the fees or charges may not legally be added to the  
33 existing debt.

34 "(n) Collects or attempts to collect, **by any means, including through legal action**, interest  
35 or other charges or fees that exceed the actual debt unless the agreement, contract or instrument  
36 that creates the debt expressly authorizes, or a law expressly allows, the interest or other charges  
37 or fees. **A debt collector may not be held liable in any action brought under this paragraph**  
38 **if the debt collector shows by a preponderance of evidence that the violation was not inten-**  
39 **tional and resulted from a bona fide error notwithstanding the maintenance of procedures**  
40 **reasonably adapted to avoid any such error. The fact that the debt collector obtains a judg-**  
41 **ment for less than the amount sought in the complaint, or fails to obtain a judgment at all,**  
42 **does not by itself constitute evidence of a violation of this paragraph.**

43 "(o) Threatens to assign or sell a debtor's account and misrepresents or implies that the debtor  
44 would lose any defense to the debt or would be subjected to harsh, vindictive or abusive collection  
45 tactics.

1 “(p) Uses the seal or letterhead of a public official or a public agency, as those terms are defined  
2 in ORS 171.725.

3 “(q) Collects or attempts to collect any debt that the debt collector knows, or after exercising  
4 reasonable diligence would know, arises from medical expenses that qualify for reimbursement under  
5 the Oregon Health Plan or under Medicaid, except that:

6 “(A) The debt collector does not engage in an unlawful collection practice if the debt collector  
7 can produce an affidavit or certificate from the original creditor that shows that the original cred-  
8 itor complied with Oregon Health Authority rules barring payments for services that Medicaid fee-  
9 for-service plans or contracted health care plans cover; and

10 “(B) For purposes of this paragraph, a prepaid managed care health services organization, a  
11 coordinated care organization or a public body, as defined in ORS 174.109, or an agent or assignee  
12 of the organization or public body, is not a debt collector if the organization or public body seeks  
13 to collect a debt that arises under ORS 416.540.

14 “(r) Files a legal action to collect or files a legal action to attempt to collect a debt if the debt  
15 collector knows, or after exercising reasonable diligence would know, that an applicable statute of  
16 limitations bars the collection or the collection attempt.

17 “[*s*] *Knowingly collects any amount, including any interest fee, charge or expense incidental to the*  
18 *principal obligation, unless the amount is expressly authorized by the agreement creating the debt or*  
19 *permitted by law.*]

20 “**(s) Collects or attempts to collect or threatens to collect a debt by any means, including**  
21 **through legal action, if the debt collector knows, or through the exercise of reasonable care**  
22 **should know, that the debt does not exist or is not owed by the debtor. A debt collector may**  
23 **not be held liable in any action brought under this paragraph if the debt collector shows by**  
24 **a preponderance of evidence that the violation was not intentional and resulted from a bona**  
25 **fade error notwithstanding the maintenance of procedures reasonably adapted to avoid any**  
26 **such error. The fact that the debt collector obtains a judgment for less than the amount**  
27 **sought in the complaint or fails to obtain a judgment at all does not by itself establish a vi-**  
28 **olation of this paragraph.**

29 “(t) Collects or attempts to collect a debt if the debt collector is a debt buyer, or is acting on  
30 a debt buyer’s behalf, and collects or attempts to collect purchased debt before providing to a  
31 debtor, within 30 days after the date of the debtor’s request, all of the documents listed in subsection  
32 (4)(b) of this section.

33 “(u) Collects or attempts to collect a debt without complying with the requirements of ORS  
34 646A.677.

35 “(3) A debt collector engages in an unlawful collection practice if the debt collector, by use of  
36 any direct or indirect action, conduct or practice, enforces or attempts to enforce an obligation  
37 made void and unenforceable by the provisions of ORS 759.720 (3) to (5).

38 “(4) A debt buyer or debt collector acting on behalf of a debt buyer engages in an unlawful  
39 collection practice if the debt buyer or debt collector:

40 “(a) Files legal action against a debtor or files legal action to attempt to collect a debt if the  
41 debt buyer or debt collector knows or after exercising reasonable diligence would know that an  
42 applicable statute of limitations bars the legal action to collect or the legal action to attempt to  
43 collect the debt;

44 “(b) Brings a legal action against a debtor or otherwise brings a legal action to attempt to col-  
45 lect a debt without possessing business records that satisfy the requirements of ORS 40.460 (6), or

1 of ORS 24.115, if the record is a foreign judgment, that establish the nature and the amount of the  
2 debt and that include:

3 “(A) The original creditor’s name, written as the original creditor used the name in dealings  
4 with the debtor;

5 “(B) The name and address of the debtor;

6 “(C) The name, address and telephone number of the person that owns the debt and a statement  
7 as to whether the person is a debt buyer;

8 “(D) The last four digits of the original creditor’s account number for the debt, if the original  
9 creditor’s account number for the debt had four or more digits;

10 “(E) A detailed and itemized statement of:

11 “(i) The amount the debtor last paid on the debt, if the debtor made a payment, and the date  
12 of the payment;

13 “(ii) The amount and date of the debtor’s last payment on the debt before the debtor defaulted  
14 or before the debt became charged-off debt;

15 “(iii) The balance due on the debt on the date on which the debt became charged-off debt;

16 “(iv) The amount and rate of interest, any fees and any charges that the original creditor im-  
17 posed, if the debt buyer or debt collector knows the amount, rate, fee or charge;

18 “(v) The amount and rate of interest, any fees and any charges that the debt buyer or any pre-  
19 vious owner of the debt imposed, if the debt buyer or debt collector knows the amount, rate, fee or  
20 charge;

21 “(vi) The attorney fees the debt buyer or debt collector seeks, if the debt buyer or debt collector  
22 expects to recover attorney fees; and

23 “(vii) Any other fee, cost or charge the debt buyer seeks to recover;

24 “(F) Evidence that the debt buyer and only the debt buyer owns the debt;

25 “(G) The date on which the debt buyer purchased the debt; and

26 “(H) A copy of the agreement between the original creditor and the debtor that is either:

27 “(i) The contract or other writing the debtor signed that created and is evidence of the original  
28 debt; or

29 “(ii) A copy of the most recent monthly statement that shows a purchase transaction or balance  
30 transfer or the debtor’s last payment, if the debtor made a payment, if the debt is a credit card debt  
31 or other debt for which a contract or other writing that is evidence of the debt does not exist;

32 “(c) Fails to provide to a debtor, after the debt buyer or debt collector receives payment in cash  
33 or the debtor requests the receipt, a receipt that:

34 “(A) Shows the name of the creditor or creditors for whom the debt buyer or debt collector re-  
35 ceived the payment and, if the creditor is not the original creditor, the account number that the  
36 original creditor assigned; and

37 “(B) States clearly whether the debt buyer or debt collector accepts the payment as payment in  
38 full or as a full and final compromise of the debt and, if not, the balance remaining on the debt after  
39 the payment;

40 “(d) Collects or attempts to collect a debt before providing, in response to a debtor’s request,  
41 the documents required under paragraph (b) of this subsection. A debt buyer or a debt collector that  
42 acts on the debt buyer’s behalf does not engage in an unlawful collection practice under this para-  
43 graph if the debt buyer or debt collector collects or attempts to collect a debt after providing the  
44 required documents to the debtor; or

45 “(e) Uses any direct or indirect action, conduct or practice to violate a provision of this section

1 or ORS 646A.670.

2 “(5) A debt collector is not acting on a debt buyer’s behalf, and is not subject to the duties to  
3 which a debt buyer is subject under this section and ORS 646A.670, if the debt collector collects or  
4 attempts to collect a debt on behalf of an owner that retains a direct interest in the debt or if the  
5 debt is not a debt that a debt buyer purchased.

6 “**SECTION 30.** ORS 646.641 is amended to read:

7 “646.641. (1) Any person injured as a result of willful use or employment by another person of  
8 an unlawful collection practice may bring an action in an appropriate court to enjoin the practice  
9 or to recover actual damages or [\$200] **\$1,000**, whichever is greater. The court or the jury may  
10 award punitive damages, and the court may provide such equitable relief as it deems necessary or  
11 proper.
