SUMMARY

Digest: Fixes firm dates for measures during session. (Flesch Readability Score: 66.7). Establishes deadlines for completion of legislative measures for the 2024 regular session of the Eighty-Second Legislative Assembly.

CONCURRENT RESOLUTION

2 Be It Resolved by the Legislative Assembly of the State of Oregon:

(1) This resolution constitutes a rule of proceeding of the Senate and the House of Represen tatives of the Eighty-second Legislative Assembly.

5 (2) The Senate and the House of Representatives shall adhere to the following schedule and 6 deadlines for the 2024 regular session of the Eighty-second Legislative Assembly:

7 (a) The Senate and the House of Representatives shall convene in regular session on February
8 5, 2024.

9 (b) Committee chairpersons shall schedule work sessions for measures in the chamber of origin 10 no later than February 12, 2024. This paragraph does not apply to the Joint Committee on Ways 11 and Means, other joint committees, Senate Committee on Finance and Revenue, House Committee 12 on Revenue, Senate Committee on Rules, House Committee on Rules, Senate Committee on Conduct 13 and House Committee on Conduct.

14 (c) Committees shall consider measures in the chamber of origin no later than February 19, 2024. This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees, 1516 Senate Committee on Finance and Revenue, House Committee on Revenue, Senate Committee on 17 Rules, House Committee on Rules, Senate Committee on Conduct and House Committee on Conduct. 18 (d) Committee chairpersons shall schedule work sessions for measures in the second chamber no later than February 23, 2024. This paragraph does not apply to the Joint Committee on Ways 19 20and Means, other joint committees except for the Joint Committee on Transportation, Senate Com-21mittee on Finance and Revenue, House Committee on Revenue, Senate Committee on Rules, House Committee on Rules, Senate Committee on Conduct and House Committee on Conduct. 22

(e) Committees shall consider measures in the second chamber no later than February 29, 2024.
This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees
except for the Joint Committee on Transportation, Senate Committee on Finance and Revenue,
House Committee on Revenue, Senate Committee on Rules, House Committee on Rules, Senate
Committee on Conduct and House Committee on Conduct.
