Senate Concurrent Resolution 209

SUMMARY

It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

CONCURRENT RESOLUTION

Digest: Honors the life and memory of Joanne Russell Verger. (Flesch Readability Score: 66.1). In memoriam: Joanne Russell Verger, 1930-2023.

2	Whereas Joanne Russell Verger was born in Amite, Louisiana, on July 19, 1930, to Robert
3	Weldon Russell and Nannie Claire Russell (Lingo); and
4	Whereas as the last of four children, Joanne Verger's upbringing in the throes of the Great
5	Depression left an indelible mark on her life; and
6	Whereas growing up in the Deep South contributed to a rich and full childhood that Joanne
7	Verger would recall fondly later in life; and
8	Whereas Joanne Verger's grandfather was a Methodist minister, and he imprinted on her a
9	devout sense of faith, modesty and incredible spiritual and personal discipline; and
10	Whereas Joanne Verger was an excellent student in high school and graduated at the age of
11	16; and
12	Whereas after high school, Joanne Verger enrolled at Northwestern State College in Louisiana
13	where she excelled as a thespian and Shakespearean actress, starring as Helena in A Midsummer
14	Night's Dream; and
15	Whereas while in college, Joanna Verger reconnected with her childhood friend Lawton, whom
16	she first met when she was in third grade; and
17	Whereas Joanne and Lawton Verger were married on November 19, 1950; and
18	Whereas Joanne and Lawton Verger later moved to Baton Rouge, Louisiana, where Lawton took
19	a job as a Pontiac salesman; and
20	Whereas Joanne and Lawton Verger welcomed their first child, Kathy, in 1952, followed by their
21	sons Jim and John in 1955 and 1957 and their daughter Anne Adair in 1960; and
22	Whereas in 1969, Joanne and Lawton Verger moved to Coos Bay, Oregon, where they took
23	ownership of an automobile dealership; and
24	Whereas Joanne Verger became the tourism director for the City of Coos Bay and later helped
25	create the Bay Area Fun Festival and the Blackberry Arts Festival; and
26	Whereas Joanne Verger won a seat on the Coos Bay City Council in 1990; and
27	Whereas Joanne Verger was elected the City of Coos Bay's first female mayor in 1992; and
28	Whereas Joanne Verger was elected to the Oregon Legislative Assembly in 2000, where she
29	served as a member of the House of Representatives from 2001 to 2005 and as a member of the
30	Senate from 2005 to 2013; and

Whereas Joanne Verger was a tireless advocate for her community and a champion for rural 1 2 Oregonians everywhere; and 3 Whereas Joanne Verger represented the true spirit of bipartisanship, working across party lines to create a better Oregon; and 4 Whereas Joanne Verger served the State of Oregon with dignity, honesty, kindness and resolve; 5 and 6 7 Whereas Joanne Verger wrote two books, Dancing with the Daffodils and Moonlight on the Pond, reflecting on her childhood memories in the Deep South; and 8 9 Whereas Joanne Verger passed away at the age of 93 on September 22, 2023; and Whereas Joanne Verger is survived by her four children and their spouses, Jim and Diane 10 Verger, Kathy and Jerry Muscus, Anne Johnson, and John and Yvette Verger; her four grandchil-11 12 dren, Aaron Johnson, Logan Reeder, James Verger and Nissa Thompson; and her great-grandchild, Alexandra Verger; now, therefore, 13 Be It Resolved by the Legislative Assembly of the State of Oregon: 14 15 That we, the members of the Eighty-second Legislative Assembly, celebrate the life and accom-16 plishments of Joanne Russell Verger, and we recognize and honor her contributions to the people of this state; and be it further 17 18 Resolved, That we share a deep sense of loss with the entire Capitol community in the absence 19 of this remarkable public servant; and be it further
