4 an emergency.”.

7 **ADMINISTRATION AND REPORTING**
8

9 **“SECTION 1. (1) No later than September 15, 2024, the Director of**
10 **the Employment Department shall report to an interim committee of**
11 **the Legislative Assembly related to labor and business information on:**

12 **“(a) The payment of benefits under ORS chapter 657B to seasonal**
13 **employees and persons employed through hiring halls; and**

14 **“(b) The consideration of implementing programmatic changes to**
15 **the paid family and medical leave program established under ORS**
16 **chapter 657B.**

17 **“(2) No later than September 15, 2024, the Bureau of Labor and In-**
18 **dustries and the Employment Department shall jointly report to an**
19 **interim committee of the Legislative Assembly related to labor and**
20 **business on the apportionment of duties between the Bureau of Labor**
21 **and Industries and the Employment Department regarding the pro-**

1 **tected leave provisions of ORS chapters 657B and 659A, including:**

2 **“(a) The current roles and responsibilities of the agencies with re-**
3 **spect to:**

4 **“(A) Administration, rulemaking, education and enforcement of the**
5 **protected leave provisions; and**

6 **“(B) Other aspects of the protected leave provisions, including is-**
7 **ssues concerning discrimination, retaliation and job protection;**

8 **“(b) Possible future roles and responsibilities of the agencies with**
9 **respect to the topics described under paragraph (a) of this subsection;**
10 **and**

11 **“(c) Any statutory changes that are necessary to clarify the roles**
12 **and responsibilities of the agencies to enable the agencies to provide**
13 **the best support to employees and employers regarding protected**
14 **leave.**

16 **“TECHNICAL CHANGES**

17

18 **“SECTION 2.** ORS 653.455 is amended to read:

19 **“653.455. (1) As used in this section:**

20 **“(a) ‘Group communication’ means communication to all eligible employ-**
21 **ees, either written or oral.**

22 **“(b) ‘Ticketed event’ means a sporting, entertainment, civic, charitable or**
23 **other event that requires a ticket for admission. The ticket may be elec-**
24 **tronic, physical or a name on a list held by the event organizer.**

25 **“(2) An employer shall provide the following compensation to an employee**
26 **for each employer-requested change that occurs to the employee’s written**
27 **work schedule without the advance notice required in ORS 653.436:**

28 **“(a) One hour of pay at the employee’s regular rate of pay, in addition**
29 **to wages earned, when the employer:**

30 **“(A) Adds more than 30 minutes of work to the employee’s work shift;**

1 “(B) Changes the date or start or end time of the employee’s work shift
2 with no loss of hours; or

3 “(C) Schedules the employee for an additional work shift or on-call shift.

4 “(b) One-half times the employee’s regular rate of pay per hour for each
5 scheduled hour that the employee does not work when the employer:

6 “(A) Subtracts hours from the employee’s work shift before or after the
7 employee reports for duty;

8 “(B) Changes the date or start or end time of the employee’s work shift,
9 resulting in a loss of work shift hours;

10 “(C) Cancels the employee’s work shift; or

11 “(D) Does not ask the employee to perform work when the employee is
12 scheduled for an on-call shift.

13 “(3) The requirements for additional compensation in this section do not
14 apply when:

15 “(a) An employer changes the start or end time of an employee’s work
16 shift by 30 minutes or less;

17 “(b) An employee mutually agrees with another employee to employee-
18 initiated work shift swaps or coverage. The employer may require that work
19 shift swaps or coverage under this paragraph be preapproved by the em-
20 ployer. The employer may assist employees in finding such arrangements,
21 provided that any employer assistance must be limited to helping an em-
22 ployee identify other employees who may be available to provide work shift
23 swaps or coverage and may not include the employer arranging the work
24 shift swap or coverage;

25 “(c) An employee requests changes to the employee’s written work
26 schedule, including adding or subtracting hours, and the employee documents
27 the request in writing;

28 “(d) An employer makes changes to an employee’s written work schedule
29 at the employee’s request under ORS 653.436 (6);

30 “(e) An employer subtracts hours from an employee’s work schedule for

1 disciplinary reasons for just cause, provided the employer documents the in-
2 cident leading to the employee's discipline in writing;

3 “(f) An employee's work shift or on-call shift cannot begin or continue
4 due to threats to employees or property or due to the recommendation of a
5 public official;

6 “(g) Operations cannot begin or continue because public utilities fail to
7 supply electricity, water or gas or there is a failure in the public utilities
8 or sewer system;

9 “(h) Operations cannot begin or continue due to a natural disaster or a
10 similar cause not within the employer's control, including when the natural
11 disaster or similar cause physically affects the work site;

12 “(i) Operations hours change or are substantially altered because a
13 ticketed event is canceled, rescheduled or changes in duration due to cir-
14 cumstances that are outside the employer's control and that occur after the
15 employer provides the written work schedule under ORS 653.436;

16 “(j) An employer requests that an employee on a voluntary standby list
17 work additional hours as described in ORS 653.432 and the employee consents
18 to work the additional hours; [or]

19 “(k)(A) An employer requests that an employee work additional hours to
20 address unanticipated customer needs or unexpected employee absence;

21 “(B) The employee consents in writing to work the additional hours;

22 “(C) If the employer maintains a voluntary standby list described in ORS
23 653.432, the employer has contacted all of the employees listed on the vol-
24 untary standby list and requires additional employee coverage; and

25 “(D)(i) If the employee is working a work shift at the time the employer
26 makes the request, the employer makes the request either individually or as
27 part of a group communication; or

28 “(ii) If the employee is not working a work shift at the time the employer
29 makes the request, the employer makes the request through a group
30 communication[.]; **or**

1 **“(L) An employer is provided with less than 14 days’ notice before**
2 **the first day of the work schedule of the need for leave under ORS**
3 **chapters 657B or 659A, or of the return from the use of leave under**
4 **ORS chapters 657B or 659A, and the employer makes a change to the**
5 **schedule of an employee who was temporarily assigned to specific**
6 **shifts to cover for an employee on leave under ORS chapters 657B or**
7 **659A.**

8 **“SECTION 3.** ORS 657B.010 is amended to read:

9 “657B.010. As used in this chapter:

10 “(1) ‘Alternate base year’ means the last four completed calendar quarters
11 preceding the benefit year.

12 “(2) ‘Average weekly wage’ means the amount calculated by the Employ-
13 ment Department as the state average weekly covered wage under ORS
14 657.150 (4)(e) as determined not more than once per year.

15 “(3) ‘Base year’ means the first four of the last five completed calendar
16 quarters preceding the benefit year.

17 “(4) ‘Benefits’ means family and medical leave insurance benefits.

18 “(5)(a) ‘Benefit year’ means, except as provided in paragraph (b) of this
19 subsection, a period of 52 consecutive weeks beginning on the Sunday im-
20 mediately preceding the date on which family leave, medical leave or safe
21 leave commences.

22 “(b) ‘Benefit year’ means, in the event that the 52-week period described
23 in paragraph (a) of this subsection would result in an overlap of any quarter
24 of the base year of a previously filed valid claim, a period of 53 consecutive
25 weeks beginning on the Sunday immediately preceding the date on which
26 family leave, medical leave or safe leave commences.

27 “(6) ‘Child’ means:

28 “(a) A biological child, adopted child, stepchild or foster child of a cov-
29 ered individual or of the covered individual’s spouse or domestic partner;

30 “(b) A person who is or was a legal ward of a covered individual or of

1 the covered individual’s spouse or domestic partner; or

2 “(c) A person who is or was in a relationship of in loco parentis with a
3 covered individual or with the covered individual’s spouse or domestic part-
4 ner.

5 “(7) ‘Claimant’ means an individual who has submitted an application or
6 established a claim for benefits.

7 “(8) ‘Contribution’ or ‘contributions’ means the money payments made by
8 any of the following under ORS 657B.150:

9 “(a) An employer;

10 “(b) An employee;

11 “(c) A self-employed individual;

12 “(d) A tribal government; or

13 “(e) An employee of a tribal government.

14 “(9) ‘Covered individual’ means any one of the following who qualifies
15 under ORS 657B.015 to receive family and medical leave insurance benefits:

16 “(a) An eligible employee;

17 “(b) A self-employed individual; or

18 “(c) An employee of a tribal government.

19 “(10) ‘Domestic partner’ means an individual joined in a domestic part-
20 nership.

21 “(11) ‘Domestic partnership’ has the meaning given that term in ORS
22 106.310.

23 “(12) ‘Eligible employee’ means:

24 “(a)(A) An employee who has earned at least \$1,000 in wages during the
25 base year; or

26 “(B) If an employee has not earned at least \$1,000 in wages during the
27 base year, an employee who has earned at least \$1,000 in wages during the
28 alternate base year; and

29 “(b) An employee to whom paid family and medical leave insurance ben-
30 efits may be available under ORS 657B.015.

1 “(13) ‘Eligible employee’s average weekly wage’ means an amount calcu-
2 lated by the Director of the Employment Department by dividing the total
3 wages earned by an eligible employee during the base year by the number
4 of weeks in the base year.

5 “(14)(a) ‘Employee’ means:

6 “(A) An individual performing services for an employer for remuneration
7 or under any contract of hire, written or oral, express or implied.

8 “(B) A home care worker as defined in ORS 410.600.

9 “(b) ‘Employee’ does not include:

10 “(A) An independent contractor as defined in ORS 670.600.

11 “(B) A participant in a work training program administered under a state
12 or federal assistance program.

13 “(C) A participant in a work-study program that provides students in
14 secondary or postsecondary educational institutions with employment op-
15 portunities for financial assistance or vocational training.

16 “(D) A railroad worker exempted under the federal Railroad Unemploy-
17 ment Insurance Act.

18 “(E) A volunteer.

19 “(F) A judge as defined in ORS 260.005.

20 “(G) A member of the Legislative Assembly.

21 “(H) A holder of public office as defined in ORS 260.005.

22 “(15)(a) ‘Employer’ means any person that employs one or more employees
23 working anywhere in this state or any agent or employee of such person to
24 whom the duties of the person under this chapter have been delegated.

25 “(b) ‘Employer’ includes:

26 “(A) A political subdivision of this state or any county, city, district,
27 authority or public corporation, or any instrumentality of a county, city,
28 district, authority or public corporation, organized and existing under law
29 or charter;

30 “(B) An individual;

1 “(C) Any type of organization, corporation, partnership, limited liability
2 company, association, trust, estate, joint stock company or insurance com-
3 pany;

4 “(D) Any successor in interest to an entity described in subparagraph (C)
5 of this paragraph;

6 “(E) A trustee, trustee in bankruptcy or receiver; or

7 “(F) A trustee or legal representative of a deceased person.

8 “(c) ‘Employer’ does not include the federal government or a tribal gov-
9 ernment.

10 “(16) ‘Employment agency’ has the meaning given that term in ORS
11 658.005.

12 “(17) ‘Family and medical leave insurance benefits’ means the wage re-
13 placement benefits that are available to a covered individual under ORS
14 657B.050 or under the terms of an employer plan approved under ORS
15 657B.210, for family leave, medical leave or safe leave.

16 “(18)(a) ‘Family leave’ means leave from work taken by a covered indi-
17 vidual:

18 “(A) To care for and bond with a child during the first year after the
19 child’s birth or during the first year after the placement of the child through
20 foster care or adoption; or

21 “(B) To care for a family member with a serious health condition.

22 “(b) ‘Family leave’ does not mean:

23 “(A) Leave described in ORS 659A.159 [(1)(d)] **(1)(a) except for leave to**
24 **care for a child who requires home care due to an illness, injury or**

27 “(C) Leave authorized under ORS 659A.093.

28 “(19) ‘Family member’ means:

1 partner;

2 “(c) A parent [*of a covered individual*] or the parent’s spouse or domestic
3 partner;

4 “(d) A sibling or stepsibling of a covered individual or the sibling’s or
5 stepsibling’s spouse or domestic partner;

6 “(e) A grandparent of a covered individual or the grandparent’s spouse
7 or domestic partner;

8 “(f) A grandchild of a covered individual or the grandchild’s spouse or

11 “(h) Any individual related by blood or affinity whose close association
12 with a covered individual is the equivalent of a family relationship.

2 “(b) An independent contractor as defined in ORS 670.600.

3 “(24) ‘Serious health condition’ [*has the meaning given that term in ORS*
4 *659A.150.*] **means:**

5 “(a) **An illness, injury, impairment or physical or mental condition**
6 **that requires inpatient care in a hospital, hospice or residential med-**
7 **ical care facility;**

8 “(b) **An illness, disease or condition that in the medical judgment**
9 **of the treating health care provider poses an imminent danger of**
10 **death, is terminal in prognosis with a reasonable possibility of death**
11 **in the near future, or requires constant care;**

12 “(c) **Any period of disability due to pregnancy, or period of absence**
13 **for prenatal care; or**

14 “(d) **Any period of absence for the donation of a body part, organ**
15 **or tissue, including preoperative or diagnostic services, surgery, post-**
16 **operative treatment and recovery.**

20 “657B.030. (1) Family and medical leave insurance benefits are in addition
21 to any paid sick time under ORS 653.606, vacation leave or other paid leave
22 earned by an employee.

23 “(2)(a) [*An employer may permit an employee to use all or a portion of paid*
24 *sick time, vacation leave or any other paid leave earned by the employee in*
25 *addition to]* **Except as otherwise provided in paragraph (b) of this sub-**
26 **section, an employee is entitled to use any accrued paid sick leave,**

10 period of family leave on the same terms as if the employee had continued
11 to work. If family member coverage is provided to the employee, family
12 member coverage must be maintained during the period of family leave. The
13 employee must continue to make any regular contributions to the cost of the
14 health insurance premiums.

15 “(c) Notwithstanding ORS 652.610 (3) and except as provided in paragraph
16 (b) of this subsection, if the employer is required or elects to pay any part
17 of the costs of providing disability, life or other insurance coverage for an
18 employee during the period of family leave that should have been paid by the
19 employee, the employer may deduct from the employee's pay such amounts
20 upon the employee's return to work until the amount the employer advanced
21 toward the payments is paid. In no event may the total amount deducted for
22 insurance under the provisions of this subsection exceed 10 percent of the
23 employee's gross pay each pay period.

24 “(6) Notwithstanding ORS 652.610 (3), if the employer pays any part of the
25 costs of health, disability, life or other insurance coverage for an employee
26 under the provisions of subsection (5) of this section, and the employee does
27 not return to employment with the employer after taking family leave, the
28 employer may deduct amounts paid by the employer from any amounts owed
29 by the employer to the employee, or may seek to recover those amounts by
30 any other legal means, unless the employee fails to return to work because

1 of:]

2 “[a] A continuation, reoccurrence or onset of a serious health condition
3 that would entitle the employee to leave for one of the purposes specified by
4 ORS 659A.159 (1)(b) or (c); or]

5 “[b] Other] circumstances beyond the control of the employee.

6 **“SECTION 18.** ORS 659A.177 is amended to read:

7 “659A.177. [(1) Notwithstanding any other provision of ORS 659A.150 to
8 659A.186, if a teacher requests leave for one of the purposes specified in ORS
9 659A.159 (1)(b) or (c), the need for the leave is foreseeable, and the employee
10 will be on leave for more than 20 percent of the total number of working days
11 in the period during which the leave would extend, the employer of the teacher
12 may require that the employee elect one of the two following options:]

13 “[a] The employee may elect to take leave for a period or periods of a
14 particular duration, not to exceed the duration of the anticipated medical
15 treatment; or]

16 “[b] The employee may elect to transfer temporarily to an available alter-
17 native position that better accommodates recurring periods of leave than the
18 regular position of the employee. The teacher must be qualified for the alter-
19 native position, and the position must have pay and benefits that are equivalent
20 to the pay and benefits of the employee’s regular position.]

21 “[2) Notwithstanding any other provision of ORS 659A.150 to 659A.186, if
22 a teacher commences a period of family leave for the purpose specified in ORS
23 659A.159 (1)(c) more than five weeks before the end of an academic term, the
24 employer of the teacher may require that the employee continue on family leave
25 until the end of the term if:]

26 “[a] The leave is of at least three weeks’ duration; and]

27 “[b] The employee’s return to employment would occur during the three-
28 week period before the end of the term.]

29 “[3) Notwithstanding any other provision of ORS 659A.150 to 659A.186, if
30 a teacher commences a period of family leave for one of the purposes specified

1 *in ORS 659A.159 (1)(a) or (b) during the five weeks before the end of an aca-*
2 *demie term, the employer of the teacher may require that the employee continue*
3 *on family leave until the end of the term if:]*

4 “[(a) *The leave is of at least two weeks’ duration; and]*

5 “[(b) *The employee’s return to employment would occur during the two-week*
6 *period before the end of the term.]*

7 “[(4)] (1) Notwithstanding any other provision of ORS 659A.150 to
8 659A.186, if a teacher commences a period of family leave for [*one of the*
9 *purposes]* **the purpose** specified in ORS 659A.159 [(1)(a), (b) or (e)] (1)(b)
10 during the three-week period before the end of the term, and the duration
11 of the leave is greater than five working days, the employer of the teacher
12 may require that the employee continue on family leave until the end of the
13 term.

14 “[(5)] (2) The provisions of this section apply only to an employee who is
15 employed principally in an instructional capacity by a public kindergarten,
16 elementary school, secondary school or education service district.

17 **“SECTION 19.** ORS 659A.186 is amended to read:

18 “659A.186. (1) ORS 659A.150 to 659A.186 do not limit any right of an em-
19 ployee to any leave that is similar to the leave described in ORS 659A.159
20 (1) and to which the employee may be entitled under any agreement between
21 the employer and the employee, collective bargaining agreement or employer
22 policy.

23 “(2) ORS 659A.150 to 659A.186 shall be construed to the extent possible
24 in a manner that is consistent with any similar provisions of the federal
25 Family and Medical Leave Act of 1993. If family leave taken under ORS
26 659A.150 to 659A.186 qualifies as protected leave pursuant to the federal
27 Family and Medical Leave Act of 1993 (P.L. 103-3) [*or qualifies as family*
28 *leave or medical leave taken pursuant to ORS chapter 657B]*, family leave
29 taken under ORS 659A.150 to 659A.186 must be taken concurrently with, and
30 not in addition to, any leave taken under the federal Family and Medical

1 Leave Act of 1993 (P.L. 103-3) [*and under ORS chapter 657B*].
