**PROPOSED AMENDMENTS TO
SENATE BILL 1508**

1 On page 1 of the printed bill, line 2, after “care;” insert “creating new
2 provisions; and” and delete “and 414.701” and insert “, 414.701 and
3 743A.069”.

4 After line 3, insert:

“QUALITY OF LIFE MEASURES”

8 On page 4, delete lines 39 and 40 and insert:

9 “(iii) Determines that any of a researcher’s conclusions and analyses
10 about the value or cost-effectiveness of a treatment, that were relied upon
11 by the staff of the commission in making a recommendation regarding the
12 treatment, did not rely upon and were not influ-”.

13 On page 14, after line 11, insert:

“HEALTH INSURANCE COVERAGE OF INSULIN

17 **“SECTION 7.** ORS 743A.069 is amended to read:

18 “743A.069. (1) As used in this section:

19 “(a) ‘Health benefit plan’ has the meaning given that term in ORS
20 743B.005.

21 “(b) ‘Insulin’ has the meaning given that term in ORS 689.696.

1 “(2) A health benefit plan offered in this state may not require an enrollee
2 in the plan to incur cost-sharing or other out-of-pocket costs[, *as adjusted*
3 *under subsection (3) of this section,*] that exceed [\$75] **\$35** for each 30-day
4 supply of a type of insulin prescribed for the treatment of diabetes or [\$225]
5 **\$105** for each 90-day supply.

6 “[~~(3)~~ *The Department of Consumer and Business Services shall, by rule,*
7 *annually adjust the maximum cost specified in subsection (2) of this section*
8 *by the percentage increase, if any, in the cost of living for the previous calen-*
9 *dar year, based on changes in the Consumer Price Index for All Urban Con-*
10 *sumers, West Region (All Items), as published by the Bureau of Labor*
11 *Statistics of the United States Department of Labor.*]

12 “[~~(4)~~ **(3)** The coverage under this section may not be subject to a
13 deductible imposed by a health benefit plan.

14 “[~~(5)~~ **(4)** This section does not prohibit a health benefit plan from using
15 a drug formulary or other utilization review protocol applicable to pre-
16 scription drug coverage under the plan.

17 “[~~(6)~~ **(5)** This section is not subject to ORS 743A.001.

18 **“SECTION 8. The amendments to ORS 743A.069 by section 7 of this**
19 **2024 Act apply to health benefit plans issued, renewed or extended on**
20 **or after the effective date of this 2024 Act.**
