**PROPOSED AMENDMENTS TO  
SENATE BILL 1595**

1 On page 1 of the printed bill, line 5, delete “prescribing an effective  
2 date” and insert “declaring an emergency”.

3 Delete lines 7 through 26 and delete pages 2 through 59 and insert:

4 **“SECTION 1.** ORS 18.345 is amended to read:

5 “18.345. (1) All property **of a judgment debtor**, including franchises, or  
6 rights or interest [*therein, of the judgment debtor, shall be*] **in the judgment**  
7 **debtor’s property, is** liable to an execution, except as provided in this sec-  
8 tion and in other statutes granting exemptions from execution. The following  
9 property **of the judgment debtor**, or rights or interest [*therein of the judg-*  
10 *ment debtor*] **in the property**, except as provided in ORS 18.305, [*shall be*]  
11 **is** exempt from execution:

12 “(a) Books, pictures and musical instruments to the value of \$600.

13 “(b) Wearing apparel, jewelry and other personal items to the value of  
14 \$1,800.

15 “(c) The tools, implements, apparatus, team, harness or library, necessary  
16 to enable the judgment debtor to carry on the trade, occupation or profession  
17 by which the judgment debtor habitually earns a living, to the value of  
18 \$5,000.

19 “[*(d) A vehicle to the value of \$3,000. As used in this paragraph ‘vehicle’*  
20 *includes an automobile, truck, trailer, truck and trailer or other motor*  
21 *vehicle.*]

1       “(d)(A) A vehicle, including an automobile, truck, trailer, truck and  
2 trailer or other motor vehicle, to the value of \$10,000; or

3       “(B) If the judgment debtor owes a debt that arises out of a child  
4 support or spousal support obligation or a money award judgment that  
5 includes restitution, a vehicle, including an automobile, truck, trailer,  
6 truck and trailer or other motor vehicle, to the value of \$3,000.

7       “(e) Domestic animals and poultry kept for family use, to the total value  
8 of \$1,000 and food sufficient to support such animals and poultry for 60 days.

9       “(f) Household goods, furniture, radios, a television set and utensils all  
10 to the total value of \$3,000, if the judgment debtor holds the property pri-  
11 marily for the personal, family or household use of the judgment debtor;  
12 provisions actually provided for family use and necessary for the support of  
13 a householder and family for 60 days and also 60 days’ supply of fuel.

14       “(g) All property of the state or any county or incorporated city therein,  
15 or of any other public or municipal corporation of like character.

16       “(h) All professionally prescribed health aids for the **judgment** debtor or  
17 a dependent of the **judgment** debtor.

18       “(i) Spousal support, child support, or separate maintenance to the extent  
19 reasonably necessary for the support of the **judgment** debtor and any de-  
20 pendent of the **judgment** debtor.

21       “(j) The **judgment** debtor’s right to receive, or property that is traceable  
22 to, an award under any crime victim reparation law.

23       “(k) The **judgment** debtor’s right to receive, or property that is traceable  
24 to, a payment or payments, not to exceed a total of \$10,000, on account of  
25 personal bodily injury of the **judgment** debtor or an individual of whom the  
26 **judgment** debtor is a dependent.

27       “(L) The **judgment** debtor’s right to receive, or property that is traceable  
28 to, a payment in compensation of loss of future earnings of the **judgment**  
29 debtor or an individual of whom the **judgment** debtor is or was a dependent,  
30 to the extent reasonably necessary for the support of the **judgment** debtor

1 and any dependent of the **judgment** debtor.

2 “(m) Veterans’ benefits and loans.

3 “(n) The **judgment** debtor’s right to receive an earned income tax credit  
4 under the federal tax laws and any moneys that are traceable to a payment  
5 of an earned income tax credit under the federal tax laws.

6 “(o) The **judgment** debtor’s right to the assets held in, or right to receive  
7 payments under, a medical savings account or health savings account au-  
8 thorized under section 220 or 223 of the Internal Revenue Code.

9 “(p) The **judgment** debtor’s interest, not to exceed \$400 in value, in any  
10 personal property. However, this exemption may not be used to increase the  
11 amount of any other exemption.

12 “(q) The **judgment** debtor’s right to receive a tax credit under ORS  
13 315.273, and any moneys that are traceable to a payment of a tax credit under  
14 ORS 315.273.

15 “(2) If the property claimed by the judgment debtor as exempt is adjudi-  
16 cated by the court out of which the execution issued to be of a value in ex-  
17 cess of that allowed by the appropriate paragraph of subsection (1) of this  
18 section, the officer seizing the property shall proceed to sell such property.  
19 Out of the proceeds of such sale, the officer shall deduct costs of sale and  
20 shall pay to the judgment debtor an amount equivalent to the value declared  
21 to be exempt by any of the paragraphs of subsection (1) of this section and  
22 shall apply the balance of the proceeds of sale on the execution. A sale may  
23 not be made under such execution unless the highest bid made exceeds the  
24 appropriate exemption claimed and allowed plus costs of sale. If no bid is  
25 received in excess of the value allowed by the appropriate paragraph of  
26 subsection (1) of this section, the costs of sale shall be borne by the judgment  
27 creditor.

28 “(3) If two or more members of a household are joint judgment debtors,  
29 each judgment debtor shall be entitled to claim the exemptions in subsection  
30 (1)(a), (b), (c), (d) and (p) of this section in the same or different properties.

1 The exemptions provided by subsection (1)(a), (b), (c), (d), (j), (k) and (p) of  
2 this section, when claimed for jointly owned property, may be combined at  
3 the option of the **judgment** debtors.

4 “(4) Notwithstanding any other provision of law except ORS 657.855, if a  
5 writ of garnishment or other execution is issued to collect past due support  
6 as defined in ORS 18.600, 50 percent of unemployment compensation benefits,  
7 workers’ compensation benefits and other benefits paid to the **judgment**  
8 debtor by the United States, by the state or by a political subdivision of the  
9 state are exempt. The exemption related to unemployment compensation  
10 benefits provided by this subsection is subject to ORS 657.855. The ex-  
11 emption provided by this subsection applies without regard to whether the  
12 payment is made on a periodic basis or in a lump sum, including any lump  
13 sum payable pursuant to a settlement or judgment. Notwithstanding sub-  
14 section (1)(k) of this section, if a payment is made under a settlement or  
15 judgment on account of personal bodily injury and the garnishment or other  
16 execution is issued to collect past due support as defined in ORS 18.600, the  
17 lesser of 50 percent of the payment or \$7,500 is exempt.

18 **“SECTION 2.** ORS 18.348 is amended to read:

19 “18.348. (1) Funds that are exempt from execution under ORS 18.358,  
20 18.385, 178.345, 238.445, 344.580, 407.595, 411.760, 414.095, 655.530, 656.234,  
21 657.855 and 748.207 remain exempt when deposited in an account in a finan-  
22 cial institution as long as the exempt funds are reasonably identifiable.

23 “(2) Subsection (1) of this section does not apply to any accumulation of  
24 funds greater than \$7,500.

25 “(3) All funds that are exempt under federal law remain exempt when  
26 deposited in an account in a financial institution as long as the exempt funds  
27 are reasonably identifiable.

28 “(4) The application of subsections (1) and (3) of this section is not af-  
29 fected by the commingling of exempt and nonexempt funds in an account.  
30 For the purpose of identifying exempt funds in an account, first in, first out

1 accounting principles shall be used.

2 “(5) The provisions of this section do not affect the duties of a garnishee  
3 with respect to amounts in accounts that are not subject to garnishment  
4 under ORS [18.784] **18.785**.

5 **“SECTION 3.** ORS 18.385 is amended to read:

6 “18.385. (1) Except as provided in this section, 75 percent of the disposable  
7 earnings of an individual are exempt from execution.

8 “(2) **Except as provided in subsection (6) of this section,** the dispos-  
9 able earnings of an individual are exempt from execution to the extent that  
10 payment under a garnishment would result in net disposable earnings for an  
11 individual of less than the following amounts:

12 “[*(a) \$254 for any period of one week or less;*]

13 “[*(b) \$509 for any two-week period;*]

14 “[*(c) \$545 for any half-month period;*]

15 “[*(d) \$1,090 for any one-month period; and*]

16 “[*(e) For any other period longer than one week, \$254 multiplied by that*  
17 *fraction produced by dividing the number of days for which the earnings are*  
18 *paid by seven. The amount calculated under this paragraph must be rounded*  
19 *to the nearest dollar.*]

20 **“(a) For any period of one week or less:**

21 **“(A) For wages payable before January 1, 2025, \$254.**

22 **“(B) For wages payable on or after January 1, 2025, and before July**  
23 **1, 2025, \$305.**

24 **“(C) For wages payable on or after July 1, 2025, and before July 1,**  
25 **2026, \$338.**

26 **“(D) For wages payable on or after July 1, 2026, and before July 1,**  
27 **2027, \$400.**

28 **“(E) For wages payable on or after July 1, 2027, the minimum wage**  
29 **specified in ORS 653.025 (1), multiplied by 30.**

30 **“(b) For any two-week period:**

- 1       **“(A) For wages payable before January 1, 2025, \$509.**
- 2       **“(B) For wages payable on or after January 1, 2025, and before July**  
3 **1, 2025, \$611.**
- 4       **“(C) For wages payable on or after July 1, 2025, and before July 1,**  
5 **2026, \$675.**
- 6       **“(D) For wages payable on or after July 1, 2026, and before July 1,**  
7 **2027, \$832.**
- 8       **“(E) For wages payable on or after July 1, 2027, the minimum wage**  
9 **specified in ORS 653.025 (1), multiplied by 60.**
- 10       **“(c) For any half-month period:**
- 11       **“(A) For wages payable before January 1, 2025, \$545.**
- 12       **“(B) For wages payable on or after January 1, 2025, and before July**  
13 **1, 2025, \$655.**
- 14       **“(C) For wages payable on or after July 1, 2025, and before July 1,**  
15 **2026, \$737.**
- 16       **“(D) For wages payable on or after July 1, 2026, and before July 1,**  
17 **2027, \$912.**
- 18       **“(E) For wages payable on or after July 1, 2027, the minimum wage**  
19 **specified in ORS 653.025 (1), multiplied by 65.**
- 20       **“(d) For any one-month period:**
- 21       **“(A) For wages payable before January 1, 2025, \$1,090.**
- 22       **“(B) For wages payable on or after January 1, 2025, and before July**  
23 **1, 2025, \$1,309.**
- 24       **“(C) For wages payable on or after July 1, 2025, and before July 1,**  
25 **2026, \$1,458.**
- 26       **“(D) For wages payable on or after July 1, 2026, and before July 1,**  
27 **2027, \$1,792.**
- 28       **“(E) For wages payable on or after July 1, 2027, the minimum wage**  
29 **specified in ORS 653.025 (1), multiplied by 130.**
- 30       **“(e) For any other period longer than one week:**

1       “(A) The following amount multiplied by that fraction produced by  
2 dividing the number of days for which the earnings are paid by seven,  
3 rounded to the nearest dollar:

4       “(i) For wages payable before January 1, 2025, \$254.

5       “(ii) For wages payable on or after January 1, 2025, and before July  
6 1, 2025, \$305.

7       “(iii) For wages payable on or after July 1, 2025, and before July 1,  
8 2026, \$338.

9       “(iv) For wages payable on or after July 1, 2026, and before July 1,  
10 2027, \$400.

11       “(B) For wages payable on or after July 1, 2027, the minimum wage  
12 specified in ORS 653.025 (1), multiplied by 30 and multiplied again by  
13 that fraction produced by dividing the number of days for which the  
14 earnings are paid by seven. The amount calculated under this sub-  
15 paragraph must be rounded to the nearest dollar.

16       “(3) Beginning in 2027, the State Court Administrator shall calcu-  
17 late the exemption amounts specified in subsection (2) of this section  
18 each year on or before July 1 and shall publish the results of the cal-  
19 culations on the Judicial Department website. In making the calcu-  
20 lations, the State Court Administrator shall round to the nearest  
21 dollar. The adjusted exemption amounts become effective on July 1 of  
22 the year in which the State Court Administrator makes the calcu-  
23 lation.

24       “[(3)] (4) If an individual is paid for a period shorter than one week[.]:

25       “(a) The exemption calculated under subsection (2) of this section may  
26 not exceed [\$254] the following amount for any one-week period[.]:

27       “(A) For wages payable before January 1, 2025, \$254.

28       “(B) For wages payable on or after January 1, 2025, and before July  
29 1, 2025, \$305.

30       “(C) For wages payable on or after July 1, 2025, and before July 1,

1 2026, \$338.

2 “(D) For wages payable on or after July 1, 2026, and before July 1,  
3 2027, \$400.

4 “(E) For wages payable on or after July 1, 2027, the minimum wage  
5 specified in ORS 653.025 (1), multiplied by 30.

6 “(b) The exemption calculated under subsection (6) of this section  
7 may not exceed \$254.

8 “[4] (5) An employer shall deduct from the amount of disposable  
9 earnings determined to be nonexempt under subsections (1) [to (3)], (2) and  
10 (4) of this section any amounts withheld from the individual’s earnings for  
11 the same period of time under an order issued pursuant to ORS 25.378 or  
12 419B.408 or ORS chapter 110. The employer shall make payment under a  
13 garnishment only of those amounts remaining after the deduction is made.

14 “(6) If a writ of garnishment includes or is attached to a notice from  
15 a state or federal child support agency, or includes or is attached to  
16 an attestation that a debt arises out of a child support or spousal  
17 support obligation or a money award judgment that includes  
18 restitution, the individual’s disposable earnings are exempt only to the  
19 extent that payment under a garnishment would result in net dispos-  
20 able earnings for an individual of less than the following amounts:

21 “(a) \$254 for any period of one week or less;

22 “(b) \$509 for any two-week period;

23 “(c) \$545 for any half-month period;

24 “(d) \$1,090 for any one-month period; and

25 “(e) For any other period longer than one week, \$254 multiplied by  
26 that fraction produced by dividing the number of days for which the  
27 earnings are paid by seven. The amount calculated under this para-  
28 graph must be rounded to the nearest dollar.

29 “[5] (7) Subsections (1) to [4] (6) of this section do not apply to:

30 “(a) Any order of a court of bankruptcy.



1 “(b) Any debt due for federal tax.

2 “[6] (8) Subsections (2) to [(4)] (6) of this section do not apply to any  
3 debt due for state tax. Subsection (1) of this section does not apply to a debt  
4 due for state tax if a state agency issues a special notice of garnishment  
5 under ORS 18.855 (6).

6 “[7] (9) A court may not make, execute or enforce any order or process  
7 in violation of this section.

8 “[8] (10) Any waiver by an individual of the provisions of this section  
9 is void.

10 “[9] (11) An employer may not discharge any individual because the in-  
11 dividual has had earnings garnished.

12 **“SECTION 4.** ORS 18.395 is amended to read:

13 **“18.395. (1)(a) Except as provided in paragraph (b) of this subsection,**  
14 **a homestead [shall be] is exempt from sale on execution, from the lien of**  
15 **every judgment and from liability in any form for the debts of the owner to**  
16 **the amount in value of [\$40,000] \$150,000, except as otherwise provided by**  
17 **law. The exemption [shall be] is effective without the necessity of a claim**  
18 **thereof by the judgment debtor. When two or more members of a household**  
19 **are judgment debtors whose interests in the homestead are subject to sale**  
20 **on execution, the lien of a judgment or liability in any form, their combined**  
21 **exemptions under this section shall not exceed [\$50,000] \$300,000.**

22 **“(b) A homestead is exempt from sale on execution, from the lien**  
23 **of every judgment and from liability in any form for the debts of the**  
24 **owner arising out of a child support or spousal support obligation or**  
25 **a money award judgment that includes restitution to the amount in**  
26 **value of \$40,000, except as otherwise provided by law. The exemption**  
27 **is effective without the necessity of a claim thereof by the judgment**  
28 **debtor. When two or more members of a household are judgment**  
29 **debtors whose interests in the homestead are subject to sale on exe-**  
30 **cution, the lien of a judgment or liability in any form, their combined**

1 **exemptions under this section shall not exceed \$50,000.**

2 **“(c) To qualify for the exemption under paragraph (a) or (b) of this**  
3 **subsection,** the homestead must be the actual abode of and occupied by the  
4 owner, or the owner’s spouse, parent or child, but the exemption shall not  
5 be impaired by:

6 **“[(a)] (A) Temporary removal or temporary absence with the intention to**  
7 **reoccupy the same as a homestead;**

8 **“[(b)] (B) Removal or absence from the property; or**

9 **“[(c)] (C) The sale of the property.**

10 **“(d)(A) The State Court Administrator shall index the amounts**  
11 **identified as exempt from execution under paragraph (a) of this sub-**  
12 **section each year on or before July 1 to reflect increases or decreases**  
13 **in the cost of living for the previous calendar year, based on changes**  
14 **in the Consumer Price Index for All Urban Consumers, West Region**  
15 **(All Items), as published by the Bureau of Labor Statistics of the**  
16 **United States Department of Labor or a successor agency. The State**  
17 **Court Administrator shall publish the adjusted exemption limitations**  
18 **on the Judicial Department website. In adjusting the amounts, the**  
19 **State Court Administrator shall round to the nearest \$100, but shall**  
20 **use unrounded adjusted amounts to calculate the amounts of the ex-**  
21 **emptions during the succeeding year. The new amounts become ef-**  
22 **fective on July 1 of the year in which the State Court Administrator**  
23 **makes the adjustment.**

24 **“(B) The indexing described in subparagraph (A) of this paragraph**  
25 **does not apply to the amount of any exemption specified for a debt**  
26 **that arises out of a child support or spousal support obligation or a**  
27 **money award judgment that includes restitution.**

28 **“(2) The exemption [shall extend] extends to the proceeds derived from**  
29 **[such sale to an amount not exceeding \$40,000 or \$50,000, whichever amount]**  
30 **selling the homestead in the amount that is applicable under subsection**

1 (1)(a) or (b) of this section, if the proceeds are held for a period not ex-  
2 ceeding one year and held with the intention to procure another homestead  
3 therewith.

4 “(3) The exemption period under subsection [(1)(b) and (c)] **(1)(c)(B) and**  
5 **(C)** of this section [shall be] **is** one year from the removal, absence or sale,  
6 whichever occurs first.

7 “(4) When the owner of a homestead has been granted a discharge in  
8 bankruptcy or has conveyed the homestead property, the value thereof, for  
9 the purpose of determining a leviable interest in excess of the homestead  
10 exemption, [shall be] **is** the value on the date of the petition in bankruptcy,  
11 whether the value is determined in the bankruptcy proceedings or not, or on  
12 the date the conveyance becomes effective, whichever [shall first occur] **oc-**  
13 **curs first**. However, with respect to judgments not discharged in the bank-  
14 ruptcy, or entered against the owner after discharge, the value on the  
15 effective date of conveyance [shall be] **is** controlling.

16 “(5) Except as provided in subsection (7) of this section, [no] **a** homestead  
17 that is the actual abode of and occupied by the judgment debtor, or that is  
18 the actual abode of and occupied by a spouse, dependent parent or dependent  
19 child of the judgment debtor, [shall] **may not** be sold on execution to satisfy  
20 a judgment that at the time of entry does not exceed \$3,000. However, such  
21 judgment [shall remain] **remains** a lien upon the real property, and the  
22 property may be sold on execution:

23 “(a) At any time after the sale of the property by the judgment debtor;  
24 and

25 “(b) At any time after the property is no longer the actual abode of and  
26 occupied by the judgment debtor or the spouse, dependent parent or depend-  
27 ent child of the judgment debtor.

28 “(6) The limitation on execution sales imposed by subsection (5) of this  
29 section is not impaired by temporary removal or temporary absence with the  
30 intention to reoccupy the property as a homestead.

1 “(7) The limitation on execution sales imposed by subsection (5) of this  
2 section does not apply if two or more judgments are owing to a single judg-  
3 ment creditor and the total amount owing to the judgment creditor, deter-  
4 mined by adding the amount of each individual judgment as of the date the  
5 judgment was entered, is greater than \$3,000.

6 “(8) Upon the issuance of an order authorizing sale as required by ORS  
7 18.904, and in conformance with subsection (5) of this section, the sheriff  
8 may proceed to sell the property. If the homestead exemption applies, the  
9 sheriff shall pay the homestead owner out of the proceeds the [*sum of \$40,000*  
10 *or \$50,000, whichever is applicable,*] **applicable amount under subsection**  
11 **(1)(a) or (b) of this section** and apply the balance of the proceeds on the  
12 execution. However, [*no sale shall be made where the homestead* ] **the sheriff**  
13 **may not sell the homestead if an** exemption applies unless the sum bid for  
14 the homestead [*is in excess of the sum of the costs of sale and \$40,000 or*  
15 *\$50,000, whichever is applicable*] **exceeds the sum of the costs of the sale**  
16 **and the amount of the applicable exemption.** If no such bid is received,  
17 the **petitioner shall bear the** expense of the sale [*shall be borne by the*  
18 *petitioner*].

19 “(9) The homestead exemption provided by this section applies to a  
20 purchaser’s interest under a land sale contract, as defined by ORS 18.960.

21 “(10) The homestead exemption provided by this section applies to:

22 “(a) A floating home, as defined by ORS 830.700; and

23 “(b) A manufactured dwelling, as defined by ORS 446.003.

24 “**SECTION 5.** ORS 18.402 is amended to read:

25 “18.402. [*The homestead mentioned in ORS 18.395 shall consist*] **A home-**  
26 **stead described in ORS 18.395 consists**, when not located in any town or  
27 city laid off into blocks and lots, of any quantity of land not exceeding 160  
28 acres, and when located in any such town or city, of any quantity of land  
29 not exceeding one block. However, a homestead under this section [*shall not*  
30 *exceed in value the sum of \$40,000 or \$50,000, whichever amount is applicable*

1 *under*] **may not exceed in value the applicable amount specified in ORS**  
2 **18.395 (1)(a) or (b).**

3 **“SECTION 6.** ORS 18.412 is amended to read:

4 “18.412. (1) At any time after the date of execution of an agreement to  
5 transfer the ownership of property in which a homestead exemption exists  
6 pursuant to ORS 18.395, the homestead owner or the owner’s transferee may  
7 give notice of intent to discharge the property from the judgment lien to a  
8 judgment creditor. Each notice [*shall*] **must** bear the caption of the action  
9 in which the judgment was recovered and [*shall*] **must**:

10 “(a) Identify the property and the judgment and state that the judgment  
11 debtor is about to transfer, or has transferred, the property and that the  
12 transfer is intended to discharge the property from any lien effect of the  
13 judgment;

14 “(b) State the fair market value of the property on the date of the notice  
15 or of any applicable petition in bankruptcy, whichever is applicable, and list  
16 the encumbrances against the property, including the nature and date of each  
17 encumbrance, the name of the encumbrancer and the amount presently se-  
18 cured by each encumbrance;

19 “(c) State that the property is claimed by the person giving the notice to  
20 be wholly exempt from the lien of the judgment or, if the value of the prop-  
21 erty exceeds the sum of the encumbrances specified as required under para-  
22 graph (b) of this subsection that are senior to the judgment lien and [*\$40,000*  
23 *or \$50,000, whichever amount of the homestead exemption is applicable under*]  
24 **the applicable amount of the homestead exemption specified in ORS**  
25 **18.395 (1)(a) or (b),** that the amount of the excess or the amount due on the  
26 judgment, whichever is less, will be deposited with the court administrator  
27 for the court in which the judgment was entered for the use of the judgment  
28 holder; and

29 “(d) Advise the holder of the judgment that the property may be dis-  
30 charged from any lien arising from the judgment, without further notice to

1 the judgment creditor, unless prior to a specified date, which in no case may  
2 be earlier than 14 days after the date of mailing of the notice, the judgment  
3 creditor files objections and a request for a hearing on the matter as pro-  
4 vided in ORS 18.415.

5 “(2) Each notice described by subsection (1) of this section [*shall*] **must**  
6 be sent by certified mail to the judgment creditor, as shown by the court  
7 records, at the judgment creditor’s present or last-known address according  
8 to the best knowledge of the person sending the notice. A copy of each no-  
9 tice, together with proof of mailing, may be filed with the court administra-  
10 tor for the court in which the judgment was entered and [*shall*] **must** be  
11 filed by the court administrator with the records and files of the action in  
12 which the judgment was recovered.

13 **“SECTION 7.** ORS 18.600 is amended to read:

14 “18.600. As used in ORS 18.600 to 18.850:

15 “(1) ‘Account’ means an account at a financial institution, including a  
16 master account or subaccount, to which an electronic payment may be di-  
17 rectly routed.

18 “(2) ‘Check’ has the meaning given that term in ORS 73.0104.

19 “(3) ‘Creditor’ means a person to whom a debt is owed by a debtor.

25 “(a) A benefit payment from the United States Social Security Adminis-  
26 tration that is protected under 42 U.S.C. 407 and 1383(d)(1);

27 “(b) A benefit payment from the United States Department of Veterans  
28 Affairs that is protected under 38 U.S.C. 5301(a);

29 “(c) A benefit payment from the Railroad Retirement Board that is pro-  
30 tected under 45 U.S.C. 231m(a) and 352(e); or

1 “(d) A benefit payment from the United States Office of Personnel Man-  
2 agement that is protected under 5 U.S.C. 8346 and 8470.

3 “(7) ‘Financial institution’ means a financial institution or trust company

20 INSTRUCTIONS TO GARNISHEE

21

22 Except as specifically provided in these instructions, you must complete  
23 and deliver the Garnishee Response within seven calendar days after you  
24 receive the writ of garnishment. If the writ does not comply with Oregon  
25 law, the writ is not effective to garnish any property of the Debtor, but you  
26 still must complete and deliver the Garnishee Response. You must complete  
27 and deliver the response even though you cannot determine from the writ  
28 whether you hold any property or owe any debt to the Debtor. If the seventh  
29 calendar day is a Saturday, Sunday or legal holiday, you must deliver your  
30 response on or before the next following day that is not a Saturday, Sunday



1 or legal holiday.

2

3 The writ is not effective, and you need not make a Garnishee Response,  
4 if:

6 • You do not receive the writ within 60 days after the date of issuance  
7 shown on the face of the writ.

9 • You do not receive an original writ of garnishment or a copy of the

12 Statutes that may affect your rights and duties under the writ can be

15 NOTE: The Garnishor may be the Creditor, the attorney for the Creditor  
16 or some other person who is authorized by law to issue the writ of  
17 garnishment. See the writ to determine who the Garnishor is.

18

19 STEP 1. FILL OUT THE GARNISHEE RESPONSE.

20

21 All garnishees who are required to deliver a garnishee response must fill  
22 in Part I of the Garnishee Response. Garnishees who employ the Debtor must  
23 also fill in Part II of the response. You should keep a copy of the response  
24 for your records.

25

26 Completing Part I of the Garnishee Response. If you discover before you  
27 deliver your response that a bankruptcy petition has been filed by or on be-  
28 half of the Debtor, and the bankruptcy petition was filed after a judgment  
29 was entered against the Debtor or after the debt otherwise became subject  
30 to garnishment (see the date specified in the writ), you must put a check by

1 the appropriate statement in Part I. If a bankruptcy petition has been filed,  
2 you should not make any payments to the Garnishor unless the court orders  
3 otherwise. You need not complete any other part of the response, but you  
4 still must sign the response and deliver it in the manner described in Step  
5 2 of these instructions.

6 In all other cases you must list in Part I all money and personal property  
7 of the Debtor that is in your possession, control or custody at the time of  
8 delivery of the writ. You must also list all debts that you owe to the Debtor,  
9 whether or not those debts are currently due (e.g., money loaned to you by  
10 the Debtor that is to be repaid at a later time).

11 If you are the employer of the Debtor at the time the writ is delivered to  
12 you, you must put a check by the appropriate statement in Part I. In addi-  
13 tion, you must complete Part II of the response.

14 If you believe that you may hold property of the Debtor or that you owe  
15 a debt to the Debtor, but you are not sure, you must put a check by the  
16 appropriate statement and provide an explanation. When you find out what  
17 property you hold that belongs to the Debtor, or you find out whether you  
18 owe money to the Debtor and how much, you must prepare and deliver an  
19 amended response. You must do this even if you find out that you have no  
20 property of the Debtor or that you do not owe anything to the Debtor.

21 If you determine that the writ, on its face, does not comply with Oregon  
22 laws governing writs of garnishment, or if you are unable to determine the  
23 identity of the Debtor from the information in the writ, then the writ is not  
24 effective to garnish any property of the Debtor. You must put a check by the  
25 appropriate statement in Part I and provide an explanation. You still must  
26 complete the response and deliver the response in the manner described in  
27 Step 2 of these instructions.

28 If you have received an order to withhold income that applies to the in-  
29 come of the Debtor and that order has priority over the garnishment, and if  
30 compliance with the order will reduce or eliminate the money or property

1 that you would otherwise deliver under the garnishment, you must put a  
2 check by the appropriate statement in Part I. You still must fill out the re-  
3 mainder of the response and deliver the response in the manner described in  
4 Step 2 of these instructions. If you employ the Debtor, you still must com-  
5 plete Part II of the response.

6 If you receive notice of a challenge to the garnishment before you send  
7 your response, you must complete and deliver your response as otherwise  
8 required by these instructions. However, see Step 3 of these instructions re-  
9 garding payment of money or delivery of property after receipt of notice of  
10 a challenge to the garnishment.

11 If you owe a debt to the Debtor and the Debtor owes a debt to the holder  
12 of an underlying lien on your property, you may be able to offset the amount  
13 payable to the underlying lienholder. See ORS 18.620. You must note that  
14 you have made the offset in Part I of the response (under “Other”) and  
15 specify the amount that was offset.

16

17 Completing Part II of the Garnishee Response (employers only). You must  
18 fill in Part II of the response if you employ the Debtor on the date the writ  
19 of garnishment is delivered to you, or if you previously employed the Debtor  
20 and still owe wages to the Debtor on the date the writ is delivered to you.

21

22 Wages affected. Except as provided below, the writ garnishes all wages  
23 that you owe to the Debtor for work performed before the date you received  
24 the writ, even though the wages will not be paid until a later date. The writ  
25 also garnishes all wages that are attributable to services performed during  
26 the 90-day period following the date you received the writ, even though you  
27 would not pay the Debtor for all or part of those services until after the end  
28 of the 90-day period. Wages subject to garnishment under the writ include  
29 all amounts paid by you as an employer, whether on an hourly, weekly or  
30 monthly basis, and include commission payments and bonuses.

1        Example 1: Debtor A is employed by you and is paid a monthly salary  
2        on the first day of each month. You receive a writ of garnishment on  
3        July 17. The writ garnishes all wages that you owe to Debtor A for  
4        work performed on or before July 17. If Debtor A was paid on July 1  
5        for services performed in the month of June, the writ garnishes Debtor  
6        A's salary for the period beginning July 1 and ending October 15 (90  
7        days after receipt of the writ).

8  
9        The writ does not garnish any wages you owe to a Debtor for a specific  
10       pay period if:

11       (a) The writ is delivered to you within two business days before the  
12       Debtor's normal payday for the pay period;

13       (b) When the writ is delivered to you, the Debtor's wages are paid by di-  
14       rect deposit to a financial institution, or you use an independent contractor  
15       as payroll administrator for your payroll; and

16       (c) Before the writ was delivered to you, you issued instructions to the  
17       financial institution or the payroll administrator to pay the Debtor for the  
18       pay period.

19       If any wages are not garnishable by reason of the issuance of instructions  
20       to a financial institution or a payroll administrator as described above, you  
21       must so note in the Garnishee Response. Thereafter, you must pay to the  
22       Garnishor all wages that are subject to garnishment that are attributable to  
23       services performed by the Debtor during the 90-day period following the date  
24       you received the writ.

25  
26       Calculation of wages subject to garnishment. A Wage Exemption Calcu-  
27       lation form is attached to the writ of garnishment. You must use this form  
28       to calculate the amount of the Debtor's wages that is subject to garnishment.  
29       You should read the instructions printed on the Wage Exemption Calculation  
30       form to determine the normal wage exemption and the minimum wage ex-

1 exemption for each payment you make under the writ.

2 A Wage Exemption Calculation form must be sent with the first payment  
3 you make under the writ. For the 90-day period during which the writ is ef-  
4 fective, you must also fill out and return a Wage Exemption Calculation  
5 form with a subsequent payment any time the initial calculation changes.  
6 Finally, you must fill out and return a Wage Exemption Calculation form  
7 with the final payment that you make under the writ.

8

9 Payment of amount subject to garnishment. Payments under the writ must  
10 be made at the following times, unless the amount owing on the judgment  
11 or other debt is fully paid before the final payment is made or the writ is  
12 released:

13 (a) You must make a payment to the Garnishor of all wages subject to  
14 garnishment at the time you next pay wages to the Debtor. Complete the  
15 wage exemption computation, using the Wage Exemption Calculation form,  
16 to determine the portion of the Debtor's wages that is subject to  
17 garnishment. Be sure to adjust the minimum exemption amount for any  
18 payment that covers less than a full pay period. You must include a copy  
19 of the Wage Exemption Calculation form with this first payment.

20

21 Example 2: Using the facts given in Example 1, when you next make  
22 any payment of wages to Debtor A after you receive the writ on July  
23 17, you must complete the Wage Exemption Calculation form and send  
24 the form to the Garnishor along with all amounts determined to be  
25 subject to garnishment that are attributable to the period covered by  
26 the payment. If you pay Debtor A on August 1, the payment will be  
27 for all wages attributable to the period beginning July 1 and ending  
28 July 31.

29

30 (b) Unless the writ of garnishment is satisfied or released, during the

1 90-day period following the date you received the writ, you must pay to the  
2 Garnishor all wages that are determined to be subject to garnishment  
3 whenever you issue a paycheck to the Debtor. If the Debtor is paid on a  
4 weekly basis, you must make payment under the writ on a weekly basis. If  
5 the Debtor is paid on a monthly basis, you must make payment under the  
6 writ on a monthly basis. If the amount paid to the Debtor varies from pay-  
7 check to paycheck, or changes at any time from the amount being paid at  
8 the time the writ was delivered to you, you must perform a new wage ex-  
9 emption computation to determine the amount of wages subject to  
10 garnishment under the writ. You must send a copy of the new Wage Ex-  
11 emption Calculation form with your payment to the Garnishor.

12

13 Example 3: Using the facts given above, as you make each subsequent  
14 payment of wages to Debtor A you must make a payment of that por-  
15 tion of the Debtor's wages that are subject to garnishment. If you  
16 continue to pay Debtor A on the first of each month, payments must  
17 be made on September 1 and October 1.

18

19 (c) Upon the expiration of the 90-day period, you must make a final pay-  
20 ment to the Garnishor for all wages that were owing to the Debtor for the  
21 work performed by the Debtor through the 90th day following your receipt  
22 of the writ. This payment may be made at the time of the Debtor's next  
23 paycheck. You will need to complete another Wage Exemption Calculation  
24 form to determine the amount of the wages subject to garnishment.

25

26 Example 4: Using the facts given above, you must make a final pay-  
27 ment for the wages owing to Debtor A for the period beginning Octo-  
28 ber 1 and ending October 15. You may make this payment at the time  
29 you issue Debtor A's paycheck on November 1, but you must make the  
30 payment at any time you issue a paycheck to Debtor A after October

1 15. Be sure that in completing the wage exemption computation for the  
2 final payment you adjust the minimum exemption amount to take into  
3 account the fact that the period covered is only 15 days of the full  
4 month (see instructions on Wage Exemption Calculation form).

5  
6 Processing fee. You may collect a \$2 processing fee for each week of  
7 wages, or fraction of a week of wages, for which a payment is made under  
8 the writ. The fee must be collected after you make the last payment under  
9 the writ. The fee must be withheld from the wages of the debtor, and is in  
10 addition to the amounts withheld for payment to the Garnishor under the  
11 writ or under any other writ you have received.

12  
13 If you receive more than one writ of garnishment. If you receive a second  
14 writ of garnishment for the same Debtor from another Garnishor, the first  
15 writ will have priority for wages. The priority of the first writ lasts for the  
16 90-day period following delivery of that writ to you, or until the first writ  
17 is paid in full, whichever comes first. In your response to the second writ,  
18 you must put a check by the appropriate statement in Part II and indicate  
19 the date on which the first writ will expire (90 days after the date you re-  
20 ceived the writ). You should make no payments under the second writ until  
21 expiration of the first writ. The expiration date of the second writ is 90 days  
22 after the date you received the second writ; the expiration date is not af-  
23 fected by any delay in payment attributable to the priority of the first writ.

24  
25 STEP 2. DELIVER THE GARNISHEE RESPONSE.

26  
27 You must deliver your Garnishee Response and copies of the response in  
28 the manner provided in this step. The response and copies may be mailed or  
29 delivered personally.

1 You must complete and deliver the Garnishee Response within seven  
2 calendar days after you receive the writ of garnishment. If the seventh cal-  
3 endar day is a Saturday, Sunday or legal holiday, you must deliver your re-  
4 sponse on or before the next following day that is not a Saturday, Sunday  
5 or legal holiday.

6

7 If you are required to hold any property under the writ or make any  
8 payment under the writ, either at the time of making your response or later,  
9 you must:

10 (a) Send the original of your Garnishee Response to the Garnishor at the  
11 address indicated on the writ under Important Addresses.

12 (b) Send a copy of your Garnishee Response to the court administrator  
13 at the address indicated on the writ under Important Addresses.

14 (c) Send a copy of your Garnishee Response to the Debtor if an address  
15 is indicated on the writ under Important Addresses.

16

17 If you are not required to hold any property under the writ or make any  
18 payment under the writ, either at the time of making your response or later,  
19 you must:

20 (a) Send the original of your Garnishee Response to the Garnishor at the  
21 address indicated on the writ under Important Addresses.

22 (b) Send a copy of your Garnishee Response to the Debtor if an address  
23 is indicated on the writ under Important Addresses.

24

25 STEP 3. DELIVER THE FUNDS OR OTHER PROPERTY.

26

27 As long as the writ is in effect, you may be liable to the Creditor if you  
28 pay any debt or turn over any property to the Debtor except as specifically  
29 allowed by law. If you have any money or property of the Debtor in your  
30 possession, control or custody at the time of delivery of the writ, or owe any



1 debt to the Debtor, you must pay the money or hold the property as required  
2 by this step. Exceptions to this requirement are listed below.

3

4 IF YOU ARE HOLDING MONEY FOR THE DEBTOR OR OWE A DEBT  
5 THAT IS CURRENTLY DUE, you must pay the money to the Garnishor with  
6 your response. You must send your payment to the Garnishor at the address  
7 indicated on the writ under Important Addresses. Make your check payable  
8 to the Garnishor.

9

10 IF YOU OWE A DEBT TO THE DEBTOR THAT WILL BECOME DUE  
11 WITHIN 45 DAYS AFTER THE DATE YOU RECEIVED THE WRIT, you  
12 must send your payment directly to the Garnishor at the address provided  
13 in the writ when the debt becomes due. Make your check payable to the  
14 Garnishor.

15

16 IF YOU ARE HOLDING PROPERTY THAT BELONGS TO THE  
17 DEBTOR, OR OWE A DEBT TO THE DEBTOR THAT WILL NOT BECOME  
18 DUE WITHIN 45 DAYS AFTER THE DATE YOU RECEIVED THE WRIT,  
19 you must keep the property or debt in your possession, control or custody  
20 until you receive written notice from the Sheriff. The Sheriff's notice will  
21 tell you what to do with the property or debt. If you have followed all of the  
22 instructions in the writ and you receive no notice from the Sheriff within  
23 30 days after the date on which you delivered your Garnishee Response, you  
24 may treat the writ as being of no further force or effect.

25

26 EXCEPTIONS:

27

28 1. Challenge to garnishment or specific directions from court. If you are  
29 making any payments under the garnishment and before making a payment  
30 you receive notice of a challenge to the garnishment from the court, or re-

1 ceive a specific direction from the court to make payments to the court, you  
2 must send or deliver the payment directly to the court administrator. If the  
3 money is currently due when you receive the notice, send the payment  
4 promptly to the court. If the payment is for a debt that is payable within 45  
5 days after you receive the writ, make the payment to the court promptly  
6 when it becomes due. If you make payment by check, make the check payable  
7 to the State of Oregon. Because you may be liable for any payment that does  
8 not reach the court, it is better not to send cash by mail.

9 A challenge to the garnishment does not affect your duty to follow the  
10 instructions you receive from the Sheriff for property that belongs to the  
11 Debtor and debts that you owe to the Debtor that do not become due within  
12 45 days.

13

14 2. Previous writ of garnishment. If you receive a second writ of  
15 garnishment for the same Debtor from another Garnishor, the first writ will  
16 have priority and you need not make payments or deliver property under the  
17 second writ to the extent that compliance with the first writ will reduce or  
18 eliminate the payment of money or delivery of property that you would oth-  
19 erwise make under the garnishment. You must still deliver a Garnishee Re-  
20 sponse to the second writ, and must commence payment under the second  
21 writ as soon as the first writ is satisfied or expires.

22

23 3. Offset for payment of underlying lien. If you owe a debt to the Debtor  
24 and the Debtor owes a debt to the holder of an underlying lien on your  
25 property, you may be able to offset the amount payable to the underlying  
26 lienholder. See ORS 18.620.

27

28 4. Subsequent events:

29

30 (a) Bankruptcy. If you make your response and then discover that a vol-

1untary or involuntary bankruptcy petition has been filed by or on behalf of  
2the Debtor after the judgment was entered against the Debtor or after the  
3debt otherwise became subject to garnishment (see date in writ), you may  
4not make any further payments or delivery of property under the writ unless  
5the court orders otherwise. If you have not delivered all property that is  
6subject to garnishment under this writ when you discover that a bankruptcy  
7petition has been filed, you must mail the following notice to the Garnishor  
8and to the Debtor.

9

10 (b) Order to withhold income. If you make your response and then receive  
11 an order to withhold income that has priority over the writ, you may make  
12 payments or deliver property under the writ only after payment of the  
13 amounts required under the order to withhold income. If you have not de-  
14 livered all property that is subject to garnishment under this writ when you  
15 receive an order to withhold income that has priority, you must mail the  
16 following notice to the Garnishor and to the Debtor.

1 Items), as published by the Bureau of Labor Statistics of the United  
2 States Department of Labor or a successor agency, and may vary from  
3 year to year.

4 (3) If, after making the determination in (1)(d) above, you find that  
5 the total amount in all of the Debtor's accounts with your institution  
6 exceeds the base protected account balance shown on the Oregon Ju-  
7 dicial Department website as exempt from garnishment:

8 (a) The base protected account balance is not subject to  
9 garnishment.

10 (b) You must provide full customary access to the base protected

7       **(5) If in the garnishment account review you determine that any**  
8 **of the payments listed in (4) above were made by direct deposit or**  
9 **electronic transfer to any of the Debtor's accounts with your institu-**  
10 **tion within the lookback period, you may not garnish, and must pro-**  
11 **vide full customary access to, the sum of:**

7 Before making a payment under the writ, you may first deduct any pro-

14 You need not deliver any property contained in a safe deposit box unless  
15 the Garnishor pays you in advance for the costs that will be incurred in

18 If you are required to conduct a garnishment account review and you  
19 determine from the review that one or more of the payments listed in ORS  
20 [18.784 (3)] **18.785 (2)(c)(B)** have been deposited into the Debtor’s account  
21 by direct deposit or electronic payment during the lookback period described  
22 in ORS [18.784 (2)] **18.785 (2)(d)**, and that there is a positive balance in the  
23 account, you must issue a notice to the account holder in substantially the  
24 form set forth in ORS 18.847. The notice must be issued directly to the ac-  
25 count holder or to a fiduciary who administers the account and receives  
26 communications on behalf of the account holder. The notice must be sent  
27 separately to the account holder and may not be included with other mate-  
28 rials being provided to the account holder that do not relate to the  
29 garnishment. You must send the notice to the account holder within three  
30 business days after you complete the garnishment account review. You may

1 issue one notice with information related to multiple accounts of a single  
2 account holder.

24 (e.g., for the final payment at the end of the 90-day period covered by  
25 the writ).

26

27        **Example 2:** You pay Debtor A on a monthly basis. You are re-  
28 quired to make a final payment under a writ of garnishment for  
29 the wages owing to Debtor A for the period beginning October 1  
30 and ending October 15. This period is equal to 2.143 weeks (15

1           divided by 7). The minimum exemption is \$544 ( $\$254 \times 2.143$   
2           rounded to the nearest dollar).

3  
4           The amount of time actually worked by the Debtor during the pe-  
5           riod covered by the paycheck does not affect the calculation of the  
6           minimum exemption.

7  
8           Example 3: You pay Debtor A on a weekly basis. Debtor A works  
9           two days per week. The minimum exemption is \$254 for each  
10          weekly payment you make for Debtor A.

11  
12          If the payment you are making is based on a period of time less  
13          than one week, the minimum wage exemption may not exceed \$254 for  
14          any one-week period.

15  
16          If you receive more than one writ of garnishment. If you receive  
17          more than one writ of garnishment for the same debtor, the writs have  
18          priority based on the date on which you receive them. If the full  
19          amount of wages subject to garnishment for a given pay period is paid  
20          on the first writ, you should not make any payment on subsequently  
21          received writs until the first writ expires. In some cases, it may be  
22          necessary to make payments on two or more writs for the same pay  
23          period.

24  
25          Example 4: You have received two writs of garnishment for  
26          Debtor A. You pay Debtor A on a monthly basis. The first writ  
27          expires on October 16. The second writ will not expire until No-  
28          vember 15. You will need to prepare two wage exemption calcu-  
29          lation forms for Debtor A's October wages and make payments  
30          under both writs. The wage exemption calculation form for the

1 first writ will be for the wages attributable to October 1 to Oc-  
2 tober 15 as described in Example 2. The wage exemption calcu-  
3 lation form for the second writ will be for all wages for the  
4 month of October, but the amounts withheld under the first writ  
5 must be subtracted on Line 8 to determine the October wages  
6 subject to garnishment under the second writ.

2 business, engages in consumer transactions that result in a consumer owing  
3 a debt to the person.

4 “(f) ‘Debt’ means an obligation or alleged obligation that arises out of a

6 “(g)(A) ‘Debt buyer’ means a person that regularly engages in the business  
7 of purchasing charged-off debt for the purpose of collecting the charged-off  
8 debt or hiring another person to collect or bring legal action to collect the  
9 charged-off debt.

10 “(B) ‘Debt buyer’ does not include a person that acquires charged-off debt  
11 as an incidental part of acquiring a portfolio of debt that is predominantly  
12 not charged-off debt.

13 “(h) ‘Debt collector’ means a person that by direct or indirect action,  
14 conduct or practice collects or attempts to collect a debt owed, or alleged  
15 to be owed, to a creditor or debt buyer.

16 “(i) ‘Debtor’ means a consumer who owes or allegedly owes a debt, in-  
17 cluding a consumer who owes an amount that differs from the amount that  
18 a debt collector attempts to collect or that a debt buyer purchased or at-  
19 tempts to collect.

20 “(j) ‘Legal action’ means a lawsuit, mediation, arbitration or any other  
21 proceeding in any court, including a small claims court.

22 “(k) ‘Original creditor’ means the last entity that extended credit to a  
23 consumer to purchase goods or services, to lease goods or as a loan of mon-  
24 eys.

25 “(L) ‘Person’ means an individual, corporation, trust, partnership, incor-  
26 porated or unincorporated association or any other legal entity.

27 “(2) A debt collector engages in an unlawful collection practice if the debt  
28 collector, while collecting or attempting to collect a debt, does any of the  
29 following:

30 “(a) Uses or threatens to use force or violence to cause physical harm to

1 a debtor or to the debtor's family or property.

2 "(b) Threatens arrest or criminal prosecution.

3 "(c) Threatens to seize, attach or sell a debtor's property if doing so re-  
4 quires a court order and the debt collector does not disclose that seizing,  
5 attaching or selling the debtor's property requires prior court proceedings.

6 "(d) Uses profane, obscene or abusive language in communicating with a  
7 debtor or the debtor's family.

8 "(e) Communicates with a debtor or any member of the debtor's family  
9 repeatedly or continuously or at times known to be inconvenient to the  
10 debtor or any member of the debtor's family and with intent to harass or  
11 annoy the debtor or any member of the debtor's family.

12 "(f) Communicates or threatens to communicate with a debtor's employer  
13 concerning the nature or existence of the debt.

14 "(g) Communicates without a debtor's permission or threatens to commu-  
15 nicate with the debtor at the debtor's place of employment if the place of  
16 employment is other than the debtor's residence, except that the debt col-  
17 lector may:

18 "(A) Write to the debtor at the debtor's place of employment if a home  
19 address is not reasonably available and if the envelope does not reveal that  
20 the communication is from a debt collector other than the person that pro-  
21 vided the goods, services or credit from which the debt arose.

22 "(B) Telephone a debtor's place of employment without informing any  
23 other person of the nature of the call or identifying the caller as a debt  
24 collector but only if the debt collector in good faith has made an unsuc-  
25 cessful attempt to telephone the debtor at the debtor's residence during the  
26 day or during the evening between the hours of 6 p.m. and 9 p.m. The debt  
27 collector may not contact the debtor at the debtor's place of employment  
28 more frequently than once each business week and may not telephone the  
29 debtor at the debtor's place of employment if the debtor notifies the debt  
30 collector not to telephone at the debtor's place of employment or if the debt

1 collector knows or has reason to know that the debtor's employer prohibits  
2 the debtor from receiving such communication. For the purposes of this  
3 subparagraph, any language in any agreement, contract or instrument that  
4 creates or is evidence of the debt and that purports to authorize telephone  
5 calls at the debtor's place of employment does not give permission to the debt  
6 collector to call the debtor at the debtor's place of employment.

7       “(h) Communicates with a debtor in writing without clearly identifying  
8 the name of the debt collector, the name of the person, if any, for whom the  
9 debt collector is attempting to collect the debt and the debt collector's  
10 business address, on all initial communications. In subsequent communi-  
11 cations involving multiple accounts, the debt collector may eliminate the  
12 name of the person, if any, for whom the debt collector is attempting to  
13 collect the debt and substitute the term 'various' in place of the person's  
14 name.

15       “(i) Communicates with a debtor orally without disclosing to the debtor,  
16 within 30 seconds after beginning the communication, the name of the indi-  
17 vidual who is initiating the communication and the true purpose of the  
18 communication.

19       “(j) Conceals the true purpose of the communication so as to cause any  
20 expense to a debtor in the form of long distance telephone calls, telegram  
21 fees, additional charges for wireless communication or other charges the  
22 debtor might incur by using a medium of communication.

23       “(k) Attempts or threatens to enforce a right or remedy while knowing  
24 or having reason to know that the right or remedy does not exist, or  
25 threatens to take any action that the debt collector in the regular course of  
26 business does not take.

27       “(L) Uses any form of communication that simulates legal or judicial  
28 process or that appears to be authorized, issued or approved by a govern-  
29 mental agency, governmental official or an attorney at law if the corre-  
30 sponding governmental agency, governmental official or attorney at law has

1 not in fact authorized or approved the communication.

2 “(m) Represents that an existing debt may be increased by the addition  
3 of attorney fees, investigation fees or any other fees or charges if the fees  
4 or charges may not legally be added to the existing debt.

5 “(n) Collects or attempts to collect, **by any means, including through**  
6 **legal action**, interest or other charges or fees that exceed the actual debt  
7 unless the agreement, contract or instrument that creates the debt expressly  
8 authorizes, or a law expressly allows, the interest or other charges or fees.  
9 **A debt collector may not be held liable in any action brought under**  
10 **this paragraph if the debt collector shows by a preponderance of evi-**  
11 **dence that the violation was not intentional and resulted from a bona**  
12 **vide error notwithstanding the maintenance of procedures reasonably**  
13 **adapted to avoid any such error. The fact that the debt collector ob-**  
14 **tains a judgment for less than the amount sought in the complaint,**

21 as those terms are defined in ORS 171.725.

22 “(q) Collects or attempts to collect any debt that the debt collector knows,  
23 or after exercising reasonable diligence would know, arises from medical  
24 expenses that qualify for reimbursement under the Oregon Health Plan or  
25 under Medicaid, except that:

26 “(A) The debt collector does not engage in an unlawful collection practice  
27 if the debt collector can produce an affidavit or certificate from the original  
28 creditor that shows that the original creditor complied with Oregon Health  
29 Authority rules barring payments for services that Medicaid fee-for-service  
30 plans or contracted health care plans cover; and



1 “(B) For purposes of this paragraph, a prepaid managed care health ser-  
2 vices organization, a coordinated care organization or a public body, as de-  
3 fined in ORS 174.109, or an agent or assignee of the organization or public  
4 body, is not a debt collector if the organization or public body seeks to col-  
5 lect a debt that arises under ORS 416.540.

6 “(r) Files a legal action to collect or files a legal action to attempt to  
7 collect a debt if the debt collector knows, or after exercising reasonable  
8 diligence would know, that an applicable statute of limitations bars the col-  
9 lection or the collection attempt.

10 “[s) *Knowingly collects any amount, including any interest fee, charge or*  
11 *expense incidental to the principal obligation, unless the amount is expressly*  
12 *authorized by the agreement creating the debt or permitted by law.*]

13 “(s) **Collects or attempts to collect or threatens to collect a debt by**  
14 **any means, including through legal action, while knowing or having**  
15 **reason to know that the debt does not exist or is not owed by the**  
16 **debtor. A debt collector may not be held liable in any action brought**  
17 **under this paragraph if the debt collector shows by a preponderance**  
18 **of evidence that the violation was not intentional and resulted from**

1 “(3) A debt collector engages in an unlawful collection practice if the debt  
2 collector, by use of any direct or indirect action, conduct or practice, en-  
3 forces or attempts to enforce an obligation made void and unenforceable by  
4 the provisions of ORS 759.720 (3) to (5).

5 “(4) A debt buyer or debt collector acting on behalf of a debt buyer en-  
6 gages in an unlawful collection practice if the debt buyer or debt collector:

7 “(a) Files legal action against a debtor or files legal action to attempt to  
8 collect a debt if the debt buyer or debt collector knows or after exercising  
9 reasonable diligence would know that an applicable statute of limitations  
10 bars the legal action to collect or the legal action to attempt to collect the  
11 debt;

12 “(b) Brings a legal action against a debtor or otherwise brings a legal  
13 action to attempt to collect a debt without possessing business records that  
14 satisfy the requirements of ORS 40.460 (6), or of ORS 24.115, if the record is

13 “(H) A copy of the agreement between the original creditor and the debtor  
14 that is either:

15 “(i) The contract or other writing the debtor signed that created and is  
16 evidence of the original debt; or

17 “(ii) A copy of the most recent monthly statement that shows a purchase  
18 transaction or balance transfer or the debtor’s last payment, if the debtor  
19 made a payment, if the debt is a credit card debt or other debt for which a  
20 contract or other writing that is evidence of the debt does not exist;

21 “(c) Fails to provide to a debtor, after the debt buyer or debt collector  
22 receives payment in cash or the debtor requests the receipt, a receipt that:

23 “(A) Shows the name of the creditor or creditors for whom the debt buyer  
24 or debt collector received the payment and, if the creditor is not the original  
25 creditor, the account number that the original creditor assigned; and

26 “(B) States clearly whether the debt buyer or debt collector accepts the  
27 payment as payment in full or as a full and final compromise of the debt and,  
28 if not, the balance remaining on the debt after the payment;

29 “(d) Collects or attempts to collect a debt before providing, in response  
30 to a debtor’s request, the documents required under paragraph (b) of this

1 subsection. A debt buyer or a debt collector that acts on the debt buyer’s  
2 behalf does not engage in an unlawful collection practice under this para-  
3 graph if the debt buyer or debt collector collects or attempts to collect a debt  
4 after providing the required documents to the debtor; or

5 “(e) Uses any direct or indirect action, conduct or practice to violate a  
6 provision of this section or ORS 646A.670.

7 “(5) A debt collector is not acting on a debt buyer’s behalf, and is not  
8 subject to the duties to which a debt buyer is subject under this section and  
9 ORS 646A.670, if the debt collector collects or attempts to collect a debt on  
10 behalf of an owner that retains a direct interest in the debt or if the debt  
11 is not a debt that a debt buyer purchased.

12 **“SECTION 30.** ORS 646.641 is amended to read:

13 “646.641. (1) Any person injured as a result of willful use or employment  
14 by another person of an unlawful collection practice may bring an action in  
15 an appropriate court to enjoin the practice or to recover actual damages or  
16 [~~\$200~~] **\$1,000**, whichever is greater. The court or the jury may award punitive  
17 damages, and the court may provide such equitable relief as it deems neces-  
18 sary or proper.

19 “(2) In any action brought by a person under this section, the court may  
20 award reasonable attorney fees [*to the prevailing party*] **and costs at trial**  
21 **and on appeal to a prevailing plaintiff. The court may award reason-**  
22 **able attorney fees and costs at trial and on appeal to a prevailing de-**  
23 **fendant only if the court finds that the plaintiff had no objectively**  
24 **reasonable basis for bringing the action or asserting the ground for**  
25 **appeal.**

26 “(3) Actions brought under this section shall be commenced within [*one*  
27 *year*] **three years** from the date of the injury.

29 **“SECTION 32.** (1) **Sections 19 and 27 of this 2024 Act and the**

5 “(a) Become operative on January 1, 2025; and

6 “(b) Apply to writs of garnishment and writs of execution issued  
7 on or after January 1, 2025, and to notices of wage garnishment that  
8 are in effect on or after January 1, 2025.

9 “(2) An agency of state government, as defined in ORS 174.111, may  
10 take any action before the operative date specified in subsection (1)  
11 of this section to enable the agency to exercise, on and after the op-  
12 erative date specified in subsection (1) of this section, all of the duties,  
13 functions and powers conferred on the agency by sections 19 and 27  
14 of this 2024 Act and the amendments to ORS 18.345, 18.348, 18.385,  
15 18.395, 18.402, 18.412, 18.600, 18.618, 18.658, 18.785, 18.787, 18.788, 18.790,  
16 18.835, 18.838, 18.840, 18.845, 18.847, 18.854, 18.855, 18.888, 18.892, 18.896  
17 and ORCP 84 D by sections 1 to 17, 20 to 25 and 28 of this 2024 Act and  
18 the repeal of ORS 18.784 by section 31 of this 2024 Act.

19 “SECTION 33. The amendments to ORS 646.639 and 646.641 by  
20 sections 29 and 30 of this 2024 Act apply to attempts to collect a debt  
21 that occur on or after the effective date of this 2024 Act.

22 “SECTION 34. This 2024 Act being necessary for the immediate  
23 preservation of the public peace, health and safety, an emergency is  
24 declared to exist, and this 2024 Act takes effect on its passage.”.

25
