"SECTION 3. In addition to and not in lieu of any other appropriation, there is appropriated to the Oregon Business Development Department, for the biennium ending June 30, 2025, out of the General Fund, the amount of \$250,000, for the purpose of carrying out section 4 of this 2024 Act.

"(b) Relevant state agencies, including but not limited to the Department of Environmental Quality and the Oregon Health Authority.
"(c) A representative of the Regional Solutions Program as described in ORS 284.754.

"(d) Organizations representing cities, counties, special districts,
 economic development districts and public ports.

"(4) The department may hire a staff position, contract with quali fied entities or enter into intergovernmental agreements to carry out
 this section.

"(5) No later than February 15, 2025, the department shall submit
 a report to the committees of the Legislative Assembly related to wa ter, in the manner provided in ORS 192.245, addressing:

"(a) The updated Oregon Infrastructure and Community Facilities
 Inventory.

"(b) The actions and resources needed to maintain and improve the
 Oregon Infrastructure and Community Facilities Inventory.".
