**PROPOSED AMENDMENTS TO
HOUSE BILL 4010**

- 1 On page 2 of the printed bill, delete lines 6 through 15 and insert:
2 “**NOTE:** Section 3 was deleted by amendment. Subsequent sections were
3 not renumbered.”.
- 4 On page 6, delete lines 41 through 45.
5 On page 7, delete lines 1 through 10 and insert:
6 “**NOTE:** Sections 6 and 7 were deleted by amendment. Subsequent
7 sections were not renumbered.”.
- 8 On page 8, delete lines 35 through 45.
9 On page 9, delete lines 1 through 12 and insert:
10 “**NOTE:** Sections 12 and 13 were deleted by amendment. Subsequent
11 sections were not renumbered.”.
- 12 On page 38, after line 2, insert:
13 “**SECTION 47a.** ORS 315.616 is amended to read:
14 “315.616. A resident or nonresident individual who is certified as eligible
15 under ORS 442.561, 442.562, 442.563 or 442.564, and is licensed as a physician
16 under ORS chapter 677, licensed as a [*physician assistant*] **physician asso-**
17 **ciate** under ORS [*chapter 677*] **677.505 to 677.525**, licensed as a nurse prac-
18 titioner under ORS [*chapter 678*] **678.375 to 678.390**, licensed as a certified
19 registered nurse anesthetist under ORS [*chapter 678*] **as defined in ORS**
20 **678.010**, licensed as a dentist under ORS chapter 679 or licensed as an
21 optometrist under ORS 683.010 to 683.340 is entitled to the tax credit de-

1 scribed in ORS 315.613 even if not a member of the hospital medical staff if
2 the Office of Rural Health certifies that the individual:

3 “(1) Is engaged for at least 20 hours per week, averaged over the month,
4 during the tax year in a rural practice; and

5 “(2)(a) If a physician or a [*physician assistant*] **physician associate**, can
6 cause a patient to be admitted to the hospital;

7 “(b) If a certified registered nurse anesthetist, is employed by or has a
8 contractual relationship with one of the hospitals described in ORS 315.613
9 (1); or

10 “(c) If an optometrist, has consulting privileges with a hospital listed in
11 ORS 315.613 (1). This paragraph does not apply to an optometrist who qual-
12 ifies as a ‘frontier rural practitioner,’ as defined by the Office of Rural
13 Health.”.
