30 **“SECTION 6. The amendments to ORS 825.476 by section 5 of this**

1 2024 Act apply to taxes imposed on or after the effective date of this
2 2024 Act.

4 **“REPORT**

6 **“SECTION 7. (1) The Department of Transportation shall prepare a**
7 **report on the statutory changes necessary to balance transportation**
8 **cost responsibility between light and heavy vehicles while also reduc-**
9 **ing the overall weight-mile tax. The report must, at a minimum, in-**
10 **clude:**

11 **“(a) Information about the feasibility of implementing a diesel fuel**
12 **tax;**

13 **“(b) The expected revenue impact of implementing a diesel fuel tax**
14 **and road usage charge;**

15 **“(c) Recommendations on reducing weight-mile tax revenue by in-**
16 **creasing revenue from a diesel fuel tax or road usage charge or a**
17 **combination thereof; and**

18 **“(d) Any other information the department considers important to**
19 **include in the report.**

20 **“(2) In preparing the report, the department shall coordinate with**
21 **the following:**

22 **“(a) The Legislative Revenue Officer or the officer’s designee;**

23 **“(b) The Legislative Policy and Research Director or the director’s**
24 **designee;**

25 **“(c) The chairpersons and vice-chairpersons of the Joint Committee**
26 **on Transportation;**

27 **“(d) A representative of the American Automobile Association;**

28 **“(e) A representative of the Oregon Trucking Association; and**

29 **“(f) A representative of the International Fuel Tax Association In-**
30 **corporated.**

1 **“(3) The department shall submit the report in the manner provided**
2 **by ORS 192.245, and shall include recommendations for legislation, to**
3 **the Joint Committee on Transportation no later than September 15,**
4 **2024.**

5 **“SECTION 8. Section 7 of this 2024 Act is repealed on January 2,**
6 **2025.”.**
