## Taxpayers Association of Oregon urges a No vote on HJR 201 and HB 4075

Oregon Is Already the "Highest Tax State" in the Union:

- As reported last year by CNBC, Oregon is first for middle class effective tax rate. ${ }^{1}$
- Bloomberg reports Portland is the second for most taxed place in America. Those making a salary of $\$ 250,000$ in Portland pay over $\$ 100,000$ in taxes. ${ }^{2}$
- A recent Willamette Week article ranks Oregon ranks fifth for worst affordable housing state. ${ }^{3}$


## HJR 201/HB 4075 work against Governor Kotek's priority to house more Oregonians.

Seniors, the disabled, unemployed, first-time home buyers and people on fixed incomes will be hit hardest by HJR 201/HB 4075.

Small businesses will also feel the pinch. These measures raise taxes on business by providing the ability to tax business personal property and intangibles.

HJR 201 proposes a problematic governance structure that:

- Subverts Local Control from Cities and Counties by creating a new statewide administrative authority on public safety,
- strips the budgeting power of the legislative assembly and gives it to the authority,
- Lacks executive oversight for the new statewide authority.

"I am a disable Veteran, Agent Orange victim and my wife is receiving disability for a long term illness. We are barely able to meet our current obligations. We are now at the point to pay for any additional taxes we will have to cut back on the basic, food, heat and electricity, plus the fuel needed to travel 100 mile round trip to many of our medical appointments. This new proposed property tax would put us in a very difficult financial spot". -- Steve B.
