Testimony submitted after the 48-hour time period will not be uploaded to OLIS. If you are not able to submit your testimony within the open record window, feel free to submit your testimony to your legislator or to committee members directly.

All meeting materials, including your name and any personal information contained in the submitted form, except for your email, are posted to OLIS and are accessible to all major search engines, including Google, Bing, and Yahoo.
