As an MD who has been very concerned about this issue, I wrote an article entitled "The Death of Compassion" under the name Dr. Joy Love on Medium.com. I have been the target of malfeasance of all kinds since I began speaking up about the dangers of the corporate practice of medicine, especially in recent years. "I'm a longtime user of Bentonite clay from several different companies. I chose to order this brand due to it being food grade, good price, & most importantly being packaged in a canister- type container. As the attempt on my life previously described was related to me speaking up about this very issue in the past, it would not surprise me at all if my current experiences are just an escalation of efforts to keep voices like mine quiet in the war going on to put profits over people.
