Kenny had a very difficult childhood, and as he got older he could of easily strayed down the wrong path, but instead he chose the Oregon Army National Guard. He worked on Camp Rilea in Warrenton, Oregon Monday through Friday, and drilled once a month, and two weeks out of the year with 1/162 Infantry. While at Camp Rilea he worked for the Maintenance Section, Recruiting, and Logistics. He had many skill sets that helped support the operations at Camp Rilea and make us a premier training site.

Kenny learned that 2/162 Infantry Battalion was deploying to Iraq, and because he missed the deployment with 1/162 Infantry Battalion he felt obligated to deploy and do his part. Kenny attempted to deploy as a logistician, which was his assigned job. 2/162 Infantry had know Logistic slots available for deployment, as they were all filled. I mentioned to him that they were in need of Infantry Soldiers, and that Canp Rikea was certified to put on an 11B Infantry School in order to fill slots for 2/162 Infantry deployment. Without hesitation Kenny said Chief can you help get me enrolled for 11B school. He said, I don't care what job I have to do I got ro go on this deployment. Kenny got into tge Infantry School, and graduated with high honors. After graduating Kenny and the 2/162 Infantry Battalion where off to their mobilization station, and than Irag. Kenny would call me and my wife every Sunday to let us know he was doing fine, that he needede nothing, and that his patrol missions he went on were successful. He called one Saturday to let me know, that he wouldn't be calling at his normal time Sunday because his unit had a special patrol to go on at that time, and that he would call after tge mission was complete. That Saturday night was the last time I spoke to Kenny, because that Sunday he went on the mission tge vehicle he was in was blown up by an IED.

It would be a crying shame if SRC213 didn't make it to the senate floor and isn't passed. Kenny sacrificed his life for Country and State. He volunteered for a deployment, when he could have easily stayed home in Orgeon. He was what every leader wants as a soldier. Kenny, would have gone far in the Oregon National

Guard, he was headed in the right direction m, and he would have made one hell of a leader one day. If it wasn't for that one Sunday afternoons mission he went out on and didn't make it back alive.

Oregon lost a Soldier, and those at Camp Rilea lost a Soldier, a friend, and a brother. I myself lost a Soldier, an employee, a true friend, and also Kenny was just luhe a son to me. He spent time with me and my family, we went to water parks, basketball games, and much more. Kenny had plans after the deployment he wanted to further his education and also get into computers. Kenny is missed, and will always be missed.

He deserves to be recognized and honored for his service to country. As I stated earlier it would be a disservice if SRC213 didn't make it to the floor and be passed.
