Committee composition

- 10 voting members:
 - 5 management representatives
 - 5 labor representatives
- Appointed by the governor, confirmed by the Senate
- DCBS director serves as a nonvoting ex officio member

Committee administration

- Operates under the Department of Consumer and Business Services
- Workers' Compensation Division provides staff support
- Monthly meetings, more frequent during session
- Meetings are public; agendas and minutes posted online

Committee process

- Studies workers' compensation laws and regulations
- Evaluates benefit adequacy, cost containment, and system efficiency
- Advises on programs funded by the Workers' Benefit Fund

Working with MLAC

- Guidelines for presenting legislative idea or concepts to MLAC: https://www.oregon.gov/DCBS/mlac/Documents/MLAC-legislation-review-guidelines.pdf
- Stakeholders and community members can contact MLAC administrator to ask for a bill to be scheduled on the agenda
- MLAC wants to see bill language before a final vote on the bill
- If MLAC votes on bill, MLAC administrator will provide formal letter to legislative committee that bill was supported or not

Reporting and legislative interface

- Reviews all bills related to workers' compensation
- Submits formal recommendations to the Legislature
- Can be tasked by legislators to study specific areas

Decision-making framework

- Balances labor protections with business cost concerns
- Recommendations require consensus
- Political neutrality enhances MLAC's influence
