Re: Legislative Counsel's 2025-2027 Reduction Options

Dear Cochairs Lieber and Sanchez,

This letter serves as the Office of the Legislative Counsel's response to the October 1, 2025, request of the Legislative Fiscal Office for agency reduction options for the 2025-2027 biennium.

Mission statement

Overseen by the Legislative Counsel Committee, the Office of the Legislative Counsel provides legal and publication services to the Legislative Assembly and its members and other agencies of state government. Legislative Counsel drafts measures and amendments for legislators, legislative committees and state agencies; provides legal advice to legislators and legislative committees; reviews state agency rules for legal sufficiency; prepares indexes and tables for legislative publications; and edits, publishes, sells and distributes the Oregon Revised Statutes, the official bound session laws and other print and electronic publications.

Budget overview

Legislative Counsel's budget consists of three principal programs: the General Program, the Oregon Revised Statutes (ORS) Publications Program and the Legislative Publications Program.

The General Program consists of drafting measures and amendments for legislators and legislative committees, performing legal research and writing opinions for legislators and legislative committees, providing committee testimony and floor session support to members, answering legal questions from members and legislative staff and providing general counsel services like public records request processing and contract review. The General Program includes drafting services that are provided to executive and judicial branch agencies during limited periods of time during the two-year legislative cycle. Pursuant to ORS 173.130, Legislative

Counsel charges officers and agencies of executive and judicial branches for drafting services. Finally, pursuant to ORS 183.710 to 183.730, Legislative Counsel reviews all newly adopted or amended administrative rules for legal sufficiency.

The ORS Publications Program covers the editing, preparation, printing, sale and distribution of the *Oregon Revised Statutes*, including an annotations volume and even-year supplement, and five specialty publications. All proceeds from sales of ORS materials are deposited in the ORS Revolving Account and continuously appropriated for publication and distribution of ORS. Any unexpended and unobligated balance in the ORS Revolving Account in excess of \$500,000 as of July 1 of any odd-numbered year is transferred from the account to the General Fund to be available for general governmental expenditures. On July 1, 2025, the balance of the ORS Revolving Account was \$522,549.

The Legislative Publications Program covers the publication and distribution of the hardbound and constitutionally mandated *Oregon Laws*, which serves as the permanent official record of legislative enactments.³

Legislative Counsel's 2025-2027 legislatively adopted budget totals \$25,865,208 for all funds:

\$22,454,653 General Fund \$729,634 Other Funds Non-Limited \$2,680,921 Other Funds Limited

Legislative Counsel reduction options

As reflected in our mission, Legislative Counsel is an organization that strives to provide excellent client service, most typically in the form of drafting services and legal opinion research and writing provided to members and committees of the Legislative Assembly. Preserving the capability to perform these core services with the high-quality standards and high-speed responsiveness expected of us by the Legislative Assembly is our central objective in identifying specific reduction options. We note that legislative and judicial branch agencies are legally required to retain any remaining General Fund balances, typically referred to as reversions, from the previous biennium for the payment of expenses for the next biennium. To mitigate the impact of General Fund reductions on core services and positions, Legislative Counsel joins with other legislative branch agencies in prioritizing the use of these anticipated reversions from the 2023-2025 biennium to help achieve the reduction targets.

For the 2023-2025 biennium, Legislative Counsel is projected to have a remaining General Fund appropriation totaling \$1,830,120. However, \$1,100,146 has been used to support budget adjustments in the 2025-2027 legislatively adopted budget. A portion of the remaining reversion balance would be used to meet a 2.5 percent reduction target of \$561,366. To meet a 5 percent reduction target of \$1,122,733, the entire 2023-2025 projected reversion balance would be used, as well as a reduction in services and supplies, vacancy savings and personal services.

The ORS Publications Program is dedicated to the printing and distribution of the *Oregon Revised Statutes* and specialty publications. The Legislative Counsel Committee could decide to transfer amounts to the General Fund that the committee considers "unnecessary for use in publishing and distributing future editions or publications." The Legislative Publications Program does not contain a similar exception and would require a statutory change to make a reduction to the program.⁵

Other Funds Limited reductions would come from the General Program's Drafting Services subprogram. To meet a 2.5 percent reduction target of \$67,023, vacancy savings, temporary appointments and services and supplies would be utilized. To meet a 5 percent reduction target of \$134,046, a further reduction to temporary appointments would be utilized.

Other considerations

Although reductions to services and supplies would limit Legislative Counsel's ability to address unanticipated costs, the reductions noted are not expected to impact the office's core program and services. The programs and services that Legislative Counsel provides do not duplicate any programs or services provided by any other state agency. Finally, there is no new or expanded program or service being performed by Legislative Counsel that was established on or after July 1, 2021.
