Subject: 2025-27 BLSW Reduction Options

BLSW Statutory Mission:

The mission of the State Board of Licensed Social Workers is to protect the citizens of Oregon by setting a strong standard of practice and ethics through the regulation of social workers.

The Board of Licensed Social Workers (BLSW) thoroughly examined the 25 – 27 Legislatively Adopted Budget and selected reductions resulting in decreased overall service delivery. Once implemented, enhanced services (such as BLSW attendance at industry conferences and trainings, on site meetings at community locations, BLSW delivered on site trainings, etc.) would be lowered or eliminated. BLSW would deliver only those services closer to our core mission but reduced from the current level of service delivery.

Here are **few examples** of the items BLSW has reduced or eliminated:

- In-state and out-of-state travel
- Employee training
- Forecasted reserve for a licensing system upgrade and office supplies (such as office chairs, sit / stand stations and monitors).

BLSW also significantly reduced funds allocated for contracted temporary office and investigations staff designed to match customer needs. These funds were originally allocated as a cost savings mechanism which allowed BLSW to be responsive to intermittently increased customer demand without the need to hire additional permanent staff.
