Dear Co-Chairs Senator Kate Lieber and Representative Tawna Sanchez,

The Oregon Board of Medical Imaging (OBMI), a completely Other Fund agency, has the privilege of upholding its mission:

*To promote, preserve and protect the public health, safety and welfare of Oregonians who are undergoing medical imaging studies performed by agency license and permit holders for the purpose of medical diagnosis and therapy*

OBMI licensees, over 8000 strong, are the backbone for maintaining the Medical Imaging departments in hospitals, clinics and medical facilities throughout Oregon.

The reduction options were developed to preserve the integrity of the agency's function to ensure the safety of Oregonians through licensure and when needed, disciplinary action. OBMI functions efficiently and timely as demonstrated with excellent scores on the Key Performance Measures. Priority in developing the reductions options was based on the essential need for all positions and FTE to maintain services and programs that concern the licensure of the Five Imaging Modalities and the Limited X-Ray Machine operators.

No new, nor any expanded programs are anticipated.
