Report Requirements

- ▶ What: a report that lists all of the information technology budget and project requests that the Legislative Assembly approved
- ▶ When: due October 31 of each odd-numbered year
- ► From: State Chief Information Officer
- To:
 - Governor
 - Joint Legislative Committee on Information Management and Technology





Report methodology

- ► LFO reviewed agency budget bills
- ► LFO requested budget report by agency of IT categories
- State CIO requested information from agencies
- State CIO performed reasonableness checks of information submitted by agencies to information gathered by LFO
- State CIO shared draft with LFO
- State CIO shared agency component draft with agencies and adjusted based on agency feedback




Report assumptions / caveats

- Report is compilation of enterprise best efforts
- Assumed budgets and projects approved were requested
- Agency IT organization structures vary, instructions were provided to maximize consistency
- Agency assessment and rates for EIS services may be duplicated between the agency IT budget and EIS IT budget
- Some project budgets may be a combination of one-time implementation costs and ongoing maintenance





- Leveraging E-Government .gov platform
 - Oregon Department of Fish and Wildlife
- ► Leveraging ESRI statewide licensing agreement
 - Department of Geology and Mineral Industries





Next Steps

- ► The State CIO shall adopt a policy and a procedure for state agencies to follow in requesting funding for IT budgets and projects
- ► The State CIO, in collaboration with the Legislative Fiscal Office, shall establish criteria for assigning priorities among the budgets and projects
- ► Enterprise Information Services, in collaboration with affected state agencies, shall evaluate budget and project requests the state agencies submit
- Not later than November 30 of the even-numbered year in each biennium the State CIO shall submit a report of requests to the Governor and the Joint Legislative Committee on Information Management and Technology
