

# Community Development Block Grant Disaster Recovery (CDBG-DR) - \$422M



CDBG-DR **long-term recovery** funds are used to help individuals, communities, and businesses impacted by the 2020 Labor Day Disasters, especially with housing recovery.

- Grant agreement signed with HUD in 2023.
- CDBG-DR is intended to be funding of last resort.

**Introduced Legal Services and Resilience Planning programs** with the Governor's Office and Oregon State Bar.

**Substantial Action Plan Amendment** moved AHD funding for Marion/Linn to PIER for Santiam Sewer project.

Funds must be drawn by **February 2029** (six years after HUD-OHCS grant agreement signature).



# CDBG-DR Obligated, Awarded, and Expended

- **OBLIGATED** includes projects in planning, review, and pre-award.
- **AWARDED** includes executed contracts and intergovernmental agreements; awarded amounts are available for subrecipients to request reimbursement.
- **EXPENDED** includes funding distributed through September 2025.

**May 2025:** ~\$25M in executed contracts

- 8 projects were active
- 7 were approved
- 8 were under review
- OHCS was waiting for Jackson, Clackamas, and Marion/Linn to conclude project selections

**Oct 2025:** ~\$31M in executed contracts

- 2 projects are under review
- 8 are approved
- 20 projects are active
- All selection committees have concluded



# Affordable Housing Development (AHD)

All \$104M made available under the AHD program has been awarded to counties, available for reimbursement as requested.

# Housing Support Services

Since May, DRR has launched **two new programs** under HSS available to survivors: Downpayment Assistance and Housing Counseling.

# Homeowner Assistance Reconstruction Program

Updated: 11/14/25

HARP funds can be used for a myriad of activities including home purchase, manufactured home replacement or repair, site-built home reconstruction or repair, and reimbursement, which came online in May of 2025.

# HARP Application Deadline

Updated: 11/14/25

## Overview

- HARP will no longer be accepting new applications after 12/31/25.
- Average of 8-10 applications processed per month.
- Construction is time-intensive, grant closes in 2029.

## Revisions

- Extending recommended eligibility questionnaire deadline to Nov 30<sup>th</sup>
- Once questionnaire is received, application advancement will be secured provided it remains active.



# Legal Services & Resilience Planning

## Resilience Planning:

- Contracted with the Governors' Office (GO) to administer the program.
- Procured assistance from University of Oregon and Oregon State University to provide support for overall plan development/resilience research.
- 53 agreements executed with local partners to conduct resilience forums in their communities to elevate local resilience needs for inclusion into the overall state plan.



## Legal Services:

- Program is up and running with Oregon State Bar (OSB).
- To date, 11 attorneys recruited to provide legal assistance.

# Future Planning & Lessons Learned

- **Data sharing:** Federal, state agency, and local partners
- **Local implementation:** Leveraging community relationships and engaging culturally specific organizations
- **CDBG-DR funding comes with greater restrictions:** Leverage other programs that have more flexibility to support as many impacted households as possible
- **Pair Disaster Case Management (DCM) with local expertise:** Allows local organizations to use resources that help them better support on-the-ground needs
- **Communication and engagement:** Coordinate communication and engagement strategies to share information and set clear expectations for survivors



# Future Planning & Lessons Learned Cont.

- **Updated housing recovery workflow toward permanent housing solutions**
  - Shelter and Temporary Housing (ODHS)
  - Permanent Housing (OHCS)
- Allow for survivors to continue to receive **wraparound services** throughout recovery process.
- **Streamline experience** for survivors and DCM casework with DCM services through Temporary Housing.
- DCM services close when Permanent Housing is achieved.
- **Coordination, relationships, and support** of long-term recovery groups, community action agencies, and other organizations are **essential** to this work.
  - Local community knowledge/expertise helps understand unique needs of individual communities.
