PUBLIC TRANSIT Quail Trail Public Transit Bus

- 5 routes/day, 5 times a day, to and from Chiloquin to Klamath Falls.
- Chiloquin to Sprague River, Beatty, & Klamath Falls & back. Only 1 route and 1 day a week. We have FTA Tribal Transit funding to open this route up to 2 days a week. This route will be specific to Sprague River.
