OREGON WATERSHED ENHANCEMENT BOARD

The Governor has appointed the following individual to the Oregon Watershed Enhancement Board subject to Senate confirmation.¹

Composition³

The board consists of 18 members, including:

- six public members, appointed by the Governor (BORJA, BUSHNELL, COATES, HOEFLICH, MCCLARY, MCLEOD-SKINNER);
- a representative of the Environmental Quality Commission (WEBB);
- a representative of the State Fish and Wildlife Commission (LABHART);
- a representative of the State Board of Forestry (AGPAOA);
- a representative of the State Board of Agriculture (BOYER);
- a representative of the Water Resources Commission (WOLFE);
- the Oregon State University Extension Service director, or designee, nonvoting (KERSHNER);
- a representative of the U.S. Fish and Wildlife Service, nonvoting (ZWARTJES);
- a representative of the U.S. Forest Service, nonvoting (STAAB);
- a representative of the U.S. Bureau of Land Management, nonvoting (CURTIS);
- a representative of the Natural Resources Conservation Service of the U.S. Department of Agriculture, nonvoting (TACHELLA);

- a representative of the U.S. Environmental Protection Agency, nonvoting (BROWN); and
- a representative of the National Marine Fisheries Service of the U.S. of Commerce, nonvoting (VACANT).

The voting members must be knowledgeable about natural resource issues, represent all geographic regions of this state, and include at least one representative of a tribe. The voting members select a chair from among the voting members. At least eight voting members must be present to take action to award grant funds.

Duties⁴

The Oregon Plan for Salmon and Watersheds is a comprehensive program for the protection and recovery of species and for the restoration of watersheds. The board administers the Oregon Plan through grants funded by the Oregon Lottery, federal programs, and the salmon license plate. The board must:

- adopt rules and standards to carry out the watershed enhancement program;
- coordinate its activities with the Natural Resources Division of the State Department of Agriculture;
- facilitate the implementation and administration of the grant programs;
- maintain and administer specified accounts;
- report biennially to the Legislative Assembly on program implementation; and
- report biennially to the Governor and Legislative Assembly about the implementation and effectiveness of the Oregon Plan.
