## STATE BOARD OF CHIROPRACTIC EXAMINERS

---

The Governor has appointed the following individuals to the State Board of Chiropractic Examiners, subject to Senate confirmation..<sup>1</sup>

### New Appointment

John Tuttle of Portland

Scott Fuller of Beaverton

### Terms

January 1, 2026 – December 31, 2028

### Statement of Economic Interest<sup>2</sup>

Not required.

### Composition<sup>3</sup>

The board consists of seven Oregon residents:

- five licensed chiropractors (BARANICK, **FULLER**, MILANOVICH, O'NEILL, **TUTTLE**); and
- two public members (SCHMIDT, WARREN-JOHNSON).

All members may serve recurring three-year terms. Licensed chiropractors must be licensed in Oregon and must have practiced for five years prior to appointment. Public members may not be chiropractors, or a spouse, domestic partner, child, parent, or sibling of a chiropractor. A member may be removed immediately if they are not an Oregon resident, are not licensed, or have three consecutive unexcused absences. The board elects its president, vice president, and secretary-treasurer and must meet each January and July.

## **Duties<sup>4</sup>**

The board regulates chiropractic practice in Oregon. Its duties include

- adopting a seal which is affixed to all licenses it issues;
- adopting rules for the administration and performance of its work;
- adopting minimum educational requirements for licensure; and
- appointing and forming peer review committees to evaluate complaints against chiropractic physicians.
