## STATE BOARD OF DIRECT ENTRY MIDWIFERY

The Governor has appointed the following individual to the State Board of Direct Entry Midwifery subject to Senate confirmation.<sup>1</sup>

#### **New Appointment**

Lori Hedlund of Dallas

#### Term

November 20, 2025 – November 19, 2028

### **Appointment/Confirmation Authority**

ORS 687.470 (2023)

### Statement of Economic Interest<sup>2</sup>

Not required.

#### Composition<sup>3</sup>

The board consists of seven Oregon residents, including:

- four licensed direct entry midwives (CLARK, **HEDLUND**, PETTIBONE, MANCE);
- one certified nurse midwife (MORALES);
- one licensed physician involved, at the time of appointment, in obstetrical care or education (RONICK); and
- one member of the public (FISHER).

Members serve three-year terms. Licensed direct entry midwives may be from a list of nominees, submitted by related professional organizations. The board elects its chair.<sup>4</sup>

#### Duties<sup>5</sup>

The board must adopt rules for the administration of direct entry midwifery licensing, practice, and discipline.
